Amending Regulations under the War Regulations Act, 1914.

ORDER IN COUNCIL.

At the Government Buildings at Wellington, this eighth day of March, 1915.

## Present:

THE HONOURABLE J. ALLEN PRESIDING IN COUNCIL.

WHEREAS by Order in Council made and gazetted on the twenty-sixth day of January, one thousand nine hundred and fifteen, regulations were made providing that no goods imported into New Zealand from Norway, Sweden, Denmark, Holland, Switzerland, or Italy should be delivered from the control of the Customs without complying with the said regulations: And whereas it is now deemed expedient to amend the said regulations:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by the War Regulations Act, 1914, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Excutive Council of the said Dominion, doth hereby amend the said regulations by revoking paragraph (b) of regulation thirteen, save with respect to goods which have already left the country from which they are imported before the date of this Order in Council.

#### ORDER IN COUNCIL.

At the Government Buildings at Wellington, this eighth day of March, 1915.

#### Present:

THE HONOURABLE J. ALLEN PRESIDING IN COUNCIL.

WHEREAS by section forty-seven of the Customs Act, 1913, as extended by section twenty-four of the Regulation of Trade and Commerce Act, 1914, it is enacted that the Governor may from time to time, by Order in Council gazetted, prohibit the exportation of any goods the prohibition of the exportation of which is in his opinion necessary in the public interest: And whereas in the opinion of the Governor it is necessary in the public interest that the exportation of veal and

rabbits, except as hereinafter specified, should be prohibited:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by section forty-seven of the Customs Act, 1913, and section twenty-four of the Regulation of Trade and Commerce Act, 1914, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of that Dominion, doth hereby prohibit the exportation of veal and rabbits from the said Dominion, save and except to ports in the United Kingdom, and save and except where in the case of any other specified port or place the Minister of Customs consents to the exportation to that port or place of any specified quantity of veal or rabbits in a specified ship, and authorizes the lading and exportation thereof accordingly.
