Prohibiting the Export of Certain Goods.

LIVERPOOL, Governor.

ORDER IN COUNCIL.

At the Government Buildings at Wellington, this first day of April, 1915.

Present :

THE RIGHT HONOURABLE W. F. MASSEY, P.C., PRESIDING IN COUNCIL.

WHEREAS by section forty-seven of the Customs Act, 1913, as extended by section twenty-four of the Regulation of Trade and Commerce Act, 1914, it is enacted that the Governor may from time to time, by Order in Council gazetted, prohibit the exportation of any goods the prohibition of the exportation of which is in his opinion necessary in the public interest :

And whereas, in pursuance and exercise of the authority so conferred upon him, the Governor has, by several Orders in Council hereinafter more particularly referred to, prohibited the exportation of certain classes of goods :

And whereas in the opinion of the Governor it is necessary in the public interest, having regard to the war in which His Majesty is now engaged, to revoke the said Orders in Council, and in lieu of the prohibitions therein contained to prohibit the exportation to the places hereinafter specified of the goods set forth in the Schedules hereto :

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by section forty-seven of the Customs Act, 1913, and section twenty-four of the Regulation of Trade and Commerce Act, 1914, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of that Dominion, doth hereby revoke the Orders in Council referred to in the First Schedule hereto, and in lieu thereof doth, with the like advice and consent, prohibit, to the extent set forth in the Second, Third, Fourth, and Fifth Schedules hereto respectively, the exportation of the goods specified in those Schedules.

SECOND SCHEDULE.

GOODS THE EXPORTATION OF WHICH IS PROHIBITED TO ANY DESTINATION, EXCEPT WITH THE CONSENT OF THE MINISTER OF CUSTOMS.

Coal.
 Flour.
 Oatmeal.
 Wheat.
 Oats.
 Forage (that is to say—grass, clover, or oaten-sheaf hay, oaten-sheaf chaff, and bran).

THIRD SCHEDULE.

GOODS THE EXPORTATION OF WHICH IS PROHIBITED TO ANY OTHER DESTINATION THAN THE UNITED KINGDOM, EXCEPT WITH THE CONSENT OF THE MINISTER OF CUSTOMS.

Frozen mutton and lamb.
 Chilled and frozen beef or veal.
 Rabbits.
 Tinned meats.

FOURTH SCHEDULE.

GOODS THE EXPORTATION OF WHICH IS PROHIBITED TO FOREIGN PORTS IN EUROPE OR THE MEDITERRANEAN AND BLACK SEAS OTHER THAN THOSE OF FRANCE, RUSSIA (EXCEPT BALTIC PORTS), BELGIUM, SPAIN, AND PORTUGAL.

Bladders, casings, and sausage-skins.
 Kauri-gum and other resinous products.
 Sulphur.
 Flax (*Phormium tenax*).
 Provisions and victuals which may be used as food for man.
 Foodstuffs for animals.
 Oleaginous seeds, nuts, and kernels.
 Animal and vegetable oils and fats suitable for use in the manufacture of margarine.
 Cakes and meals made from oleaginous seeds, nuts, and kernels.
 Seeds, clover, and grass.
 Bags and sacks of all kinds.
 Asbestos.
 Copra.

FIFTH SCHEDULE.

GOODS THE EXPORTATION OF WHICH IS PROHIBITED TO ANY OTHER DESTINATION THAN THE UNITED KINGDOM AND BRITISH POSSESSIONS AND PROTECTORATES, EXCEPT WITH THE CONSENT OF THE MINISTER OF CUSTOMS.

- Wool.
- Hides, sheep-skins, calf-skins, pig-skins, pelts.
- Barley, linseed, beans, peas.
- Extracts of meat.
- Leather, dressed or undressed, suitable for saddlery, harness, military boots, or military clothing.
- Scheelite.
- Whale oil.
- Petroleum.
- Rubber and goods made of rubber.
- Copper, copper-ore, alloys of copper.
- Graphite.
- Woollen cloth suitable for uniform clothing.
- Woollen yarns.
- Woollen jerseys, jackets, gloves, socks, and men's woollen underwear of all kinds.
- Blankets and horse-rugs.
- Vessels, boats, and craft.
- All goods (not otherwise specifically referred to in any of the Schedules to this Order in Council) which are for the time being contraband of war (whether absolute or conditional) under any Proclamation or Order in Council issued by His Majesty.

LIST OF CONTRABAND.

WITH reference to the above Order in Council it is hereby notified, for the information of the public, that the list of contraband goods under the Royal Proclamations now in force is as follows:—

ABSOLUTE CONTRABAND.

- Arms of all kinds, including arms for sporting purposes, and their distinctive component parts.
- Projectiles, charges, and cartridges of all kinds, and their distinctive component parts.
- Powder and explosives specially prepared for war.
- Ingredients of explosives—namely, nitric acid, sulphuric acid, glycerine, acetone, calcium acetate, and all other metallic acetates, sulphur, potassium nitrate, the fractions of the distillation products of coal-tar between benzol and cresol inclusive, aniline, methylaniline, dimethylaniline, ammonium perchlorate, sodium perchlorate, sodium chlorate, barium chlorate, ammonium nitrate, cyanamide, potassium chlorate, calcium nitrate, mercury.
- Resinous products, camphor, and turpentine (oil and spirit).
- Gun-mountings, limber-boxes, limbers, military wagons, field forges, and their distinctive component parts.
- Range-finders, and their distinctive component parts.
- Clothing and equipment of a distinctively military character.
- Saddle, pack, and draught animals suitable for use in war.
- All kinds of harness of a distinctively military character.
- Articles of camp equipment, and their distinctive component parts.
- Armour-plates.
- Ferro alloys, including ferro-tungsten, ferro-molybdenum, ferro-manganese, ferro-vanadium, ferro-chrome, ferro-nickel, ferro-silicon, ferro-titanium, spiegeleisen.
- The following metals: Tungsten, molybdenum, vanadium, nickel, selenium, cobalt, hæmatite pig-iron, manganese.
- The following ores: Wolframite, scheelite, molybdenite, manganese ore, nickel ore, chrome ore, hæmatite iron ore, zinc ore, lead ore, bauxite, tin ore.
- Aluminium, alumina, salts of aluminium, alloys of aluminium.

Antimony, together with the sulphides and oxides of antimony and alloys of antimony.
 Copper, unwrought and part wrought, all kinds, including alloys of copper (such as brass, gun-metal, naval brass and delta metal, phosphor copper and phosphor bronze), copper and brass sheets, circles, slabs, bars, pipes, ingots, scrap, rods, plates, solid-drawn tubes, condenser plates, copper wire, brass wire, bronze wire, solder containing copper.
 Lead, pig, sheet, or pipe.
 Tin, chloride of tin.
 Barbed wire, and implements for fixing and cutting the same.
 Warships, including boats, and their distinctive component parts of such a nature that they can only be used on a vessel of war.
 Submarine sound-signalling apparatus.
 Aeroplanes, airships, balloons, and aircraft of all kinds, and their component parts, together with accessories and articles recognizable as intended for use in connection with balloons and aircraft.
 Fusel oil (amyl alcohol), amyl acetate, aceto-celluloses, trephenyl phosphate.
 Motor vehicles of all kinds, and their component parts.
 Tires for motor vehicles and for cycles, together with articles or materials especially adapted for use in the manufacture or repair of tires.
 Rubber, including raw, waste, and reclaimed rubber, and goods made wholly of rubber.
 Iron-pyrites.
 Mineral oils and motor spirit.
 Implements and apparatus designed exclusively for the manufacture of munitions of war, for the manufacture or repair of arms, or war material for use on land or sea.
 Raw wool, wool tops and noils, woollen and worsted yarns.
 Castor-oil.
 Paraffin wax.
 Copper iodide.
 Lubricants.
 Hides of cattle and horses; skins of calves, pigs, sheep, goats, and deer.
 Leather, undressed or dressed, suitable for saddlery, harness, military boots, or military clothing.
 Ammonia and its salts, whether simple or compound; ammonia liquor.
 Urea, aniline, and their compounds.

CONDITIONAL CONTRABAND.

Foodstuffs.
 Forage and feeding-stuffs for animals.
 Oleaginous seeds, nuts, and kernels.
 Animal and vegetable oils and fats (other than linseed oil) suitable for use in the manufacture of margarine.
 Cakes and meals made from oleaginous seeds, nuts, and kernels.
 Clothing, fabrics for clothing, and boots and shoes, suitable for use in war.
 Gold and silver in coin or bullion; paper money.
 Vehicles of all kinds (other than motor vehicles) available for use in war, and their component parts.
 Vessels, craft, and boats of all kinds; floating docks, parts of docks, and their component parts.
 Railway material, both fixed and rolling stock, and materials for telegraphs, wireless telegraphs, and telephones.
 Fuel other than mineral oils.
 Powder and explosives not specially prepared for use in war.
 Horse-shoes and shoeing materials.
 Harness and saddlery.
 Field-glasses, telescopes, chronometers, and all kinds of nautical instruments.
 Tanning substances of all kinds.
