*Allowing the Export of Specified Goods to British Destinations.*

 ORDER IN COUNCIL.

At the Government House at Wellington, this twenty-second day of November, 1915.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by section forty-seven of the Customs Act, 1913, as extended by section twenty-four of the Regulation of Trade and Commerce Act, 1914, it is enacted that the Governor may from time to time, by Order in Council gazetted, prohibit the exportation of any goods the prohibition of the exportation of which is necessary in the public interest:

And whereas, in pursuance and exercise of the authority so conferred upon him, the Governor has, by Order in Council dated the first day of April, one thousand nine hundred and fifteen, and published in the *New Zealand Gazette* of the sixth day of April, one thousand nine hundred and fifteen, prohibited the exportation of various goods under the conditions set forth in the said Order in Council:

And whereas in the opinion of the Governor it is necessary in the public interest to amend the said Order in Council to the extent hereinafter stated:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by section forty-seven of the Customs Act, 1913, and section twenty-four of the Regulation of Trade and Commerce Act, 1914, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of that Dominion, doth hereby amend the aforesaid Order in Council by deleting from the Second Schedule thereto the following goods, namely:—

- Flour.
- Oatmeal.
- Wheat.
- Oats.
- Forage (that is to say—oaten-sheaf hay, oaten-sheaf chaff, and bran).

And by inserting in the Fifth Schedule thereto the following goods, namely:—

Flour, oatmeal, wheat.

Oats.

Forage (that is to say—oaten-sheaf hay, oaten-sheaf chaff, and bran).

And doth, with the like advice and consent, order that this Order in Council shall come into force on and after the twenty-second day of November, one thousand nine hundred and fifteen.

And whereas in the opinion of the Governor it is necessary in the public interest that the exportation of unset diamonds should be prohibited to the extent and in the manner hereinafter appearing:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by section forty-seven of the Customs Act, 1913, and section twenty-four of the Regulation of Trade and Commerce Act, 1914, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of that Dominion, doth hereby prohibit the exportation of unset diamonds from the said Dominion save with the consent of the Minister of Customs.

*Prohibiting the Importation of Unset Diamonds.*

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by section forty-six of the Customs Act, 1913, as extended by section two of the Regulation of Trade and Commerce Amendment Act, 1915, it is enacted that the Governor may by Order in Council prohibit the importation of any goods the prohibition of the importation of which is in his opinion necessary in the public interest:

And whereas in the opinion of the Governor it is necessary in the public interest that the importation of unset diamonds should be prohibited to the extent and in the manner hereinafter appearing:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by section forty-six of the Customs Act, 1913, and section two of the Regulation of Trade and Commerce Amendment Act, 1915, and of all other powers and authorities enabling him in that behalf, doth hereby prohibit the importation of unset diamonds into the Dominion of New Zealand save with the consent of the Minister of Customs.
