Amending War Regulations of 13th October, 1916, in so far as they relate to Certificates of Interest in respect of Goods imported into New Zealand from Hayti.

LIVERPOOL, Governor. ORDER IN COUNCIL.

At the Government House at Wellington, this twenty-sixth day of March,

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

HEREAS by Order in Council dated the thirteenth day of October, one thousand nine hundred and sixteen, and published in the Gazette of the same date, His Excellency the Governor of the Dominion of New Zealand, in pursuance of the War Regulations Act, 1914, and its amendments, made certain regulations under that Act providing, inter alia, that a certificate of interest as defined in the said Order in Council is required in respect of all goods imported into New Zealand from the countries mentioned in the Second Schedule thereto: And whereas the requirement as to certificates of interest does not apply in respect of goods imported into New Zealand from Hayti: And whereas in the opinion of the Governor it is necessary in the public interest that certificates of interest as aforesaid should be required in respect of goods imported into New Zealand from Hayti:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers conferred on him by the War Regulations Act, 1914, and its amendments, doth hereby amend the hereinbefore-recited Order in Council of the thirteenth day of October, one thousand nine hundred and sixteen, in the manner set forth in the Schedule hereto.

SCHEDULE.

A CERTIFICATE of interest, within the meaning of the hereinbefore-recited Order in Council of the 13th day of October, 1916, shall hereafter be required in respect of all goods imported into New Zealand from Hayti, and the said Order in Council is hereby amended accordingly by omitting from the Second Schedule thereto the word "Hayti."

Amending Regulations under the War Regulations Amendment Act, 1916 (relating to the Delegation of Powers by Attorneys and Others).

At the Government House at Wellington, this twenty-sixth day of March, 1917.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by section three of the War Regulations Amendment Act, 1916, it is provided that the Governor in Council may by regulations make such provisions as he thinks advisable for enabling an attorney, agent, trustee, executor, or administrator while out of New Zealand to exercise and perform his powers, functions, and duties as such in New Zealand through the agency of the Public Trustee, or any other attorney, delegate, or substitute, and for determining the rights and liabilities resulting from any such delegation of authority: And whereas by Order in Council made pursuant to the said section on the second day of September, one thousand nine hundred and sixteen, it is provided that an attorney, agent, trustee, executor, or administrator who, being a member of an Expeditionary Force under the Expeditionary Forces Act, 1915, is absent from New Zealand on His Majesty's service, or is about to leave New Zealand on such service, may, by a power of attorney executed by him, delegate to the Public Trustee all or any of the powers, functions, or duties conferred or imposed upon him as such attorney, agent, trustee, executor, or administrator: And whereas it is advisable to extend the powers so conferred in the manner hereinafter set forth:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of that Dominion, and in pursuance and exercise of the powers conferred on me by section three of the War Regulations Amendment Act, 1916, and of all other powers and authorities enabling me in that behalf, do hereby extend the herein-before-recited regulations of the second day of September, one thousand nine hundred and sixteen, in the manner set forth in the Schedule hereto.

SCHEDULE.

1. In addition to the powers of delegation conferred by the hereinbefore-recited regulations, an attorney, agent, trustee, executor, or administrator who, being a member of an Expeditionary Force under the Expeditionary Forces Act, 1915, is absent from New Zealand on His Majesty's service, or is about to leave New Zealand on such service, may, by a power of attorney executed by him, delegate all or any of the powers, functions, or duties conferred or imposed upon him as such attorney, agent, trustee, executor, or administrator to any person or body corporate that may be approved for the purpose by a Judge of the Supreme Court, or a Stipendiary Magistrate, on application in that behalf by that attorney, agent, trustee, executor, or administrator.

2. Where, pursuant to the powers conferred by the last preceding

2. Where, pursuant to the powers conferred by the last preceding clause, any powers, functions, or duties are delegated to any person or body corporate other than the Public Trustee, all references to the Public Trustee in clauses 2, 3, 4, and 5 of the regulations aforesaid shall, for the purposes of such delegation, be deemed to be references to that person or body corporate, and the said clauses shall be construed accordingly.

Amending an Order in Council of 15th February, 1917, fixing the Maximum Price of Butter.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

W HEREAS by Order in Council dated the fifteenth day of February, one thousand nine hundred and seventeen, and published in the Gazette of the same date, His Excellency the Governor of the Dominion

of New Zealand, in pursuance of the authority conferred on him by section two of the Regulation of Trade and Commerce Act, 1914, did fix and determine the maximum price of butter in New Zealand in accordance with the provisions of the Schedule to that Order in Council: And whereas by clause seven of the said Schedule it is provided that nothing in the said Order in Council shall apply to butter destined by the purchaser for exportation and not for consumption or use in New Zealand: And whereas it is further provided by the said clause seven that the term "exportation" includes shipment as ships' stores: And whereas it is desirable that the application of the said Order in Council should be extended as hereinafter provided:

Now, therefore, His Excellency the Governor of the Dominion of New

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers conferred on him by section two of the Regulation of Trade and Commerce Act, 1914, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby extend the operation of the hereinbefore-recited Order in Council in the manner set forth in the Schedule hereto, and doth hereby declare that this Order in Council shall come into force on the twenty-eighth day of March, one thousand nine hundred and

seventeen.

SCHEDULE.

THE Order in Council hereinbefore referred to shall, notwithstanding anything to the contrary therein expressed, extend and apply to butter destined by the purchaser for shipment as ships' stores for the use of any vessel belonging to a shipowner all of whose ships are engaged exclusively in the coastal trade of New Zealand.
