WHEREAS by a Proclamation dated the fourth day of October, one thousand pine handled. of October, one thousand nine hundred and seventeen, and published in the New Zealand Gazette of the eleventh day of October, one thousand nine hundred and seventeen, the boundaries of the Counties of Patangata and Waipukurau were altered by the exclusion of a certain area from the County of Patangata and the inclusion of such area in the County of Waipukurau:
And whereas it is desirable that the area so added to the

And whereas it is desirable that the area so added to the County of Waipukurau should be included in a riding to be known as the Purimu Riding of that county:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section twenty-two of the Counties Act, 1908, do hereby declare that the areas included as aforesaid in the County of Waipukurau shall, as on and from the third day of April, one thousand nine hundred and eighteen he included. of April, one thousand nine hundred and eighteen, be included in a riding to be known as the Purimu Riding of the said county, and that the boundaries of that riding shall be those set forth in the Schedule hereto.
