ORDER IN COUNCIL.

At the Government Buildings at Wellington, this fifteenth day of December, 1919.

THE HONOURABLE SIR WILLIAM FRASER PRESIDING IN COUNCIL.

N pursuance and exercise of the power and authority conferred upon him by the War Regulations Act, 1914, and of every other power and authority enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of that Dominion, doth hereby revoke the War Regulations referred to in the Schedule hereto and providing for certificates in respect of imported goods.

THE HONOURABLE SIR WILLIAM FRASER PRESIDING IN COUNCIL. HEREAS provision has been made by the Undesirable Immigrants Exclusion Act, 1919, to prevent the entry into New Zealand of undesirable immigrants:

And whereas it is therefore expedient to revoke the War Regulations

relating to the same matter

Now, therefore, His Excellency the Covernor General of the Dominion of New Zealand, acting the and with the advice and consent of the Executive Council of that Dominion, doth hereby, in pursuance and exercise of the power and authority conferred upon him by the War Regulations Act, 1914, and of every other power and authority enabling him in this behalf, revoke the War Regulations referred to in the Schedule hereto; and doth hereby colore that this Order in design shall come into force on the first day of January, one thousand nine hundred and twenty.
