Shooting Season for Native Game, Ashburton Acclimatization District.

LIVERPOOL, Governor-General.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following native game—viz., grey duck, black teal, and black swan—may be killed within the Ashburton Acclimatization District, comprising the County of Ashburton (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive.

And I do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twenty head in all.

SCHEDULE.

AREAS WHEREIN NATIVE GAME SHALL NOT BE KILLED.

1. ALL that area in the Canterbury Land District, being the two small lakes known as Maori Lakes, situated in the Heron and Tripp Survey Districts, and the area included in a line running parallel to and twenty chains distant from the shores of those lakes.

2. All lands notified or set apart as sanctuaries or reserves for the preservation of imported or native game.

Shooting Season for Imported and Native Game, License Fee, &c., Auckland Acclimatization District.

LIVERPOOL, Governor-General.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game—viz., cock pheasants and Californian and Australian quail—may be killed within the Auckland Acclimatization District, comprising all that area in the North Auckland, Auckland, Taranaki, and Wellington Land Districts bounded by a line commencing at the mouth of the Mokau River, and proceeding thence along high-water mark, Tasman Sea, in a northerly direction generally (crossing the mouths of all harbours and rivers by the way) to the Kaipara Harbour entrance to a point midway between Kaipara Heads; thence up the centre of the channels, Kaipara Harbour, leading to the mouth of Oruawhero River; thence up the middle of that river, Topuni River, and Hakaru River to the north-west corner of Section 33, Oruawhero Parish; thence along the south-western boundaries of Sections 65, 64, 61, 60, 57, 56, 51, and 50, all in Mangawhai Parish, and along the eastern boundary of the last-mentioned section to a public road; thence south-easterly along that road to a point opposite south-west corner of Section 92 in the aforesaid parish; thence across that road and proceeding along the western boundaries generally of said Section 92 and Sections 90, 89, 88, 87, and 86 in the aforesaid parish to a public road; thence north-westerly along that road to a stream near the headwaters of the Mangawhai Harbour; thence down the middle of that stream and the middle of that harbour to the sea; thence along high-water mark of the sea, Hauraki Gulf and Firth of Thames (crossing the mouths of all harbours and rivers by the way), to the mouth of the

Waikawau River in Block VI, Hastings Survey District; thence up the middle of that river to its source, and along a right line from said source to Northhead, Tairua Harbour; thence southerly along high-water mark, Bay of Plenty (crossing the mouths of all harbours and rivers by the way), to the mouth of the Waihi River in Block III, Waihi North Survey District; thence south-westerly along a right line to Mount Te Aroha Trig. Station; thence north-easterly along a right line (in the direction of Ngakuriwhare Trig. Station, Block I, Katikati North) to the western boundary of the Tauranga Confiscation Block; thence south-easterly by right lines from hill to hill along the summit of the range forming the western boundary of the aforesaid Tauranga Confiscation Block and passing over Ngatamahinerau, Mimio-tohanga, and Waiuanu to Te Weraiti Trig. Station; thence south-easterly along a right line to Puwhenua Trig. Station (in Block VIII, Tapapa Survey District); thence south-westerly along a right line to Rangitoto Mountain; thence south-easterly along a right line to the source of the Ongaruhe River; thence southerly along a mountain range passing through Weraroa, Tuhingamata, Motere, and Hauhangaroa Trig. Stations to Maungaku Trig. Station; thence southerly along the western boundary of the Waione Block to the Wanganui River; thence down the middle of that river to its confluence with the Ohura River; thence up the middle of the Ohura River to the 39th parallel of south latitude; thence easterly along the said parallel of latitude to the western boundary of Block IV, Pouatu Survey District; thence due north along that boundary and the western boundary of Block XVI, Waro Survey District, to the confiscation line; thence north-easterly along that line to the Tangarakau Stream; thence up the middle of that stream and up the middle of the Waitaanga Stream to the Kotare Road at the southern boundary of Section 2, Block VII, Waro Survey District; thence westerly along the Kotare Road to the south-west corner of Section 1, Block VII; thence along the south-west boundary of the said section and along the southern, western, and northern boundaries of Section 3, Block VI, Waro Survey District, to the western boundary of Section 4, Block VI, Waro Survey District; thence along the western boundaries generally of Sections 4 and 5, and along the south-western and northern boundaries of Section 6 (all in Block VI, Waro Survey District) to the Mohakatino Road; thence northerly along that road to a stream which crosses the Mohakatino-Pariminihi 1st East Block and flows into the Mohakatino Stream near the westernmost corner of Section 1, Block III, Waro Survey District; thence down that stream to the said confluence and up the said Mohakatino Stream and along the northern boundary of Section 3, Block III, Waro Survey District, to Tawhitirau Trig. Station; thence along the south-western and western boundaries of Mokau-Mohakatino 1st Block to the Mokau River; thence down the middle of that river to the sea, the place of commencement: including in the hereinbefore-described area the islands of Waiheke and Ponui and Great Barrier Island (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive. And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Chief Postmasters at Auckland and Thames, and the Postmasters at Ahuroa, Aria, Avondale, Awakino, Awhitu, Bombay, Buckland, Cambridge, Clevedon, Devonport, Drury, East Tamaki, Ellerslie, Frankton Junction, Glen Murray, Gordonton, Hairini, Hamilton, Hamilton East, Helensville, Henderson, Hikutaia, Hinuera, Hobsonville, Howick, Hunua, Huntly, Kaipara Flats, Karangahake, Karekare, Kaukapakapa, Kawhia, Kihikihi, Kingsland, Kinohaku, Komata, Kumeu, Leigh, Manawaru, Mangaiti, Mangapehi, Manurewa, Marakopa, Maramarua, Makatana, Matamata, Matiere, Mauku, Mercer, Morrinsville, Mount Albert, Newmarket, Newton, Ngaruawahia, Northcote, Ohaupo, Ohura, Okoroire, Omahu, Onehunga, Onewhero, Ongaruhe, Otahuhu, Otorohanga, Paeroa, Pakuranga, Papakura, Papatoetoe, Parakakau, Paterangi, Patumahoe, Pipiroa, Pirongia, Point Chevalier, Pokeno, Port Albert, Puhoi, Pukekawa, Pukekohe, Putaruru, Raglan, Rangiriri, Silverdale, Tahuna, Tairua, Takapuna, Tangitu, Taupiri, Te Aroha, Te Awamutu, Te Hana, Te Kuiti, Te Mata, Te Rauamo, Te Uku, Tirau, Tuakau, Turua, Waerenga, Waharoa, Waihi, Waihou, Waikino, Waikumete, Waimauku, Waiorongomai, Waitekauri, Waitoa, Waitomo Caves, Waituku, Waiwera, Waiton, Waotu, Warkworth, Wellsford, Whatawhata, Whawharua, and Whitford, are hereby appointed to sign and issue the said licenses to kill imported game.

And I do further notify that the following native game—viz., pukeko and black swan—may be killed within the above-mentioned district (except in the areas mentioned in the Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day

of July, one thousand nine hundred and twenty, both days inclusive, and that no live birds of any species shall be used as decoys on or near any waters within the Auckland Acclimatization District, nor shall more than twenty-five artificial decoys be used at any one time, whether by one or several persons, on any particular water within an area of less than 100 square yards; and do hereby restrict the number of native game that may be killed by any one person in any one day to not more than twenty-five head in all.

SCHEDULE.

AREAS WHEREIN IMPORTED AND NATIVE GAME SHALL NOT BE KILLED.

1. ALL that area in the County of Waitemata bounded on the north by the Wairau Creek from its mouth to the main road from Devonport to Waiwera; on the west by the said road to its junction with the Sea View Road; on the south by that road to the sea; and on the east by the sea to the point of departure.
2. All those areas at Waitakerei, Nihotapu, and Huia, in the County of Waitemata, vested in or under the control of the Auckland City Council for the purposes of waterworks, recreation, or the conservation of the native flora and fauna.
3. Little Barrier Island, Hauturu, Auckland (see *New Zealand Gazette* No. 104, of the 14th December, 1899, page 2266).
4. Hen and Chickens Islands.
5. All that area within a radius of three miles from the General Post-office, Auckland.
6. The Rangiriri (or Karaka) Lake, Waikato.
7. St. John's Lake and area adjacent (see *New Zealand Gazette* No. 43, of the 2nd May, 1901, page 986).
8. All that section, containing by admeasurement 141 acres, more or less, being the Hamilton Domain, including the Rotoiti or Hamilton Lake, Borough of Hamilton.
9. Fresh-water Lake, known as Lake Hakanoa, near Huntly, Waikato, and an area of five chains in width surrounding the said lake.
10. All that part of the Waihou River between the Waiorongomai Bridge and the Mangaiti Bridge over such river.
11. Great Barrier Island County.
12. Auckland Acclimatization Society's Game Farm at Cambridge.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game—viz., cock pheasants and Australian quail—may be killed within the Bay of Islands Acclimatization District, comprising the County of Bay of Islands and part of the County of Hokianga (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive. And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Postmasters at Russell, Kohukohu, Kaikohe, Kawakawa, Rawene, Herekino, Ohaeawai, Broadwood, Hukerenui, Opononi, Opua, Taheke, Towai, Waimamakau, Waiotemarama, Whangape, and Okaihau are hereby appointed to sign and issue the said licenses to kill imported game.

And I do further notify that the following native game—viz., grey duck, teal, pukeko, and black swan—may be killed within the above-mentioned district (except in the areas mentioned in the Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both

days inclusive; and I do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twenty-five head in all.

ALL that area in the Auckland Land District consisting of the following Native blocks: Tautahanga, Te Pua, Waimimiti, Maungakawakawa, Te Ngako, Haowhenua, Okokako, Tangatapu, Te Ahuahu, Pokapu, Kaporahoru, Kaiwhakairi, Ahitunatawa, Karawa, Poukai, Rarakareo, Pirikotaha, and Sections Nos. 1 and 2, situated in Blocks XI, XII, XV, and XVI, Omapere Survey District.

Shooting Season for Imported and Native Game, License Fee, &c., Buller Acclimatization District.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game—viz., hares—may be killed within the said Buller Acclimatization District, comprising the Buller and part of the Inangahua Counties, in the Nelson Land District, bounded towards the north-west generally by a line starting at a point on the Tasman Sea coast at Kohaihai Bluff, in Block XIII, Whakapoi Survey District, and proceeding up a leading spur and along the summit of a range over Mount Domett to Mount Cobb; thence towards the north-east generally by a line along the summit of the western ranges over Mount Snowdon and Mount Peel to Mount Arthur; thence towards the south-east by a line along the summit of a leading range over Mount Luna and along the summit of Lyell Range to Bald Hill; thence by a line down a leading spur on the western side of Eight-mile or Boundary Stream to the mouth of that stream; thence down the left bank of the Buller River and up the right bank of the Inangahua River to a point due north of Mount Haast; thence by a right line to Mount Haast; thence by a right line to the nearest point of the Grey River; thence towards the south-west generally by a line down the middle of the Grey River to its confluence with the Otututu River; thence by a line up the middle of the Otututu River to its source near Mount Faraday; thence by a right line to Mount Faraday; thence towards the south-east by a line along the summit of the Paparoa Range to a point near the source of the Punaikaiki or Deadman's River; thence towards the south-west generally by a right line to that source, and by a line down the middle of that river to the sea; thence towards the north-west by the Tasman Sea to Kohaihai Bluff, the place of commencement (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and I do hereby restrict the number of hares that may be killed by any one person in any one day to twenty. And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Chief Postmaster at Westport is hereby appointed to sign and issue the said licenses to kill imported game.

And I do further notify that the following native game—viz., grey duck, pukeko, and black swan—may be killed within the above-mentioned district (except in the areas mentioned in the Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and I do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twenty head in all.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game—viz., cock pheasants and Australian quail—may be killed within the Coromandel Acclimatization District, comprising the County of Coromandel and Gannet Island (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and I do hereby restrict the number of cock pheasants that may be killed by any one person in any one day to twelve. And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Postmasters at Whitianga, Cabbage Bay, Kuaotunu, and Coromandel are hereby appointed to sign and issue the said licenses to kill imported game.

And I do further notify that the following native game—viz., grey duck, teal, and black swan—may be killed within the above-mentioned district (except in the areas mentioned in the Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and I do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twenty-five head in all.

And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Postmasters at Feilding, Kimbolton, Apiti, Halcombe, Pohangina, Rangiwahia, and Ashhurst are hereby appointed to sign and issue the said licenses to kill imported game.

And I do further notify that the following native game—viz., grey duck and black swan—may be killed within the above-mentioned district (except in the areas mentioned in the Second Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and I do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twenty-five head in all.

Shooting Season for Imported and Native Game, License Fee, &c., Whangarei Acclimatization District.

LIVERPOOL, Governor-General.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game—viz., cock pheasants and Australian quail—may be killed within the Whangarei Acclimatization District, comprising the County of Whangarei and part of the County of Otamatea (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and do hereby restrict the number of cock pheasants that may be killed by any one person in any one day to twelve. And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Postmasters at Aponga, Hikurangi, Kamo, Kiripaka, Limestone, Mangapai, Mangawai, Maungakamea, Parakao, Parua Bay, Poroti, Ruakaka, Titoki, Waikiekie, Waipu, Whakapara, and Whangarei are hereby appointed to sign and issue the said licenses to kill imported game.

And I do further notify that the following native game—viz., black swan, grey duck, pukeko, and teal—may be killed within the above-mentioned district (except in the areas mentioned in the Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twelve head in all.

SCHEDULE.

AREAS WHEREIN IMPORTED AND NATIVE GAME SHALL NOT BE KILLED.

ALL that area in the Auckland Land District, containing by admeasurement approximately twenty-eight square miles, situated in Purua and Whangarei Survey Districts, and comprising all the land within the circumference of a circle having a radius of three miles, and its centre near the hatcherie at the intersection of the eastern boundary of Ketenikau No. 7, in Block VIII, Purua Survey District, with the north side of the road cutting off the extreme south-eastern corner of the said Ketenikau No. 7.

The boundary as exactly indicated above passes approximately through the places locally known as follows: Starting at the north it crosses Kauri Road just south of Big Mountain Trig. Station; thence going westerly and southerly it crosses the Ruatangata Road at Ngararatunua Settlement; afterwards crossing Three-mile Bush Road near Campbell's; after passing through State Forest Reserves of 1,580 acres and 1,600 acres it strikes Maunu Road near Black Bridge; crossing Otaika Road at Raumanga it passes to the south-east of the Borough of Whangarei, and crosses Head's Road at Reyburn's house; after crossing Whareora Road near the caves and Kiripaka Road near the church the boundary passes through Cork's Farm and back to starting-point; including the Borough of Whangarei and the Town District of Kamo.

All that area in the Auckland Land District, containing by admeasurement 1,600 acres, more or less being a reserve for water-conservation, situated in Blocks XI and XII, Purua Survey District. Bounded towards the north-east by Taikoia Block, Pukemiro Block, and Sections 55, 52, and 76; towards the east by Harahora Block; towards the south generally by Sections 1, 2, and 3, Taikawiri Block, Sections 4, 5, 6, 7, and 8, Waihoanga Block, and Te Hape Block; and towards the west generally by Section 28, Crown Land, and State forest reserve.

Also all lands notified or set apart as sanctuaries or reserves for the preservation of imported or native game.

Certain Species of Birds indigenous to New Zealand not to be deemed protected.

ORDER IN COUNCIL.

At the Government House at Wellington, this twelfth day of April, 1920.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers and authorities vested in him by the Animals Protection Act, 1908, as amended by the Animals Protection Amendment Act, 1910, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby suspend the operation of section ten of the said Animals Protection Amendment Act, 1910, for the period commencing on the first day of May, one thousand nine hundred and twenty, and ending on the thirty-first day of July, one thousand nine hundred and twenty, with respect to the species of birds indigenous to New Zealand mentioned in the Schedule hereto; and, with the like advice and consent, doth declare that such suspension shall be subject to the provisions contained in the Warrants in respect of the shooting season in each acclimatization district.

Notice respecting Native and Imported Game.

Department of Internal Affairs,

THE attention of sportsmen, game-dealers, and others is called to the following provisions of the Animals Protection Act, 1908, and the Animals Protection Amendment Act, 1910

THE ANIMALS PROTECTION ACT, 1908.

SECTION 36.—No person shall kill, destroy, or shoot at any game or native game with anything but a shoulder gun, and no such gun must exceed size No. 10 at muzzle. No gun shall exceed 10 lb. in weight.

Any person offending against this provision is liable to a penalty not exceeding £20.

Section 31.—No imported game or native game to be exported without the written consent of the Minister of Internal Affairs.

Season for taking or killing native and imported game (other than deer and godwits), 1st May to 31st July.

Section 10.—Fee for license to take or kill imported game (other than deer) to be £1.

Section 30.—No imported or native game, whether chilled or otherwise, to be held in possession for a greater period than seven days after close of season.

THE ANIMALS PROTECTION ACT, 1910.

Section 2.—Use of cylinders prohibited.

Section 10.—Every person who destroys or injures or captures any bird which is indigenous to New Zealand, or who robs or destroys the nest of any such bird, is liable to a fine not exceeding £20.

The following native game has been exempted from above provisions during shooting season: Pukeko, teal, grey duck, spoonbill duck, wild geese, and black swan.
