IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following native game --viz., grey duck, black teal, and black swan-may be killed within the Ashburton Acclimatization District, comprising the County of Ashburton (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive

And I do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twenty head in all.

#### SCHEDULE.

AREAS WHEREIN NATIVE GAME SHALL NOT BE KILLED.

1. ALL that area in the Canterbury Land District, being the two small lakes known as Maori Lakes, situated in the Heron and Tripp Survey Districts, and the area included in a line running parallel to and twenty chains distant from the shores of those lakes.

2. All lands notified or set apart as sanctuaries or reserves for the preservation of imported or native game.

IN exercise of the powers vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game--viz., cock pheasants and Cali-fornian and Australian quail--may be killed within the Auckland Acclimatization District, comprising all that area in the North Auckland, Auckland, Taranaki, and Wellington Land Districts bounded by a line commencing at the mouth of the Mokau River, and proceeding thence along high-water mark, Tasman Sea, in a northerly direction generally (crossing the mouths of all harbours and rivers by the way) to the Kaipara Harbour entrance to a point midway between Kaipara Heads; thence up the centre of the channels, Kaipara Harbour, leading to the mouth of Oruawhero River; thence up the middle of that river, Topuni River, and Hakaru River to the north-west corner of Section 33, Oruawhero Parish : thence along the south-western boundaries of Sections 65, 64, 61, 60, 57, 56, 51, and 50, all in Mangawhai Parish, and along the eastern boundary of the last-mentioned section to a public road; thence south-easterly along that road to a point opposite south-west corner of Section 92 in the afore-said parish; thence across that road and proceeding along the weatern houndaries of Section 92 in the afore-said parish; thence across that road and proceeding along the weatern boundary of the last-mentioned section said parish; thence across that road and proceeding along the western boundaries generally of said Section 92 and Sections 90, 89, 88, 87, and 86 in the aforesaid parish to a Sections 30, 89, 88, 87, and 80 in the aloresaid parish to a public road; thence north-westerly along that road to a stream near the headwaters of the Mangawhai Harbour; thence down the middle of that stream and the middle of that harbour to the sea; thence along high-water mark of the sea, Hauraki Gulf and Firth of Thames (crossing the mouths of all harbours and rivers by the way), to the mouth of the

Station (in Block VIII, Tapapa Survey District); thence south-westerly along a right line to Rangitoto Mountain; thence south-easterly along a right line to the source of the Onga-ruhe River; thence southerly along a mountain range passing through Weraroa, Tuhingamata, Motere, and Hauhangaroa Trig. Stations to Maungaku Trig. Station; thence southerly along the western boundary of the Waione Block to the Wanganui River; thence down the middle of that river to its confluence with the Ohura River; thence up the middle of the Ohura River to the 39th parallel of south latitude; thence easterly along the said parallel of latitude to the western boundary of Block IV, Pouatu Survey District; thence due north along that boundary and the western boundary of Block XVI, Waro Survey District, to the con-fiscation line; thence north-easterly along that line to the Tangarakau Stream; thence up the middle of that stream and up the middle of the Waitaanga Stream to the Kotare Road at the southern boundary of Section 2, Block VII; Waro Survey District; thence westerly along the Kotare Road to the south-west corner of Section 1, Block VII; thence along the south-west boundary of the said section and along the southern, western, and northern boundaries of Section 3 Road to the south-west corner of Section 1, Block VII; thence along the south-west boundary of the said section and along the southern, western, and northern boundaries of Section 3, Block VI, Waro Survey District, to the western boundary of Section 4, Block VI, Waro Survey District; thence along the western boundaries generally of Sections 4 and 5, and along the south-western and northern boundaries of Section 6 (all in Block VI, Waro Survey District) to the Mohakatino Road; thence northerly along that road to a stream which crosses the Mohakatino Parininihi 1D East Block and flows into the Mohakatino Stream near the westernmost corner of Section 1, Block III, Waro Survey District; thence down that stream to the said confluence and up the said Mohakatino Stream and along the northern boundary of Section 3, Block that stream to the said confluence and up the said Mohakatino Stream and along the northern boundary of Section 3, Block III, Waro Survey District, to Tawhitirau Trig. Station 30; thence along a right line in the direction of the confluence of the northern branch of the Waipawa River with the Makaroro River to the summit of the Ruahine Range; thence southerly along the summit of the said range to the source of the Pourangaki Stream, and down that stream to its confluence with the Kawhatau Stream, down the middle of the said Kawhatau Stream to its confluence with the Rangitikei with the Kawhatau Stream, down the middle of the said Kawhatau Stream to its confluence with the Rangitikei River; thence down the middle of the Rangitikei River to the Awahuri-Bull's Road, and easterly along that road to the Oroua River; thence up the middle of the Oroua River to the Wellington – New Plymouth Railway line; thence south-casterly along said railway-line and Stony Creek Road to the Palmerston-Ashhurst Road; thence north-easterly along that road to the northernmost corner of Section 454, Block VIII, Kairanga Survey District; thence south-easterly along the Raukawa Road fronting Sections 454 and 455 of along the Raukawa Road fronting Sections 454 and 455 of the said block to the centre of the Manawatu River; thence up the middle of that river to and along the northern boundary of the Wellington Land District to the mouth of the Waimata River; thence southerly along the sea-coast to Cape Palliser, westerly generally along the sea-coast to Cape Tcrawhiti, and northerly along the sea-coast to the mouth of the Wangaehu River, the point of commencement : including all adjacent islands except Kapiti.

I veroise of the powers vested in me by the Animals Pro-tection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby notify that the following imported game—viz., cock pheasants and Australian quail — may be killed within the Whangarei Acclimatization District, comprising the County of Whangarei and part of the County of Otamatea (except in the areas mentioned in the Schedule hereto), from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and do hereby restrict the number of cock pheasants that may be killed by any one person in any one day to twelve. And I do further notify that licenses to kill such imported game within the said district shall be issued to any person on payment of the sum of twenty shillings each; and the Postmasters at Aponga, Hikurangi, Kamo, Kiripaka, Limestone, Mangapai, Mangawai, Maungakaramea, Parakao, Parua Bay, Poroti, Ruakaka, Titoki, Waikiekie, Waipu, Whakapara, and Wha-ngarei are hereby appointed to sign and issue the said licenses to kill imported game. Mad I do further notify that the following native game— viz., black swan, grey duck, pukeko, and teal—may be killed within the above-mentioned district (except in the areas mentioned in the Schedule hereto) from the first day of May, one thousand nine hundred and twenty, to the thirty-first day of July, one thousand nine hundred and twenty, both days inclusive; and do hereby restrict the number of such native game that may be killed by any one person in any one day to not more than twelve head in all.

#### SCHEDULE.

AREAS WHEREIN IMPORTED AND NATIVE GAME SHALL NOT BE KILLED.

ALL that area in the Auckland Land District, containing by admeasurement approximately twenty eight square miles, situated in Purus and Whangarei Survey Districts, and com-prising all the land within the circumference of a circle hav-ing a radius of three miles, and its centre near the hatcheries at the intersection of the eastern boundary of Ketenikau No. 7, in Block VIII, Purua Survey District, with the north side of the road cutting off the extreme south-eastern corner of the said Ketenikau No. 7. The boundary as exactly indicated above passes approxi-mately through the places locally known as follows: Starting at the north if Eastern wire Pacet of the Starting Mention

at the north it crosses Kauri Road just south of Big Mountain Trig. Station; thence going westerly and southerly it crosses the Ruatangata Road at Ngararatunua Settlement; after wards crossing Three-mile Bush Road near Campbell's; after passing through State Forest Reserves of 1,580 acres and 1,600 acres it strikes Mannu Road near Black Bridge; cross-ing Otaika Road at Baymana it passes to the crossnot acres it strikes maint Road hear black Bridge; cross-ing Otaika Road at Raumanga it passes to the south-east of the Borough of Whangaroi, and crosses Head's Road at Reyburn's house; after crossing Whareora Road near the caves and Kiripaka Road near the church the boundary passes through Cork's Farm and back to starting-point; including the Borough of Whangarei and the Town District of Kamo of Kamo

All that area in the Auckland Land District, containing by admeasurement 1,600 acres, more or less being a reserve for water-conservation, situated in Blocks XI and XII, Purua for water-conservation, situated in Blocks XI and XII, Purua Survey District.
