FRANKLIN COUNTY COUNCIL.

Special Order adjusting Representation in the County and altering Riding Boundaries.

In exercise of the powers conferred on it by section 23 of the Counties Act, 1908, the Franklin County Council hereby resolves, by way of special order, as follows:—

1. The present division of the County of Franklin into nine ridings is revoked, and in lieu thereof the said county shall be divided into ten ridings, to be called respectively Awhitu Riding, Waiuku Riding, Waipipi Riding, Karaka Riding, Mauku Riding, Pukekohe East Riding, Pukekohe West Riding, Drury Riding, Mercer Riding, and Hunua Riding, which said ridings are respectively described in the Schedule hereto.

2. The said Franklin County Council shall consist of ten members, and each riding shall elect one Councillor.

3. The alteration hereby made shall take effect on and after the 28th day of October, 1920.

All that area in the North Auckland Land District bounded towards the north generally by a right line from a point on the western shore of Waiuku Estuary and due west from the south head of Taihiki Estuary produced to the said head, and thence by the last-mentioned estuary to the western boundary-line of Section 103, Waiuku East Parish; thence towards the north-east generally by Sections 103, 102, 101, and 91, Waiuku East Parish, to the road at the westernmost corner of the last-mentioned section; thence by that road bounding Sections 91, 89, 88, 87, 86, 85, 84, and 83, Waiuku East Parish, to Section 19, Puni Parish; thence by said Section 19 and by Sections 18, 2, and 1, Puni Parish, to the Section 19 and by Sections 18, 2, and 1, Puni Parish, to the Purapura Native Reserve; thence by that Native reserve and its south-western boundary-line produced to the left bank of the Waikato River; thence towards the south-east by the left bank of that river to a point due south of the south-western corner of Te Uku Block (Native reserve); thence towards the the reserve is the reserve to a point due south of the south-western corner of Te Uku Block (Native reserve); Schedule hereto.

2. The said Franklin County Council shall consist of ten members, and each riding shall elect one Councillor.

All that area in the North Auckland Land District bounded towards the south-west by the Tasman Sea from a point on the coast being the termination of a right line from the middle of the road at the south-western angle of Section 147, Wailing Parish, and being a line in continuation of the road forming the south-western angle of Section 147, Wailines of Allotments 8 and 9, Suburbs of Purapura, across another pipi Parish, and being a line in continuation of the road forming the south-western angle of Section 147, Wailines of Allotment 11, Suburbs of Purapura, across another pipi Parish, and being a line in continuation of the road forming the south-western boundary-lines of Sections 29 and 28, Waiuku East Parish, the south-western boundary-lines of Allotments 8 and 9, Suburbs of Purapura, across another pipi Parish, and being a line in continuation of the road towards the west generally by a right line to the said corner; thence by the western boundary; thence by the road towards the west generally by a right line to the said corner; thence by the western boundary; thence by the road forming its northern boundary-lines of Sections 226 and 225, and the southern boundary-lines of Sections 29 and 28, Waiuku East Parish, the south-western boundary-lines of Allotments 8 and 9, Suburbs of Purapura, across another pipi Parish, and being a line in continuation of the road towards the western boundary-lines of Allotments 8 and 9, Suburbs of Purapura, across a road, by the south-eastern and western road, by the south-eastern and western boundary-lines of Section 24, Waiuku East Parish, to the across a road, by the south-eastern and western boundary-lines of Section 24, Waiuku East Parish, to the across a road, by the south-eastern and western boundary-lines of Sections 22, 12 of Waiuku Town District at north-western corner of Section 11, Waiuku East Parish (cometery reserve); thence by the Waiuku Town District as described on page 3047 of the New Zeoland Gazette of 1914 to the western shore of the Waiuku Estuary; and thence by the western shore of that estuary and the Awhitu Riding, hereinbefore described, to the place of commencement.

3. Waipipi Riding.

All that area in the North Auckland Land District bounded towards the north-west by the Awhitz Riding, hereinbefore described, from the Tasman See to Mokorau, in the Waiuku Estuary; thence towards the north-east by the Waiuku Estuary, and by the Waiuku Towa District as described on page 3047 of the New Zealand Gazette of 1914, and by the Waiuku Riding, hereinbefore described, to the left bank of the Waikato River; towards the south-east by the said left bank to the Tasman Sea; thence towards the south-west by the Tasman Sea to the Awhitu Riding hereinbefore described.

4. Karaka Riding,

All that area in the North Auckland Land District bounded All that area in the North Augustand Land District bounded towards the north-west generally by the Manukau Harbour from Te Hihi Estuary to Karaka Point; thence towards the north-east by the Pahurehure Estuary and by the north-eastern side of Hingaia and Slippery Creeks to a point in the middle of the Great South Road; thence towards the east generally by the middle of that road to a point in line with the northern boundary-line of Section 40, Opaheke Parish; the northern boundary-line of Section 40, Opaheke Parish; thence by a right line to the north-eastern corner of said Section 40; thence by the said northern boundary-line and its production to the middle of the stream forming the western boundary of the said Section 40; thence by a line along the middle of that stream to a point in line with the north-west boundary-line of a subdivision of Section 41 (102 acres 1 rood 10 perches), Opaheke Parish, the property of J. C. Clark in the year 1900; thence by a right line to the northernmost corner of the said subdivision of the said Section 41 (containing 100 acres), the property of Frank Ballard in the year 1900, to the western boundary of the Parish of Opaheke; thence by the Opaheke Parish to the south-eastern corner of Section 81, Karaka Parish; thence towards the south-east Section 81, Karaka Parish; thence towards the south-east by the Pukekohe Parish to the southernmost corner of Section 60, Karaka Parish; thence towards the south-west by the Pukekohe Parish and Waiau Parish to the north-western corner of Section 10, Karaka Parish; thence still towards the south-west by the right bank of the Te Hihi Estuary to the Manukau Harbour at the point of commencement.

5. Mauku Riding.

All that area in the North Auckland Land District bounded towards the north-west generally by the Manukau Harbour from the westernmost corner of Section 35, Waiau Parish, from the westernmost corner of Section 35, Waiau Parish, to the Te Hihi Estuary; thence towards the north-east by the Karaka Riding, hereinbefore described, to the Pukekohe Parish boundary at the south-eastern corner of Lot 5 of Section 11, Waiau Parish; thence towards the south-east and north-east by the Pukekohe Parish; thence again towards the south-east by Sections 33, 35, 37, 40, 41, 43, 42, 1, and 2, Parish of Puni; thence towards the south-west by the Waiuku and Awhitu Ridings, hereinbefore described, to Manukau Harbour, the place of commencement.

6. Pukekohe East Riding

All that area in the North Auckland Land District bounded towards the north-west generally by the Karaka Riding, hereinbefore described, from the easternmost corner of Section 82, Karaka Parish, to the southernmost corner of Section 41, Opaheke Parish; thence again towards the northwest by the south-eastern boundary of the said Section 41, Opaheke Parish, to the northernmost corner of Allotment 10 of Section 5, Opaheke Parish; thence towards the east generally. of Section 5, Opaneke Parish; thence towards the east generally by the creek forming part of the western boundary of Section 47 of Opaneke Parish, across a road, by the said creek forming the western and southern boundary-lines of Section 88, Opaneke Parish, to the north-westernmost corner of Section 253; thence by the western and southern boundary-lines of said Section 253, part of the western boundary-line of Section 47, Opaneke Parish, western boundary-line of Section 48, Opaneke Parish, western boundary-line of Section 47, Opaneke Parish, western boundary-line of Section 47, Opaneke Parish, western boundary-line of Section 47, Opaneke Parish 41, Western Boundary-line of Section 42, Western Boundary-line of Section 41, Western Boundary-line of Section 41, Western Boundary-line of Section 41, Western Boundar section 44, Opaneke Parish, western boundary-lines of sections 50 and 51, Opaneke Parish, and southern boundary-line of said Section 51, and that boundary-line produced to the middle of the Great South Road; thence towards the east generally by the middle of that road to a point in line with the north-western boundary-line of Section 22, Mangatawhiri Parish; thence by a right line to the north-eastern corner of said Section 22; thence towards the south-east by Sections 22, 46, 45, 44, and 43, Mangatawhiri Parish, to the north-eastern corner of Section 43, Mangatawhiri Parish; thence towards the north-east by the south-western boundary-line of Section 43, and that boundary-line produced to the middle of the Razorback to Whangarata Road; thence towards the south-east by the middle of that road to a point

in line with the north-eastern corner of part of Lots 4 and 5 of a subdivision of Sections 9 and 47/50, Mangatawhiri Parish (containing 161 acres 0 roods 29 perches), the property of Bird Brothers in the year 1920; thence by a right line to the said corner; thence towards the east by the eastern boundary-line of the said part of Lots 4 and 5 to the northern boundary-line of Lot 2 and part Lot 3 of a subdivision of Sections 9 and 47/49, Mangatawhiri Parish (79 acres 3 roeds 26 perches), owned by Susan Brewster in the year 1920; thence towards the north and east by part of the northern boundary-line and the eastern boundary-line of the said Lot 2 and part Lot 3 to the northern boundary-line of Lot 3 of 1 (containing 88 acres 0 roods 29 perches), being a subdivision of Sections part 9 and 47/49, Mangatawhiri Parish (owned by Leonard Middleton in the year 1920); thence towards the north by the northern boundary-line of said Lot 3 of 1, and towards the east by the eastern boundary-line of said Lot 3 of 1 and that boundary-line produced to said Lot 3 of 1; and towards the east by the eastern boundary-line of said Lot 3 of 1 and that boundary-line produced to the middle of the Whangarata to Pokeno Road; thence to-wards the south-east by the middle of that road to a point in line with the north-eastern boundary-line of Section 10, Mangatawhiri Parish; thence by a right line to the north-eastern corner of said Section 10; thence towards the north-east by Sections 16 and part 7 of the aforesaid parish to the public road at the south-eastern corner of said Section 10; thence by a right line across the said road to the northern public road at the south-eastern corner of said Section 10; thence by a right line across the said road to the northern boundary-line of Section S.W. 68, Mangatawhiri Parish; thence towards the north and north-east generally by a public road to the north-eastern corner of Section N.E. 68, Mangatawhiri Parish; thence towards the east by Section 69, Mangatawhiri Parish; thence towards the south-east and east generally by the road along the southern boundary-line of Section S.W. 68, Mangatawhiri Parish, and the eastern boundary-lines of Sections 66 and 65, Mangatawhiri Parish, to the right bank of the Waikato River; thence by a line due south to the left bank of the Waikato River; thence towards the south generally by the said left bank of the Waikato River to a point due south of the westernmost corner of Section 108, Tuakan Parish; thence towards the west generally by a right line to the said corner; thence by the south-eastern boundary-lines of Section 109, Tuakan Parish, Section 43, Pukekohe Parish, Sections 7 and 6, Tuakan Parish; thence across a road; thence by southern Parish, Section 43, Pukekohe Parish, Sections 7 and 6, Tuakau Parish; thence across a road; thence by southern boundary-line of Section 11A, Tuakau Parish, south-eastern and north-eastern boundary-lines of Section 11, Tuakau Parish, eastern boundary-lines of Sections 10 and 13 of Tuakau Parish, to the North Island Main Trunk Railway line; thence by the said railway-line to the south-eastern boundary-line of Section 24, Pukekohe Parish; thence by the Borough of Pukekohe as described on page 1135 of the New Zealand Gazette of 1916 to the southern boundary-line of Section 14, Pukekohe Parish; thence by the southern and eastern boundary-lines of said Section 14, eastern boundary-lines of Sections 13 and 3 of the Parish of Pukekohe, to the place of commencement: excluding therefrom the Tuakau Town District, as described on page 2516 of the New Zealand Gazette, 1914. Gazetle, 1914.

7. Pukekohe West Riding.

All that area in the North Auckland Land District bounded towards the north-west generally by the Mauku and Karaka Ridings, hereinbefore described, from the northernmost corner Ridings, hereinbefore described, from the northernmost corner of Section 2, Puni Parish, to the south-easternmost corner of Section 82, Karaka Parish; thence towards the east generally by the Pukekohe East Riding, hereinbefore described, to a point on the left bank of the Waikato River due south of the westernmost corner of Section 108, Tuakau Parish; thence towards the south and south-east generally by the said left bank of the Waikato River to a point on said left bank produced by a right line from the south-western boundary-line of Purapura Native Reserve; thence towards the west generally by the Waiuku Riding, hereinbefore described, to the place of commencement: excluding therefrom the Borough of Pukekohe, as described on page 1135 of the New Zealand Gazette of 1916.

8. Mercer Riding.

All that area in the North Auckland Land District bounded towards the west and north generally by the Pukekohe East Riding, hereinbefore described, from a point on the left bank of the Waikato River due south of the south-eastern corner of Section 65, Mangatawhiri Parish, and by the Drury Riding, hereinafter described, to the middle of the road opposite the southernmost corner of Section 136, Opaheke Parish; thence towards the north-west generally by the middle of the said public road forming the eastern boundary-line of said Section 136, and part of the eastern boundary-line of Section 134, Opaheke Parish, to a point opposite the south-western corner of Section 13, Otau Parish; thence by the southern and eastern boundary-lines of said Section 12, Otau Parish, southern boundary-lines of Sections 81a and 108, Otau Parish, eastern boundary-lines of Sections 81a and 108, Otau Parish, eastern boundary-lines of All that area in the North Auckland Land District bounded

said Section 108, Sections 61, 59, 58, 57, 55, 103, and 102, Otau Parish, to the Manukau County boundary at the northeastern corner of said Section 102; thence towards the north by the Manukau County as described on page 1989 of the New Zealand Gazette of 1915 to the Hauraki Gulf; thence towards the east by the said Hauraki Gulf to the Pukorokoro Creek; thence towards the south by a right line across the said creek to the portheasternment corner of Section 82 Koheroa Parish; thence by that section and by the Pokeno-Miranda Road to the middle of the Mangatangi Stream; thence by the middle of that stream to the Maramarua River, and by the middle of that stream to the maramarus River, and by the middle of the Maramarus River to its confluence with the Whangamarino River; thence towards the south by the middle of the Whangamarino River to the left bank of the Waikato River; thence by the left bank of the Waikato River to the place of commencement.

9. Drury Riding.

All that area in the North Auckland Land District bounded All that area in the North Auckland Land District bounded towards the north generally by the Papakura Town District, as described in the New Zealand Gazette of 1919, page 138, and by the Manukau County, as described in the New Zealand Gazette No. 70, of 1915, page 1989, from the Pahurehure Estuary to the southernmost corner of Section 171, Hunua Parish; thence towards the north-east and south by the Estuary to the southernmost corner of Section 171, Hunua Parish; thence towards the north-east and south by the Parish of Hunua to Hay's Creek; thence towards the east generally by that creek, by the western and south-western boundary-lines of the parts of Section 52, Opaheke Parish, owned by W. Bate and P. Holt in the year 1899, to the northwestern corner of Section 81, Hunua Parish; and thence by Hunua Parish to the south-western corner of Section 199 of that parish; thence again towards the north generally by the said Hunua Parish to a point on the Maungawheau Stream in line with the middle of the road abutting on the said stream at the north-easternmost corner of Section 125. said stream at the north-easternmost corner of Section 125, Opaheke Parish; thence from that point again towards the east generally by the middle of the said road forming the east generally by the middle of the said road forming the western boundary-lines of Sections 96, 126, 203, 205 (E.R.), 209, and 90, Opaheke Parish, to a point in line with the southern boundary-line of Section 90, Opaheke Parish; thence again towards the north by the southern boundary-line of said Section 90 produced to a point in the middle of the public road forming the eastern boundary-line of said Section 90; thence again towards the east generally by the middle of the said public road forming the western boundary-lines of Sections 133, 135, and 136, Opaheke Parish, to a point in line with the southernmost corner of said Section 136; thence again towards the south generally by the south-eastern boundary-line of Section 135, Maungatawhiri Parish, by a right line produced from the southernmost corner of said Section 135, and passing through Section 239, Maungatawhiri Parish, to the easternmost corner of Section 238, Mangawhiri Parish, to the easternmost corner of Section 238, Mangatawhiri Parish, by the northern, north-western, and part of the western boundary-lines of said Section 239, Mangatawhiri Parish, to the northernmost corner of Section 240, Mangatawhiri Parish; thence by the north-western boundary-line of said Section 240 produced to the middle of a public road; thence by the middle of a public road to a

point opposite the northernmost corner of Section 227, Mangatawhiri Parish; thence by part of the western boundary-line of said Section 227 and northern boundary-line of Section 104, Mangatawhiri Parish, to the road at the north-western corner of said Section 104; thence by the eastern side of the road to a point in line with the northern boundary-line of Section 171, Mangatawhiri Parish; thence across that road and by Section 171 aforesaid to the road forming its north-western boundary; thence by the eastern side of that road to the south-western corner of Section 169, Mangatawhiri Parish; thence across that road and by Sections 168 and 156, Mangatawhiri Parish, to the road at the north-western corner of the tawhiri Parish, to the road at the north-western corner of the last-mentioned section; thence across that road and by its western side to the road forming the north-western boundary of Section 147, Mangatawhiri Parish; thence by the southern side of that road to the north-western corner of Section 146, side of that road to the north-western corner of Section 146, Mangatawhiri Parish; thence by the western boundary-line of said Section 146 to the north-eastern corner of Allotment 21 of Suburban Section 2, Mangatawhiri Parish; thence by the northern boundary-line of said Allotment 21, across a public road, and by the northern boundary-line of Allotment 11 of said Suburban Section 2, Mangatawhiri Parish, produced to the middle of the Great South Road; thence towards the west generally by the Pukekohe East and Karaka Ridings, hereinbefore described, to the Pahurehure Estuary; and thence again towards the north-west by the said Pahurehure Estuary to the place of commencement.

10. Hunua Riding.

All that area in the North Auckland Land District bounded towards the north generally by the Manukau County, as described on page 1989 of the New Zealand Gazette of 1915, from the southernmost corner of Section 171, Hunua Parish, to the north-eastern corner of Section 102, Otau Parish; thence towards the east generally by the Mercer Riding, hereinbefore described, to the middle of the public road opposite the southernmost corner of Section 136, Opaheke Parish; thence towards the west, south, and north generally by the Drury towards the west, south, and north generally by the Drury Riding, hereinbefore described, to the place of commencement.
