Altering Boundaries of Waitotara and Patea Counties.

[L.S.] JELLICOE, Governor-General. A PROCLAMATION.

WHEREAS it is provided by subsection two of section three of the Counties Amendment Act, 1913, that the boundaries of any one or more counties may be altered in accordance with a resolution proposing the alteration passed by the Council of each of such counties in which the

And whereas a resolution was passed by the Waitotara County Council on the twelfth day of July, one thousand nine hundred and twenty, and sealed with the seal of the Council of the said county on the twelfth day of July, one thousand nine hundred and twenty:

And whereas a similar resolution was passed by the Patea County Council on the thirteenth day of September, one thousand nine hundred and twenty, and sealed with the seal of the said county on the thirteenth day of September, one thousand nine hundred and twenty, praying for the alteration of the boundaries of such counties in the manner described in the said resolutions and in the First Schedule hereto: And whereas it is expedient to make such alteration in accordance with the said resolutions:

Now, therefore, in pursuance and exercise of the power and authority conferred on me by the said Act, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the First Schedule hereto, being now part of the Patea County, shall, as on and from the first day of April, one thousand nine hundred and twenty-one, be deemed to be added to and form part of the Waitotara County; and, with the like power and authority, do proclaim and declare that the boundaries of the Counties of Waitotara and Patea respectively shall, as on and from the aforesaid

River from its intersection by a right line running from Mount Humphries to the confluence of that river with the River from its intersection by a right line running from Mount Humphries to the confluence of that river with the Tangarakau River to the sea, along the seashore to the mouth of the Waitotara River, and along the middle of that river to a point opposite the mouth of the Mangaone Stream, to and along that stream and along the southern boundary of Section 16, Block V, Nukumaru Survey District, to Wharekarangi Trig. Station; thence along the eastern boundary of Section 16 aforesaid to and along the Mangaone Stream to the south-eastern corner of Lot 4 on plan No. 659, deposited in the office of the District Land Registrar at Wellington; thence along the south-eastern boundary of that lot to and across the Waitotara Road and along the western boundaries of Lots 14 and 17 on plan No. 918, deposited as aforesaid, to Orangihoangi Trig. Station, and along the south-eastern and north-eastern boundaries of Section 11, Block XIV, Momahaki Survey District, and the Mangamingi Stream, to and along the Te Korokio Stream, and along the western and northern boundaries of the Manganui-o-tahu Block to the western boundary of Lot 3 of Mangapapa No. 18 Block; thence along that boundary and the western and northern boundaries of that road and the summit of the range over Maungarau Trig. Station to Mount Humphries; and thence along a right line running in the direction of the confluence of the Tangarakau River with the Wanganui River to the middle of the latter river, the place of commencement: excluding the part of the Borough of Wanganui which is in the above-described area and the Town District of Castlecliff and Gonville. and Gonville.

BOUNDARIES OF PATEA COUNTY.

Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the said Municipal Corporations Amendment Act, 1913, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that on and from the first day of April, one thousand nine hundred and twenty-one, the area described in the Schedule hereto shall be excluded from the County of Manayertu and included in the Borrough of from the County of Manawatu and included in the Borough of Feilding.

SCHEDULE.

AREA INCLUDED IN THE BOROUGH OF FEILDING.

ALL that area in the Wellington Land District bounded by a line commencing at the north-western corner of Allotment 23 on plan 999, deposited in the office of the District Land Registrar at Wellington, and proceeding in a southerly direction along the western boundary of that allotment and the production thereof to the north-western corner of Allotment 26 on the aforesaid plan No. 999; thence towards the west by the northern boundary of Allotment 25 on the said plan for a distance of 204.6 links; thence towards the southeast by lines bearing 171° 40′ for a distance of 292.8 links, and 134° 12′ for a distance of 112 links to the western boundary of the aforesaid Allotment 26, and towards the south by the western boundaries of Allotments 26 and 26A on the aforesaid plan No. 999 to the south-western corner of the said Allotment 26A; thence towards the west generally by the northern ALL that area in the Wellington Land District bounded by a plan No. 999 to the south-western corner of the said Allotment 26a; thence towards the west generally by the northern side of the Ranfurly Road to a point in line with the eastern boundary of Allotment 6 on the aforesaid plan No. 999; thence southerly across Ranfurly Road to and by the eastern boundary of Allotment 6 aforesaid to the northern boundary of Allotment 4 on plan 2289, deposited in the office of the District Land Registrar at Wellington; thence towards the east by the said northern boundary of Allotment 4 to a public road; thence towards the south generally by the southern side of that road to the north-eastern corner of Allotment 1 on the aforesaid plan No. 2289, again towards the south by the eastern boundary of the aforesaid Allotment 1 and that boundary produced to Glasgow Terrace; thence towards the west by the northern side of Glasgow Terrace to a point in line with the eastern side of Windsor Terrace; thence towards the south by a right line across Glasgow Terrace and by the eastern side of Windsor Terrace to the southern side of Warwick Street; thence towards the east by the said southern Warwick Street; thence towards the east by the said southern side of Warwick Street and the production thereof to the eastern side of the Awahuri Road; thence towards the northeast by the said eastern side of the Awahuri Road to a point in line with the southern side of Geisen Road; thence towards the west and north-east generally by the southern and western boundaries of the Borough of Feilding, as described in New Zealand Gazette No. 25, of the 27th March, 1902, page 732, to

the Feilding-Sandon Road; thence towards the west by the southern side of the Feilding-Sandon Road to the north-western corner of Allotment 23 on the aforesaid plan No. 999, the place of commencement.

WHEREAS application has been made, under section twenty, subsection one, of the Finance Act, 1919, for the precedent consent of the Governor-General in Council to enable the Otago Harbour Board to borrow the sum of two hundred and five thousand pounds for the renewal of loans falling due in London, and it is expedient that such consent should issue:

HEREAS by Proclamation dated the eighth day of September, one thousand nine hundred and twenty, and gazetted on the ninth day of the same month, the Borough of Ngaruawahia (hereinafter referred to as the "said borough") was constituted, comprising the whole of the Town District of Ngaruawahia (hereinafter referred to as the "said town district") and a part of the County of Raglan:

And whereas it is desirable to make arrangements with respect to the property, rights, claims, obligations, liabilities, contracts, and engagements of the Ngaruawahia Town Board:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in him by section three hundred and sixty-eight of the Municipal Corporations Act, 1908, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that as from the constitution of the said borough the Corporation of the said borough shall, in respect of all the property, rights, claims, obligations, liabilities, contracts, and engagements of the Ngaruawahia Town Board:

And doth hereby further declare that it shall be lawful for the Council of the said borough, during the period from the constitution of the said borough, until the thirty-first day of

And doth hereby further declare that it shall be lawful for the Council of the said borough, during the period from the constitution of the said borough until the thirty-first day of March, one thousand nine hundred and twenty-one, being the end of the present financial year, to borrow moneys from its bank by way of overdraft, but so that the amount of such overdraft shall not at the end of the present financial year exceed the total amount of the income of the Ngaruawahia Town Board for the year ended the thirty-first day of March, one thousand nine hundred and twenty, not including in such income any moneys received by way of grant from the General Government, or any moneys borrowed or any moneys received for separate rates or special rates:

And doth further declare that the Chairman and members of the Board of the said town district shall be deemed to have been the local authority of the said borough during the period between the said date of constitution and the date of coming into office of the first Council of the said borough.
