*Regulations under the Immigration Restriction Act, 1908, and the Immigration Restriction Amendment Act, 1920.*

ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 10th day of January, 1921.

Present :

THE RIGHT HONOURABLE W. F. MASSEY, P.C., PRESIDING IN COUNCIL.

IN pursuance and exercise of the powers conferred on him by the Immigration Restriction Act, 1908, and the Immigration Restriction Amendment Act, 1920, and of all other powers and authorities enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby revoke the regulations specified in the Second Schedule hereto, and doth hereby make the following regulations.

REGULATIONS.

1. In these regulations the expression "the principal Act" means the Immigration Restriction Act, 1908 :

"The Amendment Act, 1920," means the Immigration Restriction Amendment Act, 1920.

2. (1.) The permit to enter New Zealand required under section 5 of the Amendment Act, 1920, may be in the form numbered 1 or the form numbered 2 in the First Schedule hereto.

(2.) The temporary permit under section 8 of the Amendment Act, 1920, shall be in the form numbered 2 in the First Schedule hereto.

(3.) Every permit as aforesaid shall be issued subject to the conditions printed thereon.

3. The form of application for a permit to enter New Zealand as required by section 9 of the Amendment Act, 1920, shall be in the form numbered 3 in the First Schedule hereto.

4. (1.) For the purpose of ensuring compliance with the provisions of the principal Act and the Amendment Act, 1920, an Officer of Customs shall board every vessel arriving from places beyond New Zealand forthwith after its arrival at any port or harbour in New Zealand.

(2.) The master of the vessel shall forthwith deliver to the Officer of Customs the passenger-list and crew-list, or a true copy thereof, and shall truly answer any questions relating to the passengers and crew put to him by the Officer for the purposes of the said Acts.

5. The master of every vessel arriving from places beyond New Zealand shall certify in writing, in the form numbered 4 in the First Schedule hereto, as to whether there is any passenger or member of the crew on board his ship who is subject to the restrictions indicated upon the said form or in the notes thereto. Such certificate shall be delivered by the master to the Officer of Customs.

6. The master shall make suitable arrangements to the satisfaction of the Officer of Customs for enabling him to inspect and examine each passenger and each member of the crew, and shall also provide such writing-materials and accommodation as may be required by that Officer for the purposes of the said Acts and these regulations.

7. The Officer of Customs may put such questions as he deems necessary to any passenger or member of the crew for the purposes of the said Acts, and every person who refuses or fails to answer any such question, or who answers any such question in a manner which is false or misleading in any material particular, commits an offence against these regulations.

8. The Health Officer shall inform the Officer of Customs as to any person on board the vessel who comes within the restrictions of section 4 or of paragraphs (b) and (c) of subsection (1) of section 14 of the principal Act.

9. No vessel arriving from beyond New Zealand shall come alongside any wharf or landing-place without the permission of an Officer of Customs.

10. Any prohibited immigrant arriving at a New Zealand port *en route* to some place beyond New Zealand may be permitted to land for a period not exceeding twenty-one days : Provided that in every such case there shall be deposited with the Collector of Customs security by cash, or a bond or other satisfactory security, that the person named therein shall report himself to the Collector upon departure from New Zealand within the time specified.

11. (1.) Every person resident in New Zealand who desires to leave New Zealand with the intention of returning thereto, and who is a person who would require a permit to enter New Zealand, shall apply for a certificate of registration to

the Collector of Customs at the port nearest to the place where he is best known, or at the final port of departure. Every such person shall be required to provide two unretouched and unmounted half-length recent photographs of himself, not to exceed in size 4½ in. by 3½ in., and to be not less than 3 in. by 2 in.

(2.) One of the photographs aforesaid shall be securely attached to the certificate, and the other to the duplicate of the same.

(3.) The Collector shall thereupon issue a certificate in the form numbered 5 in the First Schedule hereto, and deliver it to the person applying for the same when the said person is on board the ship by which he is to leave New Zealand. A duplicate of this certificate shall be retained by the Collector and shall be filed in his office.

12. (1.) On the return to New Zealand of a person holding a certificate of registration as herein provided, the Collector at the first port of arrival, if satisfied of the identity of the holder with the person named in the certificate, and that he has returned within four years after the date of registration, shall permit such person to land in New Zealand.

(2.) All such certificates presented by returned persons shall be forwarded by the Collector at the port of arrival to the Collector at the port of issue, and shall be filed with the duplicate.

13. Every person who commits a breach of these regulations shall be liable to a fine of £50.

CONDITIONS OF THIS PERMIT.

This permit is issued subject to the following conditions :—

- (1.) That the immigrant shall deposit with the Collector of Customs at the port of arrival the sum of £10 as security that he/she will report personally and deliver up this permit to the Collector of Customs at the port of departure.
- (2.) The Collector of Customs at the port of departure will refund the amount deposited upon satisfactory identification and upon compliance with these regulations.
- (3.) The amount deposited on account of any person who departs without being identified, or who remains in New Zealand beyond the time permitted, shall be forfeited and paid to the Public Account.
- (4.) Certificates when delivered up at the port of departure shall be forwarded by the Collector to the Comptroller of Customs.

(2.) This application must be filled up in the English language.

(3.) If the applicant intends to remain only temporarily in New Zealand, it will not be necessary to fill in particulars under (c), (k), (l), and (n), but he must state the length of time during which he desires to stay. Unless for extraordinary reasons temporary permits will be granted only for six months.

(4.) This application must be sent by post from the country where the applicant was born, or where he has resided for one year prior to the date of application.

- (1.) Persons who are not of British birth and parentage.
- (2.) Persons who are not in possession of permits to enter New Zealand or certificates of registration entitling the holders to return to New Zealand within four years of the date of the issue thereof.
- (3.) Persons who are lunatic, idiotic, deaf, dumb, blind, or infirm.
- (4.) Persons who are suffering from tuberculosis, syphilis, leprosy, and any contagious disease which is loathsome or dangerous.
- (5.) Any person the date of whose arrival in New Zealand is earlier than two years after the termination of any imprisonment suffered by him in respect of any offence which, if committed in New Zealand, would be punishable by death or imprisonment for two years or upwards, not being a mere political offence, and no pardon having been granted.

Duty on Cigars manufactured in New Zealand.

IN pursuance and exercise of the powers and authorities vested in him by section forty-nine of the Finance Act, 1917, and of all other powers and authorities enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby (1) fix at seven thousand pounds weight the maximum quantity of cigars, containing less than seventy-five per centum of tobacco grown in New Zealand, which may be made by Gershon Pezaro, of Auckland, during any calendar year commencing from the first day of January, one thousand nine hundred and twenty-one, and upon which excise duty at four shillings the pound shall be paid upon delivery from his factory; and (2) prescribe that all cigars made by the said Gershon Pezaro in excess of such quantity as aforesaid shall pay an excise duty of six shillings and sixpence the pound.

WHEREAS it is provided by section thirty-nine of the Finance Act, 1920, that the Governor-General in Council may, on the application of any Fire Board established under the Fire Brigades Act, 1908, extend within certain limits the powers of that Board to borrow moneys in excess of the limits fixed by section six of the Fire Brigades Amendment Act, 1908 :

And whereas applications have been made by the Boards of the Auckland, New Plymouth, and Palmerston North Fire Districts for such increases in the borrowing-powers of the said Boards, as provided by the said section thirty-nine, and it is desirable to grant such requests :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in him by section thirty-nine of the Finance Act, 1920, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that the powers of the said Auckland, New Plymouth, and Palmerston North Fire Boards to borrow moneys in excess of the limits fixed by section six of the Fire Brigades Amendment Act, 1908, are hereby extended, but so as not to exceed the sum of thirty thousand pounds in the case of the Auckland Fire Board, and the sum of twenty thousand pounds in the cases of the New Plymouth and the Palmerston North Fire Boards respectively ; provided that no moneys as aforesaid shall be borrowed except subject to the provisions of the Fire Brigades Act, 1908, and its amendments.

ORDER IN COUNCIL.

WHEREAS, in accordance with the provisions of the third section of the Land Drainage Act, 1908, a majority of the ratepayers in the area of land described in the Schedule hereto, situated in the County of Waimea, have presented a petition to His Excellency the Governor-General of the Dominion of New Zealand, praying that the said area be constituted a drainage district under the provisions of the said Act :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority contained in the third section of the Land Drainage Act, 1908, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby constitute and declare the area of land described

in the Schedule hereto to be a district for the purposes of Part I of the said Act, to be called by the name of the "Wakapuaka Drainage District"; and also, in pursuance and exercise of the power and authority contained in the fourth section of the said Act, doth hereby declare that the Board of Trustees of the said district shall consist of five persons to be elected as members of the said Board, under and in accordance with the said Act.

SCHEDULE.

WAKAPUAKA DRAINAGE DISTRICT.

ALL that area in the Nelson Land District bounded by a line commencing at the north-western corner of Section IV, Suburban North District (Block V, Wakapuaka Survey District), and proceeding thence south-easterly along the south-western boundary of that section and its production across the main road; thence along the watershed through Sections 23 and 22, Suburban South District, passing through Trig. Station Sub. 3 and Section I, Square 23, to its southernmost corner; thence along the southern boundary of Section 6 to Trig. Station Sub. 4, and southerly along the watershed to Trig. Station C; thence along the southern boundary of Section 30, Square 23, to Trig. Station Sub. Bc, and along a right line to a point on the watershed where it is intersected by the production of the south-western boundary of Section 77, Suburban North District; thence along the watershed to the main road at the Gentle Annie Saddle; thence along a right line to the south-western corner of Section 69, Suburban North District, and along the south-eastern boundary of Section 68 to its north-eastern corner; thence along a right line to the easternmost corner of Section 73, Square 23, and along the western boundary of that section to the northernmost corner; thence north-easterly to an iron pipe 63 links distant on the Native reserve boundary, and north-westerly along that boundary for a distance of 44 chains; thence along the watershed through Section VI, Suburban North District, to the north-eastern corner of Section 35, and through Sections VI and 36 to the shore of the Tasman Bay; thence south-westerly along the Boulder Bank to the point of commencement.

IT is hereby notified that a petition has been presented to His Excellency the Governor-General, under section 11 of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1919, as amended by section 86 of the Reserves and other Lands Disposal Act, 1920, praying that the area described in such petition and in the Schedule hereto be constituted a road district, to be known as the Ostend Road District.
