*Declaring certain Areas added to the County of Wairarapa South to be included in certain Ridings of such County.*

A PROCLAMATION.

WHEREAS by Order in Council dated the twenty-ninth day of November, one thousand nine hundred and twenty, and published in the *New Zealand Gazette* of the ninth day of December, one thousand nine hundred and twenty, the boundaries of the County of Wairarapa South and Borough of Carterton were altered by the exclusion of certain areas from the Borough of Carterton and the inclusion of such areas in the County of Wairarapa South: And whereas it is desirable that the areas so added to the County of Wairarapa South should be included in the Belvedere and Dalefield Ridings of that county:

Now, therefore, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section twenty-two of the Counties Act, 1908, do hereby declare that the areas included as aforesaid in the County of Wairarapa South shall on and from the first day of April, one thousand nine hundred and twenty-one, be included in the Belvedere and Dalefield Ridings of the said county, and that the boundaries of such ridings shall be those set forth under the respective headings in the Schedule hereto.

SCHEDULE.

BOUNDARIES OF BELVEDERE RIDING, COUNTY OF WAIRARAPA SOUTH.

ALL that area in the Wellington Land District, in the County of Wairarapa South, bounded by a line commencing at the intersection of the Waingawa River and the Masterton-Carterton main road, and proceeding south-westerly along said main road to the Borough of Carterton; thence along the north-eastern and north-western boundaries of said borough to the north-eastern boundary of Section 241, Taratahi Plain Block; thence along the north-eastern boundaries of Sections 241, 240, and 237 to the southernmost corner of Allotment 36 of Section 238; thence along the eastern and northern boundary of said Allotment 36 and the northern boundary of Allotment 35 of Section 238 to Section 308, Block VI, Tiffen Survey District; thence along the eastern and northern boundaries of said Section 308, the northern boundaries of Sections 308, 307, and 306, the eastern and northern boundaries of Sections 2 and 3, Block V, Tiffen Survey District, and the western boundary of the said Section 3 to the Kaitangata Stream; thence along a right line due west to the county boundary, and northerly and south-easterly generally along the county boundary to the point of commencement.

BOUNDARIES OF DALEFIELD RIDING, COUNTY OF WAIRARAPA SOUTH.

All that area in the Wellington Land District, in the County of Wairarapa South, bounded by a line commencing at the south-western corner of Belvedere Riding above described, and proceeding thence along the northern boundary of that riding to the Borough of Carterton; thence along the north-western, south-western, and south-eastern boundaries of that borough to its easternmost corner; thence along the southern boundary of Section 144, Taratahi Plains Block, to Somerset Road, and south-easterly along that road to the eastern boundary of Section 122; thence along that boundary to Park Road, and south-easterly along that road to the south-eastern boundary of Section 131; thence along the south-eastern boundaries of Sections 131, 134, 138, 144, and 148; thence by the roads forming the south-western and southern boundaries of Section 127, and the southern boundaries of Sections 126 and 115 to Section 289; thence along the western boundaries of Sections 289, 290, 291, and 292, and the northern and eastern boundaries of Subdivision 5 of Taumata Block to the Ruamahanga River; thence down that river to the county boundary, and north-westerly along the county boundary to the point of commencement.

WHEREAS by section three hundred and thirty-five of the Native Land Act, 1909, and section fourteen of the Native Land Amendment Act, 1912, it is provided that, with the precedent consent of the Governor-General in Council, a body corporate under Part XVII of the Native Land Act, 1909, may, on the security of a mortgage or charge of the land vested in it, borrow money from a State Loan Department or from any person or body corporate:

IN pursuance and exercise of the powers conferred by the Public Works Amendment Act, 1908, the Public Works Amendment Act, 1911, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth—subject to the conditions set forth in the Schedule hereto, and to the regulations made under section two of the Public Works Amendment Act, 1911, and dated the twenty-second day of September, one thousand nine hundred and nineteen, published in the *New Zealand Gazette* of the twenty-fifth day of the same month, or any regulations hereafter made in amendment thereof or in substitution therefor (and hereinafter collectively referred to as “the regulations”), and which regulations shall be deemed to be incorporated herein—hereby grant to the Taumarunui Borough Council (hereinafter with its successors and assigns referred to as “the licensee”) a license to take and use from the Wanganui River (hereinafter referred to as “the said river”), in the Auckland and Wellington Land Districts, for the purposes hereinafter set forth, a stream of water (hereinafter referred to as “the said water”) not exceeding five hundred cubic feet per second at any one time; and also to erect and maintain electric lines for power, lighting, heating, or other uses within the area of supply hereinafter described, such electric lines at present proposed to be erected being indicated by means of lines shown on the plan marked P.W.D. 50982, and deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District; but nothing herein shall be held to guarantee that the said stream contains sufficient water to supply five hundred cubic feet per second hereinbefore mentioned.

SCHEDULE.

1. PLANS.

The licensee shall, before the works hereby authorized are commenced, forward for the approval of the Minister of Public Works (hereinafter referred to as “the Minister”)—

- (a.) Full detailed drawings and specifications of the diverting weir and dam.
- (b.) Drawings showing how and in what manner the water diverted is to be returned to the said river.
- (c.) Contour plan showing difference in level of water due to the construction of the headworks.

2. UTILIZATION OF THE WATER.

The said water shall be used solely for the purpose of generating electricity, and shall be returned to the said river at or near the power-house.

3. LOCATION OF HEADWORKS.

The said water shall be taken from the said river at the headworks, situated on the west bank of the Wanganui River about 20 chains below Piriaka, at a point indicated on the plan marked P.W.D. 50799, deposited in the office of the Minister at Wellington, in the Wellington Land District.

4. GENERAL DESCRIPTION OF WORKS.

The licensee is hereby authorized to construct, maintain, and use the following works for the purposes of this license; the position of the said works being indicated on the plans marked P.W.D. 50799 and 50800, deposited in the office of the Minister as aforesaid:—

- (a.) Headworks consisting of a dam and necessary intake.
- (b.) Race leading from such dam to the power-house hereinafter referred to.
- (c.) A power-house with all necessary equipment, including water turbines, generators, transformers, lightning-arresters, switchboards, switches, exciters, and other appliances for generating electricity.
- (d.) A transmission-line over the route shown by means of a yellow line on the said plan P.W.D. 50800.
- (e.) Such further transmission and other lines within the area of supply as may from time to time be required within such area of supply, and after compliance with the provisions of clause 48 of the regulations.

5. INSPECTION OF WORKS.

The Inspecting Engineer, both during and after the construction of the works, shall have free access to and liberty at any time to inspect the same so as to ensure that the provisions of this license are given due effect to.

6. MAINTENANCE OF WORKS.

After the said works have been completed the licensee shall maintain the same in proper working-order during the continuance of this license.

7. RIGHT TO ENTER LANDS, ETC.

The licensee shall have the right at any time or times during the continuance of this license, with the consent of the Minister, to enter upon any road or other land, whether vested in or occupied by the Crown or any other person or body corporate, and there to construct, erect, lay down, maintain, renew, or repair all such transmission-lines, poles, or other things as are required for the transmission of electricity between the generating-stations and any of the sub-stations to which this license applies.

8. POWER TO TAKE LAND.

The licensee is hereby empowered to take, under the Public Works Act, 1908, as for a public work such land as may, in the opinion of the Governor-General, be necessary to enable the licensee to construct and maintain the various works authorized by this license.

9. DURATION OF LICENSE.

This license shall, unless sooner determined in accordance with the provisions hereinafter expressed, continue in force for a period of forty-two years from the date hereof. Upon the expiry of the said term, or upon the sooner determination of this license by revocation or otherwise, all rights hereby granted to the licensee shall thereupon cease and determine, but such expiration or determination shall not relieve the licensee of any liability theretofore incurred under this license.

10. RENTAL.

The licensee shall, in respect of this license, pay to the Public Works Engineer for the district, or otherwise as the Minister may from time to time require, a rental at the rate of 1s. per annum per kilowatt of maximum output, as recorded by the wattmeter to be installed by the licensee at the power-house mentioned in clause 4 (c) hereof; payment to be made yearly on the 31st day of March in each year, commencing from the day electrical power is first supplied. For the purpose of this clause “maximum output” means twice the number of units generated in the half-hour during

which the output is the maximum for the year. The said period shall be recorded at the end of each half-hour commencing from noon of each day. The minimum rental shall not be less than £10 per annum.

#### 11. GRANTING OF OTHER WATER-RIGHTS.

Nothing herein shall prevent the Governor-General in Council from granting to any person or body corporate other than the licensee a license to take water from any portion of the said stream, except at the place where the licensee is by this license empowered to take it; provided that no such license shall so operate as to reduce the natural fall between the headworks and tail-water, or the volume of the water which the licensee is by this license authorized to take from the said stream.

#### 12. VARIATION IN CONDITIONS OF LICENSE.

The terms and conditions of this license may at any time or from time to time, at the request or with the consent in writing of the licensee, be altered by the Governor-General by Order in Council.

#### 13. SURRENDER OF LICENSE.

The licensee may at any time, with the consent of the Minister, surrender this license, and shall thereupon, if so required by the Minister, remove from the ground all removable equipment, machinery, buildings, poles, transmission-lines, and other plant herein authorized to be installed or provided. If the licensee fails or neglects so to remove the said plant within twelve months after being required so to do, such equipment, machinery, buildings, poles, lines, and other plant shall, without payment or compensation, vest in and become the property of the Crown.

#### 14. CHARGES FOR ELECTRICAL ENERGY.

The charges for electrical energy shall not exceed 1s. per unit for lighting purposes, and 6d. per unit for motor-power, heating, or cooking purposes; provided that "lighting purposes" shall include the operation of motor generators for lighting purposes; and provided further that if accounts are paid within fourteen days of due date the charges shall not exceed 9d. per unit for lighting purposes and 4½d. per unit for motor-power, cooking, or heating purposes.

#### 15. AREA OF SUPPLY.

The area of supply comprises the Borough of Taumarunui and Town District of Manunui as at present constituted, and also that portion of the Kaitieke and West Taupo Counties comprised within broken black lines as shown on the plan marked P.W.D. 50800, deposited in the office of the Minister at Wellington, in the Wellington Land District.

#### 16. SYSTEM OF SUPPLY.

The system of supply shall be as described in paragraph (e) of clause 3 of the regulations.

The generating voltage shall be approximately 3,300 volts between the terminals.

#### 17. DATUM TEMPERATURE.

For the purposes of calculating stresses as provided in clause 15 of the regulations, the datum temperature shall be taken as 20 degrees Fahrenheit.

#### 18. INTERCHANGE OF SUPPLY OF ELECTRICAL ENERGY.

(a.) In the event of the Minister establishing a hydro-electric power scheme outside the area of supply of a frequency of 50 cycles per second on the three-phase alternating-current system, he may require the licensee to connect that system with the licensee's electrical system in such a manner that an interchange of electrical energy between the two systems may be made from time to time and when required by either the licensee or the Minister, up to at least one-half of the total capacity of the plant installed at the licensee's power-house.

(b.) The licensee shall erect and maintain in good order, at the expense of the licensee, the necessary transmission-lines between the licensee's power-house and a point on the boundary of the area of supply to be determined by the Minister.

(c.) The Minister shall erect and maintain in good order, at the expense of the Minister, the necessary transmission-lines outside the area of supply, for the purpose of connecting the two systems at the point last mentioned in subclause (b) hereof.

(d.) The licensee and the Minister respectively shall on demand, and from time to time, as and when required, supply to each other so much of the surplus electrical energy as is then required and is available, but not in excess of one-half of the capacity of the plant installed in the licensee's power-house.

(e.) The price to be paid by the licensee or the Minister shall not exceed the following rates:—

Between the hours of 8 a.m. and 8 p.m. daily: 1d. per unit.

Between the hours of 8 p.m. and 8 a.m. daily: ½d. per unit.

To be measured in each case at the point last mentioned in subclause (b) hereof.

(f.) For the purpose of this clause either the licensee or the Minister may have the unit measured in kilo-volt-ampere hours instead of kilowatt hours.

#### 19. COMPENSATION PAYABLE FOR LAND INJURIOUSLY AFFECTED, ETC.

In respect of all land injuriously affected, and in respect of all damages done by the exercise of any of the powers conferred upon the licensee by this license, the licensee shall from time to time, as and when any such injury or damage accrues or happens, pay compensation in accordance with the provisions of the Public Works Act, 1908, in the same manner (subject to all necessary modifications) as if such licensee were a local authority and the claim was one for injury or damage arising out of the construction of a public work.

#### 20. CROWN NOT LIABLE TO PAY COMPENSATION.

Nothing in this license shall be held to cast upon or imply any liability upon His Majesty the King or upon the Government of New Zealand to pay compensation to any person, corporate body, or local authority by reason of the exercise by the licensee of the authority hereby granted; but the licensee shall be liable for any loss or damage which any person, corporate body, or local authority may sustain as the result of the exercise by the licensee of any of the powers granted by this license.

#### 21. CONSUMERS ENTITLED TO SUPPLY.

The licensee shall supply and sell to any person, company, or corporate body within the area of supply requiring the same, for any purpose within that area, electricity to the extent to which it may be available; provided that such person, company, or corporate body pays the cost of connecting his or its premises with the transmission-line erected by the licensee in pursuance of this license, or alternatively pays a line rental at a rate not exceeding 15 per cent. on the cost of such connecting line together with any additional transmission-line required to supply such person, company, or corporate body.

#### 22. BED OF RIVER NOT LEASED.

Nothing herein shall be held to constitute a lease from the Crown of the bed of the said river, nor shall the provisions of Part IX of the Property Law Act, 1908, apply to this license.

#### 23. CONTRACT BETWEEN LICENSEE AND CROWN.

This license shall be deemed to constitute a contract as between the licensee and His Majesty the King, and may be enforced as a contract by and against His said Majesty or the licensee accordingly.

#### 24. TIME FOR SUBSTANTIAL COMPLETION OF WORKS.

The licensee shall substantially complete the works hereby authorized within a period of two years from the date of this license, or within such further time as the Minister may allow in the event of the work being delayed by strikes, lock-outs, breakdowns, or other unavoidable causes not due to any neglect by the licensee.

#### 25. DEFAULT.

If the licensee fails or neglects to observe any of the conditions or obligations imposed by this license, then and in any such case the provisions of clauses 50 and 51 of the regulations shall apply to the breach of any such condition or obligation.

#### 26. REQUIREMENTS OF THE KAITIEKE COUNTY COUNCIL AND MANUNUI TOWN BOARD.

Notwithstanding anything hereinbefore contained, the licensee shall not be entitled to erect, maintain, or use any electric lines within the Kaitieke County or Manunui Town District, except subject to such conditions, not inconsistent with the provisions of this license and the regulations relating thereto, or any variation of this license or the regulations, or new regulations which may take the place of these regulations, as may from time to time be agreed upon between the licensee and the Kaitieke County Council or between the licensee and the Manunui Town Board.

#### 27. BARE WIRES.

No bare wires shall be erected until the consent of the Minister has first been obtained in accordance with the regulations.

DESCRIPTION OF SECTIONS.

Section 11, Block V.—The access is from Kopaki Railway-station, distant about eleven miles and a half, of which ten miles are good dray-road; the remainder is unformed. The section comprises easy to steep slopes; about one-third is open fern and manuka country, mostly ploughable, the remainder of the section is heavy-bush land. IN exercise of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in the Buller Acclimatization District, comprising the Buller and Inangahua Counties, bounded towards the north-west generally by a line starting at a point on the Tasman Sea coast at Kohaihai Bluff, in Block XIII, Whakapoi Survey District, and proceeding up a leading spur and along the summit of a range over Mount Domett to Mount Cobb; thence towards the north-east generally by a line along the summit of the western ranges over Mount Snowdon and Mount Peel to Mount Arthur; thence towards the south-east by a line along the summit of a leading range over Mount Luna and along the summit of Lyell Range to Bald Hill; thence by a line down a leading spur on the western side of Eight-mile or Boundary Stream to the mouth of

that stream; thence down the left bank of the Buller River and up the right bank of the Inangahua River to a point due north of Mount Haast; thence by a right line to Mount Haast; thence by a right line to the nearest point of the Grey River; thence towards the south-west generally by a line down the middle of the Grey River to its confluence with the Otututu River; thence by a line up the middle of the Otututu River to its source near Mount Faraday; thence by a right line to Mount Faraday; thence towards the south-east by a line along the summit of the Paparoa Range to a point near the source of the Puna-kaiki or Deadman's River; thence towards the south-west generally by a right line to that source, and by a line down the middle of that river to the sea; and thence towards the north-west by the Tasman Sea to Kohaihai Bluff, the place of commencement; and the conditions affecting the same, and also the form of license and the fee payable therefor.

7. Any person committing a breach of any of these regulations shall be liable, on conviction, to a fine not exceeding £20.

IN exercise of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in the South Canterbury Acclimatization District (as defined in the *New Zealand Gazette* of the sixteenth day of December, one thousand eight hundred and ninety-seven, comprising the Counties of Geraldine and Levels and part of the County of Mackenzie), and the conditions affecting the same, and also the form of license and the fee payable therefor.

IN exercise of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in the Waitaki Acclimatization District, comprising all that area in the Canterbury and Otago Land Districts bounded towards the north-west by the summit of the Southern Alps from the north-eastern corner of Vincent County to Mount Cook; thence towards the north-east by a right line over Ball Hut to the Tasman Glacier, by the western side of the Tasman Glacier to the Tasman River, by a line along the middle of that river and through the middle of Lake Pukaki to and along the middle of the Pukaki River and the middle of the Waitaki River to the sea; towards the east by the sea to Waihemo County; and towards the south-west and west by Waihemo, Maniototo, and Vincent Counties to the summit of the Southern Alps, the place of commencement; and the conditions affecting the same, and also the form of license and the fee payable therefor.

REGULATIONS.

1. RED-DEER stags may be taken or killed within the Waitaki Acclimatization District from the 1st day of April, 1921, to the 20th day of May, 1921 (both days inclusive).

8. Regulations as to deer "tags," per *New Zealand Gazette* No. 40, Vol. I, of 20th May, 1909, page 1408, shall be strictly adhered to by each licensee, who, in addition thereto, shall return all unused "tags" to the secretary of the Waitaki Acclimatization Society, at Oamaru, immediately

IN exercise of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in the Otago Acclimatization District, and the conditions affecting the same, and also the form of license and the fee payable therefor.

REGULATIONS.

1. RED-DEER may be taken or killed within the Otago Acclimatization District, in the Hunter Valley, Dingle, Hawea Flat, and Makarora districts from the 1st day of April, 1921, to the 20th day of May, 1921 (both days inclusive), and in the Greenvale, Wart Hill, Upper Pomahaka, and Whitecomb districts from the 24th day of March, 1921, to the 13th day of May, 1921 (both days inclusive). In both districts stalkers are only authorized to shoot on the blocks specified in their respective licenses.

2. Fallow-deer bucks may be taken or killed within the said district, except in the areas described in the First Schedule hereto, from the 1st day of April, 1921, to the 15th day of May, 1921 (both days inclusive).

3. Licenses to take or kill red-deer stags may be issued by the Chief Postmaster, Dunedin, on the recommendation of the Secretary of the Otago Acclimatization Society, on payment of a license fee of £6 for the Hunter Valley, Dingle, Hawea Flat, and Makarora districts, and £4 for the Greenvale, Wart Hill, Upper Pomahaka, and Whitecomb districts; and licenses to take or kill fallow-deer bucks may be issued by the said Chief Postmaster, Dunedin, and the Postmaster at Tapanui, upon a like recommendation, on payment of a license fee of £2; such licenses to be issued in the form prescribed in the Second Schedule hereto, and subject to the said Act and these regulations.

4. No licensee shall take or kill more than three red-deer stags in the Hunter Valley, Dingle, Hawea Flat, or Makarora districts, nor more than two red-deer stags in the Greenvale, Wart Hill, Upper Pomahaka, and Whitecomb districts, nor more than two fallow-deer bucks; and no red-deer stag shall be killed carrying antlers with less than ten points, and no fallow-deer buck shall be killed carrying antlers with less than fourteen points (on a palmate of less than 4 in.). Ball cartridge only to be used.

5. The licensee must give notice to the said Chief Postmaster or the Postmaster at Tapanui of the date on which it is his intention to stalk deer; such notice to be posted, or delivered, or telegraphed three clear days before such date.

6. No doe, hind, or fawn shall be taken or killed on any pretext whatever, and no licensee shall allow any dog to accompany either himself or any attendant he may have with him.

7. No person other than the license-holder, whether accompanying the license-holder or not, will be allowed to carry a rifle on the shooting blocks during the season as authorized by these regulations.

8. Nothing herein contained shall extend to authorizing any person to sell any deer or any portion thereof.

9. Regulations as to deer "tags," per *New Zealand Gazette* No. 40, Vol. I, of 20th May, 1909, page 1408, shall be strictly adhered to by each licensee who, in addition thereto, shall

return all unused "tags" to the Secretary of the Otago Acclimatization Society immediately he has finished stalking for the season for which such tags have been issued, together with a statement of the number of deer shot.

10. Any person committing a breach of any of these regulations shall be liable, on conviction, to a fine not exceeding £20.

HIS Majesty the King has been graciously pleased to sanction a memorial being presented to the next-of-kin of all those members of the British, Dominion, Colonial, and Indian mercantile marine (including licensed pilots, fishermen, and crews of pilotage and lighthouse authorities vessels, and of Post Office cable ships) who have lost their lives through enemy action while serving on British ships, and to the next-of-kin of British members of the crews of neutral or allied vessels under the direct control of the Admiralty or the Ministry of Shipping who have lost their lives through enemy action while serving on such vessels between 4th August, 1914, and 11th November, 1918. This memorial is to take the form of a bronze plaque of emblematic design as issued in respect of the combatant services and a parchment scroll with appropriate wording, each of which will bear the deceased's Christian names and surname. The memorials will be accompanied by a letter from His Majesty.
