WHEREAS a petition was presented, under section fourteen of the Municipal Corporations Act, 1908, praying for the inclusion of the Point Chevalier Road District in the City of Auckland:

And whereas objections to the proposal were received, and a Commission to consider the same was duly appointed, and recommended that such road district be included in such

And whereas it is proposed to include the said Point Chevalier Road District in the said City of Auckland:

And whereas doubts have arisen as to the validity of the above proceedings on the ground that they should have been taken according to the form prescribed by section one hundred and twenty of the Municipal Corporations Act, 1908, and not as above set out: and not as above set out:

And whereas it is considered expedient to validate the And whereas it is considered expedient to validate the aforesaid proceedings, so as to render them in all respects as valid and effectual for the purposes of constituting one united borough as if they had been taken according to the form prescribed by section one hundred and twenty of the Municipal Corporations Act, 1908:

Now, therefore, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon me by section three hundred and sixty-eight of the

said Act, and of every other power and authority enabling me in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby validate all proceedings taken relative to the inclusion of the Point Chevalier Road District in the City of Auckland accordingly.

WHEREAS a petition has been presented to the Governor-General, under section fourteen of the Municipal Corporations Amendment Act, 1913, praying the Governor-General to alter the boundaries of the City of Auckland by including therein the area described in the Schedule hereto, comprising the Point Chevalier Road District:

And whereas a notice, showing the proposed alteration in boundaries of the said city, has been gazetted and publicly notified:

And whereas objections in writing against such alteration were lodged:

And whereas, after inquiry and report by a Commission appointed under the said section, a poll was taken under the provisions of the Municipal Corporations Amendment Act, 1914, on the eighteenth day of December, one thousand nine hundred and twenty, on the proposal to include the said area in the City of Auckland, and the result of that poll was in favour of the said proposal:

And whereas it is expedient to make the desired alteration: Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the Municipal Corporations Act, 1908, and its amendments, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that as on and from the first day of March, one thousand nine hundred and twenty-one, the area described in the Schedule hereto, being the area now comprised within the Point Chevalier Road District, shall be included in the City of Auckland.

THEREAS, in accordance with the provisions of section WHEREAS, in accordance with the provisions of section thirteen of the Municipal Corporations Amendment Act, 1913, a petition was presented to His Excellency the Governor-General praying that a certain area be constituted a borough, to be known as the Borough of Otaki.

And whereas a Commission appointed under the said section made inquiries, and recommended that the said area with certain alterations be constituted a borough:

And whereas a poll was taken on Wednesday, the twelfth day of January one thousand nine hundred and thirteen.

And whereas a poll was taken on Wednesday, the twelfth day of January, one thousand nine hundred and thirteen, within the area as fixed by the said Commission, upon the proposal that the said area should be constituted a borough:

And whereas the proceedings in connection with the said poll were irregular, in that the arrangements for such poll were not made by the Governor-General, as provided by subsection (f) of the said section, and it is expedient to validate the said proceedings:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred on him by section three hundred and sixty-eight of the Municipal Corporations Act, 1908, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that the proceedings in connection with the poll taken on the proposal to constitute the said area a borough shall be valid to all intents and purposes as if the arrangements in

connection therewith had been duly made by the Governor-General as provided by the said section; and doth hereby declare that the said proceedings shall not be called in question by reason only of the irregularity aforesaid.

Now, therefore, in pursuance and exercise of the powers and authorities vested in me by the Municipal Corporations Act, 1908, as amended by the Municipal Corporations Amendment Act, 1913, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the Schedule hereto shall be constituted a borough under the said Acts on and from the first day of March, one thousand nine hundred and twenty-one; that the name of such borough shall be the Borough of Otaki; that the said borough shall be an undivided borough; and that the number of Councillors to be elected thereto shall be six, exclusive of the Mayor.

thereto shall be six, exclusive of the Mayor.

And I do further proclaim and declare that Frederick George Davies, of Otaki, shall be the Returning Officer to conduct the first election of Mayor and Councillors of the said borough; and that the said Frederick George Davies shall be the Town Clerk and the person to prepare the district electors roll for the purposes of the said first election.

And, lastly, I do proclaim and declare that the first election of Mayor and Councillors of the said borough shall be held on Wednesday, the twenty-third day of March, one thousand nine hundred and twenty-one; and that the first meeting of the Council of the said borough shall be held on Thursday, the twenty-fourth day of March, one thousand nine hundred and twenty-one, at half past seven o'clock in the afternoon, at the office of the Otaki Town Board, Otaki.

SCHEDULE.

ALL that area in the Wellington Land District, bounded towards the north by a line commencing at the mouth of the Waitohu Stream in Block V, Waitohu Survey District, and thence proceeding along the middle of the said stream to the eastern side of the old coach road; thence towards the east by the said eastern side of the old coach road to the northwestern corner of Pukekaraka No. 5; thence towards the north and east generally by the northern and eastern boundaries of the said Pukekaraka No. 5 to the northern boundary of Te Tokitoki No. 3: again towards the east by the said of Te Tokitoki No. 3; again towards the east by the said northern boundary of Te Tokitoki No. 3; again towards the east by the said northern boundary of Te Tokitoki No. 3 to the most western corner of Waitohu 11c No. 2; thence towards the north by the western boundary of the said Waitohu 11c No. 2 to its northernmost corner; again towards the east by the northern boundaries of the said Waitohu 11c No. 2, Waitohu 11s, and Huruatai No. 7 to the easternmost corner of the last-mentioned block, there towards the south and east by the eastern block; thence towards the south and east by the eastern boundaries of the said Haruatai No. 7 and the Church Mission block; thence towards the south and east by the eastern boundaries of the said Haruatai No. 7 and the Church Mission grant to the south-western corner of Haruatai No. 2a; again towards the east by the southern boundaries of Haruatai Nos. 2a and part 2b to the south-western corner of the said Haruatai 2b at its junction with the Haruatai Stream; thence by a right line across the said Haruatai Stream towards the east along the southern side of the northern branch of the said Haruatai Stream to the North Island Main Trunk Railway line; thence towards the south-east generally by the northern side of the said railway-line to where it joins angle peg No. IV of the county road in Kaingaraki No. 6 Block; thence by a right line across the angle of the said county road to the northern side thereof; thence again towards the seuth-east generally by the said northern side of the county road to its junction with the northern side of the road which passes through Kaingaraki No. 9; thence towards the west by the northern side of the

said road and the production thereof to the western side of River Bank Road; thence towards the north by the said western side of River Bank Road to the southernmost corner of Harurunui No. 1 Block; thence towards the west generally of Harurunui No. 1 Block; thence towards the west generally along the southern and western boundaries of the said Harurunui No. 1 and Tutangatakino No. 9 Blocks to the northern side of the old course of the Otaki River; thence along the northern side of the said old course of the Otaki River to the Rangiuru Creek; thence along the eastern side of that creek to a point in line with the south-western boundary of Taumanuka No. 31 Block; thence across the said Rangiuru Creek to and along the south-western boundary of Taumanuka No. 31 Block to the sea; and thence along high-water mark of the sea to the mouth of the Waitohu Stream, the place of commencement

IN exercise and pursuance of the powers and authorities vested in me by the River Boards Act, 1908, as amended by the River Boards Amendment Act, 1913, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that, as on and from the date hereof, that part of the said Dominion de-scribed in the Schedule hereto shall be and the same is hereby constituted a district under the said Act, and shall be known by the name of the Kaituna River District; and that the number of members who are to constitute the Board of the the number of members who are to constitute the Board of the said district shall be nine. And I do also proclaim and declare that Horace William Earp, of Te Puke, shall be the Returning Officer to conduct the first election of nine members of the aforesaid Board; that Saturday, the twelfth day of March, one thousand nine hundred and twenty-one, shall be the day, and the Office of the Town Board, Te Puke, the Schoolhouse, Paengaroa, the Schoolhouse, Maketu, and the Railway Waiting-room, Papamoa, shall be the polling-places for holding such first election; and that Friday, the eighteenth day of March, one thousand nine hundred and twenty-one, at eleven o'clock in the morning, shall be the time, and the day of March, one thousand nine hundred and twenty-one, at eleven o'clock in the morning, shall be the time, and the Office of the Town Board at Te Puke shall be the place, at which the first meeting of the members of the Board of the said Kaituna River District shall be held; and, lastly, I do proclaim and declare that Horace William Earp, of Te Puke, shall be the person to make a roll of electors for the purpose of the aforesaid first election, in the manner prescribed by section eight of the said River Boards Act, 1908.

KAITUNA RIVER DISTRICT.

All that area in the Auckland Land District bounded by a line commencing at a point on the high-water mark of the Bay of Plenty in line with the western boundary of Section 9, Block I, Te Tumu Survey District, and proceeding thence south-easterly along the said high-water mark to the eastern side of the old outlet of the Kaituna River at Maketu; thence south-westerly along the eastern bank of the old course of the said river to the Maketu-Paengaroa Road, and along that road to the south-eastern corner of Section 9, Block IV, Maketu Survey District, along the southern boundaries of Sections 9 and 10, Block IV, and Section 1, Block III, Maketu Survey District, to the Te Puke - Paengaroa main road, along that road in a north-westerly direction to the south-eastern boundary of Paengaroa North D 1 Block, along that boundary to the Kaituna River, and down that river to the northern boundary of Rangiuru No. 3; thence along that boundary to the Waiari Stream, and up that stream to the northern boundary of Te Puke No. 2c 1, and along that soundary to the No. 1 Road; thence northerly along the said No. 1 Road to northern boundary of Section 19, Block II, and along the said boundary to a point in line with the eastern boundary of the Town of Te Puke Extension No. 1; thence to and along the said eastern boundary to the main road, and easterly along the said main road to the eastern boundary of the Te Puke Town District; thence following along the eastern, northern, and part of the western boundary of Section 3, Block II, Maketu Survey District, and westerly along said boundary and its production across the Atuaroa Stream, and across a road to a point on its western side: thence south-westerly along a right line to the southernmost corner of Section 17, Block I, Maketu Survey District; thence along the southern boundary of the said Section 17, the north-western boundary of the said Section 17, the north-western boundary of the Hikutawatawa Block to the south-western boundary of the Hikutawatawa Bloc ALL that area in the Auckland Land District bounded by a the point of commencement.
