WHEREAS, in pursuance of section fourteen of the Municipal Corporations Amendment Act, 1913, a petition was presented to the Governor-General, praying that a certain area be excluded from the Borough of Sumner

a certain area be excluded from the Borough of Sumner and included in the County of Heathcote:

And whereas a Commission appointed under the said section held inquiries, and recommended that the said area should be excluded as aforesaid from the Borough of Sumner:

And whereas it is deemed expedient to make such alterations of boundaries of the said borough:

Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the said Municipal Corporations Amendment Act, 1913, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that on and from the first day of April, one thousand nine hundred and twenty-one, the area described in the Schedule hereto shall be excluded from the Borough of Sumner and included in the County of Heathcote.
