Declaring a certain Area added to the County of Woodville to be included in Woodville Riding thereof.

JELLICOE, Governor-General. L.S. A PROCLAMATION.

W HEREAS by a Proclamation dated the fourteenth day of October, one thousand rine hands VV of October, one thousand nine hundred and twenty-one, and published in the New Zealand Gazette of the twentieth day of October, one thousand nine hundred and twenty-one, the boundaries of the counties of Woodville and Pohangina were altered by the exclusion of a certain area from the County of Pohangina and the inclusion of such area in the County of Woodville:

And whereas it is desirable that the area so added to the County of Woodville should be included in the Woodville Riding of that county:

Now, therefore, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, in pursuance vernor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section twenty-one of the Counties Act, 1920, do hereby declare that the area included as aforesaid in the County of Woodville shall, as on and from the second day of November, one thousand nine hundred and twenty-one, be included in the Woodville Riding of the said county, and that the boundaries of that riding shall be those set forth in the Schedule hereto.

SCHEDULE.

WOODVILLE RIDING.

ALL that area in the land districts of Hawke's Bay and Wellington, in the County of Woodville, bounded towards the north-east by the Maharahara Riding as described in the New Zealand Gazette, 1901, page 1838, from the Pohangina County to the Woodville-Dannevirke Main Road; towards the south-east and south generally by that road to the Mangoatua Stream; by the said stream to the Manawatu River; towards the south-west by that river to the Pohangina County; and towards the west generally by the said Pohangina County: excluding therefrom the Borough of Woodville.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand; and issued under the Seal of that Dominion, at the Government House at Wellington, this 31st day of October, 1921.

Boundaries of Manaia Town District altered.

JELLICOE, Governor-General. fr.s. A PROCLAMATION.

WHEREAS by a Proclamation dated the twenty-third day of May one thousand include the twenty-third day of May, one thousand eight hundred and eighty-two, and published in the New Zealand Gazette of the twentyfifth day of May, one thousand eight hundred and eighty-two, the Town District of Manaia was duly constituted and pro-claimed under the Town Districts Act, 1881, with the bound-aries described in the Schedule to the said Proclamation:

And whereas it is expedient to alter the boundaries of the said town district in the manner hereinafter set forth:

Now, therefore, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, in pur-Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers vested in me by the Town Boards Act, 1908, do hereby alter the boundaries of the said Town District of Manaia by excluding therefrom the areas described in the First Schedule hereto; and do hereby declare that on and after the first day of April, one thousand nine hundred and twenty-two, the boundaries of the said town district shall be those described in the Second Schedule hereto; and do hereby further declare that on and from the aforesaid date the boundaries of the County from the aforesaid date the boundaries of the County of Waimate West, affected by the said alteration, shall be those described in the Third Schedule hereto.

FIRST SCHEDULE.

Areas excluded from Manaia Town District and included in Waimate West County.

ALL that area in the Taranaki Land District commencing at the north-west corner of Section 110, Block VII, Waimate Survey District, and proceeding thence easterly along the northern boundary of the said section to the Waiokura Stream; thence southerly along the said stream to the south-eastern corner of Section 23 (cemetery reserve); thence westerly along the southern boundaries of Sections 23 and 22 to Has-sard Street, across Hassard Street, and along the southern boundaries of Sections 14 and 13 to Sutherland Road; thence boundaries of Sections 14 and 13 to Sutherland Road; thence northerly along Sutherland Road to the north-western corner of Section 13; thence easterly along the northern boundaries of Sections 13 and 14 to Hassard Street, across Hassard Street to the northern side of Cemetery Road; thence easterly along Cemetery Road to the south-western corner of Section 78; thence northerly along the western boundary of Section 78 to the north-western corner of the said section to the south-eastern corner of Section 74; thence northerly along the eastern boundary of the said section to South Road, across South Road, thence westerly along the northern side of South Road to a point 500 links east of the south-western corner of Section 110; thence northerly to a point 500 links east of the production of the southern boundary of Section 81; thence west to the south-eastern corner of Section 81; thence northerly along the eastern boundaries of Sections 81 and 82 to the north-west corner of Section 110, the point of commencement.

Also all that area commencing at the south-western corner of Section 61, and proceeding northerly along the western boundary of the said section to its north-western corner; thence easterly along its northern boundary to Kaipi Street; thence by the production of the northern boundary of Section 61, across Kaipi Street, and across Sections 62 and 63 to Sutherland Road; thence southerly along the western side of Sutherland Road to the south-eastern corner of Section 63; thence westerly along the southern boundary of Sections 63 and 62 to Kaipi Street, across Kaipi Street, and westerly along the southern boundary of Section 61 to the south-western corner of Section 61, the place of commencement.

SECOND SCHEDULE. MANAIA TOWN DISTRICT.

ALL that area in the Taranaki Land District commencing at the north-western corner of Recreation Reserve 109, Block VII, Waimate Survey District, and proceeding easterly along the northern boundary of Recreation Reserve 109 to the Waiokura Stream; thence southerly along the said stream to the south-eastern corner of the said Recreation Reserve 109; thence westerly along the southern boundary of the said reserve to the eastern boundary of Section 82; thence southerly along the eastern boundary of the said sections to the south-eastern corner of Section 81; thence easterly along the production of the southern boundary-line of Section 81 a distance of 500 links; thence southerly to a point 500 links east of the south-western corner of Section 110; be the said distances more of less; thence easterly along the northern side of the South Road to a point opposite the eastern boundary of Section 74; thence southerly across that road and along the eastern boundary of the said section to its south-eastern corner; thence westerly along the southern boundary of Section 74 to the eastern boundary of Sections 75, 76, and 77 to the northern side of Cemetery Road; thence westerly along Cemetery Road to Hassard Street, across Hassard Street to the south-eastern corner of Section 71; thence westerly along the southern boundaries of Section 71, 70, 69, 68, 67, 66, 65, and 64 to Sutherland Road, across Sutherland Road to the south-eastern corner of Section 63; thence northerly along the eastern boundary of Section 63 to a point in line with the southern boundary-line of Section 60; thence westerly by a right line across Sections 63, 62, and Kaipi Street to the south-eastern corner of Section 60; thence

westerly along that boundary to the south-western corner of the said section; thence northerly along the western boundaries of Sections 60, 59, and 57 to South Road, across South Road, and along the western boundaries of Sections 99, 98, and 97 to Karaka Street, across Karaka Street, and along the western boundaries of Sections 96 and 95 to the north-western corner of the last-mentioned section; thence easterly along the northern boundary of Section 95 to Kaipi Street, across Kaipi Street, and along the northern boundaries of Sections 94, 93, 92, 91, and 90 to Manaia Road, across Manaia Road, and along the northern boundaries of Sections 89, 88, 87, 86, and 85 to Hassard Street, across Hassard Street, and northerly along the western boundary of Section 109 to its north-western corner, the place of commencement.

THIRD SCHEDULE.

WAIMATE WEST COUNTY.

ALL that area in the Taranaki Land District bounded by a line commencing at the north-western corner of Section 1, Block XIII, Kaupokonui Survey District, and proceeding easterly along the northern boundaries of Blocks XIII, XIV, and XV to the middle of the Palmer Road; thence southerly along the middle of that road to the northern boundary of Section 147, Block IV, Waimate Survey District; thence westerly along that boundary to the north-eastern corner of Section 75, Block III, Waimate Survey District; thence southerly along the eastern boundary of Block III, Waimate Survey District, to the Inaha Road; thence due west to and southerly along the middle of that road to the sea; thence westerly along the middle of that road to the sea; thence westerly along the sea-coast to the western boundary of Subdivision F of Sections 4, Block III, and 2, Block II, Oco Survey District; thence north-easterly along that boundary to the South Road; thence north-westerly along the southern side of that road to a point in line with the western boundary of Subdivision C of Section 1, Block II, Oco Survey District; thence to and along that boundary to the southern boundary of Section 1, being part of Section 24, Block II; thence westerly along that boundary to the middle of the Oco River, and up the middle of that river to the southern side of Skeet Road; thence westerly along the southern side of Skeet Road; thence westerly along the southern side of Section 39, Block XIV, Opunake Survey District; thence to and along that boundary to the southern boundary of Section 33; thence easterly along that boundary and northerly along the eastern boundaries of Sections 33, 32, 31, and 30, Block XIV, Opunake Survey District, to the point of commencement, excluding the Town District of Manaia.
