The New Electoral Districts for the North Island.

A PROCLAMATION.

WHEREAS the North Island Representation Commission, appointed under the provisions of the Legislature Act, 1908, have made their report to me under their hands and seals, setting forth the names and boundaries of the electoral districts for the North Island, fixed by them in accordance with the Legislature Act, 1908:

Now, therefore, in pursuance and exercise of the power and authority vested in me by the twenty-second section of the Legislature Act, 1908, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby proclaim the names and boundaries of the electoral districts for the North Island, so fixed by the said Commission, to be those respectively mentioned and set out in the Schedule hereto.

SCHEDULE.

I. BAY OF ISLANDS.

THIS district is bounded towards the north-east generally by the sea from North Cape to the Ngunguru River; thence towards the south generally by the said Ngunguru River and a public road intersecting the Kopipi, Tutataenui, and Te Toiroa Blocks of Blocks IV and III, Whangarei Survey District, to the northern boundary of the said Block IV; thence by the northern boundaries of the aforesaid Block IV, Blocks III, II, and I of the said Whangarei Survey District to the north-eastern boundary of the south-eastern portion of Section 50, Hikurangi Parish; thence in a south-easterly direction by the said north-eastern boundary of the south-eastern portion of the said Section 50 and the north-eastern boundary of the north-eastern portion of Section 67 of the said Hikurangi Parish to the Maihorahia Stream; thence by that stream to its confluence with the Mangahuru River at the north-eastern boundary of Section 38 of the said Block V, Purua Survey District; thence by the said Mangahuru River to its confluence with the Wairua River on the north-eastern boundary of Kopunisho Block, in Block IV of the said Purua Survey District; thence in a south-westerly direction by the said Wairua River to its confluence with the Mangakahia River; thence towards the west generally by the said Mangakahia River to the south-eastern corner of Section 8, Block XV,

Mangakahia Survey District; thence by the north-eastern boundary of the Maungaru Block to the forest reserves lying to the south-west of the road forming the south-western boundaries of Sections 11, 2, and 1, Block XV, Mangakahia Survey District; thence by the south-western boundary of the reserve lying to the south-west of the road forming the south-western boundaries of Sections 11 and 10, Block X, of the said Mangakahia Survey District; thence by the north-eastern boundary of the forest reserve lying to the south-west and south of Sections 9 and 8A of the said Block X of the said Mangakahia Survey District to the north-eastern boundary of Section 13, Te Karaka Block; thence along the north-eastern boundary of the said Section 13, the north-eastern and north-western boundaries of Section 12, the north-eastern and north-western boundaries of Section 10, the north-eastern boundaries of Sections 25 and 24, all of the said Te Karaka Block, to the north-western boundary of the aforesaid Te Karaka Block; thence in a south-westerly direction by the said north-western boundary to a point in line with the northern boundary of Section 10, Block XII, Tutamoe Survey District; thence by a right line to and along the said northern boundary of the said Section 10, the northern boundary of Section 14, the northern and western boundaries of Section 9, all of Block XII, Tutamoe Survey District; thence along the north-eastern boundaries of Sections 9, 10, 11, 12, 13, and 14, Block XI, Tutamoe Survey District, to the eastern boundary of Block X of the said survey district; thence in a southerly direction by the eastern boundary of the said Block X to the south-eastern corner of same; thence in a north-westerly direction by a right line to the source of the Te Wai-o-whata Stream; thence by the said stream to the Te Wai-o-Kumarau River; thence in a westerly direction by the said Te Wai-o-Kumarau River to the north-eastern corner of Section 7, Block V, Tutamoe Survey District (Marlborough Small-farm Association); thence by the north-eastern boundaries of the said Section 7, Sections 6 and 5, of the said Block V, Tutamoe Survey District, the northern boundary of Section 10, Block I, Tutamoe Survey District, to the road on the western boundary of the said Section 10; thence by that road and the northern boundaries of Sections 19, 20, 21, and 22, Block VIII, Waipoua Survey District, the northern and western boundaries of the said Block VIII of the said Waipoua Survey District, to the Waipoua River; thence by that river to the sea; and bounded towards the south-west and north by the sea to the place of commencement: including all adjacent islands.

2. MARSDEN.

This district is bounded towards the north-west and north generally by the Bay of Islands Electoral District, hereinbefore described, from the confluence of the Mangakahia and Wairua Rivers to the sea at the mouth of the Ngunguru River; and bounded towards the north-east generally by the sea to the mouth of the Weiti River; bounded towards the south generally by the said Weiti River to the south-eastern corner of Section 253, Pukeatua Parish; thence by the north-eastern boundary of the said Section 253 to and along the road forming the north-western boundary of the aforesaid Section 253, the northern boundaries of Sections 252 and 251, the northern and north-western boundaries of Section 250, the north-western boundary of Section 249, to the junction of roads on the north-western boundary of the said Section 249; thence by the road forming the northern boundary of Section 94, the north-eastern boundaries of Sections 93 and 92, the northern and north-western boundary of Section 91, to the junction of roads on the north-western boundary of the said Section 91; thence by the road forming the northern boundary of Section 89, the north-western boundaries of Sections 88, 320A, 87, the northern boundaries of Sections 86 and 85, the northern boundary generally of Section 84, to the north-western corner of the said Section 84, thence by the north-western boundary of the aforesaid Section 84, all of the said Pukeatua Parish, to the Kaukapakapa River; thence by that river to the south-eastern corner of Section 64, Kaukapakapa Parish; thence bounded towards the south-west generally by the north-eastern boundary of the said Section 64, the south-eastern boundary of Section 62, to the road forming the south-western and western boundaries of Sections 63, 58, 57, and 52, the road forming the northern boundary of the said Section 52 and the north-western boundary of Section 29, all of the said Kaukapakapa Parish, to the Waitoki Stream; thence by that stream to the road at the easternmost corner of Section 170 of Makarau Parish; thence by that road to the junction of roads on the northern boundary of the said Section 170, and by the road forming the northern boundary of the aforesaid Section 170, the north-eastern boundaries of Sections 168, 166, 102, 103, 180, 90, 70, 69, 67, 65, 33, 31, the southern, western, and north-western boundaries of Section 30, all of Makarau Parish, to the Makarau River, and by that river to its confluence with the Rauhori Stream, forming the south-eastern boundary of Komokoriki Parish; thence by the said south-eastern boundary of the said Komokoriki Parish to its junction with the Ahuroa Parish; thence by the south-western boundary of the said Ahuroa Parish to the north-western corner of the south-western portion of Section 31, Ahuroa Parish; thence by the north-western boundaries of Sections 31 and 32 and their production to and along the road forming the south-western and north-western boundary of Section 30, to and along the road forming the western boundary of Section 87, to and along the road forming the northern boundaries of the said Section 87, Sections 83 and 84, to the junction of roads on the south-western boundary of Section 17; thence by a road to the westernmost corner of the said Section 17; thence by the north-western boundary of the aforesaid Section 17 to and along the road forming the western boundaries of Sections 35, 36, 37, 38, 39, and 55, all of Ahuroa Parish, to the road forming the south-eastern boundary of Section 13, Kourawhero Parish; thence by that road and the south-western and north-western boundaries of the said Section 13 to the south-eastern corner of the north-eastern portion of Section 53; thence by the south-eastern boundaries of Sections 53, 54, and 45, all of Kourawhero Parish, to the Onehunga Stream; thence by that stream to the Pikoko Stream; thence by that stream to the Kaitoto Stream; thence by that stream to the Hoteo River, and by that river to the north-eastern corner of Section 111, Tauhoa Parish; thence by the north-eastern boundary of the said Section 111 to the North Auckland Railway-line; thence by the said railway-line to the road forming the south-eastern boundary of Section 126, Block XVI, Otamatea Survey District; thence by that road to the main Port Albert - Warkworth Road; thence in a southerly direction by that road to and along the road running in a north-westerly direction through Section 9 of the said block and survey district; thence by the road forming the north-eastern boundaries of Sections 127, 128, Oruawharo Parish, to the junction of roads at the north-western corner of Section 126 of the said Oruawharo Parish; thence by a right line due north to the Whakapirau River; thence by that river to the Mainene River; thence by that river to the Topuni River, and by that river to the crossing of the Great North Road; thence by that road to the south-eastern boundary of Section 147, Wairau Parish; thence by the south-eastern boundary of the said Section 147 to the Kaiwaka River; thence by that river to the Wairau River; thence by that river to the Waikore Stream, and by that stream to and along the north-eastern boundary of the Okahurewa Block to the south-eastern boundary of Wairau Parish; thence by the south-eastern, south-western, and north-western boundaries of the said

Wairau Parish to and along the eastern boundary of Mareretu Parish, to and along the south-western boundary of Raranga Parish, to and along the south-western and north-western boundaries of Maungakarama Parish, to the Waotama River; thence by that river to the Tangihua River; thence by that river to the Wairoa River; thence by that river to its confluence with the Mangakahia River, the place of commencement: including Mokohinou, Kawau, Motuketekete, Moturekareka, Motuhora, Tiritiri, and adjacent islands.

3. KAIPARA.

This district is bounded towards the north-east generally by the Bay of Islands Electoral District, hereinbefore described, from the sea at the mouth of the Waipoua River to the confluence of the Mangakahia and Wairua Rivers, and by the Marsden Electoral District, hereinbefore described, from the said confluence to the sea at the mouth of the Weiti River; thence by the sea from the mouth of the said Weiti River to the mouth of the Wairau Stream, at the south-eastern corner of Allotment 23 of Section 5, Takapuna Parish; thence bounded towards the south generally by the south-eastern boundary of the said Allotment 23, the southern boundaries of Allotments 24 and 25, to Sea View Road; thence by that road to Beaconsfield Road; thence by that road to Gordon Avenue; thence by Gordon Avenue and the north-western boundary of Section 3 to and along the road forming the southern boundary of Section 12 to and along the road forming part of the eastern boundary of Section 105 and intersecting the north-eastern portion of the said Section 105 to and along the north-western boundaries of Sections 105, 106, 107, 108, 109, and 110 to the road forming the eastern boundary of Section 220; thence by that road to and along the south-eastern boundary of the said Section 220 to and along the north-western boundaries of Sections 124 and 126, all of Takapuna Parish, to the road on the eastern side of Kaipatiki Creek; thence by that road to the head of the said Kaipatiki Creek; thence by the aforesaid Kaipatiki Creek and Hellyer's Creek to the Waitemata Harbour; thence by the said Waitemata Harbour to and along Brigham's Creek to the north-eastern corner of Section 1, Waipareira Parish; thence by the northern boundary of the said Section 1 to the abandoned railway-line, and by the said railway-line to its junction with the North Auckland Railway-line; thence by that railway-line to its intersection with the south-eastern boundary of Lot 9 of the Taupaki East Block; thence by the road forming the south-eastern boundary of the said Lot 9 to and along the road forming the eastern boundaries of Lots 18, 19, 26, 27, and 28, the eastern and south-eastern boundaries of Lot 29 to and along the road forming the southern boundaries of the said Lot 29, Lots 31, 32, and 33, to and along the south-eastern boundary of Lot 46, the eastern boundary of Lot 21, all of Taupaki East and West Blocks to the northern boundary of the Waitakerei Parish; thence by the northern boundary of the said Waitakerei Parish to the sea at the north-western corner of Allotment 102 of the aforesaid Waitakerei Parish; thence bounded towards the south-west by the sea from the north-western corner of the said Allotment 102 to the mouth of the Waipoua River, the place of commencement: including all adjacent islands.

4. WAITEMATA.

This district is bounded towards the north generally by the Kaipara Electoral District, hereinbefore described, from the mouth of Hellyer's Creek to the sea at the mouth of the Wairau Stream; thence bounded towards the north-east generally by the sea and Rangitoto Channel from the mouth of the said Wairau Stream to the North Head; thence bounded towards the south and south-west generally by the northern shores of the Waitemata Harbour from the North Head to the mouth of Hellyer's Creek, the place of commencement.

5. EDEN.

This district is bounded towards the north generally by the Kaipara Electoral District, hereinbefore described, from the sea at the north-western corner of Allotment 102 of Waitakerei Parish to the Waitemata Harbour, at the mouth of Hellyer's Creek; and thence bounded towards the east generally by the Waitemata Electoral District, hereinbefore described, from the mouth of the said Hellyer's Creek to Kendall's Bay; thence by a right line across the said Waitemata Harbour to the mouth of Motion's Creek, on the southern shore of the aforesaid harbour; thence by the said creek to and along the road forming the north-western boundary of Allotment 13 of Section 9, Suburbs of Auckland, to the north-eastern corner of the said Allotment 13; thence by the western and southern boundaries of Allotment 12 and the eastern boundary of Allotment 17 of Section 9 aforesaid to the Great North Road; thence by that road to the north-eastern corner of Allotment 21 of Section 7, Suburbs of Auckland; thence by the south-eastern boundary of that allotment and the northern boundaries of Allotments 35, 34, and 28 to School Road; thence by School Road to Western Springs

Road; thence by that road to the New North Road; thence by that road to New Edendale Road; thence bounded towards the east generally by that road to Coyle Street; thence by that street to Fowld's Avenue; thence by that avenue to Taumata Road; thence by that road to Euston Road, and by that road to the northernmost corner of Allotment 87, Parish of Titirangi; thence by the north-western boundary of that allotment to and along the north-eastern and south-eastern boundaries of Allotment 51 of the said parish to Richardson Road; thence by that road to and along the south-eastern and south-western boundaries of Allotment 67, to and along the road forming the north-western boundary of Allotment 72, and along the north-western boundary of Allotment 74, all of the said Titirangi Parish, to Manukau Harbour, at the mouth of the Wairaki Stream; thence bounded towards the south-east generally by the north-eastern shores of Manukau Harbour from the mouth of the said Wairaki Stream to the sea; thence bounded towards the south-west generally by the sea to the north-western corner of Allotment 102 of Waitakeri Parish, the place of commencement: including all wharves and extensions seaward.

6. AUCKLAND WEST.

This district is bounded towards the north-west and north-east generally by the southern shores of the Waitemata Harbour to a point in line with the western side of the right-of-way leading from Patterson Street into Victoria Park; thence bounded towards the east generally by a right line to and along the said right-of-way leading into Victoria Park, to Patterson Street; thence by Patterson Street and College Road to Cascade Street; thence by that street to Middle Street; thence by that street to Franklin Road; thence by that road to Wellington Street; thence by that street to Hepburn Street; thence by that street to Williamson Avenue; thence bounded towards the south and south-west generally by Williamson Avenue to Rose Road; thence by that road to Wallingford Road; thence by that road to Richmond Road; thence by that road to Cox's Creek; thence by Cox's Creek to Waitemata Harbour, the place of commencement: and including all wharves and extensions seaward. This district includes Great Barrier Island County, Little Barrier, Rangiahua, and adjacent islands.

7. AUCKLAND CENTRAL.

This district is bounded towards the west generally by the Auckland West Electoral District, hereinbefore described, from the junction of Rose Road and Williamson Avenue to the Waitemata Harbour; thence bounded towards the north-west generally by the said Waitemata Harbour to Queen Street; thence bounded towards the east generally by that street to Karangahape Road; thence by that road to East Street; thence by that street to France Street; thence by that street to Edwin Street; thence by that street to Montague Street; thence by Montague Street to Gundry Street; thence by that street to Newton Road; thence by that road to Fleet Street; thence by that street to Virginia Avenue; thence by that avenue to the New North Road; thence by that road to a point in line with the northern side of Alexandra Street; thence by a right line to and along the said Alexandra Street to Niger Street; thence by that street to and along the north-western boundaries of Allotments 9, 8, 7, and 4 of Section 5, Suburbs of Auckland, to and along the north-eastern boundary of Allotment 13 of Section 7, to and across the Great North Road, to and along Pollen Street to Williamson Avenue, and by that avenue to its junction with Rose Road, the place of commencement: including all wharves and extensions seaward.

8. GREY LYNN.

This district is bounded towards the north-east generally by the Auckland West and Auckland Central Electoral Districts, hereinbefore described, from the mouth of Cox's Creek to the junction of Virginia Avenue with the New North Road; thence by the New North Road to Ngahuru Street; thence by that street to a point in line with the south-eastern side of Shaddock Street; thence by a right line to and along the said south-eastern side of Shaddock Street to the Auckland-Kaipara Railway-line; thence by that railway-line to the Mount Eden Road; thence by that road to and along the road forming the north-eastern boundary of the Mount Eden Recreation Reserve, to and along the eastern and southern boundaries of the said recreation reserve to the north-eastern corner of Allotment 10 of original Section 6, Suburbs of Auckland; thence bounded towards the south-west generally by the eastern and southern boundaries of the said Allotment 10 to the Mount Eden Road; thence by that road to Prospect Rise; thence by Prospect Rise to and along the western boundary of Lot 5, of Lots 40 and 41 of Allotments 4 and 5 of original Section 10, Suburbs of Auckland, to and along the northern boundary of Allotment 5 of the said Section 10 to Valley Road; thence by that road to Dominion Road; thence by that road to Onslow Road; thence by that road to the New North Road, and by that road to the north-eastern

boundary of the Eden Electoral District, hereinbefore described, at the junction of the said New North Road and New Edendale Road; thence by the said Eden Electoral District to the mouth of Motion's Creek; thence bounded towards the north-west generally by the Waitemata Harbour from the mouth of the said Motion's Creek to the mouth of Cox's Creek, the place of commencement.

9. AUCKLAND EAST.

This district is bounded towards the west generally by the Auckland Central Electoral District, hereinbefore described, from the junction of Virginia Road with the New North Road to the Waitemata Harbour at Queen Street; thence bounded towards the north generally by the said Waitemata Harbour to the eastern end of Quay Street; thence bounded towards the east generally by the road forming the south-eastern boundary of the railway-yards to the Strand; thence by the Strand to Gitto's Street; thence by that street to Alpha Road; thence by that road to Manukau Road; thence by that road to Henley Street; thence by that street to its junction with Falcon Street; thence by a right line from the centre of the said junction to the north-eastern corner of the Auckland Domain; thence by the eastern boundary of the said Domain to the junction of Titoki and George Streets; thence by George Street to Manukau Road; thence by that road to and along the north-eastern boundary of Allotment 21 of original Section 4, Suburbs of Auckland, to Slaughterhouse Creek; thence by that creek to the south-eastern corner of Allotment 23 of the said original Section 4; thence by the southern boundary of the said Allotment 23 to the north-eastern corner of the Public Hall site; thence by the eastern boundary of the said site to its south-eastern corner; thence by a right line in line with the southern boundary of the aforesaid site to a point 303 links from the south-western corner of the before-mentioned site; thence by a right line parallel to the eastern side of Manukau Road (1818-9 links) to a point in line with the northern side of Buckland Road; thence by a right line to and along the northern side of the said Buckland Road to Gillies Avenue; thence by that avenue to Seccombe's Road; thence by that road to Almora Road; thence by that road to Grenfell Road; thence by that road to the Grey Lynn Electoral District, hereinbefore described, at the eastern boundary of the Mount Eden Recreation Reserve; thence bounded towards the south-west generally by the said Grey Lynn Electoral District from the junction of the said Grenfell Road with the Mount Eden Recreation Reserve to the junction of Virginia Road with the New North Road, the place of commencement: including all wharves and extensions seaward. This district also includes the Rakino, Motutapu, Rangitoto, Mohikirewa, Motuihi, Waiheke, Pahiki, Rotoroa, Pakatoa, Ponui, and adjacent islands.

10. PARNELL.

This district is bounded towards the west generally by the Grey Lynn and Auckland East Electoral Districts, hereinbefore described, from the south-eastern corner of Allotment 10 of original Section 6, Suburbs of Auckland, to the Waitemata Harbour at the eastern end of Quay Street; thence bounded towards the north generally by the Waitemata Harbour and Hobson's Bay to the entrance to the Orakei Basin; thence bounded towards the east generally by a right line from the entrance to the said basin to the mouth of the Orakei Creek; thence by the Orakei Creek to and along the eastern boundary of Allotment 238 of original Section 16, Suburbs of Auckland (Native reserve) to the Remuera Road; thence by that road to the road known as the Ladies' Mile; thence by that road to Bella Street; thence by that street to Morrin Street; thence by that street to Gladstone Street; thence by that street and the road forming the north-eastern boundary of Allotment 7A of original Section 12, Suburbs of Auckland (Hospital Reserve) to the Great South Road; thence bounded towards the south generally by that road to its intersection with Green Lane; thence by that lane to the north-eastern corner of Allotment 21A of original Section 11, Suburbs of Auckland (Costley Home); thence by the eastern boundaries of the said Allotment 21A, the western boundaries of Allotments 9 and 11 to the northern boundary of Allotment Part 13, all of original Section 12, Suburbs of Auckland (educational reserve); thence by the northern, eastern, and southern boundaries of the said educational reserve to the Auckland-Onehunga Road; thence by that road to Owen's Road; thence by that road to the south-eastern corner of Allotment 57 of original Section 6, Suburbs of Auckland; thence by the southern and western boundaries of the said Allotment 57 to the south-eastern corner of Allotment 10, the place of commencement.

11. ROSKILL.

This district is bounded towards the north generally by the Grey Lynn and Parnell Electoral Districts, hereinbefore described, from the junction of the New North Road with the New Edendale Road to the junction of Owen's Road with

the Auckland-Onehunga Road; thence bounded towards the east by the said Parnell Electoral District from the junction of the said Owen's Road with the Auckland-Onehunga Road to the south-eastern corner of Allotment 35 of original Section 10, Suburbs of Auckland; thence towards the south and east generally by the southern boundary of the said Allotment 35 to the road forming the eastern boundary of Allotment 58 of the aforesaid Section 10; thence by that road to Selwyn Road; thence by Selwyn Road to St. Andrew's Road; thence by that road to Landscape Road; thence by that road to Three Kings Road; thence by that road to Mount Albert Road; thence by that road to May Road, at the north-western corner of the eastern portion of Allotment 47, Parish of Titirangi; thence by that road to Richardson Road, and by that road to the Eden Electoral District, hereinbefore described, at the junction of the said Richardson Road at the easternmost corner of Allotment 67 of the aforesaid Parish of Titirangi; thence bounded towards the west generally by the said Eden Electoral District to the junction of the New North Road with the New Edendale Road, the place of commencement.

12. MANUKAU.

This district is bounded towards the north-west generally by the Eden, Roskill, and Parnell Electoral Districts, hereinbefore described, from the Manukau Harbour at the mouth of the Wairaki Stream to Hobson Bay of Waitemata Harbour, at the entrance to the Orakei Basin; thence towards the north generally by the Waitemata Harbour to the mouth of the Tamaki River; thence bounded towards the south-east generally by the said Tamaki River to the mouth of Otahuhu Creek; thence by that creek to and along Portage Road to the Main Trunk Railway-line; thence by that railway-line to the south-eastern corner of Lot 2, a subdivision of part of Fairbairn's Grant (registered at the Deeds Office, Auckland, in Vol. R 221, folio 74); thence by the southern boundary of the said Lot 2 to Station Road; thence by that road to a point 1250 links from the junction of the said Station Road with Portage Road; thence by a right line to Buckland Road at a point 740 links from its junction with the said Portage Road; thence by the said Buckland Road to the aforesaid Portage Road; thence by that road to and along the road forming the southern boundary of Section 55, Manurewa Parish; thence by the road forming the northern and western boundaries of Section 51 and western boundary of Section 53 of the said parish to Pukaki Creek; thence by that creek to the Manukau Harbour; thence bounded towards the south and west generally by the said Manukau Harbour to the Mangere Bridge; thence across the said bridge to and along the northern shore of the aforesaid Manukau Harbour to the mouth of the Wairaki Stream, the place of commencement: including Weeks Island and adjacent islands, and all wharves and extensions seaward.

13. FRANKLIN.

This district also includes Cuvier, Great Mercury, Slipper, and adjacent islands.

15. RAGLAN.

Station; thence by the southern boundary of the said Waimata Native Reserve to and along the south-eastern boundary of Section 1, Block XIV, and south-eastern boundary of Section 1, Block XIII, of the aforesaid Patutahi Survey District, to and along the southern boundary of Whakaongaonga 1 Block, to and along the southern boundary of Small Grazing-run 79A to the Mangarangi Stream; thence by that stream to the south-eastern corner of Lot 1 of Mangapoike 2A 3 Block; thence by the south-eastern boundary of the said Lot 1 to the south-eastern corner of Lot 5 of the said Mangapoike 2A 3 Block; thence by the eastern and northern boundaries of the said Lot 5, the north-western boundary of Lot 4, to and along the western boundary of the said Lot 1 of the said Mangapoike 2A 3 Block to the Hangaroa River; thence by that river to and along the southern and western boundaries of Tauwharetoi 3A Block, to and along the eastern and northern boundaries of the Tauwharetoi 4B Block, to and along the south-western boundary of Section 5, Block IX, Hangaroa Survey District, to and along the south-western and western boundaries of Section 2 of the said block and survey district, to and along Bushy Knoll Road, to and along the Gisborne-Waikaremoana Road, to and along the eastern and northern boundaries of Section 1 (Forest Reserve), Block VIII, Tuahu Survey District, to and along the northern boundary of Small Grazing-run 84 to the Ruakituri River; thence by that river to its intersection with a right line from the Maungapohatu Trig. Station to the Puketapu Trig. Station; thence by a right line to the said Puketapu Trig. Station; thence bounded towards the west generally by the Rotorua Electoral District, hereinbefore described, to the ocean at the Maraetotara Road in Section 246, Block III, Whakatane Survey District, the place of commencement.

22. GISBORNE.

Survey District, and the production of the eastern boundary of the last-mentioned section to the said Wairoa River; thence by that river to its confluence with the Kauhauroa Stream; thence by that stream and its production to the eastern boundary of Section 31A, Block X, Opoiti Survey District; thence by the eastern boundary of the said Section 31A, to the Makaretu Stream; thence by that stream to its confluence with the Mangapoiki River, and by that river to its intersection with the north-eastern boundary of Wairoa County at a point on a right line from the sea at Hauheke to the confluence of the Ruakituri and Wairoa Rivers; thence by that right line to the south-eastern boundary of Mangapoike 2A 3 Block; thence by the south-eastern boundary of the last-mentioned block to the south-western corner of Lot 1 of the said block, the place of commencement: including Portland Island.

23. HAWKE'S BAY.

24. NAPIER.

This district is bounded towards the north, west, and south generally by the Hawke's Bay Electoral District, hereinbefore described, and towards the east by the ocean.

25. WAIPAWA.

Station 27, Block IV of the said Mangatoro Survey District; thence by a right line to the south-western corner of Block 77 in Block III of the said Mangatoro Survey District; thence by the south-western boundary of the said Block 77 to the confluence of the Mangapuaka Stream with the Whangai Stream; thence by the said Mangapuaka Stream to its confluence with the Manawatu River; thence by that river to its confluence with the Mangatawainui River; thence by that river to its intersection with the main Napier-Woodville Road; thence by that road to its intersection with the Mangatawai-iti River; thence by that river to the south-western boundary of the Te Ohu Block, Block V, Norsewood Survey District; thence by the south-western boundary of the said block to the summit of the Ruahine Range; thence bounded towards the west generally by the said Ruahine Range to a point in line with a right line from the junction of the Makororo River with the north branch of the Waipawa River and Trig. Station 30R (Aorangi); thence by a right line to the said Trig. Station 30R (Aorangi); thence by a right line from the aforesaid Trig. Station 30R (Aorangi) towards Trig. Station 32 (Papakai) to its intersection with the Rangitikei River; thence by the said Rangitikei River to its intersection with a right line from Trig. Station 27 (Motumatai) to Trig. Station 26 (Tewheke Tewhango); thence by a right line to the said Trig. Station 26 (Tewheke Tewhango); thence by a right line towards Trig. Station 65A to the Ngaruru River, the place of commencement.

26. PAHIATUA.

thence by that road to and along the northern boundary of Section 1, Block III, and north-western boundary of Section 3, Block IV, Heao Survey District, to the Wanganui River, and thence by that river to its confluence with the Ohura River; thence bounded towards the south generally by the said Ohura River to its intersection with the 39th parallel of south latitude; thence by the said 39th parallel of south latitude to the Tangarakau Stream; 30. TARANAKI.

This district is bounded towards the north-east generally by the Waitomo Electoral District, hereinbefore described, from the mouth of the Waitara River to the confluence of the Manganui Stream with the Waitara River; thence bounded towards the south-east generally by the said Manganui Stream to its confluence with the Mangapoto Stream; thence by that stream to and along the western boundary of Section 167, Huirangi District, Block XIII, Waitara Survey District, to Roddy Road; thence by the northern boundary of the said Block XIII of the said Waitara Survey District to and along the western boundaries of Sections 151, 150, 149, and 208, all of the said Huirangi District, to and along the northern boundary of Section 1, Block XIII, of the aforesaid Waitara Survey District, to and along the eastern boundaries of Sections 133, 132, 131, 130, the eastern and northern boundaries of Section 129, all of the aforesaid Huirangi District, to Richmond Road; thence by that road to and along the southern boundary of Section 121 of the aforesaid Huirangi District, to and along the eastern and northern boundaries of Section 111, Huirangi District, Block XI, Paritutu Survey District, to Wortley Road; thence by that road to and along the northern and western boundaries of Section 98, the western boundary of Section 99, to a point in line with the southern boundary of Section 199, all of the said Huirangi District; thence by a right line to and along the southern boundary of the said Section 199, to and along the northern boundary of Section 54, Tarurutangi District, Block XI, Paritutu Survey District, to and along Hursthouse Road, to and along the northern and western boundaries of Section 53, and northern boundary of Section 49, all of the said Tarurutangi District, to King Road; thence by that road to and along the southern and western boundaries of Section 41, the southern boundary of Part Section 32 (E.R.), all of the aforesaid Tarurutangi District, to and along the southern boundary of Section 45, Hua and Waiwakaiho Hundred, Block X, Paritutu Survey District, to Upland Road; thence by that road to and along the southern boundary of Section 44, to and along the eastern and north-western boundaries of Section 48 of the said Hua and Waiwakaiho Hundred, to the Waiwakaiho Stream; thence by that stream to its source; thence by a right line to the summit of Mount Egmont; thence bounded towards the south-west by a right line from the summit of the said Mount Egmont to Puniho Road; thence by that road to the ocean; thence bounded towards the north-west by the ocean to the mouth of the Waitara River, the place of commencement.

31. STRATFORD.

Station B (Pahui); thence by a right line to the south-eastern corner of Section 48, Block VI, Ngaire Survey District; thence by the southern boundaries of Blocks VI and V of the Ngaire Survey District aforesaid to the Waingongoro River; thence by that river

to Finnerly Road; thence by that road to Hastings Road; thence by that road to the north-eastern corner of Section 32, Block VIII, Kaipokonui Survey District; thence by the northern boundaries of Sections 32 and 31 of Block VIII aforesaid to Duthie Road; thence by that road to and along the southern boundary of Section 25 of the aforesaid Block VIII to Palmer Road; thence by that road to the north-eastern corner of Block XI, Kaipokonui Survey District aforesaid; thence by the northern and western boundary of the said Block XI to and along the northern boundary of Block X to the south-eastern corner of Section 1, Block VI, Kaipokonui Survey District aforesaid; thence bounded towards the west generally by the eastern boundary of the said Section 1 to Opunake Road; thence by that road to and along the eastern boundaries of Sections 16, 13, and 11, Block VI aforesaid, to the north-eastern corner of the said Section 11; thence by a right line to the summit of Mount Egmont, the place of commencement.

32. EGMONT.

33. PATEA.

Station 32 (Papakai) to the confluence of the Panemango and Tamakomako Streams; thence by the said Panemango Stream to and along the southern boundaries of Te Ruanui 2B3, 2B4, 2B5, 2B6, and 2B7 Blocks, in Block XV, Maungakaretu Survey District, to and along the south-western boundary of Section 1, Block X, of the said Maungakaretu Survey District, to its westernmost corner; thence by a right line to Trig. Station, Maungakaretu; thence by a right line due west to Hales Road; thence by that road to and along the north-eastern boundary of Section 73, Block IX, of the aforesaid Maungakaretu Survey District, to the Koukou Stream, thence by that stream to its confluence with the Opoihi Stream; thence by that stream to its confluence with the Pangarara Stream; thence by that stream to the Wangaehu River; thence by that river to and along the southern boundary of Ohotu 7 Block to and along Fields Track, to and along the Rangitatu Stream to its confluence with the Mangawhero River; thence by that river to and along the northern boundaries of Part Tauakira 2J, 2CC, 2AA, 2Z, 2Y, 2DD and 2EE Blocks, to and along the south-eastern and south-western boundaries of Section 1, Block XII, Tauakira Survey District, to and along the south-eastern boundaries of Sections 3 and 9, Block XI, of the said Tauakira Survey District, to the Paparua Stream; thence by that stream to the Wanganui River; thence bounded towards the south-west generally by the said Wanganui River to its confluence with the Tangarakau Stream, the place of commencement.

36. RANGITIKEI.

39. MANAWATU.

This district is bounded towards the north and north-east generally by the Rangitikei, Oroua, and Palmerston Electoral Districts, hereinbefore described, from the ocean at the north-western boundary of Run 19, Block V, Koitiata Survey District, to Trig. Station Arawaru, on the summit of the Tararua Range; thence bounded towards the south-east generally by the Masterton Electoral District, hereinbefore described, to the south-western boundary of Section 3, Block IV, Waiopahu Survey District, on the summit of the said Tararua Range; thence bounded towards the south generally by the south-western and western boundary of the said Section 3, to and along the south-western boundaries of Sections 12, 13, and 20, Block XV, Mount Robinson Survey District, to and along the road forming the western boundaries of the said Sections 20 and 13, Section 10, the north-eastern boundary of Section 14, and eastern boundary of Section 7, all of the said Block XV, to and along the southern boundaries of Sections 4, 3, 2, and 1 of the aforesaid Block XV, and Section 3, Block X, all of the aforesaid Mount Robinson Survey District, to the Main Trunk Railway line; thence by the said railway-line to the northern boundary of the Borough of Levin at the Kawi Road; thence in an easterly direction by that road to and along Bartholomew Road; thence by a right line being the production of the north-

western side of that road to the south-western boundary of Subdivision 10, Horowhenua Block; thence by the south-western boundary of the said Subdivision 10 and its production to the Horowhenua Beach Road; thence by that road to the ocean; thence bounded towards the west by the ocean to the north-western boundary of Run 19, Block V, Koitiata Survey District, the place of commencement.

40. OTAKI.

This district is bounded towards the north generally by the Manawatu Electoral District, hereinbefore described, from the ocean at the Horowhenua Beach Road to the south-western boundary of Section 3, Block IV, Waiopahu Survey District, on the summit of the Tararua Range; thence bounded towards the south-east generally by the Masterton and Wairarapa Electoral Districts, hereinbefore described, to the north-eastern boundary of the Wellington Waterworks Reserve on the summit of the Tararua Range; thence bounded towards the south generally by the north-eastern boundary of the said Wellington Waterworks Reserve, to and along the north-eastern boundaries of Sections 97 and 27, Block VIII, Rimutaka Survey District, the north-eastern boundary of Section 26, Block V, the north-eastern and north-western boundary of Section 25, to and along the north-eastern boundary of Section 28, all of the said Block V, Rimutaka Survey District, to Whiteman's Valley Road; thence by that road to No. 1 Line; thence by that line to and along the road forming the south-eastern boundary of Section 84, Block IV, Belmont Survey District, to and along the south-western boundary of the said Section 84 to the Hutt River; thence bounded towards the south-east by the said river to the Wellington-Wairarapa Railway line at the railway-bridge near Hayward's Railway-station; thence by the said railway-line to the south-eastern boundary of Section 37, Block IX, of the said Belmont Survey District, at the western boundary of the Lower Hutt Borough, thence by the south-eastern and southern boundaries of the said Section 37, to and along the south-eastern boundaries of Sections 186 and 115, the north-western boundaries of Sections 28, 24, and 20 (N.R.), all of Block VIII of the aforesaid Belmont Survey District, to the northern boundary of the Petone Borough; thence by the northern and western boundaries of the said Petone Borough forming the northern and western boundaries of Block XIII of the aforesaid Belmont Survey District to Port Nicholson; thence by the western shores of the said Port Nicholson to a point in line with the south-western boundary of Section 7, Block XI, of the aforesaid Belmont Survey District; thence bounded towards the south generally by a right line to and along the south-western and north-western boundaries of the said Section 7, to and along the north-eastern boundary of Section 4 of the said Block XI to the main road from Johnsonville to Wellington; thence by that road to and along the northern boundary of Section 5, to and along the eastern and southern boundaries of Section 107, and the southern boundary of Section 95 of the said Block XI; thence by a right line from the south-western corner of the said Section 95 to the old Ohariu Road at the north-western corner of Section 94; thence by that road to the north-western corner of Section 93; thence by a right line to the south-eastern corner of Section 14; thence by the eastern boundary of the said Section 14, all of the aforesaid Block XI, and eastern boundaries of Sections 15 and 17, Block VI, of the aforesaid Belmont Survey District, to the new Ohariu Road; thence by that road to and along the Johnsonville-Ohariu Road to its intersection with the south-western boundary of Section 78, Block III, Port Nicholson Survey District; thence by the south-western boundaries of the said Section 78 and Section 75 to and along the south-eastern and north-eastern boundaries of Section 99, all of the said Block III of the said Port Nicholson Survey District, to the ocean at the northernmost corner of the said Section 99; thence bounded towards the north-west generally by the ocean to the Horowhenua Beach Road, the place of commencement: including Kapiti and Mana Islands.

41. HUTT.

This district is bounded towards the north-west and north-east generally by the Otaki Electoral District, hereinbefore described, from Port Nicholson at the southernmost corner of Block 13, Belmont Survey District, to the summit of the Tararua Range at the north-eastern boundary of the Wellington Waterworks Reserve; thence bounded towards the east generally by the Wairarapa Electoral District, hereinbefore described, to the ocean at Cape Turakirae; thence bounded towards the south and south-west generally by the ocean and the eastern and northern shores of Port Nicholson to the southernmost corner of Block XIII, Belmont Survey District, the place of commencement: including Somes Island.

42. WELLINGTON NORTH.

This district is bounded towards the north generally by the northern boundary of the Wellington Town Belt from the southern end of Weld Street, Wadestown, to and along the Pakuao Stream, crossing Grosvenor Road and High Street, to and along the north-western boundary of Section 660, to and along the north-eastern boundary of the said Section 660, to and across the Main Hutt Road, and by the Thorndon Esplanade to Port Nicholson; thence bounded towards the east generally by the said Port Nicholson and Lambton Harbour to the northernmost end of Taranaki Street; thence bounded towards the south generally by the said Taranaki Street, to and along Dixon Street, to and along Willis Street, to and along Ghuznee Street, to and along Woolcombe Street, to and along the north-eastern and north-western boundaries of Section 436, to and along the north-eastern boundary of Section 48, Town Belt, to and along the north-eastern and western boundaries of Section Part 15b (part of Gaol Reserve), to and along the southern boundary of Lot 1, to and across Fairlie Terrace, to and along Adams Terrace and the production of its north-eastern boundary to and along the north-eastern boundary of the Wellington Town Belt, and its production to and across Norway Street, to and along the south-western boundary of Lot 1, to and across Raroa Road, to and along the north-eastern boundaries of Lots 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 116, and 117, to and across Norma Crescent, to and along the north-eastern boundaries of Lots 29, 30, and 31, to and along Disley Street, to and across Moana Road, to and along the northern boundaries of Lots 32, 33, and 34 and their production to the Kaiwharawhara Stream at the easternmost corner of part Section 34; thence bounded towards the west generally by the said Kaiwharawhara Stream to a point in line with the middle of Thorby Street; thence by a right line to and along the said Thorby Street to its junction with the Northland Garden Road; thence by that road to and along Farm Road, to and along Creswick Road, to and along the southern boundary of Section Part 31 to the said Kaiwharawhara Stream; thence by that stream to and along the northern and eastern boundaries of Section Part 31, to and along the northern boundary of Section Part 30, and its production to the western boundary of the Wellington Town Belt on the eastern boundary of the Wireless Telegraph Station Reserve; thence by the western boundary of the said Town Belt to the southern end of Weld Street, Wadestown, the place of commencement: including all wharves and extensions seaward.

43. WELLINGTON CENTRAL.

This district is bounded towards the north generally by the Wellington North Electoral District, hereinbefore described, from the Kaiwharawhara Stream at the easternmost corner of Section Part 34 to Lambton Harbour at the northernmost end of Taranaki Street; thence by the said Lambton Harbour to the road on the western side of the Boat Harbour; thence bounded towards the south-east generally by that road to Clyde Quay; thence by Clyde Quay to and along Kent Terrace, to and along Buckle Street, to and along Tasman Street, to and along Rugby Street, to and along Adelaide Road to Drummond Street; thence bounded towards the south generally by the said Drummond Street, to and along the said Tasman Street, to and along Tainui Terrace and the production of its northern boundary to and along the western boundary of Lot 717, to and along the northern boundaries of Lots 711, 710, and part 691, to and along Hankey Street to the southern end of Nairn Street; thence by the south-eastern boundary of Lot 55 to its southernmost corner; thence by a right line to and along the northern boundary of Tanera Crescent, to and along the northern boundaries of Lots 16, 37, 36, 35, 34 and 197, to and along the northern end of Karepa Street; thence by the northern boundary of Lot 209, and the northern boundary of reserve part of Section 11 to its north-western corner; thence by a right line to the easternmost corner of Original Section 1; thence by a right line to the southernmost corner of Section Part 2 north of Wright's Hill; thence bounded towards the north-west generally by the north-western boundary of the Wellington Water-supply Catchment Area to the Kaiwharawhara Stream at the easternmost corner of Section Part 34, the place of commencement: including all wharves and extensions seaward.

44. WELLINGTON EAST.

This district is bounded towards the north and east generally by Lambton Harbour and Evans Bay from the road on the western side of the Boat Harbour to and along the south-eastern boundary of Lot 45 opposite the northern end of Salek Street, Kilbirnie, to Seatoun Road; thence by that road to and along the said Salek Street to Coutts Street;

thence bounded towards the south generally by the said Coutts Street to and along Ross Street, to and along Cook Street and its production to the Queen's Drive; thence by the said Queen's Drive to the southern boundary of Original Section 7, forming the northern boundary of Allotment 25, Maranui (as shown on Land Transfer Plan 879); thence by the southern boundaries of the said Original Section 7 and Original Section 5 to the south-eastern boundary of Newtown Park; thence bounded towards the west generally by the south-eastern boundary of the said Newtown Park and the eastern boundary of the Wellington Town Belt to a point in line with the middle of Mein Street; thence by a right line to and along the said Mein Street to Riddiford Street; thence by that street to and along John Street, to and along Tasman Street, to the Wellington Central Electoral District, hereinbefore described, at the western end of Drummond Street; thence by the eastern boundary of the said Wellington Central Electoral District to Lambton Harbour at the road on the western side of the Boat Harbour, the place of commencement: including all wharves and extensions seaward.

45. WELLINGTON SOUTH.

This district is bounded towards the north generally by the Wellington Central Electoral District, hereinbefore described, from the north-western corner of reserve, part of Section 11 to Tasman Street at the eastern end of Tainui Terrace; thence bounded towards the east generally by the said Wellington Central Electoral District and the Wellington East Electoral District, hereinbefore described, from the eastern end of the said Tainui Terrace to the south-eastern boundary of Newtown Park at a point in line with the middle of Owen Street; thence bounded towards the south generally by a right line to the southern end of the said Owen Street; thence by the southern boundaries of Lots 900 and 899 to the southern end of Daniel Street; thence by that street to and along the northern boundary of Newtown Park, to and along Russell Terrace, to and along Leraud Street, to and across Adelaide Road, to and along Duppa Street, to and along Stanley Street, to and along the southern boundaries of Lots 27 and 26, to and across the southern end of Emerson Street, to and along the southern and western boundaries of Lot 1, to and along the western boundaries of Lots 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, and 15, to and across the western end of Morton Street, to and along the western boundaries of Lot 16 and the Levin Memorial Home to Britomart Street; thence by that street and the production of its northern boundary to the western boundary of the Municipal golf-links; thence by the said western boundary of the said golf-links to and along the northern and western boundaries of the Wellington Town Belt to the north-western corner of Section 592; thence by a right line to Ohiro Road at the north-western corner of Lot 3 (part of Original Section 23); thence bounded towards the west generally by the said Ohiro Road to the north-eastern corner of Original Section 14, Block X, Port Nicholson Survey District; thence by the northern boundary of the said Original Section 14, to and along the western boundaries of Original Section 13 and reserve part of Section 11 to its north-western corner, the place of commencement.

46. WELLINGTON SUBURBS.

This district is bounded towards the north-west generally by the Otaki Electoral District, hereinbefore described, from the ocean at the north-western corner of Section 99, Block III, Port Nicholson Survey District, to Port Nicholson at a point in line with the south-western boundary of Section 7, Block XI, Belmont Survey District; thence bounded towards the east generally by Port Nicholson to the northern boundary of the Wellington North Electoral District, hereinbefore described; thence by the said Wellington North Electoral District and by the Wellington Central, Wellington South, and Wellington East Electoral Districts, hereinbefore described, to Evans Bay; thence by the said Evans Bay and Port Nicholson to Palmer Head; thence bounded towards the south-west and north-west by the ocean to the north-western corner of Section 99, Block III, Port Nicholson, the place of commencement: including all wharves and extensions seaward.

A PROCLAMATION.

WHEREAS the South Island Representation Commission, appointed under the provisions of the Legislature Act, 1908, have made their report to me under their hands and seals, setting forth the names and boundaries of the electoral districts for the South Island fixed by them in accordance with the Legislature Act, 1908:

Now, therefore, in pursuance and exercise of the power and authority vested in me by the twenty-second section of the Legislature Act, 1908, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby proclaim the names and boundaries of the electoral districts for the South Island, so fixed by the said Commission, to be those respectively mentioned and set out in the Schedule hereto.

SCHEDULE.

1. NELSON.

This district is bounded towards the north-west generally by the ocean from the northernmost end of Section 20, Block VIII, Motueka Survey District, to Francis Head; thence bounded towards the north-east generally by the said ocean to the northernmost corner of Section 4, Block IV, Gore Survey District, at Allen Strait; thence bounded towards the south-east generally by a right line to the north-western corner of Section 1 of the said Block IV; thence by the western boundary of the said Section 1 and south-western boundary of Section 6 of the aforesaid Block IV to and along the south-western boundary of Section 4, Block III, to and along the south-western and southern boundaries of Section 53, Block VIII, to and along the western boundary of Section 50A, to and along the eastern boundary of the Reserve for the Growth and Preservation of Timber to the northern boundary of Section 54, Block VII; thence by the northern boundary of the said Section 54 and its production to and along the western boundary of Section 49 of the said Block VII (Landless Natives' Reserve), to and along the eastern boundary of Section 19, Block VI, to and along the north-eastern boundary of Section 20 of the said Block VI; thence by the south-eastern boundary of the said Section 20, to and along the south-eastern boundary of Section 23 and north-western boundary of Section 30, both of the said Block VI, all of the said Gore Survey District, to and along the north-western boundary of the Ruakaha Native Reserve, Block II, Arapawa Survey District, to and along the southern boundary of Section 23, Block I, to and along the southern boundary of Section 7, the eastern and southern boundaries of Section 6, the south-eastern boundary of Section 1, all of the said Block I of the said Arapawa Survey District, to and along the southern boundaries of Sections 93, 101, 22A, and 92, Block IV, Linkwater Survey District, to and along the eastern and southern boundaries of Section 91, to and along the eastern and southern boundaries of Section 20, to and along the southern boundary of Section 90, all of the said Block IV, to and along the south-eastern and south-western boundaries of Section 14, Block III, to and along the north-western boundaries of Sections 6, 5, and 4, Block VII, to and along the north-eastern boundaries of Sections 2 and 64, Block VI, to Mahau Sound; thence by a right line through the said Mahau Sound to Watanihi Point; thence by the watershed to Trig. Stations AA and E; thence by the summit of the Examiner Ridge to McLaren's Peak; thence by the summit of the range to and over Editor Peak, Mount Duppa, and Saddle Hill to the source of the Hereinga Stream; thence by that stream to its confluence with the Pelorus River; thence by that river to the southern boundary of the Stoke Road District at the southern boundary of Square 18; thence by a right line running due west to its intersection with a right line bearing south 45° west from a point about two miles distant from the north-eastern corner of Section 18, Suburban South, and in line with the north-eastern boundary of the said Section 18; thence along a right line bearing south 45° west to the River Lee; thence by that river to its confluence with the Roding River; thence by that river to its confluence with the Wairoa River; thence by that river to the road forming the north-eastern boundary of Section 16, on the left bank of the said river, in Block XIII, Waimea Survey District; thence by that road, Pig Valley Road, the road passing through Wairoa Gorge, and the Church Valley Road to the junction of roads intersecting Section 40, Block XVI, Wai-iti Survey District; thence by the road forming the north-eastern boundaries of Sections 2 of 2, and 79A, and intersecting Original Sections 79 and 85, to its intersection with the Nelson-Tadmor Railway line; thence in a south-western direction by the said railway-line to the left bank of the Wai-iti River; thence in a north-easterly direction by the said left bank of the said Wai-iti River to the road

forming the south-western boundary of Section 154, Block XV, of the said Wai-iti Survey District; thence in a north-westerly direction by that road, Trass's Valley Road, and the road forming part of the north-eastern boundary of Section 1, Block XI, Sections 1 and 2, Block X, of the said survey district, to and along the eastern boundary of Section 34 to Stanleybrook-Wakefield Road; thence by that road to and along the eastern boundary of Section 8, to and along the eastern boundary of Section 10, and south-eastern boundary of Section 17, all of Block X of the aforesaid survey district, to and along the southern boundary of Section 33, the southern and eastern boundary of Section 34, Block XI, to and along the eastern boundaries of Sections 16 and 9, the southern and south-eastern boundaries of Section 8, all of Block VII, to and along the north-eastern boundary of Section 213, to and along the road forming the eastern boundary of Section 6 (F.R.) and south-eastern boundary of Section 29, all of the said Block VII, to and along the north-eastern boundaries of Sections 28 and 27 of the said Block VII, to and along the southern boundary of Section 8, Block VIII, to and along the southern and eastern boundaries of Section 10, to and along the southern and eastern boundaries of Section 2 and eastern boundary of Section 3, all of the said Block VIII, to and along the eastern boundary of Section 5, Block IV, to and along the north-eastern boundary of Section 6, to and along the eastern boundary of Section 9, to and along the south-eastern boundary of Section 10, all of the said Block IV, to and along the Nelson-Motueka Coach Road, to and along the road forming the eastern boundary of Section 3 of the aforesaid Block IV, all of the aforesaid Wai-iti Survey District, to and along the road forming the eastern boundaries of Sections 47 and 62, Block XVI, Motueka Survey District, to and along the road forming the eastern and northern boundaries of Section 31, intersecting Section 159 and forming the eastern boundaries of Sections 24 and 24A, all of the said Block XVI, to and along the road forming the eastern boundaries of Sections 83, 83A, and 96A, Block XII, to and along the road forming the north-western boundaries of Sections 95A, 60, 58, and 101, all of the said Block XII, Motueka Survey District, to and along the south-western, south-eastern, and north-eastern shores of the Moutere Mud Flat to the ocean at the northernmost end of Section 20, Block VIII, of the aforesaid Motueka Survey District, the place of commencement: including D'Urville, Stephen, Rangitoto, Trio, Maud, Forsyth, Chetwode, Rabbit, Saxtons, Oyster, Pepin, Fifeshire, and adjacent islands.

2. MOTUEKA.

This district is bounded towards the west, north-west, and north-east generally by the ocean from the mouth of the Moko-hini River to the northernmost end of Section 20, Block VIII, Motueka Survey District; thence by the Nelson Electoral District, hereinbefore described, from the said northernmost end of the said Section 20 to the Pelorus River at the southern boundary of the Stoke Road District, at the southern boundary of Square 18; thence bounded towards the south-east generally by the said Pelorus River to its source near Red Hills; thence to and along the summit of the range over the said Red Hills, Mount Rintoul, and Bush Cone to the summit of Ward's Pass, and along a right line to Trig. Station Top 2 (Mangatawai); thence along the summit of the St. Arnaud Range and the summit of the Spenser Mountains to the summit of the southern watershed of the Maruia River; thence bounded towards the south-west generally by the said summit of the southern watershed of the said Maruia River to Mount Haast; thence in a north-easterly direction by the summit of the Victoria Range to the source of the Inangahua River; thence by that river to the south-eastern corner of Section 195, Block XIV, Reefton Survey District; thence by a right line to the easternmost corner of Section 185, Block XIII, of the said Reefton Survey District; thence by the south-eastern and south-western boundaries of the said Section 185 to its westernmost corner; thence by a right line to the summit of the watershed between the Little Grey and Inangahua Rivers; thence bounded towards the west generally by the summit of the said watershed to its intersection with a right line from Mount Faraday to the confluence of the Waitahu and Inangahua Rivers; thence by a right line to the confluence of the said rivers; thence by the Waitahu River to a point in line with the eastern boundary of Section 60, Block X, Reefton Survey District; thence by a right line to and along the eastern boundary of the said Section 60 to its south-eastern corner; thence by a right line due east to its intersection with Boatman's Creek; thence by that creek to the south-eastern boundary of Section 243, Blocks X and XI, of the said Reefton Survey District; thence by the south-eastern boundary of the said Section 243 to and along the road intersecting the aforesaid Section 243 and intersecting Sections 242 and 241, to and along the road forming the north-eastern boundary of Section 2 of Block VI, to and along the road forming the north-western boundary of Section 177, Block VI, of the aforesaid Reefton Survey District, to and

along Italians' Creek, to and along Raglan's Creek, to and along the old track running along the southern side of Larry's Creek to the junction of tracks in Block VIII of the aforesaid Reef-ton Survey District; thence in a north-easterly direction by the track to the summit of the Brunner Range at Bourke's Rocks; thence by the summit of the said Brunner Range over Mount Wynn to and along the summit of the Lyell Range over Bald Hill to the source of the Mokihinui River; thence bounded towards the south generally by the said Mokihinui River to the ocean, the place of commencement.

3. BULLER.

This district is bounded towards the north-west generally by the ocean from the mouth of the Grey River to the mouth of the Mokihinui River; thence bounded towards the north and south-east generally by the Motueka Electoral District, hereinbefore described, from the mouth of the said Mokihinui River to the source of the Inangahua River at the summit of the Victoria Range; thence bounded towards the south generally by the summit of the said Victoria Range to Mount Haast; thence in a south-westerly direction by a right line to the nearest point on the Grey River; thence by the said Grey River to its confluence with the Arnold River; thence by that river to and along the southern and western boundaries of the Borough of Brunner (as described in the *New Zealand Gazette*, 1887, page 1392) to the Grey River; thence by that river to the ocean, the place of commencement.

4. WESTLAND.

This district is bounded towards the north-west generally by the ocean from the mouth of the Awarua River at Big Bay to the mouth of the Grey River; thence bounded towards the north generally by the Buller and Motueka Electoral Districts, hereinbefore described, from the mouth of the said Grey River to the summit of the Spenser Mountains at the summit of the southern watershed of the Maruia River; thence bounded towards the south-east generally by the summit of the said Spenser Mountains and the south-eastern boundary of the Land District of Westland to Mount Aspiring; thence bounded towards the south by a right line from the said Mount Aspiring to the mouth of the Awarua River at Big Bay, the place of commencement.

5. WAIRAU.

This district is bounded towards the north-west and north generally by the Motueka and the Nelson Electoral Districts, hereinbefore described, from Tophouse, Wairau Valley, on the summit of the Saint Arnaud Range, to the ocean at the northernmost corner of Section 4, Block IV, Gore Survey District; thence bounded towards the east generally by the ocean to the mouth of the Clarence River; thence bounded towards the south-east generally by that river to its confluence with the Acheron River; thence bounded towards the west generally by the said Acheron River to its confluence with the Guide River; thence by that river to its source at Barefell Pass; thence by a right line from the said Barefell Pass to Tophouse, the place of commencement: including Motuanaru, Long, Bluemin, Arapawa, The Brothers, and adjacent islands.

6. HURUNUI.

This district is bounded towards the north-west and north generally by the Westland, Motueka, and Wairau Electoral Districts, hereinbefore described, from the summit of the Southern Alps, at the westernmost corner of Block I, Davie Survey District, to the ocean at the mouth of the Clarence River; thence bounded towards the south-east by the ocean to the mouth of the Ashley River; thence bounded towards the south generally by the said Ashley River to a point in line with Bowik's Road, on the north-western boundary of Rural Section 23624, Block II, Mairaki Survey District; thence by that road to and along Carlton Road, to and along Dickenson's Road, to and along Bennett's Road, to and along Boundary Road, to and along the road forming the south-western boundaries of Rural Sections 32061 and 23352, to and along the western and southern boundaries of Rural Section 10312, to and along the road forming the eastern boundary of Educational Reserve 713, to the Cust River; thence by that river to and along the eastern boundary of Rural Section 4214 to the Oxford and Rangiora Railway line; thence by that railway-line to its intersection with a point in line with Boundary Road in Block VI of the said Mairaki Survey District; thence by a right line to and along the south-eastern boundary of Rural Section 23243, to and along the south-eastern boundaries of Rural Sections 19574 and 23164 and their production to the Eyre River; thence westerly by that river to the Sheffield and Oxford Railway line; thence by that railway-line to its intersection with the Waimakariri River; thence by that river to a point in line with the south-eastern boundary of Rural Section 18421, Block II, Hawkins Survey District; thence by a right line to and along the

south-eastern boundary of the said Rural Section 18421 and south-eastern boundaries of Rural Sections 18640, 26161, 19529, 19530, 14156, 14261, and 4023 to the Auchenflower and Kimberley Road; thence by a right line to the south-western corner of Rural Section 3719; thence south-westerly by a right line to the northernmost corner of Rural Section 3107; thence by the north-western boundary of that section to the Wakaapa River; thence by that river to its confluence with Boundary Creek; thence north-westerly by a right line to the southernmost end of Lake Lyndon; thence north-westerly by a right line to Red Hill; thence by the summit of the High Snowy Range to Trig. 8. CHRISTCHURCH NORTH.

along Papanui Road, to and along May's Road to its intersection with Rutland Street at the south-western boundary of Rural Section 1048, the place of commencement.

9. CHRISTCHURCH EAST.

This district is bounded towards the west and north generally by the Christchurch North Electoral District, hereinbefore described, from the intersection of Armagh and Colombo Streets to the River Avon at a point in line with the eastern side of North Avon Road; thence bounded towards the east generally by the said River Avon to a point in line with the middle of Fitzgerald Avenue; thence by that avenue to and along St. Asaph Street East, to and along Phillips Street, to and along the Ferry Road, to and along Ensor's Road to the Heathcote River; thence by that river to a point opposite the watercourse from Hill's Road, near Heathcote Street; thence to and by the said watercourse to Hill's Road; thence bounded towards the south generally by the said Hill's Road to and along St. Martin's Road, to and along Burnbrae Street, to the Heathcote River at the Tennyson Street Bridge; thence by that river to the Colombo Street Bridge; thence bounded towards the west generally by the said Colombo Street to and along Tennyson Street, to and along Longfellow Street, to and along Southampton Street, to and along Montrose Street, to and along Huxley Street, to and along the aforesaid Colombo Street to its intersection with Armagh Street, the place of commencement.

10. CHRISTCHURCH SOUTH.

This district is bounded towards the north and east generally by the Christchurch North and Christchurch East Electoral Districts, hereinbefore described, from the River Avon at the southern end of Rossall Street to the Heathcote River at the Colombo Street Bridge; thence bounded towards the south-east and south-west by the said Heathcote River to its intersection with the Lower Lincoln Road; thence bounded towards the north-west by that road to and along the north-western boundary of Rural Section 128 to its intersection with the Dunedin-Christchurch Railway line; thence easterly by the said railway-line to a point in line with West Town Belt; thence bounded towards the west by the said West Town Belt to the River Avon, and by that river to the southern end of Rossall Street, the place of commencement.

11. AVON.

This district is bounded towards the north generally by the Kaiapoi Electoral District, hereinbefore described, from the intersection of Hill's Road and Shirley Road to the ocean at a point in line with the northern boundary of Rural Section 17573; thence bounded towards the north-east by the ocean to the estuary of the Heathcote and Avon Rivers; thence bounded towards the south-west and south-east generally by the said estuary to the south-western side of the Canal Reserve; thence by the south-western side of the said Canal Reserve to and along Alwyn's Road, to and along Ferry Road to the eastern boundary of the Christchurch East Electoral District, hereinbefore described, at the junction of Ferry Road and Ensor's Road; thence bounded towards the south and west by the said Christchurch East Electoral District and Christchurch North Electoral District, hereinbefore described, to the intersection of Hill's Road and Shirley Road, the place of commencement.

12. RICCARTON.

13. LYTTLETON.

This district is bounded towards the north-east generally by the Riccarton, Christchurch South, Christchurch East, and

14. ELLESMERE.

15. ASHBURTON.

kihi River to its intersection with the eastern boundary of Block IV, Waihao Survey District; thence by the eastern and southern boundaries of the said Block IV of the said Waihao Survey District to its intersection with the Otaio River; thence by that river to the south-eastern corner of Run 47; thence by a right line due west to its intersection with the north branch of the Waihao River on the south-eastern boundary of Section 31481 of Block VII of the aforesaid Waihao Survey District; thence by the said north branch of the said Waihao River to its intersection with a right line from Mount Nimrod to Trig. This district is bounded towards the north-east generally by the Wakatipu Electoral District, hereinbefore described, from the ocean at Bligh Sound to the Okapua Creek at the road forming the south-western boundary of Section 15, Block VI, Chatton Survey District; thence bounded towards the east and south generally by the Mataura Electoral District, hereinbefore described, from the said Okapua Creek at the road forming the south-western boundary of Section 15, Block VI, Chatton Survey District, to the north-eastern corner of Forest Hill Hundred; thence by the southern and western boundaries of Block 64, Hokonui Survey District, and western boundary of Block 47, to and along the northern boundary of Section 449, Block 63, of the aforesaid Hokonui Survey District to Lora Stream; thence by that stream to the road at the north-eastern corner of Section 257, Block 55, Hokonui Survey District aforesaid; thence by the road forming the northern boundary of the said Section 257 and intersecting Section 215 to the Otapi Stream; thence by that stream to and along the northern boundary of Section 209, to and along the north-western boundary of Section 366, to and along the north-eastern and north-western boundaries of Section 431, to and along the north-eastern boundary of Section 659, to and along the road intersecting the said Section 659, Sections 709, 432, and 363, to the road forming the eastern boundary of Section 341; thence by that road and the road intersecting the said Section 341, to and along the road forming the northern boundary of Section 162, to and along Winton Stream, to and along the road forming the northern boundary of Section 180 and intersecting Section 181 to the Invercargill-Kingston Railway line; thence by the said railway-line to the northern boundary of the Township of Limehills at Alba Street; thence by that street to and along the Main North Road, to and along the northern boundaries of the Winton and Oreti Hundreds to the junction of roads at the north-eastern corner of Section 2, Mayfield Estate; thence bounded towards the east by the road forming the north-eastern boundaries of the said Section 2, Sections 4, 6, and 8 of the said Mayfield Estate, to and along the closed road intersecting Section 10 of the aforesaid Mayfield Estate, to and along the north-western and western boundaries of Section 11 of the aforesaid Mayfield Estate, to and along the road forming the western boundary of the southern portion of Section 62, Oreti Hundred, to and along the southern boundaries of Sections 51 and 61, to and along the road forming the western boundaries of Sections 44, 43, 80, 86, 89, 90, 91, and 94, to and along the road forming the northern and western boundary of Section 183, to and along the road forming the western boundary of Section 182, to and along the southern boundaries of Sections 69 and 25, all of the said Oreti Hundred, to the Waimatuku Stream; thence by that stream to the ocean; thence bounded towards the south and north-west generally by the ocean to Bligh Sound, the place of commencement: including Centre, Pig, Resolution, and adjacent islands.

29. INVERCARGILL.

This district is bounded towards the north generally by the Waihopai River from the New River Harbour to Mill Road; thence bounded towards the south-east generally by that road to and along Main East Road to the eastern boundary of the Borough of Invercargill; thence bounded towards the east generally by the said eastern boundary of the Borough of Invercargill to the south-eastern corner of the said borough; thence again towards the east by the eastern boundary of the Borough of South Invercargill; thence by the northern, eastern, southern and south-western boundaries of the said Borough of South Invercargill to New River Harbour; thence bounded towards the west by the eastern shores of the said New River Harbour to the tramway crossing the said harbour; thence bounded towards the south-east, south-west, and north-west generally by the said tramway, and the south-western and north-western boundaries of the aforesaid Borough of Invercargill, to the Waihopai River, the place of commencement.

30. AWARUA.

This district is bounded towards the west, north, and east generally by the Wallace and Mataura Electoral Districts, hereinbefore described, from the ocean at the mouth of the Waimatuku Stream to the ocean at a point due south of the road at the south-western corner of Section 8, Block II, Otago Survey District; thence bounded towards the south-west generally by the ocean to the mouth of the Waimatuku Stream, the place of commencement: exclusive of the Invercargill Electoral District, hereinbefore described; and including Stewart Island, Ruapuke Island, Dog Island, and all adjacent islands.
