New County of Otorohanga divided into Ridings, &c.

#### JELLICOE, Governor-General. [L.S.]A PROCLAMATION

TN pursuance and exercise of the powers and authorities vested in me by the Counties Act, 1920, and the Waikato and King-country Counties Act, 1921–22, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby divide the new County of Otorohanga, as constituted by the said Acts, into five ridings, to be called the Te Rauamoa Riding, the Honikiwi Riding, the Wharepapa Riding, the Mangaorongo Riding, and the Waipa Riding, and declare that the boundaries thereof shall be those set forth in the Schedule hereto.

And I do hereby declare that one member shall be elected

And I do hereby declare that one member shall be elected for the Te Rauamoa Riding, one member for the Honikiwi Riding, two members for the Wharepapa Riding, two members for the Mangaorongo Riding, and one member for the Waipa Riding. And I do further declare that Thursday, the eleventh day of May, one thousand nine hundred and twenty-two, shall be the day upon which the election of the Council of the said County of Otorohanga shall take place; and Monday, the fifteenth day of May, one thousand nine hundred and twenty-two, at half past nine o'clock in the forenoon, shall be the time, and the Town Hall, Otorohanga, shall be the place, at which the first meeting of the said Council shall be held.

## SCHEDULE.

# TE RAUAMOA RIDING.

ALL that area in the Otorohanga County bounded by a line commencing at the south-western corner of Section 2, Block XIII, Pirongia Survey District, and proceeding northerly and easterly along the county boundary to the Main Trunk Railway; thence south-westerly along that railway to the south-eastern corner of Section 6, Block XIII, Puniu Survey District, and westerly along the southern boundaries of South-eastern corner of Section 6, Block XIII, Puniu Survey District, and westerly along the southern boundaries of Section 6 aforesaid, Sections 18, 11, 12, Block XVI, Pirongia Survey District, Sections 7, 8, Turoto, C 2B, Section 3, Turoto A 2 No. 2, all in Block XV, Pirongia Survey District, to the Moakurarua Stream, up that stream and its tributary the Hakari Stream, thence along the southern boundaries of Sections 12 and 11, Block XIV, and Section 2, Block XIII, Pirongia Survey District, to the place of commencement.

# Honikiwi Riding.

All that area in the Otorohanga County bounded towards the north by Te Rauamoa Riding hereinbefore described, towards the east by the Main Trunk Railway from the southeastern corner of that riding to the north-eastern boundary of Otorohanga Town District, thence along the eastern and southern boundaries of that town district to the aforesaid railway, southerly along that railway to the county boundary, and north-westerly and north-easterly generally along that boundary to the south-western corner of Te Rauamoa Riding, the point of commencement. the point of commencement.

## WHAREPAPA RIDING.

All that area in the Otorohanga County bounded towards the west by the Main Trunk Railway from the southern boundary of Ouruwhero No. 1 to the county boundary; towards the north, east, and south by the county boundary to a point in line with the south-western boundary of Wharepuhunga No. 6 produced to the northern boundary of Maraeroa pulunga No. 6 produced to the northern boundary of Maraeroa A 3B; thence to and along that boundary, the south-western boundary of Wharepulunga No. 17 to its north-western corner, thence along a right line to the south-eastern corner of part Rangitoto A 24B, along the eastern boundary of that block; thence easterly along the southern boundary of Section 6, Block XVI, Mangaorongo Survey District, and the southern boundaries of Rangitoto A 27B, a piece of Crown land, and Rangitoto A 26B to the Mangatutu River; thence down that river to the southern boundary of Rangitoto A 5, along that boundary, the eastern boundary of Rangitoto A 23B, A 22B, A 24B, A 21A 2B, the north-eastern boundaries of Rangitoto A 15E, A 15D, A 14B 2, A 14B 1, A 14A; thence along the northern boundary of said Rangitoto A 14A to the eastern boundary of Block II, Mangaorongo Survey District; thence due north to the northern boundary of the area shown eastern boundary of Block II, Mangaorongo Survey District; thence due north to the northern boundary of the area shown on deposited plan 7228, along that boundary, the eastern boundary of Section 2. Block II, the south-eastern boundary of Lot 1 of Puketarata 6B 2B to the south-western corner of Section 12, Block XIV, Puniu Survey District; thence along a right line to the road at its intersection with the north-eastern boundary of Lot 1 aforesaid; thence along the said north-eastern and western boundaries of said Lot 1, the eastern boundary of Section 2, the southern boundaries of Sections 9 and 8, Block XIV aforesaid, and along the southern boundary of Ouruwhero No. 1 to the point of commencement. boundary of Ouruwhero No. 1 to the point of commencement.

#### MANGAORONGO RIDING,

All that area in the Otorohanga County bounded towards the north-west by the Otorohanga Town District and the Main Trunk Railway from the Waipa River to the Wharepapa Riding hereinbefore described; towards the north-east, east, and south by said Wharepapa Riding, the northernmost corner of part Rangitoto A 24B, thence along the northern boundary of said part Rangitoto A 24B and A 19, along the western boundary of Section 3 of Rangitoto A 18A 2 to and along the southern boundary of Rangitoto A 46B 2; thence along the eastern boundaries of Rangitoto A 45B 2B, A 45B 2A, Section 4, Block XI, Mangaorongo Survey District, the eastern and northern boundaries of the southern portion of Rangitoto A, northern portion 6 O B, the eastern and northern boundaries of Section 11, Block X, Mangaorongo Survey District, to the Waipa River; thence down that river to the point of commencement.

#### WAIPA RIDING.

All that area in the Otorohanga County bounded on the north-west by the Honikiwi Riding, on the north-east by the Mangaorongo and Wharepapa Ridings, and on the south and south-west by the county boundary.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand; and issued under the Seal of that Dominion, at the Government House at Wellington, this 24th day of April, 1922.

# [L.S.] JELLICOE, Governor-General. A PROCLAMATION.

HEREAS by a Proclamation dated the second day of March, one thousand nine hundred and twenty-two, and published in the New Zealand Gazette of the ninth day of March, one thousand nine hundred and twenty-two, the boundaries of the counties of Clifton and Inglewood were altered by the exclusion of a certain area from the County of Clifton and the inclusion of such area in the County of Inglewood:

And whereas it is desirable that the area so added to the County of Inglewood should be included in the East Riding of that county:

Now, therefore, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section twenty-one of the Counties Act, 1920, do hereby declare that the area included as aforesaid in the County of Inglewood shall, as on and from the first day of May, one thousand nine hundred and twenty-two, be included in the East Riding of the said county, and that the boundaries of that riding shall be those set forth in the Schedule hereto.

# EAST RIDING, INGLEWOOD COUNTY.

ALL that area in the Inglewood County bounded on the north and east by the county boundary, and on the southwest by the South and North Ridings as described in the New Zealand Gazette, 1920, page 2009.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand; and issued under the Seal of that Dominion, at the Government House at Wellington, this 24th day of April, 1922.
