WHEREAS the Boards of the Waihekau Drainage District whereas the Boards of the Wainesau Drainage District and of the Hungahunga Drainage District have each presented a petition praying that the said drainage districts may be united and form one united district, as provided by section fifteen of the Land Drainage Act, 1908:

And whereas the said Boards have agreed to the following

conditions, namely:

1. That all special rates made as security for loans existing at the date of the union of the said districts shall continue to be levied only within the area over which they were respectively originally levied:

2. The name of the united districts to be the Hungahunga Drainage District, and the number of trustees for such dis-

trict to be seven:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance of the powers vested in him by the said Land-Drainage Act, 1908, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the Waihekau Drainage District and the Hungahunga Drainage District shall, as on and from the first day of May, one thousand nine hundred and twenty-two form one united

Waitoa Survey District, to the road forming the north-eastern boundary of Ngutumanga Block at right angles to that road; boundary of Ngutumanga Block at right angles to that road; thence towards the north-east generally by the last-mentioned road and the north-eastern boundary of Ngutumanga Block to the railway-line; thence across the railway-line and a road to Section 14, Block XVI, Waitoa Survey District; thence by the north-western boundaries of Sections 14, 13, 12, and 11, Block XVI aforesaid; again towards the northeast by Ngutumanga Road to its junction with Taylor's Road; again towards the north-west by Taylor's Road to its junction with Mikkelsen's Road; thence towards the north-east generally by that road to the westernmost corner north-east generally by that road to the westernmost corner of Section 17, Block XI, Aroha Survey District; thence by a right line to the south-eastern corner of that section; a right line to the south-eastern corner of that section; thence by a public road to the western boundary of Section 3, Block I, Wairere Survey District; thence by the western boundary of Section 3, across Steel's Road, and by the western boundary of Section 7 to School Road; thence towards the south by School Road to the road forming the north-eastern boundary of Orongomairoa and Hungahunga No. 2 Blocks; thence by that road to the road intersecting Section 1, Block V, Wairere Survey District; thence again towards the north-west by this road to the Waihou River at the eastern corner of Section 12, Block II, Wairere Survey District; thence again towards the north-east by the Waihou River to a point in line with the south-eastern boundary of Section 4, Block X, Wairere Survey District; thence by a right line to the road at the northernmost corner of Section 27A, Block X aforesaid, and by the road forming the north-eastern boundary of vested in him by the said Land-Drainage Act, 1908, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the Waihekau Drainage District and the Hungahunga Drainage District shall, as on and from the first day of May, one thousand nine hundred and twenty-two, form one united district under and for the purposes of the said Act, the boundaries whereof shall be those described in the Schedule hereto; and doth also order and declare that the name of the said united district shall be the Hungahunga Drainage District, and that the number of trustees of the said district shall be seven.

WHEREAS, in accordance with the provisions of section WHEREAS, in accordance with the provisions of section three of the Land Drainage Act, 1908, a majority of the ratepayers in the area described in the First Schedule hereto, situated in the County of Waitaki, have presented a petition to His Excellency the Governor-General of the Dominion of New Zealand, praying that the land comprised in the said area, be excluded from the Otekaike Drainage District as constituted under the provisions of the said Act: And whereas it is expedient to alter the boundaries of such drainage district in manner hereinafter appearing:

Now, therefore, in pursuance and exercise of the power and authority contained in section three of the Land Drainage Act, 1908, His Excellency the Governor-General of the Dominion of New Zealaud, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby alter the boundaries of the said Otekaike Drainage District by excluding from such district the area of land described in the said petition and in the First Schedule hereto; and doth hereby declare that the boundaries of the said drainage district, with such alteration as herein provided for, shall be those described in the Second Schedule hereto.

ALL that parcel of land in the Wellington Land District, containing by admeasurement one hundred and fifty-two acres (152 acres), be the same a little more or less, being Section 86, Block VI, Hunua Survey District, and known generally as Whakapapa Island. Bounded towards the north generally by the Wanganui River, towards the east and south-east generally by the right branch of the Whakapapa River, and towards the west and north-west generally by the left branch of the Whakapapa River to its eastern confluence with the Wanganui River. Shooting Season for Imported Game and Native Game, License Fee, &c., Lakes Acclimatization District.

IN exercise of the powers vested in me by the Animals Protection and Game Act, 1921–22, I, William Downie Stewart, Minister of Internal Affairs of the Dominion of New Zealand, do hereby notify that the following imported game and native game—viz., Californian quail, grey duck, and black swan—may be taken or killed within the Lakes Acclimatization District, comprising the County of Lake, from the first day of May, one thousand nine hundred and twenty-two, to the thirty-first day of July, one thousand nine hundred and twenty-two (both days inclusive). And I do further notify that licenses to take or kill such imported game and native game within the said district will be issued to any person on payment of the sum of twenty shillings each; and the Postmasters at Queenstown, Arrowtown, Kingston, and Pembroke are hereby authorized to sign and issue the said licenses.

And I do further notify that licenses to take or kill grey

And I do further notify that licenses to take or kill grey duck and black swan within the said district will be issued to any person on payment of the sum of ten shillings each; and the Postmasters at Queenstown, Arrowtown, Kingston, and Pembroke are hereby authorized to sign and issue the said licenses.

And I do further restrict the number of such grey duck and black swan that may be taken or killed by any one person in any one day to not more than twenty-five head in all.

Nothing in any license to take or kill imported game and native game shall authorize the holder thereof to take or kill imported game and native game on lands actually and exclusively used by any registered acclimatization society for acclimatization purposes, or on any sanctuary or public domain.
