Altering Boundaries of Hauraki Plains and Piako Counties.

#### A PROCLAMATION.

WHEREAS it is provided by subsection two of section fourteen of the Counties Act, 1920, that the boundaries of any one or more counties may be altered in accordance with a resolution proposing the alteration passed by the Council of each of such counties in which the Counties Act is in force:

And whereas a resolution was passed by the Hauraki Plains County Council on the thirteenth day of November, one thousand nine hundred and twenty-two, and sealed with the seal of the Council of the said county on the same date:

And whereas a similar resolution was passed by the Piako County Council on the eighteenth day of December, one thousand nine hundred and twenty-two, and sealed with the seal of the said county on the same date, praying for the alteration of the boundaries of such counties in the manner described in the said resolutions and in the First Schedule hereto:

And whereas it is expedient to make such alteration in accordance with the said resolutions:

Now, therefore, in pursuance and exercise of the power and authority conferred on me by the said Act, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the First Schedule hereto, being now part of the Hauraki Plains County, shall, as on and from the first day of April, one thousand nine hundred and twenty-three, be deemed to be added to and form part of the Piako County; and, with the like power and authority, do proclaim and declare that the boundaries of the counties of Hauraki Plains and Piako respectively shall, as on and from the aforesaid date, be those set forth under their respective headings in the Second Schedule hereto.

#### FIRST SCHEDULE.

AREA TO BE ADDED TO PIAKO COUNTY.

ALL that area in the Auckland Land District bounded by a line commencing at the northernmost corner of Section 1, Tainui Settlement, and proceeding along the northern boundaries generally of that section and of Section 3, Block IV, Hapuakohe Survey District, to the Mangawhero Road; thence southerly along the middle of that road to the northern boundaries of said Sections 6 and Maukoro 2B 2 Block, the eastern boundary of the said Maukoro 2B 2 Block, the northwestern boundaries of Sections 3, 2, and 1, Block V, Waitoa Survey District, and part Maukoro Block to the Morrinsville-Waitakururu Main Road; thence along the middle of a public road forming the northern boundary of aforesaid part of Maukoro Block to the Piako River, and down the middle of that river to the northern boundary of Waitoa Survey District; thence easterly along that boundary to the southwestern boundary of Te Awaiti No. 13 2B 4, along the said south-western boundary of the Waitoa Survey District; thence easterly along that boundary to the aforesaid northern boundary of the Waitoa Survey District; thence easterly along that boundary to the middle of the Waihou River; thence southerly, westerly, and northerly along the boundary of the Hauraki Plains County as defined in the Hauraki Plains, Thames, Ohinemuri, and Piako Counties Act, 1919, to the point of commencement.

# SECOND SCHEDULE.

## BOUNDARIES OF HAURAKI PLAINS COUNTY.

ALL that area in the Auckland Land District bounded by a line commencing at a point in the middle of the mouth of the Waihou River; thence following up the middle of the said river in a southerly direction to a point in line with the northwestern bank of the canals in Canal Reserve, Block XII. Waihou Survey District; thence to and along the said bank

of canals produced to the middle of said Waihou River; thence again southerly along the middle of that river to the northern boundary of Waitoa Survey District; thence westerly along that boundary line to Te Awaiti 18 28 3 Block, along the south-eastern and south-western boundaries of that block and south-western boundary of Te Awaiti 13 28 4 Block to the aforesaid northern boundary of Waitoa Survey District; thence westerly along that boundary to Piako River, up the middle of that river to a public road forming the northern boundary of Part Maukoro Block, south-westerly along the middle of that road to the Morrins-ville-Waitekaruru Main Road; thence to and along the northern boundary of the said Maukoro Block, along the northern boundaries of Sections 1, 2, and 3, Block V, Waitoa Survey District, the eastern and northern boundaries of Maukoro No. 28 2 Block, the northern boundary of Section 6, Block IV, Hapuakohe Survey District, to the middle of that road to the north-western boundary of Section 3, Block IV, Hapuakohe Survey District, along that boundary and the north-eastern boundary of Section 1, Tainui Settlement, to the confiscation line; thence northerly along that line to the mouth of the Pukorokoro Creek; thence easterly along the sea-coast to the middle of the Waihou River, the place of commencement.

#### BOUNDARIES OF PIAKO COUNTY.

All that area in the Auckland Land District bounded by a line commencing at the northernmost corner of Section 1, Tainui Settlement, and proceeding thence along the southern boundary of the Hauraki Plains County hereinbefore described to the middle of the Waihou River; thence down the middle of that river to the north-western boundary of Te Aroha Borough; thence southerly, easterly, and northerly along the borough boundaries to a point due west of Trig. Station

567 (Te Aroha); thence due east to said Trig. Station 567 and along the confiscation-line to the common boundary-line between the Piako and the Tauranga Counties as set forth in the boundaries of the Piako County, New Zealand Statutes of 1876, page 189; thence along the said common boundary-line, being the western boundary of a forest reserve in Katikati and Aongatete Survey Districts; thence south-westerly along the northern boundaries of Whakamarama No. 2 and Okauia No. 1 Blocks to the Wairere Stream, down the middle of that stream and the middle of the Waihou River, to a point in line with the north-western boundary of Section 27a, Block X, Wairere Survey District; thence to and along that boundary and the north-western boundaries of Section 27 and Lot 24a, Turanga-o-Moana Block; thence northerly and westerly generally along the southern boundaries of Turanga-o-Moana, Aratiatia, Taramorahi No. 1, and Matamata North Blocks to the middle of the Waitoa River, down the middle of that river and up the middle of the Mangapapa River, to the south-eastern corner of Te Pae-o-te-Rawaru Block; thence along the southern boundary of that block and along the eastern boundaries of Kiwitahi No. 1 block to the north-western boundaries of Kiwitahi No. 1 block; thence by the northern boundaries generally of Kiwitahi Nos. 2 and 3a and Karokaro Blocks to the confiscation-line; and north-westerly along said confiscation-line to the point of commencement.
