ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 28th day of March, 1924.

THE RIGHT HONOURABLE W. F. MASSEY, P.C., PRESIDING IN COUNCIL.

WHEREAS, in pursuance of section one hundred and thirty-two of the Municipal Corporations Act, 1920, a petition was presented to the Governor-General praying that a certain area be excluded from the Borough of Rangiora, and included in the County of Rangiora:

And whereas a Commission appointed under the said

And whereas a Commission appointed under the said section held inquiries, and recommended certain alterations of the said area:

And whereas it is deemed expedient to make the alterations of the boundaries of the said borough recommended by the said Commission:

Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the said Municipal Corporations Act, 1920, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that as on and from the first day of April, one thousand nine hundred and twenty-four, the area described in the Schedule hereto shall be excluded from the Borough of Rangiora and included in the County of Rangiora.

SCHEDULE.

AREA EXCLUDED FROM THE BOROUGH OF RANGIOBA.

ALL that area of land in the Canterbury Land District, commencing at a point on the western side of the Rangiora West Town Belt in line with the southern side of the borough drain intersecting Section 473, Block VI, Rangiora Survey District; thence easterly, southerly, and again easterly along the southern side of the said borough drain to White Street; thence southerly along the western side of White Street to John Street; thence westerly along the northern side of John Street to a point in line with the eastern side of Green

Street; thence across John Street and along the eastern side of Green Street to Boys Road; across Boys Road; and westerly along the southern side of the said Boys Road to the West Town Belt; across the West Town Belt, and northerly along its western side to Southbrook Road; thence westerly along the south side of the said Southbrook Road to a point in line with the western side of the West Town Belt; thence northerly along that said western side to the point of commencement. Also all that area of land commencing at a point on the Christchurch-Rangiora Railway at its intersection by Northbrook Road, thence easterly along the southern side of Northbrook Road to its intersection with the East Town Belt; across the East Town Belt to its eastern side; and southerly along that side to the stream forming part of the northern boundary of Section 349, Blocks VI, VII, X, and XI, Rangiora Survey District; thence easterly along that stream to the eastern boundary of the said Section 349; thence southerly along that eastern boundary to Boys Road; across that road, and westerly along its southern side to the eastern boundary of the Christchurch-Rangiora Railway; thence northerly along that railway to the point of commencement.

Making Provision for Dissolution of Mangapapa Town Board, and Merger of Remainder of Town District.

WHEREAS by Order in Council made under the Municipal Corporations Act, 1920 (hereinafter referred to as "the said Act"), dated the seventeenth day of March, one thousand nine hundred and twenty-four, and gazetted on the twentieth day of the same month, it was declared that the area described in the Schedule hereto (hereinafter referred to

as "the said area"), shall as on and from the first day of | April, one thousand nine hundred and twenty-four, be excluded from the Mangapapa Town District (hereinafter referred to as "the said town district"), and included in the Borough of Gisborne:

And whereas it is expedient to make provision for the dissolution of the Corporation of the said town district and for the merger of the remaining area thereof in the County of Cook, and to declare to what riding of that county such remaining area shall be added:

Now, therefore, in pursuance and exercise of the powers and authorities vested in him by section one hundred and thirty-two of the said Act, and of all other powers and authorities enabling him in that behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that as on and from the second Dominion, doth hereby declare that as on and from the second day of April, one thousand nine hundred and twenty-four, the Mangapapa Town Board, being the Corporation of the said town district, shall be dissolved, and shall thereafter cease to exist; and, with the like advice and consent, doth hereby further declare that as on and from the aforesaid date the area described in the Schedule hereto, being the area remaining in the said town district after the said area herein perform mentioned has been excluded thereform shall be inbefore mentioned has been excluded therefrom, shall be included in and form part of the County of Cook; and, with the like advice and consent, doth hereby further declare that as on and from the aforesaid date the area included as afore-said in the County of Cook shall be added to and form part of the Whataupoko Riding of that county.

SCHEDULE.

AREA INCLUDED IN COUNTY OF COOK AND IN WHATAUPOKO RIDING.

ALL that area in the Gisborne Land District bounded by a ALL that area in the Gisborne Land District bounded by a line commencing at a point being the westernmost corner of Subdivision 4, Whataupoko No. 3; thence in a north-easterly direction by that boundary to and across Te Hapara Road to the south-east corner of Subdivision 35, Whataupoko No. 3, continuing in a north-easterly direction by the south-eastern boundary of the aforesaid Subdivision 35, to and

across to the centre of Ormond Road; thence in a north-westerly direction by the centre of the aforesaid Ormond Road to a point in line with the eastern boundary of Whatau-poko No. 5; thence in a north-easterly direction to and across Ormond Road and by the south-eastern boundary of the aforesaid No. 5 to the centre of Howorth Street; thence in a south eastern boundary of the street in a south eastern boundary of the street in a south eastern boundary of the street in a south eastern boundary. of the atoresaid No. 5 to the centre of Howorth Street; thence in a south-easterly direction by the centre of Howorth Street to the centre of Valley Road; thence in a south-westerly direction by the centre of the aforesaid Valley Road to a point in line with the south-west boundary of Sub-division 43, Whataupoko No. 3; thence in a south-easterly direction across the aforesaid Valley Road and by the west boundary of the aforesaid Subdivision 43 till it intersects the western boundary-line of the Cook Hospital site; thence in a north-easterly and south-easterly direction generally the western boundary-line of the Cook Hospital site; thence in a north-easterly and south-easterly direction generally by the boundaries of the aforesaid Cook Hospital site to the south-western boundary of Subdivision 46, Whataupoko No. 7; thence in a south-easterly direction generally by the south-western boundary by the aforesaid Subdivision 46, and by the south-western boundary of Lot 38, Whataupoko No. 4, to and across Mangapapa Road, and by the south-western boundary of Lot 45, Whataupoko No. 4, to the south-eastern boundary of said Whataupoko No. 4; thence north-easterly along that boundary, along the north-eastern boundary of said Whataupoko No. 3 to the north-eastern boundary of Whataupoko No. 3 to the north-enstern boundary of Whataupoko No. 5 to the Matokitoki Road; and north-westerly along the north-eastern side of that road to its intersection with a right line bearing 37° 58′ drawn from the intersection of the western north-eastern side of that road to its intersection with a right line bearing 37° 58′ drawn from the intersection of the western side of Lytton Road with the southern side of Ormond Road; thence south-westerly along said right line and western side of Lytton Road to northern boundary of Allotment 33, Halstead, along the said northern boundary of Allotment 33, the abutment of a closed road, and the northern boundary of Allotment 32°, thence southerly along the eastern boundary Allotment 32; thence southerly along the eastern boundary of Allotment 31, Halstead, across Te Hapara Road, and along the eastern boundary of Allotment 10, Hapara, to the Taruheru River; thence south-easterly along the left bank of that river to the point of commencement.
