Declaring Portions of Main Highways in the Highway Districts hereunder enumerated to be Government Roads.

JELLICOE, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 29th day of October, 1924.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers vested in him by the Public Works Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the portions of the main highways described in the Schedule hereto shall, on and after the date of the gazetting of this Order in Council, become Government roads.

SCHEDULE.

HIGHWAY DISTRICT No. 3.

1. Cambridge-Rotorua: All that portion of the Cambridge-Rotorua Main Highway, commencing at the Ngongotaha Stream and proceeding thence generally in a west-north-westerly direction via Tarukenga Station, and terminating at the western boundary of the Rotorua County, passing through the Rotorua County, being a distance of nine miles, more or less. As the same is more particularly delineated on the plan marked M.H. 30, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured blue and marked H-N.

HIGHWAY DISTRICT No. 4.

2. Gisborne-Opotiki (via the Coast): All that portion of the Gisborne-Opotiki (via the Coast) Main Highway, commencing at the left bank end of the Pakarae River Bridge and proceeding thence generally in a north-easterly direction,

and terminating at the Makatoto Stream, passing through the County of Uawa, being a distance of four miles and a half, more or less. As the same is more particularly delineated on the plan marked M.H. 22, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured blue and marked L-D.

3. Also all that portion of the said main highway commencing at the Rotokautuku Bridge – Tikitiki Main Highway (via right bank Waiapu River) at Section 2, Waitangi B, Block III, Mata Survey District, and proceeding thence generally in a northerly direction, crossing the Waiapu River; thence generally in a north-easterly direction via Rotokautuku Blocks I and V; thence crossing the Mangaoporo River; thence generally following the left bank of the Waiapu River; and terminating at its junction with the Rotokautuku—Tikitiki Main Highway (via right bank Waiapu River) at Tikitiki, passing through the County of Waiapu, being- at distance of thirteen miles, more or less. As the same is more particularly delineated on the plan marked M.H. 22, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured blue and marked K-M.

HIGHWAY DISTRICT No. 5.

4. Woodville – Palmerston North: All that portion of the Woodville – Palmerston North Main Highway, commencing at its junction with Cemetery Road on the west side of the Borough of Woodville and proceeding thence generally in a westerly direction and terminating at the eastern end of the Upper Manawatu Gorge Bridge, passing through the County of Woodville, being a distance of 1 mile 10 chains, more or less. As the same is more particularly delineated on the plan marked M.H. 35, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured blue and marked F–E.

HIGHWAY DISTRICT No. 6.

5. Kawhia to Auckland-Wellington Main Highway via Kawa: All that portion of the Kawhia to Auckland-Wel-

lington Main Highway via Kawa, commencing at the eastern end of the Puti River Bridge, and proceeding thence generally in an easterly direction, and terminating at the eastern end of the Oparau River Bridge, passing through the County of Kawhia, being a distance of three miles and a half, more or less. As the same is more particularly delineated on the plan marked M.H. 55, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured blue and marked I.—D.

6. Wellington-Napier via Wairarapa: All that portion of the Wellington-Napier Main Highway via Wairarapa, commencing at the northern end of the Ruamahunga River Bridge and proceeding thence generally in a northerly direction through Section 7, Block IV, Mikimiki Survey District; thence following existing Mount Bruce Main Highway via Kaipararo to Section 63, Block IX, Mangaone Survey District; thence through Sections 63, 44, 43, 42, R. 35, and Section 2, all in Block IX, Mangaone Survey District; and terminating at its junction with the Eketahuna-Hastwell Road, passing through the Counties of Mauriceville and Eketahuna, being a distance of nine miles and a half, more or less. As the same is more particularly delineated on the plan marked M.H. 25, deposited in the office of the Minister of Public Works at Welliugton, in the Wellington Land District, and thereon coloured blue and marked G.H.

Altering the Description of a Main Highway in the No. 7 Highway District.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

N pursuance and exercise of the powers and authorities IN pursuance and exercise of the powers and authorities vested in him by section three, subsection three, of the Main Highways Act, 1922, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth, from the date of this Order in Council, hereby alter the Order in Council dated the ninth day of June, one thousand nine hundred and twenty-four, published in the New Zealand Gazette No. 40, of the twelfth day of June, one thousand nine hundred and twenty-four, declaring public highways in the No. 7 Highway District to be main highways, by deleting the description therein of the Auckland-Wellington via Taranaki Main Highway, and substituting the following description in lieu thereof.

SCHEDULE.

AUGKLAND-Wellington Road via Taranaki: All that portion of the road known as the Auckland-Wellington Road via Taranaki, commencing at the northern boundary of the County of Clifton and proceeding thence generally in a southwesterly and southerly direction via Tongaporutu, Okau Junction, Uruti, Urenui, Waitara, Lepperton Junction, Inglewood, Stratford, Eltham, Normanby, Hawera, and terminating at the southern boundary of the Hawera County at Manawapou River, passing through the Counties of Clifton, Taranaki, Inglewood, Stratford, Eltham, and Hawera; but excluding those portions of the road in the Boroughs of Waitara, Inglewood, Stratford, Eltham, and Hawera, and also excluding that portion of the road in the County of Clifton commencing at its junction with the Mangatuna Road and proceeding thence generally in a westerly direction via Uruti, Urenui, and Waihi, and terminating at the eastern boundary of the Borough of Waitara, being a distance of 25 miles 20 chains, more or less; and also excluding that portion of the road within the County of Stratford commencing at the northern boundary of the County of Stratford and proceeding thence generally in a southerly direction via Midhirst, and terminating at the southern boundary of the County of Stratford, being a distance of 9 miles 20 chains, more or less; being therefore a net distance of 54 miles 40 chains, more or less. As the same is more particularly delineated on the plan marked M.H. 28, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.
