THEREAS, in accordance with the provisions of section WHEREAS, in accordance with the provisions of section three of the Land Drainage Act, 1908, a majority of the ratepayers in the area described in the First Schedule hereto, situated in the County of Waikato, have presented a petition to His Excellency the Governor-General of the Dominion of New Zealand, praying that the land comprised in the said area be included in the Kirikiriroa Drainage District as constituted under the provisions of the said Act: And whereas it is expedient to alter the boundaries of such drainage district in manner hereinafter appearing:

Now, therefore, in pursuance and exercise of the power and authority contained in section three of the Land Drainage-Act, 1908, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby alter the boundaries of the said Kirikiriroa Drainage District by including in such district the area of land described in the said petition and in the First Schedule hereto;

and doth hereby declare that the boundaries of the said drainage district, with such alteration as herein provided for, shall be those described in the Second Schedule hereto.

ALL that area in the Auckland Land District bounded by a line commencing at a point in the middle of the Waikato River in line with the eastern boundary of Lot 5 of Allotment 133, Parish of Komakorau; thence northerly along that boundary to a public road; thence easterly along that road to its intersection with the road forming the western boundary Allotment 81, Komakorau Parish; thence northerly along that road to the northernmost corner of the said Allotment 81; thence south-easterly along the north-eastern boundary of the said Allotment 81 to a public road; thence north-easterly along that road to the northernmost corner of Allotment 67, Komakorau Parish; thence south-easterly generally along the road forming the north-eastern boundary of the aforesaid Allotment 67 to the south-eastern boundary of the southern boundary of the said Allotment 5a; thence westerly generally along the road forming the southern boundary of the said Allotment 5a to the Waikato River; thence by a right line to the middle of the Waikato River, and by that river to the point of commencement.
