THE North Island Representation Commission appointed THE North Island Representation Commission appointed under the Legislature Act, 1908, in pursuance of section 21 of the said Act, hereby publish for general information the following proposed boundaries of the electoral districts in the North Island; and, further, give notice that written objections to the same will be received by the undersigned, the Chairman of the said Commission, at the office of the Surveyor-General, Wellington, not later than noon on Monday, the 27th day of June, 1927, for consideration by the aforesaid Commission.

# NORTH ISLAND ELECTORAL DISTRICTS.

BAY OF ISLANDS.

BAY OF ISLANDS District comprises the existing Bay of Islands Electoral District less that portion of the Tutamoe Riding of the Hobson County lying to the north of the existing Bay of Islands Electoral District boundary, and to the south of the northern boundary of Hobson County.

# KAIPARA.

Kaipara District comprises the existing Kaipara Electoral District less that portion of the Birkenhead Riding of Waitemata County lying to the south of the road extending from Lucas's Creek at the south-western corner of Section 150, Block VII, Waitemata Survey District, to the eastern boundary

of the said Birkenhead Riding at the northernmost corner of Section 117, Block VIII, Waitemata Survey District, and less that portion of the Takapuna Riding of the aforesaid Waitemata County lying to the south of the road extending from the western boundary of the said Takapuna Riding at the northern boundary of Section 172, Block IV, of the aforesaid Waitemata Survey District to the ocean at the creek south of Taiaotea. This district now includes that portion of the Tutamoe Riding of Hobson County lying to the north of the existing Bay of Islands Electoral District boundary and the northern boundary of Hobson County.

Marsden District comprises the existing Marsden Electoral District, the boundaries of which are unaltered.

# WAITEMATA.

Waitemata District comprises the existing Waitemata Electoral District less the whole of the Borough of Birkenhead. This district now includes those portions of the Birkenhead and Takapuna Ridings of Waitemata County excluded from the Kaipara Electoral District hereinbefore described.

Eden District comprises the Borough of Birkenhead, the Borough of Avondale, and that portion of Auckland City and the Borough of Mount Albert comprising the Avondale Mental Hospital Endowment, together with the Town Districts of Henderson, Glen Eden, and New Lynn. This district also includes the Waitakerei, Waipareira, Waikomiti, and Titerangi Ridings of Waitemata County.

# AUCKLAND WEST.

Auckland West District comprises the existing Auckland West Electoral District together with that portion of Auckland City lying between the existing electoral-district boundary and the southern side of Napier Street, the western side of Hepburn Street, and the north-western side of Franklin Road.

#### AUCKLAND CENTRAL.

Auckland Central District comprises the existing Auckland Central Electoral District less that portion of Auckland City now included in the Auckland West Electoral District hereinbefore described. This district now includes that portion of Auckland City lying between the existing electoral-district boundary and the southern side of Karangahape Road, the western side of Symonds Street, and north-western side of Shaddock Street and Mount Eden Railway-station.

#### AUCKLAND EAST.

Auckland East District comprises the existing Auckland East Electoral District less that portion of Auckland City now included in the Auckland Central Electoral District hereinbefore described. This district now includes that portion of Auckland City lying between the existing electoral-district boundary, the southern side of Judge's Bay, and northwestern side of St. Stephen's Avenue, and western side of Manukau Road to the northern boundary of Newmarket Borough, together with that portion of the said city lying between the existing electoral-district boundary and western side of Manukau Road from the southern side of Newmarket Borough to Owen's Road.

#### GREY LYNN.

Grey Lynn District comprises the existing Grey Lynn Electoral District less that portion of Auckland City and the Borough of Mount Eden lying to the south-east of the New North Road and the existing electoral-district boundary. This district now includes that portion of Auckland City lying to the north-west of the north-western boundary of Mount Albert Borough less the Avondale Mental Hospital Endowment now included in the Eden Electoral District hereinbefore described.

# AUCKLAND SOUTH.

Auckland South District is bounded on the north by the Grey Lynn, Auckland Central, and Auckland East Electoral Districts hereinbefore described from the junction of Western Springs Road with New North Road to the junction of Owens Road with Manukau Road: bounded on the east by Manukau Road from the junction of Owens Road to junction with Arcadia Road: bounded on the south by the said Arcadia Road, Merivale Avenue, Balmoral and St. Luke's Roads: bounded on the west by the said St. Luke's Road, Gordon Road, Bournmouth Road, Arawa Avenue, Leslie Avenue, and Argyle Road to the New North Road; thence by that road to its junction with Western Springs Road, the place of commencement.

# Roskill.

Roskill District is bounded on the north by the Eden and Grey Lynn Electoral District hereinbefore described from the eastern boundary of Avondale Borough at the south-western corner of the Avondale Mental Hospital Endowment to the junction of Western Springs Road with New North Road; thence bounded on the east and north by the Auckland South Electoral District hereinbefore described from the said junction of the Western Springs Road with the New North Road to the junction of Arcadia Road with Manukau Road; thence bounded on the east by the Manukau and Auckland-Onehunga Roads to the south-eastern corner of Allotment 35 of original Section 10, Suburbs of Auckland; thence by the southern boundary of the said Allotment 35 to and along the road forming the eastern boundaries of Allotments 57 and 58 of the aforesaid Section 10 to Selwyn Road; thence by that road to St. Andrew's Road; thence by that road to the Mount Albert Road; thence by that road to the western boundary of Onehunga Borough; thence by that boundary to the Manukau Harbour; thence bounded towards the south by the said harbour to the Eden Electoral District boundary at the south-eastern corner of Avondale Borough; thence bounded towards the west by the Eden Electoral District hereinbefore described from Manukau Harbour to the south-western corner of the Avondale Mental Hospital Endowment, the place of commencement.

# PARNELL.

Parnell District comprises the existing Parnell Electoral District less those portions of Auckland City now included in the Auckland East Electoral District hereinbefore described. This district now includes that portion of Eden County lying to the north-west of College Road, St. Helier's Bay Road, Massey Road, Sylvia Street, Line Street, and the Parade from the easternmost corner of Ellerslie Town District to St. Helier's Bay, together with that portion of Auckland City lying to the east of the existing electoral-district boundary and north of the northern boundary of the said Ellerslie Town District.

#### MANUKAU.

This district is bounded on the north and north-west by the Roskill and Parnell Electoral Districts hereinbefore described from the junction of Selwyn Road with St. Andrew's Road to St. Helier's Bay: thence bounded on the east by the Tamaki River to Otahuhu Creek; thence bounded on the south by the said creek, the northern boundary of Otahuhu Borough, and Manukau Harbour to the south-western corner of Onehunga Borough; thence bounded towards the west by the Roskill Electoral District hereinbefore described from the south-western corner of Onehunga Borough to the junction of Selwyn Road with St. Andrew's Road, the place of commencement.

#### FRANKLIN.

This district comprises the Pukekohe Borough, the Town Districts of Manurewa, Papakura, Tuakau, and Waiuku, together with that portion of the Franklin County lying to the north of the Waikato River and west of the Mercer Riding of the said Franklin County, and west of that portion of the Drury Riding boundary extending from the south-eastern corner of Papakura Town District to the existing Franklin Electoral District boundary; also that portion of the said Drury Riding lying to the west of the said existing Franklin Electoral District boundary. This district also includes that portion of the Papakura Riding of Manukau County lying to the south-west of the Manurewa Town District and north-west of the Waimahia Stream; also that portion of the said riding lying to the south of the Papakura Stream, and bounded on the north-east by the road forming the north-eastern boundaries of Sections 22, 28, 35, and 42, Block XV, Otahuhu Survey District, and on the south by the northern boundary of the Papakura Town District.

#### MERCER.

This district comprises the Borough of Otahuhu, the Papatoetoe, Howick, and Mercer Town Districts, together with those portions of the Manukau and Franklin Counties not included in the Franklin Electoral District hereinbefore described. This district also includes the whole of the Whangamarino Riding of Waikato County; also the whole of the Waitakaruru and Patetonga Ridings of Hauraki Plains County, together with that portion of the Ngatea Riding of the said Hauraki Plains County lying to the south-west of the northern and eastern boundaries of Block VIII, Piako Survey District, and the northern boundaries of Blocks IX and X of Waihou Survey District.

# THAMES.

Thames District comprises the Boroughs of Thames, Waihi, and Paeroa, and the Town District of Turua, together with the whole of the Coromandel and Thames Counties, the Waimanawa, Waitekauri, and Paeroa Ridings of Ohinemuri County; also that portion of Hauraki Plains County not included in the Mercer Electoral District hereinbefore described. This district also includes Cuvier, Great Mercury, Whanganui, Slipper, and adjacent islands.

# RAGLAN.

Raglan District is bounded on the north by the Waikato River from the ocean to the Mercer Town District; thence on the east by the existing Raglan and Hamilton Electoral District boundaries to the Waikato River at its confluence with the Mystery Stream; thence by the said Waikato River to and along the eastern boundary of Waipa County, to and along the south-eastern boundary of Pukekura Riding, to and along the south-eastern and south-western boundaries of Rangiaohia Riding of said Waipa County, to and along the north-eastern and north-western boundaries of Te Awamutu Borough, to and along the south-eastern and south-western boundaries of Mangapiko Riding of the aforesaid Waipa County to the western boundary of the aforementioned Waipa County; thence by that boundary and the southern boundary of Raglan County to the ocean at Aotea Harbour, and thence by the ocean to the Waikato River, the place of commencement.

# HAMILTON.

Hamilton District comprises the existing Hamilton Electoral District less that portion of the Ruakura Riding of Waikato County lying to the south-east of the existing electoral-district boundary, and north-east of the road forming the south-western boundary of Lots 11 and 13 of L.T. Plan No. 7346; also less that portion of the said Ruakura Riding lying between the said road and the Hamilton-Morrinsville and Hamilton-Cambridge Railways; also less the whole of the Tamahere Riding of the said Waikato County, together with that portion of the Cambridge Riding of the aforesaid Waikato County lying to the west of the said existing electoral district boundary.

#### WAIKATO.

Waikato District comprises the Cambridge and Morrinsville Waikato District comprises the Cambridge and Morrinsville Boroughs and that portion of the Waikato County not included in the Mercer, Raglan, and Hamilton Electoral Districts hereinbefore described, together with the Karapiro, Maungatautare, Tirau, and Peria Ridings of Matamata County; also includes the whole of the Tahuna, Waitoa, Morrinsville, and Kiwitahi Ridings of Piako County; that portion of the Walton Riding of the said Piako County lying to the south-west of the Weihou Piding of the aforessid Piako also the whole of the Waihou Riding of the aforesaid Piako County, less that portion lying to the south-east of the existing Ohinemuri Electoral District boundary.

#### TAURANGA.

Tauranga District comprises the Boroughs of Te Aroha and Tauranga, the whole of Tauranga County, and the whole of the Mangaiti, Karangahake, Waikino, and Waihi Ridings of Ohinemuri County; the whole of the Matamata Riding of Matamata County less that portion lying to the southwest of the road from Matamata Town District to the Waihou River, and forming the north-east boundary of Section 84, Block III, and Sections 9 and 10, Block VII, of the Tapapa Survey District. This district also includes that portion of the Piako County not included in the Waikato Electoral District hereinbefore described, together with the Motiti, White, and adjacent Islands.

# ROTORUA.

ROTORUA.

Rotorua District comprises the existing Rotorua Electoral District less that portion of Maketu Riding of Tauranga County lying to the east of the existing Tauranga Electoral District boundary; also less Whakatane Borough and that portion of the Taneatua Riding of Whakatane County lying to the east of the Whakatane River and north of the western and southern boundaries of Section 4 and southern boundary of Section 352, Block IX, Whakatane Survey District; less also Whale Island. This district includes the Matamata Town District and that portion of the Matamata Riding of Matamata County lying to the south-west of the road from the Matamata Town District to the Waihou River excluded from the Tauranga Electoral District hereinbefore described; together with that portion of Taringamotu Riding described; together with that portion of Taringamotu Riding described; together with that portion of Taumarunui County lying to the south-east of the Kuratau River and north of the 39th parallel; and that portion of Taupo County lying to the north of the 39th parallel and between the eastern shore of Lake Taupo and the existing Rotorua and Waimarino Electoral District boundaries.

# BAY OF PLENTY.

Bay of Plenty District comprises the existing Bay of Plenty Electoral District together with Whakatane Borough and that portion of the Taneatua Riding of Whakatane County now excluded from the Rotorua Electoral District hereinbefore described. This district also includes Whale

# GISBORNE.

Gisborne District comprises the existing Gisborne Electoral District, the boundaries of which remain unaltered.

Napier District comprises the existing Napier Electoral District, the boundaries of which remain unaltered.

# HAWKE'S BAY.

Hawke's Bay District comprises the existing Hawke's Bay Electoral District less that portion of Clive Riding of Hawke's Bay County lying between the southern boundary of the existing Napier Electoral District boundary and the southern boundary of the existing Hawke's Bay Electoral District.

# WAIPAWA.

Waipawa District comprises the existing Waipawa Electoral District together with that portion of Clive Riding of Hawke's Bay County now excluded from the Hawke's Bay Electoral District hereinbefore described; less the whole of the Ormondville Riding of Dannevirke County and the Ormondville Town

# Pahiatua.

Pahiatua District comprises the existing Pahiatua Electoral District together with the whole of the Ormondville Riding of Dannevirke County and the Ormondville Town District now excluded from the Waipawa Electoral District hereinbefore described.

Masterton District comprises the existing Masterton Electoral District together with the whole of the Mataikona

Riding of Akitio County and that portion of the Pongaroa Riding of the said Akitio County lying to the south-east of the road forming the existing Masterton Electoral District boundary; also that portion of the Alfredton Riding of Eketahuna County lying to the south of the road forning the said existing Masterton Electoral District boundary; also that portion of the East Riding of Mauriceville County lying to the south-east of the road forming the aforesaid existing Masterton Electoral District boundary; also includes that portion of the Upper Taueru Riding of Masterton County lying to the north of the Bideford Road; portions of the Te Whaiti and Rangitumau Ridings of the said Masterton County lying to the east of the before-mentioned Masterton Riding of Akitio County and that portion of the Pongaroa County lying to the east of the before-mentioned Masterton Electoral District boundary includes also that portion of the Opaki Riding of the aforesaid Masterton County lying to the south-west of the aforesaid existing Masterton Electoral District boundary.

#### WATRARAPA.

Wairarapa District comprises the existing Wairarapa Electoral District less those portions of the Akitio, Eketahuna, Mauriceville, and Masterton Counties now included in the Masterton Electoral District hereinbefore described. This Masterton Electoral District hereinbefore described. This district includes the whole of the Upper Hutt Borough together with that portion of the Mungaroa Riding of Hutt County including the forest reserve and lying to the south of Sections 6 and 2, Block III, and south-east of Section 408, Block II, Akatarawa Survey District, and lying to the east of the Akatarawa-Waikanae Road from the southernmost corner of the said Section 408 to the north-eastern boundary of Upper Hutt Borough; also that portion of the said Mungaroa Riding lying between the Wellington-Woodville Railway and the existing Otaki Electoral District boundary; also that portion of the Heretaunga Riding of the said Hutt County lying to the east of the eastern boundary of the Upper Hutt Borough and north of the said existing Otaki Electoral District boundary.

#### HUTT DISTRICT.

Hutt District comprises the whole of the Lower Hutt, Petone, and Eastbourne Boroughs; together with that portion of the Wainuiomata Riding of Hutt County lying between Port Nicholson and the eastern boundary of Section 21, northern and eastern boundaries of Sections 23 and 25, and eastern boundaries of Sections 27, 29, 30, 32, and 34, Block XVI, Belmont Survey District, together with that Petone and Lower Hutt Boroughs and known as Gear Island. This district also includes Soames Island.

# Wellington East.

Wellington East District comprises that portion of Wellington City bounded towards the north by the shores of Lambton Harbour and Evans Bay from the junction of the eastern side of the Town Belt with Oriental Parade by Lindum Terrace to Point Halswell; bounded towards the east by the shores of Port Nicholson from the said Point Halswell to Point Dorset; thence bounded towards the south by the sea from the said Point Dorset to a point in line with the north-eastern boundary of Lot 1 on D.P. No. 785, at Haughton Bay: thence by a right line to and along the line with the north-eastern boundary of Lot 1 on D.P. No. 785, at Haughton Bay; thence by a right line to and along the north-eastern boundary of the said Lot 1 to Buckley Road; thence by that road to Highgate Road; thence by that road to Melrose Road; thence by that road to the Town Belt; thence by the southern and eastern boundaries of the said Town Belt to Manchester Street; thence by that street to and along the eastern boundary of the aforesaid Town Belt to and along Crawford Road, to and along the eastern to and along Crawford Road, to and along the eastern boundary of the aforementioned Town Belt to Oriental Bay Lindum Terrace, the place of commencement; including all wharves and extensions seaward.

# Wellington Central.

Wellington Central District comprises that portion of Wellington City bounded towards the north by the shores of Lambton Harbour from the junction of Taranaki Street with the Taranaki Street Wharf to the junction of the eastern boundary of the Town Belt with Oriental Bay by Lindum Terrace; thence bounded towards the east by the Wellington East Electoral District hereinbefore described to a point in line with the centre of Mein Street; thence by a right line to and along the said Mein Street, to and along Coromandel Street to its junction with the south-eastern corner of Government House grounds, and thence by the southern boundary of the said Government House grounds to Hospital Road, and by that road to Adelaide Road, and by that road to and along John Street, to and along Tasman Street to a point in line with the centre of Finlay Terrace; thence by a right line to and along the said Finlay Terrace, to and along Wallace Street, to and along Rolleston Street, to and along the south-western and north-western boundary of Section 685, to and along Bell Road to its junction with the Town Belt at Heaton Terrace; thence by the western boundary of the said Town Belt and its production to Brooklyn Road, and by that road to a point in line with the south extern boundary of Section 1985. to a point in line with the south-eastern boundary of Secto a point in line with the south-eastern boundary of Section 55; thence by a right line to and along the said south-eastern boundary of the said Section 55 to Nairn Street, and by that street to and along Willis Street to the northernmost corner of Section 117, and by the north-eastern boundary of the said Section 117 to and along Binham Street, to and along Vivian Street, to and along Taranaki Street to its junction with Taranaki Street Wharf, the place of commencement; including all wharves and extensions seaward.

#### WELLINGTON SOUTH.

Wellington South District comprises that portion of Wellington City bounded towards the north by the Wellington Central Electoral District hereinbefore described from the Town Belt at the junction of Bell Road with Heaton Terrace to the eastern boundary of the said Town Belt at a point in line with the centre of Mein Street; thence bounded towards the east by the Wellington East Electoral District hereinbefore described to the ocean at Haughton Bay; thence bounded towards the south by the ocean to the south-western corner of Section 27, Block XIII, Port Nicholson Survey District; thence bounded towards the west by the western and northern boundaries of the said Section 27 to Ohiro Road; thence by that road to the north-western corner of Lot 3 (part of original Section 23); thence by a right line to the north-western corner of Section 592; thence by the western boundary of the Town Belt to the junction of Bell Road with Heaton Terrace, the place of commencement.

#### WELLINGTON NORTH.

Wellington North District comprises that portion of the Wellington North District comprises that portion of the Wellington City bounded on the north by the northern boundary of the Wellington Town Belt from the southern end of Weld Street, Wadestown, to and along the Pakuao Stream, crossing Grosvenor Road and High Street, to and along the north-western and north-eastern boundaries of Section 660, to and across the Main Hutt Road, and by the Thorndon Esplanade and its production to Port Nicholson at the outer-breastwork of the reclamation now in course of construction; thence bounded towards the east by the said Port Nicholson and Lambton Harbour to the junction of Taranaki Street with the Taranaki Street Wharf; thence bounded towards the south-east by the Wellington Central Electoral District hereinbefore described to the production of the western boundary of the said Town Belt with Brooklyn Road; thence bounded towards the west generally by the said Brooklyn Road to and along Ohiro Road, to and along the northern boundary of Tanera Crescent, to and along the northern boundaries of Lots 16 and 37, to and along the eastern boundary of Lot 22, to and along Mortimer Terrace, to and Section 660, to and across the Main Hutt Road, and by the northern boundaries of Lots 16 and 37, to and along the eastern boundary of Lot 22, to and along Mortimer Terrace, to and along Epuni Street, to and along Aro Street, to and along Devon Street, to and along the southern boundary of Lot 1, to and along the western boundary of Section, part 15 B (part of Gaol Reserve) to the southern boundary of the said Town Belt; thence by the southern and south-eastern boundaries of the aforesaid Town Belt, to and along McKenzie Terrace, to and across Mount Street, to and along the south-eastern boundary of the before-mentioned Town Belt, to and along the north-western boundary of Section 456, to and along the north-western boundary of Section 456, to and along Everton Terrace, to and along Talavera Terrace, to and along Wesley Road, to and along the northern boundary of the Botanical Gardens, to and along Tinakori Road, to and along the north-eastern boundary of Section 11, Orangi Kaulock, to and along the north-western boundary of Lot 1, part Section 12, of the said block to the Town Belt; thence by the western boundary of the said Town Belt to the southern end of Weld Street, Wadestown, the place of commencement; including all wharves and extensions sea-

# WELLINGTON SUBURBS.

Wellington Suburbs District comprises that portion of the City of Wellington bounded towards the east by the Wellington North, Wellington Central, and Wellington South Electoral Districts hereinbefore described from the outer breastwork of Districts hereinbefore described from the outer breastwork of the reclamation now in course of formation to the southwestern corner of Section 27, Block XVI, Port Nicholson Survey District; thence bounded towards the west generally by the western boundary of the said City of Wellington to the easternmost corner of Section 10 at a point in line with the north-eastern boundary of Karamu Street, Ngaio; thence by the north-eastern boundary of Lot 27 (part Section 7) to and along Chelmsford Street, to and along the Main Trunk railway-line, to and along Nicholson Road, to and along Jubilee Road, to and along the

south-eastern boundary of Lot 20, part Section 5, Block XI, Belmont Survey District, to and along Rangiora Avenue, to and across the Main Hutt Road to Port Nicholson, and thence by the said Port Nicholson to the said outer breastwork in line with the production of Thorndon Esplanade aforementioned, the place of commencement.

#### OTAKI.

Otaki District comprises that portion of Wellington City lying to the north of the proposed northern boundary of the Wellington Suburbs Electoral District hereinbefore described; also includes the Borough of Otaki; the Johnsonville Town District, the whole of the Makara County, the whole of the Hutt County less those portions now included in the proposed Wairarapa and Hutt Electoral Districts hereinbefore described, the whole of the Te Hure and Otaki Bidings of Horsesheur. the whole of the Te Horo and Otaki Ridings of Horowhenua County, and that portion of the Wirokino Riding of the said Horowhenua County lying to the south-west of the existing Otaki Electoral District boundary. This district also includes Mana and Kapiti Islands.

### MANAWATU.

Manawatu District comprises the existing Manawatu Electoral District together with that portion of the Fitzherbert Riding of Kairanga County lying to the south-east of the north-western boundaries of Sections 100, 98, and 97, the western boundary of Section 96, all of Block II, Arawaru Survey District, to the Fitzherbert Road West; thence by survey District, to the Fitzherbert Road West; thence by the said road to and along the Manawatu Bridge Road, to and along the Fitzherbert Road East, to and along the road forming the north-eastern boundary of Section 224, Block XV, Kairanga Survey District, and lying between the north-eastern, south-eastern, and south-western boundaries of the existing Palmerston Electoral District.

# PALMERSTON.

Palmerston District comprises the existing Palmerston Electoral District less that portion of the Fitzherbert Riding of Kairanga County now included in the Manawatu Electoral District hereinbefore described.

Oroua District comprises the existing Oroua Electoral Dis-Rangitikei County lying to the south of the Erewhon Riding of Rangitikei County lying to the south of the existing Rangitikei Electoral District boundary; also that portion of the Awarua Riding of the said Rangitikei County lying to the east of the Main Trunk railway-line and the eastern boundary of Tailway Borough of Taihape Borough.

# RANGITIKEI.

RANGITIKEI.

Rangitikei District comprises the existing Rangitikei Electoral District less those portions of the Erewhon and Awarua Ridings of Rangitikei County now included in the Oroua Electoral District hereinbefore described. This district now includes that portion of the Ruanui Riding of the said Rangitikei County lying to the west of the Main Trunk railway-line and north and west of the existing Rangitikei Electoral District boundary; also includes the whole of the Upper Wangaehu Riding of Wanganui County, together with that portion of the Mangawhero Riding of the said Wanganui County lying to the north of the said existing Rangitikei County lying to the north of the said existing Rangitikei Electoral District boundary, and the whole of the Morikau Riding of the aforesaid Wanganui County.

# WANGANUI.

Wanganui District comprises the existing Wanganui Electoral District unaltered.

# PATEA.

Patea District comprises the existing Patea Electoral District together with the whole of the Omoana, Eltham, and South Ridings of Eltham County; also those portions of the Ararata and Mokoia Ridings of Hawera County lying to the north of the existing Patea Electoral District boundary.

Egmont District comprises the existing Egmont Electoral District, less the Omoana, Eltham, and South Ridings of Eltham County and those portions of the Ararata and Mokoia Ridings of Hawera County now included in the Patea Electoral District hereinbefore described. This district now includes the whole of the West Riding of Stratford County, together with the whole of the Okato Riding of Taranaki County; also with the whole of the Okato Riding of Tarahaki County; also that portion of the Omata Riding of the said Tarahaki County lying to the south-west of the Waioratokai Stream and the road extending south from the Omata Road to the road at the northern boundary of Section 77, Block VIII, of the Paritutu Survey District; thence by that road to the intersection of roads at the eastern boundary of Section 67 of the said block and survey district; thence by the north-western and north-eastern boundaries of Section 53 of the aforesaid block and survey district, to and along the south-eastern boundaries of Sections 513, 514, 515, 516, and part 517, all of Block IX of the before-mentioned survey district, to the stream forming the eastern boundary of the said Omata Riding; also that portion of the Mangorei Riding of the aforesaid Taranaki County lying to the south-west of the south-eastern boundaries of Sections part 517, 518, 519, 520, 521, 522, 523, 524, and part 772, all of Block IX of the Paritutu Survey District, to the Mangorei River, and lying to the north-west of the said Mangorei River from its junction with the said Section 772 to its junction with the south-western boundary of the aforesaid Mangorei Riding.

# STRATFORD.

STRATFORD.

Stratford District comprises the existing Stratford Electoral District less the whole of the West Riding of Stratford County. This district now includes that portion of the Mangorei Riding of Taranaki County not included in the Egmont Electoral District hereinbefore described; it also includes the whole of the balance of Clifton County lying to the northeast of the existing Stratford Electoral District boundary.

#### NEW PLYMOUTH.

New Plymouth District comprises the existing Taranaki Electoral District less the whole of the Okato and Mangorei Ridings and portion of the Omata Riding, all of Taranaki County, now included in the Stratford and Egmont Electoral Districts hereinbefore described. This district now includes the Borough of Waitara together with that portion of the Waitara West Riding of the said Taranaki County lying between the existing Taranaki Electoral District boundary and the boundary of the said Borough of Waitara.

#### WAIMARINO.

Waimarino District comprises the existing Waimarino Electoral District less that portion of the Ruanui Riding of Rangitikei County; also less the whole of the Upper Wangaehu and Mirikau Ridings, and that part of the Mangawhero Riding, all of Wanganui County, now included in the Rangitikei Electoral District hereinbefore described; also less that portion of the Taringamotu Riding of Taumarunui County and that portion of the Taupo County now included in the Rotorua Electoral District hereinbefore described. This district now includes the Ohura Town District together with the whole of the Ohura County less that portion of the Ongaruhe Riding of the said Ohura County lying between the Upper Ohura and Ohura Roads and the existing Waimarino Electoral District boundary.

# Waitomo.

Waitomo District is bounded on the north by the Raglan Waitomo District is bounded on the north by the Ragian and Waikato Electoral Districts, hereinbefore described, from the ocean at Aotea Harbour to the Waikato River at the eastern boundary of Waipa County; thence bounded towards the east by the existing Rotorua Electoral District boundary to the northernmost point of Taumarunui County at the Pareora Trig. Station; thence bounded towards the south by the Waimarino and Stratford Electoral Districts herein-before described to the ocean at the mouth of the Mokau River; thence bounded towards the west by the ocean to Aotea Harbour, the place of commencement.

Wairau District comprises the existing Wairau Electoral District together with the whole of the Kaikoura County and that portion of the Kenepuru Sounds District between the existing electoral-district boundary and the watershed north of the Kenepuru Sound hereinbefore described, and less that portion of the Pelorus and Havelock Ridings hereinbefore described and now forming part of the Nelson Electoral

#### HURUNUI.

Hurunui District comprises the existing Hurunui Electoral District together with the whole of the Rangiora County, including Rangiora Borough and the Homebush Riding of Malvern County, less the whole of Kaikoura County, now forming part of the Wairau Electoral District hereinbefore described.

# KATAPOL.

Kaiapoi District comprises the existing Kaiapoi Electoral Kaiapoi District comprises the existing Kaiapoi Electoral District together with that portion of the Courtenay Riding of Malvern County lying between the existing electoral-district boundary and the Waimakariri River; also the whole of the Yaldhurst, West Melton, Templeton, and Islington Ridings of the Paparua County; also that portion of Papanui Riding of Waimairi County lying between the existing electoral-district boundary and the boundary of Christchurch City; also together with the northern portion of New Brighton Borough lying between the existing electoral-district boundary on the north and north-west and Sea View Road on the south, less the whole of the Rangiora County, including Rangiora Borough, now forming part of the Hurunui Electoral District hereinbefore described.

# CHRISTCHURCH NORTH.

Christehurch North District comprises the existing Christchurch North Electoral District together with that portion of the existing Riccarton Electoral District lying between Papanui and Harewood Roads and the city boundary; also Papanui and Harewood Roads and the city boundary; also that portion of the existing Electoral District of Christchurch South between Armagh and Kilmore Streets and Elgin and Colombo Streets; and less that portion between Kilmore and Armagh Streets and Park Terrace and Elgin Street; also less that portion lying between Warrington Street and Edward Avenue, Cleveland Street and Hills Road, between Edward and Kingsway Streets and Fitzgerald Street and Hills Road, and that portion bounded by Kingsway, Hills Road, Bealey Street, Bealey Avenue, and London Street.

# CHRISTCHURCH EAST.

Christchurch East District comprises the existing Christchurch East Electoral District together with that portion of Christchurch City lying between Huxley and King, Montrose and Colombo Streets.

# CHRISTCHURCH SOUTH.

Christchurch South District comprises the existing Christchurch South Electoral District together with that portion of Christchurch City lying between Park Terrace and Elgin Street, Armagh and Kilmore Streets; and less that portion of Christchurch City between Armagh, Kilmore, Elgin, and Colombo Streets now forming part of the Christchurch North Electoral District hereinbefore described; also less that portion between King and Hurlay Colombo and Montroe tion between King and Huxley, Colombo and Montrose Streets now forming part of Christchurch East Electoral District hereinbefore described.

#### Avon.

Avon District comprises the existing Avon Electoral District together with that portion hereinbefore described of the existing Christchurch North Electoral District, and less that portion of the New Brighton Borough now included in the Kaiapoi Electoral District hereinbefore described.

# RICCARTON.

Riccarton District comprises the existing Riccarton Electoral District, together with the whole of No. 2 and No. 3 Ridings of Halswell County, the whole of Wairewa County, the whole of Springs County, the Prebbleton, Broadfield, and Ladbrooks Ridings of Paparua County; also that portion of Irwell Riding of Ellesmere County lying between the Selwyn River and Cranmer Road, and Brookside and Durham Road and Lake Ellesmere; less Homebush Riding and part Courtenay Riding of Malvern County, the Yaldhurst, West Melton Templeton and Leipston Physics of Reports County. Melton, Templeton, and Islington Ridings of Paparua County; also less part of Papanui Riding of Waimairi County now forming part of the Kaiapoi Electoral District hereinbefore described.

#### LYTTELTON.

Lyttelton District comprises the existing Lyttelton Electoral District unaltered.

#### Ellesmere.

Ellesmere District comprises the existing Ellesmere Electoral District together with the Borough of Ashburton, portions of the Upper Ashburton Riding, South Rakaia Riding, South Rakaia and Wakanui Road Districts, lying between the existing electoral district boundary and the Ashburton Pivers, less that portion of the Helswell Country Ashburton River; less that portion of the Halswell County, the Ellesmere County, and the whole of the Springs and Wairewa Counties now included in the Riccarton Electoral District hereinbefore described.

# Темика.

This district comprises the whole of the Geraldine County, the Boroughs of Temuka and Geraldine, and the Town Districts of Pleasant Point and Tinwald; also the Mount Somers, Anama, Upper Ashburton, Longbeach, and Coldstream Road Districts, and that portion of the Point Riding of Levels County lying between the Ashburton River and the existing electoral-district boundary of Timaru on the east, and on the west by Flat and Ross Roads and Tengawai River, Totara Valley, and School Roads.

Timaru District comprises the existing Timaru Electoral District unaltered.

# WAITAKI.

This district comprises the whole of the Mackenzie County; the whole of Waimate County; the Ahururi, Otekaike, and Awamoko Ridings of Waitaki County; the Borough of Waimate, and the whole of Tengawai and that portion of the Otipua Riding of Levels County not included in the existing Timaru Electoral District, and Point Riding of the said Levels County, excluding the part included in Temuka Electoral District hereinbefore described.

# OAMARU.

Oamaru District comprises the existing Oamaru Electoral District together with the whole of the Hawkesbury Riding of Waikouaiti County, the Borough of Waikouaiti, and that portion of the Merton Riding of the aforesaid county lying between the existing electoral-district boundary of Chalmers and the southern boundary of Hawkesbury Riding aforesaid.

# DUNEDIN NORTH.

Dunedin North District comprises the existing Dunedin North Electoral District; less that portion of Dunedin City lying between the existing electoral-district boundary, and bounded on the west and north by Royal Terrace, Pitt, Queen, and Albany Streets, now included in the Electoral District of Dunedin West.

### DUNEDIN WEST.

Dunedin West District comprises the existing Dunedin West Electoral District together with that portion of Dunedin City now excluded from the Dunedin North Electoral District hereinbefore described; and less that portion of Dunedin City lying between Canongate, Dowling, and High Streets, and the railway boundary to its junction with the existing electoral-district boundary at Albany Street, now included in Dunedin Central Electoral District.

#### DUNEDIN CENTRAL.

DUNEDIN CENTRAL.

Dunedin Central District comprises the existing Dunedin Central Electoral District together with the balance of the North-east Harbour District, and that portion of the High-cliff Riding of Peninsula County lying between the western boundary of Section 52, Block 3, Peninsula Survey District, south-west boundaries of Sections 62, 63, 65, and 67 of Block 2 of the said survey district; and that portion of Dunedin City lying between Canongate, Dowling, and High Streets, and the existing electoral-district boundary hereinbefore described; and less that portion of Dunedin City lying between Caversham the existing electoral-district boundary hereinbefore described; and less that portion of Dunedin City lying between Caversham Valley Road, Fergusson Street, and the railway-line as far as King Street and the existing electoral-district boundary on the south; less also that portion of the said city bounded on the north by northern boundary of Section 50, on the south by Caversham Valley Road, and being the whole of Sections 50, 48, 49, 47, 46, 42, 41, 38, 37, 34, and 33, town district; less also that portion lying between Melbourne Street on the north and the existing electoral-district boundary on the south, King Edward Street on the west, and Anderson's Bay Road on the east.

#### DUNEDIN SOUTH.

Dunedin South District comprises the existing Dunedin South Electoral District together with those portions of Dunedin City now excluded from the Dunedin Central District hereinbefore described; and less that portion of North trict hereinbefore described; and less that portion of North Taieri Riding contained between the existing electoral-district boundary and the southern boundary of the said riding; and less that portion of the Kaikorai Riding now included in the Chalmers Electoral District hereinafter described; less also the Boroughs of Mosgiel and Green Island, and the Green Island Bush District.

# CHALMERS.

Chalmers District comprises the existing Chalmers Electoral District together with the Boroughs of Mosgiel and Green Island, and those portions of Taieri Riding and Green Island Bush District, and that portion of the Kaikorai Riding lying between the Chain Hills Road on the north, the existing Dunedin South Electoral boundary on the south, the western boundary of Green Island Borough, the railway-line and road forming the south-western boundary of Section 75 (Block VII, Dunedin), and East Taieri Survey District on the north-east, now excluded from the Dunedin South Electoral District now excluded from the Dunedin South Electoral District hereinbefore described; and less those portions of the exist-ing Chalmers Electoral District now included in the Dunedin Central Electoral District hereinbefore described; less also the whole of the Waitahuna and other ridings now included in the Clutha Electoral District hereinafter described, less also the whole of Strath Taicri Riding of Taicri County and that portion of Deep Stream Riding of said county now included in the Otago Central District hereinafter described.

# INVERCARGILL.

Invercargill District comprises the existing Invercargill Electoral District unaltered.

# WALLACE.

Wallace District comprises the existing Wallace Electoral District together with the portion of Waikaia Riding of Southland County lying south of East Dorne and Western Umbrella, and bounded on the east by county boundary, and on the west and south by existing electoral-district boundaries; less that portion of the Winton Riding of Southland County now included in the Awarua Electoral District hereinafter

Awarua District comprises the existing Awarua Electoral District together with that portion of the Winton Riding of Southland County bounded on the south by existing electoral-district boundary, on the west by Blocks 35 and 39 of Hokodistrict boundary, on the west by Blocks 35 and 39 of Hoko-nui Survey District, on the north by northern boundary of Blocks 36 and 37 and the Dipton Stream to the road intersecting Section 136a to the railway-line; thence by the road forming the northern boundaries of Sections 256, 363, 432, 549, 426, 658, 335, and north-western boundary of Section 796 to the northen boundary of Winton Riding, and thence by that boundary to its intersection with the existing electoral-district boundary at eastern boundary of Section 449; less that portion of Toetoes Riding of Southland County lying between the Mataura River, the sea-coast, and the existing electoral-district boundary of Mataura.

#### MATAURA.

Mataura District comprises the existing Mataura Electoral District together with that portion of the Toetoes Riding of Southland County excluded from the Awarua Electoral District hereinbefore described, and that portion of the Waipahi Riding of Clutha County lying between the existing electoral-district boundary on the north, and the southern boundary of the said riding on the south, and the railway-line on the east; also the whole of the Clinton Riding of the Clutha County now included in the existing Clutha Electoral District, including the Clinton Town District.

#### OTAGO CENTRAL.

Otago Central District comprises the former Wakatipu Electoral District together with the Idaburn, Mount Ida, Gimmerburn, Kyeburn, Puketoi, and Hyde Ridings of Maniototo County, the Green Valley, and Macrae's Ridings of Wai-

hemo County, Strath Taieri Riding of Taieri County, and the whole of Deep Stream Riding, less that portion lying south of Christmas Creek and contained between the railway-line on the west, the county boundary on the east, and the southern boundary of the said riding; also includes that portion of Gabriel's Riding of Tuapeka County lying between the eastern and southern boundaries of the said riding and the existing electoral-district boundary of the Clutha District; this district also includes the Borough of Lawrence; and less that portion of the Waikaia Riding of Southland County already included in the Wallace Electoral District hereinbefore described.

#### CLUTHA

Clutha District comprises the existing Clutha Electoral District together with the whole of the Waitetahuna, Clarendon, Waihola, and Glenlidi Ridings of Bruce County, and portions of the Mount Stuart and Tokomiro Ridings of the said county lying between the northern boundaries of the said ridings and the existing electoral district boundary now excluded from the existing Chalmers Electoral District; less those portions of the Waipahi and Clinton Ridings already included in the Mataura Electoral District hereinbefore described.
