Regulations under the Orchard and Garden Diseases Act, 1908, in regard to the Importation of Potatoes into New Zealand.— Notice No. Ag. 2661.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

HEREAS by Order in Council dated the twenty-third VV day of August, one thousand nine hundred and fifteen,' and published in the Gazette on the second day of nuceen, and published in the *Gazette* on the second day of September, one thousand nine hundred and fifteen, at page 3100, regulations (hereinafter referred to as "the said regula-tions") were made under the Orchard and Garden Diseases Act, 1908 (hereinafter referred to as "the said Act"), for the prevention of the introduction of diseases affecting fruit and plants. plants :

And whereas it is deemed expedient to revoke the said regulations in so far as they relate to the importation of

regulations in so far as they relate to the importation of potatoes, and to make other provision in lieu thereof: And whereas in the opinion of the Governor-General the unrestricted introduction of potatoes into New Zealand is likely to introduce disease into New Zealand : Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby revoke the said regulations in so far as they relate to the importation Executive Council of the said Dominion, doth hereby revoke the said regulations in so far as they relate to the importation of potatoes, and doth hereby declare that the introduction into New Zealand of potatoes is absolutely prohibited except when such introduction takes place in accordance with the following regulations, and doth further declare that such revocation shall take effect and the regulations hereby made shall come into force on the day of publication hereof in the *Gazette*: Provided always that with respect to the introduc-tion of any potatoes that may then be in transit by sea to the tion of any potatoes that may then be in transit by sea to the Dominion the said regulations shall continue to apply and the following regulations shall not apply.

REGULATIONS.

1. PRELIMINARY.

THESE regulations may be cited as the Importation of Potatoes Regulations, 1927.

2. INTERPRETATION.

- In these regulations, if not inconsistent with the context, "Disease" means any disease as defined in the said Ac These regulations, in not inconsistent with the context,....
 "Disease" means any disease as defined in the said Act, and includes any disease declared to be a disease within the meaning of that Act:
 "Director" means the Director for the time being of the Horticulture Division of the Department of Agri-culture.
- culture: "Inspector" means an Inspector under the said Act: "Owner" of potatoes includes consignee, and also the master of any vessel in which such potatoes have been brought to New Zealand.

3. PORTS OF ENTRY.

For the purposes of these regulations the Ports of Auckland, Wellington, Lyttelton, Dunedin, and Bluff are hereby appointed to be the only ports of entry for potatoes for other than seed purposes : Provided that in the case of direct consignments of such

potatoes for any other port than those above mentioned the whole consignment, or any portion thereof, as may be re-quired by the Inspector, shall be actually landed by the owner quired by the Inspector, shall be actually landed by the owner or person in charge thereof, at the owner's expense, for examination at a port of entry; and on compliance with the requirements of Regulation 4 hereof, so far as may be appli-cable, and on a permit being issued by such Inspector, after examination, authorizing their release at the port of destina-tion, such potatoes may be carried to such other port and be there cleared and landed on production of such permit to the local Customs officer. local Customs officer.

4. Admission of Potatoes for other than SEED PURPOSES.

(1) Each consignment of potatoes for other than seed purposes imported into the Dominion must be accompanied by a certificate in the form set out in the First Schedule hereto, signed by a responsible officer of the Department of Agriculture or other responsible Government officer charged with the supervision of matters relating to horticulture of the with the supervision of matters relating to norticulture of the country in which the potatoes were grown, setting forth that he has examined the potatoes; that they are entirely free from disease; the place at which they were grown; that they were grown on premises known after due investigation not to be infected with disease; and that they are packed in clean new sacks. new sacks.

(2) On the production of the certificate prescribed in the last preceding clause at the office of an Inspector situate at one of the prescribed ports of entry, such Inspector may,

after such examination as he thinks necessary, and if satisfied that the certificate applies to the potatoes proposed to be introduced, that such potatoes are in fact free from disease as so certified, and that the law has been otherwise complied with, issue a permit, in the form in the Second Schedule hereto, authorizing such potatoes to be landed and disposed of without further restriction :

Provided, however, that possession of such a certificate shall not relieve any person seeking to introduce such potatoes from any other liabilities he may be subject to under

potatoes from any other liabilities he may be subject to under the provisions of the said Act or these regulations. (3) If any potatoes are introduced or attempted to be introduced into New Zealand without being accompanied by the certificate prescribed by these regulations as necessary for such potatoes, such potatoes may, together with any package containing the same, or with which the same may have been in contact, be seized by an Inspector or other person authorized by the Minister in that behalf, or an officer of Customs, and be destroyed, or otherwise disposed of as such Inspector or other person or officer deems fit, at the expense of the owner or person in charge thereof. (4) If any potatoes are introduced or attempted to be introduced into New Zealand which, though accompanied by the certificate prescribed as necessary for such potatoes, are

the certificate prescribed as necessary for such potatoes, are yet found on examination by an Inspector to be infected with disease, such potatoes shall, together with any packages or wrappings containing or surrounding the same, or with which the same may have been in contact, be either reshipped

which the same may have been in contact, be either reshipped at once to a port or place beyond New Zealand by the person introducing or attempting to introduce them, or be destroyed at the expense of the owner or the person in charge thereof. (5) In any case in which he considers such a course neces-sary for the purpose of determining whether disease is actually present or not, it shall be competent for the Inspector to despatch samples from any consignment to a Government laboratory for special examination, and the consignment shall not be removed or dealt with in any way, otherwise than by reshipment, until the result of such special examination is known, and shall then be dealt with according to such of the preceding clauses hereof as may be applicable.

(7) Every person commits an offence against these regula

- (a) In any way introduces, attempts to introduce, or is concerned in introducing or attempting to introduce any potatoes infected with disease, or who keeps, sells, or exposes or offers for sale or barter potatoes so introduced, or in any way causes the distribution of same :
 - (b) Removes or attempts to remove or is concerned in removing any potatoes, or package or wrapping con-taining the same from any wharf or vessel or landing-place within New Zealand without first having obtained a permit from the Inspector in the form set out in the Second Schedule hereto.

5. Admission of Seed Potatoes.

(1) Seed potatoes may be imported by post only, and in lots not exceeding 12 lb. in weight.

(2) All such potatoes shall be addressed in the care of the Director.

(3) Upon their arrival in the Dominion such potatoes shall, until planted, be retained in the custody or control of the Director, and shall be grown on land approved by the Director

Director, and shall be grown on land approved by the Director for the purpose and under his supervision, but at the expense in all things of the owner. (4) No such potatoes when so planted, and no potatoes grown therefrom, shall be taken out of the ground without the written consent of the Director given on his being satisfied that such potatoes are not infected with disease. (5) If in his oninion one such votatoes are infected with

(5) If in his opinion any such potatoes are infected with disease the Director may at any time order their destruction, and any expense incurred in this connection shall be borne by the owner.

(6) Upon being notified by the Director that he has autho (b) Upon being noticed by the Director that he has altho-rized the release of such potatoes the owner shall make all necessary arrangements for digging, bagging, and taking delivery thereof. Any charges that may have been incurred in providing containers for the carriage of the potatoes and any other expenses incurred in connection with such potatoes shall be met by the owner, and shall be paid before delivery of the potatoes is given

(7) Every person commits an offence against these regulations who in any way introduces, attempts to introduce, or is tions who in any way introduces, attempts to introduce, or is concerned in introducing or attempting to introduce any seed potatoes otherwise than through the post as hereinbefore pro-vided and in lots not exceeding 12 lb. in weight, or who grows or deals with any imported seed potatoes, or potatoes grown therefrom, or causes or permits the same to be grown or dealt with otherwise than according to the provisions of these regulations.

6. RECOVERY OF EXPENSES.

The amount of any expenses imposed by these regulations upon the owner or person in charge of any potatoes shall be assessed by the Director in accordance with the time and labour (whether of officers of the Government or otherwise) involved and the material used, and when so assessed shall be deemed to be a fee fixed in pursuance of section 20 of the said Act, and shall be recoverable as a debt due to the Crown in any Court of competent jurisdiction.
