In pursuance and exercise of the powers and authorities vested in him by section three of the Main Highways Act, 1922, and of all other powers enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that on and after the date of gazetting of this Order in Council the streets or portions of streets enumerated in the Schedule hereto shall become and form part of the main highways named in each case respectively, within the meaning and for the purposes of the Main Highways Act. 1922. ways Act, 1922.

SCHEDULE.

HIGHWAY DISTRICT No. 1.

Auckland-Wainui Main Highway via Birkenhead.

Auckland-Wainui Main Highway via Birkenhead.

All those streets or portions of street in the Borough of Birkenhead—commencing at the Birkenhead Wharf, and proceeding generally in a northerly and north-westerly direction along Hinemoa Street, Hauraki Street, and Glenfield Road, and terminating at the junction of Glenfield Road and Pupuke Road at the northern boundary of the Borough of Birkenhead, being a distance of 1 mile 60 chains, more or less: as the same is more particularly delineated on the plan marked P.W.D. 71287, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red.

Whangarei-Dargaville Main Highway.

All those streets or portions of street in the Borough of Dargaville—commencing where the Main Road of Dargaville joins the Whangarei-Dargaville Main Highway at the northern boundary of the said Borough of Dargaville at the Awakino River No. 2D Block 13, Maungaru Survey District, and proceeding generally in a south-westerly and southerly direction via Jervois Street and Normanby Street; thence over the Kaihu River Bridge and along Mangawhare Road, over the Kaihu River Bridge and along Mangawhare Road, and terminating where it joins the Dargaville – Te Kopuru Main Highway on the southern boundary of the Borough of Dargaville, adjoining Aoroa No. 1, Block XV, Kaihu Survey District, being a distance of 2 miles 70 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71163, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red.

Dargaville-Maungaturoto Main Highway.

All those streets or portions of street in the Borough of Dargaville—commencing at the junction of Grey Street with Jervois Street, and proceeding generally in a southeasterly direction along the said Grey Street to the northern end of the Wairoa River Bridge where it joins the Dargaville—Maungaturoto Main Highway, being a distance of 20 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71163, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured yellow.

HIGHWAY DISTRICT No. 2. Great South Road Main Highway.

All those streets or portions of street in the Borough of Otahuhu—commencing at a point on the Great South Road at its intersection with Portage Road on the northern boundary of the Borough of Otahuhu, and proceeding generally in a south-easterly direction on to and along the Great South Road, and terminating at the southern boundary of the Borough of and terminating at the southern boundary of the Borough of Otahuhu at the bridge over the Tamaki River, and being a distance of 1 mile 47 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71165, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured

Plan 7762, deposited in the office of the District Land Registrar at Auckland, and proceeding generally in a southerly and south-easterly direction on to and along the Great South Road and Hamilton Road, and terminating on the said Hamilton Road at the south-eastern boundary of the Borough of Ngaruawahia, being a distance of I mile 77 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71166, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured

Also all those streets or portions of street in the Borough of Te Awamutu—commencing at the north-eastern boundary of Te Awamutu—commencing at the north-eastern boundary of the Borough of Te Awamutu at the Mangaoi Stream, and proceeding generally in a south-westerly, southerly, and south-easterly direction on to and along Arawata Street, Sloane Street, and Kihikihi Road, and terminating at the south-eastern boundary of the Borough of Te Awamutu at a point on the said Kihikihi Road opposite the south-eastern corner of Lot 2 of Section 139, being a distance of 1 mile 27 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71167, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.

Te Awamutu – Pirongia Main Highway.

All those streets or portions of street in the Borough of Te Awamutu—commencing at a point on Alexandra Street opposite the north-western boundary of Lot 61 of Section 241 on the western boundary of the Borough of Te Awamutu, and proceeding in a south-easterly direction on to and along the street known as Alexandra Street, and terminating where the said Alexandra Street junctions with Arawata and Sloane Streets, being a distance of 1 mile 29 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71164, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.

Hamilton-Rotorua Main Highway.

All those streets or portions of street in the Borough of Cambridge—commencing at a point on Hamilton Road opposite the south-western corner of Section 7a (Recreation Reserve) at the western boundary of the Borough of Cambridge, and proceeding generally in an easterly, south-easterly, and easterly direction on to and along Hamilton Road, Victoria Street, Duke Street East, and Gorton Road, and terminating at a point on the said Gorton Road opposite the southing at a point on the said Gorton Road opposite the south-eastern corner of Section 43a (Recreation Reserve) on the eastern boundary of the Borough of Cambridge, and being a distance of 2 miles 3 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71168, deposited in the office of the Main Highways Board at Wel-lington, in the Wellington Land District, and thereon coloured blue.

Pokeno-Waihi Main Highway.

Hamilton-Paeroa Main Highway.

All those streets or portions of street in the Borough of Morrinsville—commencing at the western boundary of the Borough of Morrinsville, and proceeding generally in a north-easterly direction on to and along the streets known as Hamilton Street and Thames Street, and terminating at a point opposite the northern corner of Section 23 of Motumaoho No. 2 Block, being a distance of I mile 47 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71171, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.

Also all those streets or portions of street in the Borough of Te Aroha—commencing at a point on Whitaker Street at the northern boundary of the Borough of Te Aroha, and proceeding generally in a south-easterly, south-westerly, and south-easterly direction on to and along the streets known as Stanley Road, and terminating at a point on the said Stanley Road opposite the eastern corner of Section 9 at the southern boundary of the Borough of Te Aroha, as shown on L.T. plan 14676, deposited in the office of the District Land Registrar 14676, deposited in the office of the District Land Registrar at Auckland, being a distance of 2 miles 18 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71172, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.

Pokeno-Tauranga to Coromandel Main Highway.

All those streets or portions of street in the Borough of Thames All those streets or portions of street in the Borough of Thames—commencing at the southern boundary of the Borough of Thames at the Kaueranga Stream Bridge, and proceeding generally in a north-westerly direction on to and along the streets known as Jellico Crescent, Queen Street, Burke Street, Beach Road, Tararu Road, Graham Street, and Coast Road, and terminating at a point on the Coast Road opposite the south-western corner of Waihoanga Block at the northern boundary of the Borough of Thames, being a distance of 4 miles 4 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71174, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.

Drury-Waiuku, via Pukekohe, Main Highway.

All those streets or portions of street in the Borough of All those streets or portions of street in the Borough of Pukekohe—commencing at the northern boundary of the Borough of Pukekohe, and proceeding generally in a south-easterly and south-westerly direction on to and along the streets known as Paerata Road, Seddon Street, West Street, and Puni Road, and terminating at the south-western boundary of the Borough of Pukekohe at a point on the said Puni Road opposite the northernmost corner of Section 66, Block YV Drary Survey District being a distance of 1 mile Block XV, Drury Survey District, being a distance of 1 mile 47 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71175, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured blue.

HIGHWAY DISTRICT No. 3, Whakatane-Tauranga Main Highway.

All those streets or portions of street in the Borough of Tauranga—commencing at the southern boundary of the Borough of Tauranga at or near the northern end of Hairini Bridge, and proceeding generally in a northerly and northwesterly direction along Turret Road and Roberts Street, and terminating at the intersection of the said Roberts Street with Cameron Road, being a distance of 1 mile 16 chains, more or less: as the same is more particularly delineated on more or less: as the same is more particularly delineated on plan marked P.W.D. 71176, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red and marked A-B.

Matamata-Tauranga Main Highway.

All those streets or portions of street in the Borough of Tauranga—commencing at the southern boundary of the Borough of Tauranga at Hospital Street, and proceeding generally in a northerly direction via Cameron Road, Brown Street, Cliff Road, and Marsh Street, and terminating at the junction of Marsh Street and Cliff Road, being a distance of 2 miles 38 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71176, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red and marked E-B-C-F.

Tauranga-Waihi Main Highway.

All those streets or portions of street in the Borough All those streets or portions of street in the Borough of Tauranga—commencing at the intersection of Eleventh Avenue and Cameron Road, and proceeding generally in a westerly direction via the said Eleventh Avenue, and terminating at the western boundary of the Borough of Tauranga, at the Judea Bridge over the Kohurererua River, being a distance of 40 chains more or less; as the same is being a distance of 40 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71176, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red.

Hisborne-Whakatane, via Motu, Main Highway.

All those streets or portions of street in the Borough of Whakatane—commencing at the western boundary of the Borough of Whakatane, and proceeding generally in an easterly, northerly, and north-easterly direction along Bridge Street, King Street, Domain Road, Commerce Street, and Strand, and terminating opposite the Whakatane Post-office, being a distance of 2 miles 36 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71177, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red and marked A-B-C.

Also all those streets or portions of street in the Borough of Opotiki—commencing at the western boundary of the Borough of Opotiki at the Waioeka River Bridge, and proceeding generally in a north-easterly direction through 308A Embankment Reserve, along Forsyth Street, Bridge Street, Church Street, Elliott Street, and terminating at the eastern boundary of the Borough of Opotiki at the bridge over the Otara River, being a distance of 1 mile 42 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71178, deposited in the Office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red.

Cambridge-Rotorua Main Highway.

All those streets or portions of street in the Borough of Retorua—commencing at the north-west rn boundary of the Borough of Rotorua at the Utahina Stream Bridge, and pro-Borough of Rotorua at the Utahina Stream Bridge, and proceeding generally in an easterly and southerly direction along Main Road, Tutanekai Street, Arawa Street, Fenton Street, then along the road passing through Recreation Reserve part 10, and terminating at the southern boundary of the Borough of Rotorua where it joins the Rotorua-Napier Main Highway, being a distance of 3 miles 64 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71179, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon hatched in red and marked A-B-C. Whakatane-Rotorua Main Highway.

All those streets or portions of street in the Borough of Wairoa—commencing at the junction of Frasertown Road with Mahia Avenue, and proceeding generally in a northerly direction via the Frasertown Road, and terminating at the northern boundary of the said Borough of Wairoa at the Awatere Stream, being a distance of 23 chains, more or less: as the same is more particularly delineated on the plan marked P.W.D. 71180, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red and marked B-D.

Napier-Wellington, via Wairarapa, Main Highway.

and terminating at the junction of Ruataniwha Road with Church Lane, being a distance of 75 chains, more or less: as the same is more particularly delineated on plan marked P.W.D. 71182, deposited in the office of the Main Highways Board at Wellington, in the Wellington Land District, and thereon coloured red and marked D-B.

Also all those streets or portions of street in the Borough of Dannevirke—commencing at the intersection of Miller Street with High Street, and proceeding thence generally in a south-easterly direction via the said Miller Street, and terminating at the southern boundary of the said Borough of Dannevirke at the north-western corner of Lot 1, Section 55.

Auckland-Wellington, via Taranaki, Main Highway.
