And whereas the prescribed deposits have now been made, and it is expedient that the said nominations should not be held invalid by reason only of the making of the said deposits subsequently to the time of nomination:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred on him by section three hundred and seventy-nine of the Municipal Corporations Act, 1920, and acting by and with the advice and consent of the 1920, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that the said respective nominations in respect of which the prescribed deposits have now been made shall be deemed valid as if such deposits had in each case been made at the time of nomination as required by the said section nineteen, and shall not be called in question by reason only of the failure to make such deposits as the time of nomination.

Regulations under the Seeds Importation Act, 1927, governing the Importation into New Zealand of Seeds.— Notice No. Ag. 2720.

IN pursuance and exercise of the powers conferred upon him by the Seeds Importation Act, 1927, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations.

REGULATIONS.

1. (1) THESE regulations may be cited as "The Seeds Importation Regulations, 1928."
(2) These regulations shall come into force on the date of publication in the Gazette, but shall not apply to any seed that may then be in transit by sea to the Dominion.
(3) For the purposes of these regulations, unless the context of the purpose.

otherwise requires.—

"The said Act" means the Seeds Importation Act, 1927:

"Import" includes attempting to import or being concerned in importing:

"Seed" means cocksfoot (Dactyles glomerata), lucerne

"Seed" means cocksfoot (Dactyles glomerata), lucerne (Medicago sativa), or white clover (Trifolium repens) seed or any other seed declared by the Governor-General in Council to be subject to the provisions of the said Act:

"Inspector" means any person appointed as Inspector for the purposes of the said Act.

2. (1) Not less than one per centum of each package of seed imported into New Zealand shall be stained prior to importation with a red colouring matter.

(2) The colouring matter to be used shall be either an alcoholic solution of saffranin or a specially prepared and effective fluid seed-staining dye.

(3) Staining shall be done by mixing one per centum of the bulk with the stain and then blending the stained parcel with the bulk lot.

3. (1) The form of certificate required by subsection (2) of section 5 of the said Act shall be in the form set out in the First Schedule hereto.

(2) The certificate shall be in duplicate. One copy shall be retained by the importer at the port of entry, and the other shall be supplied by him to the Inspector, who shall, on being satisfied that the seed covered by the certificate has been treated as prescribed in these regulations, issue a permit in the form set out in the Second Schedule hereto for the seed to be landed for the seed to be landed.
