HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by section three hundred and thirty-five of the Native Land Act, 1909, it is provided that, with the precedent consent of the Governor-General in Council, a body corporate constituted under Part XVII of the said Act may, on the security of a mortgage or charge of the land vested in it, borrow money for any of the purposes therein mentioned:

And whereas the bodies corporate constituted as aforesaid described in the Schedule hereto have applied for the precedent consent of the Governor-General in Council accordingly, and also that consent be given to any money so borrowed being paid to the committees of management of the said bodies corporate:

And whereas the Tairāwhiti District Native Land Court has recommended that such consent be granted, and it seems expedient so to do:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby, pursuant to section three hundred and thirty-five of the Native Land Act, 1909, and all other powers him enabling, grant precedent consent to the said bodies corporate, on the security of a mortgage or charge of the land vested in them, borrowing from a State Loan Department or from any person or body corporate, whether by cash credit in current account with a bank or otherwise, for the purpose of enabling the said bodies corporate to liquidate existing liabilities in respect of, and to further improve and more efficiently farm, the lands of the said bodies corporate, the sums set out hereunder opposite the name of each body corporate; and doth authorize the payment of any money so borrowed to the committees of management of the said bodies corporate; and doth consent to any instrument of alienation by way of mortgage of the lands of the said bodies corporate, given in pursuance of this Order in Council being confirmed by the Tairāwhiti District Maori Land Board.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS the Wairere Electric-power Board (hereinafter called "the said local authority") is desirous of raising the sum of three thousand five hundred pounds for the purpose of supplying electricity in the Mahoenui District by a loan to be known as "The Mahoenui Loan, 1929":

And whereas the said local authority has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council under the said Act should be given to the raising of the said loan on the terms and conditions hereinafter set forth:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities

conferred on him by the said Act, and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising by the said local authority of the said loan up to the amount of three thousand five hundred pounds for a term not exceeding twenty-six years, at such rate or rates of interest as shall not produce to the lenders a rate exceeding the rate of five pounds ten shillings per centum per annum, subject to the condition that the said local authority shall, before borrowing the said sum or any part thereof, make provision for the repayment thereof by establishing a sinking fund under the Local Bodies' Loans Act, 1926, and shall thereafter make to such sinking fund payments at intervals of not more than one year at a rate or rates which shall be not less than the rate of two pounds per centum, such payments to be made in respect of every part of the said sum for the time being so borrowed and not repaid, and the first payment to be made not later than one year after the first day from which interest to the lender is computed on any moneys so borrowed, and subject to the further condition that no portion of interest or sinking fund shall be paid out of loan-moneys.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by Order in Council dated the fourteenth day of June, 1915, and published in the *New Zealand Gazette*, No. 74, of the same day, general harbour regulations were made prescribing rules for determining the qualifications in respect of age, time of service, skill, character, and otherwise to be required of persons appointed as harbourmasters or appointed or licensed as pilots:

And whereas it is expedient to revoke such regulations and to make others in lieu thereof:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon him by section two hundred and thirty-four of the Harbours Act, 1923, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby revoke the herein-before-recited regulations, and doth hereby make the following general harbour regulations in lieu thereof; and doth hereby order and declare that they shall be in force on and from the date of this Order in Council.

## GENERAL HARBOUR REGULATIONS.

1. A CANDIDATE for the position of harbourmaster at any port which requires a harbourmaster whose whole time is devoted in connection with the harbour or pilotage must be a British subject of not less than twenty-five years of age, and must hold a foreign-going certificate of competency as master.
2. He must produce certificates to date of good conduct and sobriety, also medical certificate that he is in good health and not afflicted with any bodily infirmity rendering him unfit for the duties of the position.
3. He must also produce a recent form and colour-test certificate as required by the latest Board of Trade regulations for examination of masters and mates.
4. The above regulations shall not apply to ports where the harbourmaster is not required to devote the whole of his time to duties of the position, or to the service of the Government or Harbour Board employing him.

## PILOTS.

5. Before any person can receive an appointment as a pilot he must pass before a Board in the subjects and fulfil the conditions set forth below.
6. The Board shall be composed of not less than two nautical officers to be appointed by the Marine Department, each of whom shall possess a certificate of competency as master; one member of the Board at least must have a thorough knowledge of the harbour, river, or roadstead and its approaches in respect of which the candidate is to be examined.
7. (1) A candidate for the appointment of pilot must be a British subject and not less than twenty-two years of age, must hold a foreign-going certificate not lower than master, must produce certificates of good conduct and sobriety, also medical certificate that he is in good health and not afflicted with any bodily infirmity rendering him unfit for the duty of pilot. He must also produce a recent form and colour-test certificate as required by the latest Board of Trade regulations for examination of masters and mates.

(2) He must be examined as to his knowledge of the Harbour Regulations and By-laws, International Code, Quarantine Regulations, Rules of the Road, Lights, Fog and Distress Signals, and of the working of ships in narrow water or among shipping.

(3) Also as to his first duty when going on board and before taking charge of a vessel; mooring and unmooring; getting under way; bringing up in light and strong winds, or in a tide-way; keeping a ship clear of her anchor in a roadstead or river; and marks of the lead-line.

(4) Also as to his knowledge of the harbour, river, or roadstead and their approaches (as the case may be), its depth of water, rise, fall, and set of the currents at various times of the tide; the line of soundings; banks, rocks, or other dangers, with directions for clearing the same; the description and position of lights, buoys, and beacons: the proper time of tide to get under way; and any other nautical matter the Board may think proper.

(5) A candidate applying for the appointment of pilot in harbours or rivers to which only home-trade ships ply, or where vessels are piloted from shore by means of shore-signals

only, must have served at least one year as master or chief mate of a vessel or vessels which would be capable of entering such harbour and must hold a certificate of competency as master, home trade or of a higher grade. He must also fulfil the qualification set forth in paragraphs (2), (3) and (4) of this regulation.

8. Any person committing a breach of or failing to observe these regulations is liable to a fine not exceeding £100.

*Amending Restricted Limits for the Ports of Awanui, Mangonui, and Whangaroa.*

WHEREAS by Warrant dated the twenty-eighth day of February, one thousand nine hundred and twenty-eight, and published in the *New Zealand Gazette*, No. 60, of the first day of March following, limits were defined for, *inter alia*, the ports or harbours of Awanui, Mangonui, and Whangaroa, within which restricted-limit steamships and ships propelled by mechanical power other than steam, and to which restricted-limit certificates are issued, may ply:

And whereas it is desirable that the limits therein defined for the ports or harbours hereinbefore mentioned be amended:

Now, therefore, I, John George Cobbe, Minister of Marine, in pursuance and exercise of the power conferred upon me by section 189 of the Shipping and Seamen Act, 1908, do hereby revoke, insofar as it relates or applies to the ports or harbours of Awanui, Mangonui, and Whangaroa, the aforesaid Warrant of the twenty-eighth day of February, one thousand nine hundred and twenty-eight, and do hereby define the following limits in substitution thereof:—

**AWANUI.**

River Limits: Within a right line drawn from Point Blackney to the outer visible Motu Tara Rock, thence in a direction 260° to the foreshore of Rangauu Bay.

Extended River Limits: Inside a right line drawn from Grenville Point to Cape Karaka.

Extreme Limits: Nil.

**MANGONUI.**

River Limits: Inside Mangonui Heads.

Extended River Limits: Inside a right line drawn from Cape Karaka to Cone Rock, thence south to the foreshore of the mainland.

Extreme Limits: Nil.

**WHANGAROA.**

River Limits: Inside a right line drawn from South Head to North Head at Whangaroa Harbour entrance.

by the Matamata County Council under the above-mentioned Act, for the purpose of meeting portion of the cost of metalling and bituminous-sealing roads in the Omaha - Te Poi Special-rating Area, the Matamata County Council hereby makes and levies a special rate of one-fifteenth of a penny in the pound on the rateable value of all rateable property of the Omaha - Te Poi No. 2 Special-rating Area in the County of Matamata, described in a resolution published on page 540 of the *New Zealand Gazette*, 1925; and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable yearly on the 14th day of August in each and every year during the currency of such loan, being a period of ten years, or until the loan is fully paid off.
