ORDER IN COUNCIL.

At the Government House at Wellington, this 15th day of September, 1930.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS the Lower Mangapiko Drainage Board, being of the opinion that certain lands situated in the County of Waipa and not included in the Lower Mangapiko Drainage District (hereinafter referred to as "the said district") are deriving benefit from the drainage-works carried out by the said Board, did, in accordance with the provisions of section six of the Land Drainage Amendment Act, 1913 (hereinafter referred to as "the said Act"), present a petition to His Excellency the Governor-General praying that the boundaries of the said district might be altered so as to include such lands in the said district:

And whereas in respect thereof a Commission has been appointed to inquire and report as to the several matters mentioned in subsection three of section six of the said Act:

And whereas the Commission so appointed has reported that such lands should be included in the said district and should become liable to the extent hereinafter provided for the future levy of rates already made by the said Board:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority vested in him by section six of the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the boundaries of the said district are hereby altered so as to include in the said district the lands described in the First Schedule hereto, and that the boundaries of the said district shall be those described in the Second Schedule hereto; and with the like advice and consent doth also direct that the lands so described shall be liable for the future levy of the special rates heretofore made and levied by the said Board to provide for the payment of interest and sinking fund, or interest and principal, as the case may be, in respect of the following special loans raised by the said Board: The Drainage Loan (1919) of two thousand five hundred pounds and Supplementary Loan of two hundred and fifty pounds; that portion—viz., three thousand pounds—of the Te Rahu Subdivision Loan of three thousand five hundred pounds, raised for the reconstruction of Mangapiko Stream, and Supplementary Loan of two hundred pounds.

And whereas by Order in Council dated the fourteenth day of January, one thousand nine hundred and twenty-nine, and published in the *Gazette* of the seventeenth day of the same month at page 125, regulations amending the hereinbefore-recited regulations were made :

And whereas it is desirable to further amend the said regulations in the manner hereinafter described :

Provided that, in respect of the Upokorora River and that portion of the waters of Lake Te Anau contained within the arc of a circle having a radius of a hundred yards from a point on the left bank of the said river at its mouth, the terminal points of such arc being indicated on the banks of the lake by white posts bearing the notice "Restricted Fishing Limit," the period from the first day of March to the nineteenth day of December, both days inclusive, in any year shall be a close season for Atlantic salmon :

Provided further that this regulation shall not apply to Atlantic salmon taken by any officer of the Marine Department for purpose of pisciculture or scientific investigation :

Provided further that, with the consent of the Minister of Marine, it shall be lawful for the Southland Acclimatization Society to take from such rivers or streams as may be defined by the Minister after such consent, salmon for the purpose of pisciculture within the Southland Acclimatization District.

2. During the open season in respect of the Upokorora River and that portion of the waters of Lake Te Anau hereinbefore-described it shall be unlawful for any person to fish for Atlantic salmon therefrom with any lure or bait other than artificial fly ; and no person shall take or catch more than three Atlantic salmon in any one day.

3. During the month of October in any year it shall be unlawful for any person to fish for Atlantic salmon from a boat of any description whatsoever.

4. Any person committing a breach of any of these regulations shall be liable to a fine of fifty pounds (£50).

WHEREAS the several local authorities mentioned in the Schedule hereto are desirous of raising the respective amounts set out opposite their names therein:

And whereas the said local authorities have complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council under the said Act should be given to the raising of the loans on the terms and conditions hereinafter set forth:

And whereas, in respect of such of the said loans as are intended to be borrowed at a rate of interest not otherwise authorized, the Minister of Finance has in each case given his precedent consent as required by section one hundred and fourteen of the Local Bodies' Loans Act, 1926, to the borrowing by the said local authorities of the respective loans aforesaid, for the terms set out in the Fifth Column of the said Schedule, at respective rates of interest being such as shall not produce to the lenders rates exceeding the respective rates specified in the Sixth Column of the said Schedule:

WHEREAS by Order in Council dated the eleventh day of September, one thousand nine hundred and fifteen, and published in the *New Zealand Gazette* No. 109, of the sixteenth day of the same month, William Nepean McIntosh of Onehunga, was licensed to use and occupy, for a period of fourteen years computed from the eleventh day of September, one thousand nine hundred and fifteen, a part of the foreshore and land below low-water mark in Orapiu Bay, Waiheke Island, in order to maintain thereon a wharf erected in accordance with plan M.D. 4496, and deposited in the Office of the Marine Department at Wellington :

And whereas the said license was, with the previous consent of the Minister of Marine, transferred on the twenty-first day of May, one thousand nine hundred and twenty-eight, to the Orapiu Road Board (who, with its successors and assigns is hereinafter referred to as "the Board") :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon him by the said Act, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the purpose or object for which the said license is required by the Board as aforesaid; and in further pursuance and exercise of the said power and authority, and with the like advice and consent as aforesaid, doth hereby license and permit the Board to use and occupy that part of the foreshore and land below low-water mark as shown on plan marked M.D. 4496, so deposited as aforesaid, for the purpose of maintaining the said wharf, such license to be held and enjoyed by the Board upon and subject to the terms and conditions set forth in the First Schedule hereto, and doth prescribe that the dues set forth in the Second Schedule hereto shall be charged and taken by the Board for the use of the said wharf.

FIRST SCHEDULE.

1. In these conditions the term —

"Foreshore" means such parts of the bed, shore, or banks of a tidal water as are covered and uncovered by the flow and ebb of the tide at ordinary spring tides :

"Low-water mark" means low-water mark at ordinary spring tides :

"Minister" means the Minister of Marine as defined by the Shipping and Seamen Act, 1908, and includes any officer, person, or authority acting by or under the direction of such Minister.

2. The concessions and privileges conferred by this Order in Council shall extend and apply only to that part of the foreshore occupied by the said wharf as shown on the plan marked M.D. 4496 and deposited as aforesaid.

3. In consideration of the concessions and privileges granted by this Order in Council the Board shall pay to the Minister the sum of £1, and thereafter an annual sum of £2 10s. in advance, payable on the 1st day of April in each year, the first of such annual payments to be made on the Board being supplied with a copy of this Order in Council.

4. His Majesty or the Governor-General, and all officers of the Government Service acting in the execution of their duty, shall at all times have free ingress, passage, and egress into, through, over, and out of the said wharf without payment.

5. The Board shall maintain the above-mentioned wharf in good order and repair, and shall at all times exhibit therefrom and maintain at the Board's own cost, suitable and necessary lights for the guidance of vessels: provided that no light shall be exhibited until after it has been approved of by the Minister.

6. Any person authorized by the Minister may at all reasonable times enter upon the said wharf and view the state of repair thereof; and upon such Minister leaving at or posting to the last known registered office of the Board in

New Zealand, a notice in writing of any defect or want of repair in such wharf, requiring the Board, within a reasonable time to be therein prescribed, to repair the same, the Board shall with all convenient speed cause such defect to be removed or such repairs to be made.

7. Nothing herein contained shall authorize the Board to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs, or with any provisions of the Harbours Act, 1923, or its amendments, or any regulations made thereunder, and that are now or may hereafter be in force.

8. The rights, power, and privileges conferred by or under this Order in Council shall continue to be in force for fourteen years computed from the eleventh day of September, one thousand nine hundred and twenty-nine, unless in the meantime such rights, powers, and privileges shall be altered, modified, or revoked by competent authority; and the Board shall not assign, charge, or part with any such right, power, or privilege without the written consent of the Minister first obtained.

9. The said rights, powers, and privileges conferred under or by virtue of this Order in Council may be at any time resumed by the Governor-General, and the Board may be required to remove the wharf at the Board's cost, without payment of any compensation whatever, on giving to the Board three calendar months' previous notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to the last known registered office of the Board in New Zealand.

10. The Board shall be liable for any injury which the said wharf may cause any vessel or boat to sustain through any default or neglect on the Board's part.

11. In case the Board shall—

- (1) Commit or suffer a breach of the conditions hereinbefore set forth, or any of them;
- (2) Cease to use or occupy the said foreshore and wharf for a period of thirty days;
- (3) Be in any manner wound up or dissolved; or
- (4) Fail to pay the sums specified in clause 3 of these conditions,—

then, and in any of the said cases, this Order in Council, and every license, right, power, or privilege, may be revoked and determined by the Governor-General in Council without any notice to the Board or other proceeding whatsoever, and publication in the *New Zealand Gazette* of an Order in Council containing such revocation shall be sufficient notice to the Board and to all persons concerned or interested that this Order in Council, and the license, rights, and privileges thereby granted and conferred, have been revoked and determined.

12. In the event of this Order in Council being revoked for any reason whatsoever, or upon the expiry of the period for which the license is granted, the Board shall, if required by the Minister so to do, remove the said wharf entirely from the site, and restore the site to its original condition within three months from the date of revocation or expiry, as the case may be; and, if the Board fails so to do, the Minister may cause the said wharf to be removed and the site so restored, and may recover the costs incurred by the said removal and restoration from the Board.

13. The payment of the sums specified in clause 3 hereof shall be sufficient evidence of the acceptance by the Board of the terms and conditions of this Order in Council.

SECOND SCHEDULE.

SHIPPING WHARFAGE.

EVERY person who shall use the said wharf with any vessel shall pay for the use thereof as follows, that is to say:—

For every vessel a sum of 1d. per ton on the gross tonnage of such vessel per day for each day or part of a day a vessel shall occupy a berth alongside any vessel lying at the said wharf, or shall lie at the said wharf undergoing repairs or fitting-out only, or shall lie off the said wharf with a line attached thereto.

GOODS WHARFAGE.

Every person who shall use the said wharf for landing or shipping any goods shall, before using same, pay dues as follows, that is to say:—

1. For all goods landed on the said wharf, a rate of 2s. 6d. per ton, weight or measurement, at the option of the Board.
2. For every head of cattle or horses landed upon or shipped from the said wharf, 2s. 6d. per head.
3. For every yearling or calf so landed upon or shipped from the said wharf, the sum of 1s. per head.
4. For every head of sheep or small cattle so landed upon or shipped from the said wharf, the sum of 6d. per head.

5. If any ship shall use the said wharf for the discharge of any goods or cargo after the usual working-hours, or on wharf holidays, such ship shall pay to the Board for the use of the said wharf a charge at the rate of 1s. per ton on all goods or cargo so discharged from such ship.

This charge will only be made when, in the opinion of the Wharfinger, it is necessary to employ labour to stack or remove cargo in sheds in consequence of the discharge of such goods or cargo as aforesaid.

PASSENGERS.

For every passenger who shall land on or be shipped from the said wharf, the sum of 6d.

GOODS STORAGE.

Any person storing goods on wharf or in shed may be charged for such goods at the following rates:—

NOTE.—A cloudy and unsettled month, with moderate to strong southerly winds prevailing, and reaching gale force at times. The coldest July for thirty-five years. Precipitation, which was of a showery nature, was 20 per cent. below the average at Karori Reservoir, near Kelburn. Total bright sunshine, 108.8 hours, 37 per cent. of the possible, and four sunless days. Frost was recorded on the grass on twelve mornings, and fog was in evidence on five days. There was a very light fall of snow on the morning of the 25th. Lightning was seen on the 24th, thunder was heard on the 20th and 24th, and hail fell on seven days. Mean dew-point, 39°; and mean vapour pressure, 0.237 in.

SUMMARY FOR THE MONTH OF JULY, 1930.

July, 1930, will be remembered for the very cold weather experienced, especially during the latter half. Southerly winds prevailed almost continuously, except for a short spell between the 17th and the 19th, and frequently reached gale force. Hail showers were numerous and widespread. The high country, also, received many falls of snow which extended on several occasions to parts of the low levels. The falls in general were not heavy, and indeed on the ranges there is less than the usual amount for the time of year. Very seldom indeed, however, has snow been so widely recorded as on the morning of the 28th. Between the 27th and 29th there were comparatively few places south of Auckland, except in Westland and parts of Nelson and Marlborough, which did not receive a few flakes. In many cases it was more than thirty years since snow had been seen previously.

Frosts were naturally numerous everywhere, and from Canterbury southwards there were few nights when they were not recorded. Temperatures were much below normal, several stations having the coldest month on record. At many, however, 1895 or 1918, and in some 1901 and 1908, were colder.

Rain fell on more days than usual, but in most districts the total falls were considerably below average. The deficiencies were particularly marked in Nelson, Marlborough, and the interior of the South Island. Parts of North Canterbury and Hawke's Bay and a few isolated places elsewhere received rather more than the normal.

As a result of the low temperatures there has, of course, been very little growth of vegetation, and in many districts feed is getting scarce. Stock on the whole are in fair condition, but an anxious time for farmers is ahead, especially in connection with lambing, unless milder weather comes soon. There were some losses of early lambs in Hawke's Bay, and milk yields have fallen off. Should good, warm rains be received, however, there would be a rapid improvement in prospects.

During the first eight days of the month the weather was the finest and mildest over most of the country that had been experienced for some time. An anticyclone moved on to the Dominion on the 2nd, and on the 4th became centred over the southern portion. It remained practically stationary in this position until the 8th, and clear skies and light winds were the rule. Such rain as fell came mainly in the night time. On the 5th and 6th there was fairly general rain, with many heavy falls in the districts about and south of Auckland. The Waihou River rose very high, and some severe flooding occurred, especially in and around Thames.

Between the 8th and the 10th a small cyclone moved in a south-easterly direction past the northern extremity of the North Island. Rough weather was caused in the North Auckland, Bay of Plenty, and Gisborne and East Cape districts, and there were some heavy rainfalls. On the 10th south-easterly gales reached as far south as Cook Strait.

On the night of the 15th and 16th, while an anticyclone was extending gradually over the Dominion, a slight depression developed over the central part of the North Island and, passing eastward, was followed by a sudden and unexpected southerly gale. There were some heavy rains about Cook Strait, with numerous hail showers and snow on the high country.

From the 17th to the 19th occurred the only spell in the month during which northerly winds prevailed. These were associated with a deep depression of the westerly type which moved eastward from Tasmania. Strong southerly gales and low temperatures followed on the 20th. On the 21st a cyclone developed from a secondary depression to the one just mentioned, and moved across the North Island to the Bay of Plenty. Southerly gales again set in on the 22nd. Between the 18th and the 22nd general rains fell and the North Island, especially the eastern portions, recorded many heavy falls. From this time onward barometers remained low to the east of New Zealand, while to the west they were high. Very disturbed conditions prevailed over the Pacific Ocean, and shipping received a severe buffeting. Cold temperatures persisted, with frequent hail or snow falls in some part or other of the Dominion. Southerly gales blew at intervals from the 25th to the 29th. On the 25th and the 28th they were particularly severe, and on the 28th occurred what was perhaps the most extensive fall of snow ever recorded in the Dominion. The amount was, however, in most places only small. Coastal shipping was disorganized also, and some damage was done on the shores of Wellington Harbour on the 28th.

RESOLUTION MAKING SPECIAL RATE.

Copy of a Resolution passed at a meeting of the Wairarapa Electric-power Board held on Tuesday, the 9th September, 1930.

IN pursuance and in exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, and all other powers (if any) it thereunto enabling, the Wairarapa Electric-power Board hereby resolves as follows:—

That, for the purpose of providing for the payment of interest, sinking fund, and other charges on a loan of £9,400, authorized to be raised by the Wairarapa Electric-power Board under the above-mentioned Act for the purpose of repaying the balance of a special loan of £10,000 (ten thousand pounds) borrowed by the said Board for the purpose of financing intending consumers of electric energy in the Wairarapa Electric-power District and to provide for stock of motors, fittings, and electrical appliances, with the necessary land, buildings, and storage accommodation over and above the amount of accrued sinking funds, the said Wairarapa Electric-power Board hereby makes and levies a special rate of 1/32nd of a penny (one thirty-second of a penny) in the pound sterling on the rateable value, on the basis of the capital value, of all rateable property in the Wairarapa Electric-power District, as defined in the First Schedule of the Proclamation proclaiming the said district appearing in the *New Zealand Gazette* of the 25th day of March, 1920; and that such special rate shall be an annual-recurring rate during the currency of the said loan, and be payable yearly on the first day of October in each and every year during the currency of such loan, being a period of seven years, or until the loan is fully paid off.

RESOLUTION MAKING SPECIAL RATE.

Kahutara Stopbank Loan, £2,600, 1930.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, and all other powers (if any) it thereunto enabling, the Kahutara River Board hereby resolves as follows:—

That, for the purpose of providing for the payment of interest, sinking fund, and other charges on the Kahutara Stop-bank Special-rating Area Loan of £2,600, 1930, authorized to be raised by the Kahutara River Board under the above-mentioned Act for the purpose of completing stopbanks for river protection, the said Board hereby makes and levies a special rate of nineteen thirty-seconds (19/32nds) of one penny in the pound sterling on the rateable value (on the basis of the unimproved value) of all rateable property in the Kahutara Stopbank Special-rating District, being more particularly described in the Schedule at the foot hereof, and that such special rate shall be an annually recurring rate during the currency of such loan, being a period of twenty-five (25) years, or until the loan is fully paid off.
