HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by Order in Council dated the thirteenth day of October, one thousand nine hundred and thirty, and published in the *Gazette* of the sixteenth day of the same month, at page 3178, regulations were made for trout, perch, and tench fishing in the South Canterbury Acclimatization District:

And whereas it is desirable to amend the said regulations in the manner hereinafter described:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by Part II of the Fisheries Act, 1908, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby amend clause four of the said regulations by revoking the proviso thereto, and doth hereby make the following proviso in lieu thereof.

(b) No person shall use any mollusca, which term includes snails, pipi, fresh or salt-water mussels, oysters, winkles, or the like, or any lures or baits other than natural or artificial flies, insects, worms, or fish.

IN pursuance and exercise of the powers conferred upon him by the Education Act, and of all other powers enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby amend the regulations relating to examinations in technology made by Order in Council dated the thirtieth November, one thousand nine hundred and twenty-eight, and amended by Order in Council dated the thirteenth May, one thousand nine hundred and thirty, in the manner set forth in the Schedule hereto; and with the like advice and consent doth prescribe that this Order shall come into force on the date of publication thereof in the *New Zealand Gazette*.

SCHEDULE.

1. By adding the following to Schedule I—Syllabuses of Examination :—

MOTOR MECHANICS' WORK.

Minor Course.

NOTES.—(1) In all stages of the examinations candidates will be required to show a reasonable knowledge of drawing, elementary mechanics, practical mathematics, and the more elementary principles of magnetism and electricity so far as applications of these subjects to the topics included in the syllabuses of written and practical work are concerned.

(2) In each stage questions may be set on the subjects of the previous stage or stages, if any.

1. PRELIMINARY EXAMINATION SYLLABUS.

(A) *Theory.*

The written examination will include questions on the following subjects :—

- (1) The general principles of lubrication.
- (2) Bearings, explanation of their functioning.
- (3) Two and four cycle engines; and the operation thereof.
- (4) Engine construction; connecting rods, water-jackets, &c.
- (5) Valves; Mushroom and sleeve; causes of burning and pitting; valve timing.

(B) Practice.

The practical examination will include examples from the following list :—

- (1) Filing to a reasonable degree of accuracy ; chipping and fitting of keys ; sharpening of drills ; tempering and grinding hand tools.
- (2) Drilling, reaming, screwing, and tapping ; care and use of tools used therein.
- (3) Soldering, brazing and riveting.
- (4) Facing and grinding valves and valve seat cutting.
- (5) Annealing and bending of copper pipes.

II. INTERMEDIATE EXAMINATION SYLLABUS.

(A) Theory.

The written examination will include questions on the following subjects :—

- (1) Transmission ; clutches, wet and dry ; types of clutches, cone, multiple disc, dry plate, and Hele Shaw ; methods of adjustment and repair ; operation of clutch stops.
- (2) Gear boxes, types, selective, epicyclic ; operation.
- (3) Universal joints ; types, fabric couplings, metal joints, &c.
- (4) Rear axles ; types, live and dead, semi-float, three-quarter and full float.
- (5) Differentials ; types, bevel gear and straight tooth ; working principles, adjustments : Final drive, bevel gear, worm gear, straight and helical tooth.
- (6) Brakes ; types, internal and external, mechanical and hydraulic ; lining and materials ; methods of adjustment and equalization.
- (7) Steering gears.
- (8) Chassis, construction and methods of springing ; drive and torque reaction ; variation of torque and braking effect ; principle of front-axle assembly.

(B) Practice.

The practical examination will include examples from the following list :—

- (1) Lathework, turning, boring, setting up, &c.
- (2) Remetalling, fitting and scraping bearings.
- (3) Assembling and aligning pistons, connecting-rods, and crankshafts, and the fitting of piston rings and gudgeon pins.
- (4) Use of micrometer and vernier gauge.
- (5) Adjustments of contact breakers and distributors in connection with ignition systems, spark-plug adjustments.

III. FINAL EXAMINATION SYLLABUS.

(A) Theory.

The written examination will include questions on the following subjects :—

- (1) Fuel ; storage. Carburettors ; types, surface and spray (float feed) ; pressure and gravity gasoline systems ; vacuum tanks, care and operation ; choke-tubes, jets, compensating jets, &c., dash pots and metering pins, &c. ; hot-air pipes ; adjustments of well-known makes.
- (2) Bearings, types and materials ; ball and roller bearings ; thrust bearings, compound bearings, housings for ball and roller bearings.
- (3) Cooling systems, thermo syphon, forced circulation and air-cooled ; circulating pumps (centrifugal) thermostats.
- (4) Lubricating systems, drip, forced, and splash ; oil-pumps, gear and plunger types ; pressure and circulation indicators.
- (5) Ignition systems and timing, starting and lighting systems considered in greater detail.

(B) Practice.

- (1) Carburettor adjustment.
- (2) Wiring (lighting and ignition).
- (3) Starting and lighting systems, standard type. Single and double wire systems.
- (4) Switches and cut-outs.
- (5) Distributors and timers. Breaker mechanism and contacts.

- (6) Ignition and valve timing.
- (7) Testing and tuning up.
- (8) Troubles and remedies.

PAINING AND DECORATING.

NOTE.—The following classes of candidates will be exempted from the preliminary examination in drawing and mensuration:—

- (1) Those who have passed the examination for a Senior Free Place passing in the subjects trade drawing and freehand drawing and design.
- (2) Those who have obtained a Senior Free Place by recommendation, having reached the pass standard in arithmetic or mathematics or alternative mathematics and in trade drawing and freehand drawing and design.

SYLLABUS OF COURSES.

PRELIMINARY EXAMINATION.

The Preliminary Examination in Grade I will consist of a written paper only, which will include elementary questions founded on such subjects as the following:—

1. Drawing: Freehold drawing from copies, also from objects and memory; the elements of plane and solid geometry; the use and construction of plain scales.
2. Mensuration: The measurement of simple areas as required by painters and paperhangers. Weights and measures used for painters' materials.
3. General Principles: (a) The importance of personal cleanliness to preserve health, and of shop cleanliness to avoid waste. (b) Terms used in painting; object in painting surfaces; the principles underlying the use of paints.
4. Colouring: Visual colour values—*e.g.*, hue, tone, purity, &c. Mixing and matching; simple facts relating to colours in practice such as the deceptive effects of juxtaposition.
5. Brushes, tools, plant, and appliances: The names, description, and uses of brushes and other tools; their care and preservation.
6. Materials: The principal pigments, thinners, and driers used in painting; their names, uses, and distinctive qualities; varnishes, their classification and uses.
7. Grounds for Painting: The necessity of varying the ingredients of the priming coat according to the material to which it is to be applied; paint removal, knotting, priming, stopping, filling up, and surfacing.
8. Painting: The simple mixing and application of paints.
9. Distemper: The preparation of grounds; ingredients, composition, and application of distemper.
10. Wall-hangings: The stripping and preparation of walls for wall hangings; the preparation of pastes. Area covered by a piece of English, French, and American wall-paper respectively.
11. Imitative Painting: The preparation of grounds for different woods and the colours used.
12. Lettering: Simple Roman and block capitals, and lower case, together with numerals.
13. Decorative Processes: Elements of stencils and stencilling.

INTERMEDIATE EXAMINATION.

The Intermediate Examination in Grade II will consist of a written examination, a practical test, and specimen work.

(1) WRITTEN EXAMINATION.—The written examination may, in addition to more difficult questions on the subjects of the syllabus for the preliminary grade, include questions on such subjects as the following:—

1. Drawing: Designing simple patterns suitable for colouring and for use in definite positions. Freehand sketches illustrating the principal parts of buildings and fittings, such as mouldings, cornices, friezes, architraves; the elements of perspective.
2. Architectural: The architectural significance of plinths, cornices, friezes, architraves, corbels, string courses, surbase moulds, and similar features as to their colour and treatment.
3. Mensuration: Methods of measuring painters' work, also wall-paper and other hangings.
4. General Principles: The preservative, hygienic and decorative aspects of painters' work; economy and cleanliness in working; defects, their cause and cure.

5. Colouring: Colour theory, and the general principles underlying pleasing chromatic effect. The grouping of colours in practice according to these principles, *e.g.*—

- (a) Schemes in colour closely related to a single hue.
- (b) Assortments of powerfully contrasting hues.
- (c) Combinations in which both these principles operate together. (Such dispositions to be considered complete in themselves.)

6. Brushes, tools, plant, and appliances: The composition of, and the material used in painters' brushes; the characteristics of a good brush and its preparation for use; the use of plant and appliances; precautions in the use and arrangement of simple scaffolding.

7. Materials: Oils and diluents—their properties, distinctive qualities, and uses; driers or siccatives—their composition, nature, and actions; pigments—their physical properties and comparative value as painters' materials; comparative durability of pigments; fugitive and permanent colours; varnishes—their constituents and nature; pigments which may or may not be mixed with one another.

8. Grounds for Painting: Dampness and its treatment; faulty woods; knots, sap, &c., and their correction; the proper application of paints and the best method of painting various surfaces.

9. Painting: Faults in painting and their avoidance; the necessity of various mixings of successive coats for producing glossy, flat, semi-flat, varnish, and enamel finishes; stippling.

10. Distemper: Washable and other distempers and their limitations; colours affected by lime; tempera and water paints; stencilling and lining; stippling.

11. Scrimming, taping, strapping, &c.; pasting.

12. Wall-hangings: Varieties and makes of wall-papers and other hangings, such as textile fabrics, imitation leather papers, Japanese grass-cloth, and relief materials. Selection of papers for walls and ceilings; setting-out and hanging.

13. Imitative Painting: The artistic use of graining, marbling, and gilding; colours for, and methods of working graining of different woods; marbling and graniting.

14. Lettering: Styles and principles governing their application for various uses; elaboration, emphasis, ornamentation, and punctuation.

15. Decorative Processes: Striping, lining, and outlining; stencilling, designing, and cutting stencils; oil gilding, painting in monochrome and in polychrome, glazing and scumbling.

16. Staining Woods: Wood suitable for staining; preparation and application of stains; oil and wax polishing; special treatment of New Zealand timbers before staining or painting, such as totara and matai.

17. Varnishing: Faults in varnishing and their prevention and cure; flattening and encaustic varnishing; selection and application of varnish.

18. Burning off: Care of lamps; precautions against risks of fire from lamps, cleaning down; preparing and priming.

(2) PRACTICAL EXAMINATION AND SPECIMEN WORK.—The practical work required of a candidate will consist of an obligatory portion on the selection and harmony of colours, and of two other tests to be selected from the subjects enumerated below:—

- (a) Preparation and plain painting.
- (b) Enamelling and varnishing.
- (c) Stencil cutting and stencilling.
- (d) Plain and ornamental lettering.
- (e) Simple decoration in oil or distemper.
- (f) Graining and marbling.

The obligatory test or tests are to be specimens of the candidate's work executed in his own time; the remaining tests are to be executed under examination conditions.

FINAL EXAMINATION.

The Final Examination will consist of a written examination, a practical test, and specimen work. With his application for entry to the Final Examination every candidate must produce evidence of at least five years' training in a trade workshop, or in a recognized school teaching painting and decorating, or partly in a workshop and partly in a school.

[A form for this purpose may be had upon application to the Director. Under the latter alternative the periods of training must not run concurrently.]

(1) THE WRITTEN EXAMINATION may comprise advanced questions on any of the subjects included under the two previous examinations, together with the following :—

1. Drawing and Design : The preparation of decorative designs and working drawings.

2. Architectural : The orders and styles of architecture and their predominant features. The periods and styles of decoration and their chief characteristic details.

3. Mensuration : Taking out quantities and estimating.

4. General Principles : The management of men and works ; preparation of specifications of work for given purposes and under given conditions.

5. Colouring : Colour in its larger aspects as related to some definite position or purpose ; the consideration of external factors and their effects—*e.g.*, lighting, distance, or point of view, pre-existing coloured objects ; the proper expression of structure and surface in architecture—*e.g.*, the distribution of such colour values as shall sustain mouldings or members according to their relative importance and purpose ; the power of colour to sustain, override, or modify the effects of architectural arrangement in their final settlement of proportions.

6. Brushes, Tools, Plant, and Appliances : The management of the paint shop and stores ; the selection of plant and tools for jobs ; the testing and care of step-ladders, &c. ; arrangement of men when painting large surfaces.

7. Materials : Practical and simple chemical tests for pigments, oils, turpentine, driers, varnishes, enamels, and other materials ; selection, purchase, and storage of materials.

8. Grounds for Painting : Preparation of special surfaces as metals, cements, poillite and plaster board, &c. ; the treatment for special conditions as smoke, grease, heat, frost, and hard wear.

9. Painting : Power of paints to resist action of weather, heat, gases, acids, alkalis, &c. ; testing of paints to ascertain this power.

10. Distemper : Painting ornament in and on distemper ; the use of distemper on other than plaster grounds.

11. Wall-hangings : The selection and hanging of jute, canvas, silk, tapestry, and other materials.

12. Spray-painting and lacquering.

13. Imitative Painting : The use of imitative effects of materials and texture, as bronze, ivory, majolica, &c. ; roller and transfer processes of graining ; the representation of inlays, marquetric, mosaic, ivory, bronze, &c.

14. Lettering : Writing and embossing, gilding and colouring on glass ; elements of heraldic painting and illuminating. The treatment and application of wood and other attachable letters.

15. Decorative Processes : Polychromatic stencilling ; raised and sanded decorative painting ; matt and burnish gilding ; gesso and tapestry painting.

16. Staining : Ornamental and decorative staining ; chemical staining ; comparative value of water, oil, and spirit staining.

17. Varnishing : Different processes of felting down and hand polishing.

18. Scaffolding : General outline of scaffolding regulations.

(2) PRACTICAL EXAMINATIONS AND SPECIMEN WORK.—The practical work required of a candidate will consist of an obligatory portion on the selection and harmony of colours, and of two other tests to be selected from the subjects enumerated below :—

(a) The preparation of a design for decoration.

(b) The preparation of full size working drawings and partial execution in colour from a scale black and white sketch.

(c) The arrangement and execution of a decorative sign-board in colour and gold.

(d) Writing, embossing, and gilding on glass, wood, plaster, and other surfaces.

(e) The painting and stencilling of a panel or frieze, from given directions.

(f) The execution of examples of specified woods and marbles.

(g) The execution of a panel decorated by one of the processes included in the syllabus for the written examination and specified by the examiners.

(h) The matching and harmonizing of named colours, tints, or shades upon a moulded panel in varnish, or other specified manner.

(i) The painting of ornament in monochrome from a cast.

The obligatory test or tests are to be specimens of the candidate's work executed in his own time ; the remaining tests are to be executed under examination conditions.

Regulations under the Disabled Soldiers' Civil Re-establishment Act, 1930.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the power and authority conferred on him by section eight of the Disabled Soldiers' Civil Re-establishment Act, 1930 (hereinafter referred to as "the said Act"), His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations for the purposes of the said Act, and doth hereby declare that these regulations shall come into force on the date of publication thereof in the *Gazette*.

REGULATIONS.

1. For the purposes of these regulations—

"Committee" means a Local Advisory Committee appointed under the said Act:

"Commissioner" means the Commissioner of Pensions:

"Registrar" means a Registrar of Pensions:

"Employment Officer" means an Employment and Vocational Officer appointed under section 5 of the said Act:

"Disabled soldier" means a disabled soldier within the meaning of the said Act.

2. The members of each Committee shall at its first meeting, and thereafter from time to time as occasion requires, elect one of their own number to be chairman of the Committee, and the chairman so elected shall hold office during the currency of his term as a member of the Committee.

3. Meetings of each Committee shall be held at such times and places as are fixed by the chairman thereof. At any such meeting three members of the Committee shall constitute a quorum.

4. Each Committee may appoint such sub-committees in the smaller centres of its district as it thinks fit. Each such sub-committee shall perform such duties as the Committee from time to time directs.

5. An Employment Officer directed so to act by the Commissioner shall be the Secretary of each Committee.

6. Applications for employment and vocational training by persons resident in the district of any Committee shall be

made to an Employment Officer or a Registrar, who shall refer all such applications to the Committee for investigation and disposal.

7. Every Registrar shall render to the Committee within whose district he is stationed all such assistance in the proper investigation and disposal of any application as he is able to give by virtue of his office.

8. (1) A Committee may, with the approval of the Minister or the Commissioner, arrange for free tuition for disabled soldiers for vocational training purposes at any technical school or other State educational institution, and for vocational training of disabled soldiers in any State or private institution or in any industry or any branch or branches thereof.

(2) In arranging such training the Committee shall take into consideration whether the applicant, having due regard to his mental and physical impairment, is a suitable person to be trained for the particular industry, the likelihood of his being able to attain such reasonable degree of efficiency in such industry as to become able to continue to be employed therein without his earnings being permanently subsidized, and whether such industry is capable of sustaining the employment of the applicant.

9. A Committee or the Commissioner may arrange with any employer affected by any Order in Council that may be made under section 18 of the Finance Act, 1919, for disabled soldiers to be employed at such rate of wages below the current rate of wages fixed according to law, as the Committee considers the ex-soldier may be capable of earning.

10. A Committee may recommend to the Minister what amount, not exceeding £2 a week for a single man and £3 a week for a married man, should be paid to any disabled soldier in respect of whom such recommendation is made for the purpose of supplementing his earnings in any employment.

11. A Committee or the Commissioner may arrange with any employer or prospective employer or any Department of State for the employment of disabled ex-soldiers who are out of work.

12. A Committee may invite and receive applications for employment from disabled soldiers and inquire into and recommend to the Minister, through the Commissioner, any scheme for assisting and encouraging disabled soldiers to obtain and retain employment of a nature suitable to their disabilities.

13. Every Committee, either directly or through an Employment Officer, shall keep in touch with disabled soldiers who have been found employment, with a view to advising and further assisting them and inquiring as to the benefits and suitability of the work so found having regard to the nature of their disabilities.

14. Every Committee shall keep such records and submit such returns as may be required by the Commissioner with regard to applications for employment and vocational training.

Officers are not entitled to draw travelling-allowance for any time during which they perform relieving duty, except as follows: When in performing relieving duty an officer is not required to stay more than three nights in the place where such duty is performed, he may be paid travelling-allowance instead of relieving-allowance. But travelling-allowance may be paid for the day occupied in travelling to or from headquarters, provided that the time occupied exceeds six hours on each occasion.

In any special case the Commissioner may authorize payment of an allowance at a higher or lower rate.

An allowance in accordance with this regulation shall be granted only in cases where an officer is required to perform purely relieving duty.

A relieving-allowance shall not be paid to an officer for any period in excess of one month, or in cases where the period of relief is likely to be in excess of one month, without the previous approval of the Commissioner thereto. In such cases, where practicable, a commuted allowance will be payable.
