ARTICLES OF AGREEMENT made the 27th day of October, 1931, between HIS MAJESTY THE KING, acting through THE HONOURABLE THE MINISTER OF TRANSPORT, of the one part, and the several companies and corporate bodies carrying on in New Zealand the business of accident insurers by or on behalf of which these presents are executed, of the other part.

WHEREAS it is expedient to make arrangements in connection with claims in respect of death or bodily injury caused by the use in New Zealand of motor-vehicles that cannot be identified:

Now, therefore, it is hereby agreed between the parties hereto as follows:

(1) Where any person (hereinafter called "the claimant")

- alleges—

 (a) That a person unknown would, if ascertainable, be under (a) That a person unknown would, it ascertainable, be under a legal liability to him on account of the death of any person or of bodily injury to any person, and that such death or bodily injury was sustained or caused by or through or in connection with the use of a motor-vehicle in New Zealand; and
 (b) That it is impossible to identify such motor-vehicle;
 - and
 - (c) That such legal liability arose when registration-plates were attached to such motor-vehicle in manner for
- the time being prescribed by law; and (d) That such registration-plates were issued in respect of a period during which such legal liability arose; then the underwriters who are parties hereto (hereinafter severally and collectively called "the underwriters") agree that the matter shall be dealt with in accordance with the

(2) The claimant shall, within seven days of the date of the accident, transmit by registered post, and addressed to the Commissioner of Transport at Wellington, a statement in writing signed by him or his solicitor, or some other person

on his behalf.

(3) In special circumstances the Minister of Transport may extend the period of seven days prescribed by clause (2) hereof for such times as he may think equitable, but so that in no case shall the period within which the statement is to be transmitted to the Commissioner exceed fourteen days

from the date of the accident.

- (4) Such statement shall set forth full particulars of the circumstances upon which the claimant relies to show that his claim is one that should be dealt with under the provisions hereof, including such particulars of time, place, names and addresses of persons, and other circumstances as will suffice to inform the underwriters of the particular grounds of legal liability alleged, such as the particular respects in which the claimant alleges that the person in charge of the motor-vehicle was negligent, and also setting forth the amount and full details of his claim.
- (5) Where the claim is made on account of the death of any person the statement shall also contain full particulars of the person or persons for whom and on whose behalf the claim is made.
- (6) In every case such statement shall contain an undertaking that the claimant and the other persons (if any) for whom and on whose behalf the claim is made—

 (a) Will accept the award of the arbitrators hereinafter
 - referred to and the amount (if any) payable under such award in full satisfaction and discharge of all

existing or subsequent claims or demands on the part of such claimant and other persons (if any) in respect of or arising out of the accident mentioned in such statement against the driver of and the owner of statement against the driver of and the owner of such motor-vehicle, and against any other person who may be liable in respect of the accident, and whether the identity of such driver, owner, or other person is known or not; and

(b) Will, upon the publication of the said award and the payment of the amount (if any) payable thereunder, execute an agreement with the Commissioner of Transport as provided by clause (19) bereaf

 (7) The Commissioner shall forthwith send a copy of the statement to the State Fire Insurance General Manager on behalf of the underwriters, and the claim shall thereupon be referred to arbitration in accordance with the provisions hereinafter set out. The reference shall be to three arbitrators who, after the receipt from the Commissioner by the said General Manager on behalf of the underwriters of the statement referred to in clause (2) hereof, shall be appointed in the manner hereinafter provided before any step is taken in the manner hereinafter provided before any step is taken in the reference.
- (8) One arbitrator shall be appointed by the claimant; one arbitrator shall be appointed for the underwriters in the manner hereinafter provided; and the third arbitrator shall be a Stipendiary Magistrate who shall be appointed by the Minister of Transport. If the three arbitrators cannot all The reference to the arbitrators shall be sufficient. The reference to the arbitrators shall be deemed to be a submission within the meaning of the Arbitration Act, 1908, and the provisions of that Act shall, so far as applicable, apply to the arbitration and all proceedings thereunder. For the purpose of giving or receiving any notice or taking any steps in the arbitration proceedings, the parties shall respec-tively be deemed to be the claimant and the committee

tively be deemed to be the claimant and the committee hereinafter referred to.

(9) If either party shall refuse or neglect to appoint an arbitrator within twenty-eight days after the other party shall have appointed an arbitrator, and served a written notice upon such first-named party requiring him to appoint an arbitrator, then, upon such failure, the party making the request and having himself appointed an arbitrator, may appoint another arbitrator to act on behalf of the party so appoint a appoint, and the arbitrator so appointed may profailing to appoint, and the arbitrator so appointed may proceed and act in all respects as if he had been appointed by

ceed and act in all respects as if he had been appointed by the person so failing to make such appointment.

(10) The arbitrator to be appointed for the underwriters shall be appointed by a committee of four persons, of which committee one member shall be appointed by the Council of Fire and Accident Underwriters' Associations of New Zealand, one member by the State Fire Insurance General Manager, one member by Bennie S. Cohen and Son (N.Z.), Limited, and one member by the New Zealand Medical Assurance Society, the North Island Motor Union Mutual Insurance Company, the South Island Motor Union Mutual Insurance Association, and the Wairarapa Automobile Association Mutual Insurance Company.

(11) The appointments of members of the said Committee shall be made from time to time by notice in writing to the

shall be made from time to time by notice in writing to the Minister of Transport, and every person so appointed shall continue a member until the appointment of a person to supersede him has been made as hereby provided, and the declaration of the Minister as to the validity or regularity of declaration of the Minister as to the validity or regularity of any appointment shall be final and conclusive. In the case of a member to be appointed by the said council, the instrument of appointment shall be executed by the chairman or vice-chairman thereof. In the case of the fourth member, the managers or secretaries of the bodies charged with his appointment shall from time to time, when required by the Minister so to do, submit to the Minister the name of any person whose In the case appointment is desired, and in the event of more than one name being so submitted the Minister shall select and appoint

one of the persons whose names are so submitted.
(12) The arbitrators shall first determine whether the claimant has proved to their satisfaction all the matters referred to in clause (1) hereof and has complied with all the provisions contained in clauses (2) to (6) hereof inclusive, so far provisions contained in clauses (2) to (0) hereof inclusive, so far as applicable, and if they determine that he has proved all such matters to their satisfaction, and has complied with all such provisions, they shall then determine as being their award under the reference the amount (if any) for which the owner of the vehicle would (if the vehicle were identifiable) be legally liable to the claimant, provided that no greater amount shall be awarded than would be the measure of the legal liability of such owner if the vehicle were identifiable.

In cases where no money is payable by the Commissioner under any such award the Commissioner shall require execution of such agreement as soon as possible after the publication of the award.

(20) The total amount (including party-and-party costs)
payable under any award made pursuant to and in accordance with the provisions hereof shall be collected by the
Commissioner from the underwriters, and thereafter paid

by the Commissioner to the claimant or as the award may direct; but the Commissioner shall be liable to pay as afore-

direct; but the Commissioner shall be liable to pay as afore-said only such amount as he actually receives.

(21) Each of the underwriters shall contribute such proportion of such total amount as the amount payable to it under subsection (2) of section 15 of the Motor-vehicles Insurance (Third-party Risks) Act, 1928, for the months of June, July, and August of the year in which the accident giving rise to the claim occurred bears to the total premiums received under subsection (1) of the said section 15 during the three said months. For the purposes of this

accident giving rise to the claim occurred nears to the total premiums received under subsection (1) of the said section 15 during the three said months. For the purposes of this provision "the year" means a period of twelve months commencing on the first day of June.

(22) Each of the underwriters hereby authorizes the Secretary of the Post Office to give to the Commissioner all such information as the latter may require to enable the Commissioner to access each of the underwriters with the proportion of an award payable by such underwriter pursuant to the last preceding clause hereof.

(23) For the purpose of collecting the necessary amount, the Commissioner shall notify each underwriter in writing of such total amount and of the proportion thereof payable by it, and the assessment of the Commissioner shall be accepted by each underwriter as final and conclusive; and each underwriter shall pay such proportion to the Commissioner within seven days after receiving such notification.

(24) The provisions hereof shall not apply to any claims made in respect of any accident that occurred prior to the date of the publication of this agreement in the New Zealand Gazette.

Gazette. (25) Any of the underwriters may withdraw from this agreement and the provisions hereof upon giving to the Minister of Transport not less than three calendar months' notice in writing, expiring on the 31st day of May in any year, of its intention to do so, and upon the expiration of such notice such underwriter shall cease to be under any liability under or in respect of this agreement or the provisions hereof, but it shall in such case remain liable to the Commissioner for its proportion of any claim theretofore or thereafter made in respect of any accident occurring before the expiration of such notice. Notwithstanding any such withdrawal or withdrawals as aforesaid, and subject as aforesaid, this agreement and the provisions hereof shall continue to bind the other underwriters who shall not have withdrawn as if they were the only parties hereto. The liability of any party to these presents shall not be affected by failure to become a party hereto on the part of any person, company, or comporation whose participation herein may have been in contemplation.

(26) Upon giving not less than three calendar months'

(26) Upon giving not less than three calendar months' notice in writing to the underwriters, in like manner as a claim is hereby required to be submitted to them, the Minister of Transport may terminate this agreement, but so that the same shall continue to have effect in respect of any accident

occurring before the expiration of such notice.

(27) The Minister shall arrange for the publication of this agreement in the New Bealand Gazette as soon as possible after the date of its execution by all parties to the agreement.

Note.—A cloudy, unsettled, and wet month, with rainfall 22 per cent. above the mean. Total bright sunshine, 128-4 hours, 36 per cent. of the possible, and five sunless days. The approximate mean temperature was 3.3 F below the average, being the coldest September ever experienced in Wellington since meteorological records were first taken in 1864. Frost was recorded on the grass on three mornings. A few flakes of snow fell in the suburbs of Karori and Wadestown on the 6th. Lightning was seen on the 3rd and 7th, hail fell on the 5th and 10th, and a thick fog enveloped the western hills on the 29th. Mean dew-point at 9 hrs., was 42-2°; and mean vapour pressure, 0-268 in.

SUMMARY FOR THE MONTH OF SEPTEMBER, 1931.

General.—September proved a most unsettled month, and hopes that the winter type of weather had departed with August were not fulfilled. Temperatures were decidedly cold, particularly during the first half of the month, and once again they were less than the normal throughout the greater part of the Dominion. In some districts, indeed, it was the coldest September experienced since records have been kept. This was the case in Wellington, where the difference below normal was 3.3° F., while at Christchurch it was as much as 4.1° F.

A marked feature of the month was the predominance of southerly winds. Although usually they were only moderate in force, those on the 5th, 6th, and on the 9th were severe. One of the most serious effects of such southerly rainstorms at this time of the year is the inevitable mortality amongst lambs. In the Canterbury and Waikato districts the loss was fairly considerable, as it was also in some of the high-country stations where snow accompanied the southerlies.

Vegetation was much slower in growth than is usual in this season. Some pastures which had been eaten down were showing little signs of filling up, but towards the latter part of the month when there was a tendency for milder conditions, there was a distinct improvement in this respect. The cold, and insufficient growth of grass, were reflected in the deteriorated condition of stock, and consequently dairy herds showed a yield much below the average.

Rainfall.—Rainfall was above normal over the North Island except in the northern portion of the Auckland Peninsula and on the west side of Mount Egmont. Above-average totals were also experienced along most of the east coast of the South Island, but all the western half, Otago, and the high country, had a deficiency, a few places in Westland having less than half the usual amount, while Arthur's Pass recorded only 19 per cent. of its average.

Pressure Systems.—Of the low-pressure systems the greater number were of cyclonic form, and when a westerly depression crossed the Domi

Most of the anticyclones moved in northern latitudes, but an irregular one crossed the Dominion between the 17th and 21st, and during this period fine sunny weather was general, although cool southerlies prevailed over the North Island.

The depressions were too numerous to describe in detail, but a few of the most intense may be mentioned. On the 5th a vigorous cyclone which had moved with unusual rapidity over the North Tasman Sea was centred west of the Auckland Peninsula. It crossed the North Island during the night, and by the morning of the 6th was located off East Cape. On these two days very unpleasant conditions prevailed, and on the night of the 5th a particularly violent southerly was experienced. Rain fell almost generally, and there was a heavy fall of snow on much of the central area of the North Island. It is considered that the fall in the Rotorua and Taupo districts was the heaviest experienced in the past fourteen years. In some places the snow covered the ground to a depth of 3 ft., and the Napier-Taupo road was completely blocked against traffic between Te Pohue and Rangitaiki. The east coast districts of the South Island also received snow at this time, but except in the hill country the falls were slight. On the night of the 5th an exceptionally severe thunderstorm occurred at Opotiki.

The 7th was a fine day while an anticyclone was passing to the north of New Zealand. Pressure, however, fell again next day, and by night-time an intense westerly depression had advanced on to the Dominion with a rapidity almost equal to that of the cyclone which had recently preceded it. The boisterous north-westerly wind associated with the front of this disturbance on the 8th caused a considerable amount of damage in the Canterbury district, blowing down fences, trees, and telegraph wires. Heavy rain fell in districts with a westerly aspect, and during the night of the 8th a violent thunderstorm occurred at Reefton. Electric-wires were fused and the town was left in darkness, while windows were cracked, the telephone system was put out of action, and several residents received minor shocks. By the morning of the 9th the depression had moved to the east of the Dominion, but a slight secondary centre had developed west of Cape Maria van Diemen. The latter brought some heavy rain to the Auckland, Bay of Plenty, and Gisborne districts, Marumoko recording as much as 497 points for the twenty-four hours up to 9 a.m. on the 10th. A tornado passed in the vicinity of the Stratford Mountain House during the night of the 9th, but its damaging effect was confined to a plantation of trees. On the night of the 10th the secondary centre crossed the Auckland Peninsula, and the wind, which on the 9th had become southerly in the south of Cook Strait, blew strongly everywhere from that quarter, with extremely cold temperatures.

During the night of the 15th a cyclone developed off the Canterbury coast, and this district received a drenching south-westerly rain which continued until the afternoon of the following day. There was some minor flooding in the low-lying portions of the city, and the south-westerly gale was responsible for damage to early vegetable crops, but, on the other hand, the rain was beneficial to the farming community of Canterbury. Strong south-westerly winds prevailed generally on the 16th, but by the 17th The 7th was a fine day while an anticyclone was passing to the north of New Zealand. Pressure, however, fell again

On the morning of the 26th, Timaru experienced a heavy thunderstorm accompanied by a torrential downpour of rain and hail, associated with the rear of a sharp westerly depression which had crossed the Dominion during the early morning. B. V. PEMBERTON, Acting-Director.
