Amending Regulations under the Fisheries Act, 1908.

BLEDISLOE, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 26th day of September, 1932.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

W HEREAS by Order in Council dated the twenty-ninth day of June, one thousand nine hundred and thirty-two, and published in the *Gazette* of the seventh day of the following month, at page 1598, regulations were made under the Fisheries Act, 1908 (hereinafter called "the said Act '

And whereas it is desirable to revoke certain of the said regulations and to make other regulations for the purposes of the said Act:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by the fifth section of the said Act, and of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion doth hereby make the following membrican said Dominion, doth hereby make the following regulations for the purposes of the said Act, and doth hereby revoke Regulations 141 to 150 inclusive of the hereinbefore-recited regulations.

REGULATIONS. INTERPRETATION.

1. THESE regulations shall be known as the Whitebait Regulations, 1932. 2. These regulations shall come into force on the date of publication thereof in the *Gazette*.

3. In these regulations, if not inconsistent with the context,

the terms-

- "Hand-net" means a net which is held in the hand by the person fishing during the whole time it is in the water, and which is either moved by being dipped into or drawn through the water or is held motionless.
- " Set-net means a net that is placed in the water
- "Set net " means a net that is placed in the water so that whitebait may enter it, and is not continuously held or manipulated by the person fishing: "Whitebait" means the young of the species Galaxias attenuatus, usually known by the Maori name inanga (in the South Island frequently called inaka), and sometimes by the English name minnow.

CLOSE SEASONS.

4. The following periods are hereby prescribed as close seasons during which no person shall fish for or take whitebait :-

(a) In the North Island from the 15th day of November to the 30th day of June in the year following.
(b) In the South Island from the 16th day of December to the 31st day of July in the year following.

SIZE OF HAND-NETS FOR TAKING WHITEBAIT.

5. No hand net shall be used for taking whitebait the mouth of which has a diameter or greatest width exceeding 4 ft.:

Provided that in the Waikato River it shall be lawful to use a hand-net measuring not more than 6 ft. across the widest diameter of the mouth :

Provided further that in the Grey River it shall be lawful to use a hand-net of which the largest diameter does not exceed 5 ft.; and in the Buller River it shall be lawful to use a net the circumference of which, whatever its shape, does not exceed 12 ft.

SIZE AND USE OF SET-NETS.

6. (a) It shall be unlawful to use a set-net to fish for or take whitebait in any waters other than those prescribed in the First Schedule hereto.
(b) It shall be unlawful to fish for or take whitebait by means of set-nets exceeding in dimensions or area of opening those respectively prescribed in the Second Schedule hereto.
7. In rivers where set-nets are illegal it shall be an offence against these resultions to have the here of a beaut art time.

In rivers where set-nets are illegal it shall be an offence against these regulations to have the bag of a hand-net tied to a peg or stone or attached to any fixed object for the purpose of keeping the net fully extended.
 No person shall use more than one set-net or use a setnet and hand-net at the same time : Provided that in the tidal portions of the rivers of Westland, including the Teremakau River, more than one set-net may be left in place at the same time in the groyne or trench which is used in connection with the whitebait-fishing.

USE OF JIGGERS, GROYNES AND TRENCHES, ETC.

9. No person shall use, for the purpose of enabling him to catch whitebait, boats, hurdles (either alone or in con-junction with boats moored or held in position in a river or stream), or the device or appliance known as a "jigger," which is an appliance formed of pieces of metal or other substance attached to a line and placed in a river for the purpose of turning fish into a net; nor shall any other device or contrivance he used which tends to prevent or divert the or contrivance be used which tends to prevent or divert the movement of whitebait up or down stream, with the exception of the groynes and wings used in the places specified and under the conditions prescribed in Regulations 10 to 16 horeworder

under the conditions prescribed in Regulations 10 to 16 hereunder. 10. (a) No person shall take whitebait by using nets in conjunction with groynes or walls constructed from the banks or on the bed of a river by means of which the fish may be diverted or directed into a net:

may be diverted or directed into a net: Provided that in the rivers, estuaries, and streams in the Counties of Ashburton, Geraldine, Levels, and Waimate banks constructed of river shingle may be used, provided that the height of such bank shall not be more than 16 in. above the bed of the river at the point where such bank is constructed. It shall be illegal to construct any groyne of any other material than river shingle occurring on the snot. spot:

Provided further that in the County of Westland and in the Teremakau River whitebait-nets fixed in what are known the Teremakau Kiver wintebatt-nets inxed in what are known as trenches or groynes may be used as set-nets; but no person shall construct or use more than one groyne or trench, which shall be marked by a post or peg fixed by him above high-water mark, in line with the groyne or trench, and bearing in distinct characters the name or registered number of the person who is using such groyne or trench or similar con-trivance trivance.

(b) It shall be illegal to construct a groyne or wall or similar contrivance which extends further than half-way across the river or stream, or in any but the tidal portion of the river or stream.

11. The allocation of a position at which to construct

 The allocation of a position at which to construct a groyne or trench or similar contrivance for whitebait-fishing in the rivers and streams in the County of Westland and in the Teremakau River shall be as follows:—

 (a) The person who has last fished at an allocated position shall have the prior claim to that position in the season following, provided that he makes application to the local Inspector of Fisheries for the registration of that position in his name and takes out the pre-scribed license not later than the 31st August; and that he constructs an effective trench by the 14th day

 that he constructs an effective trench by the 14th day of September following.

- (b) After the 31st August in each year positions shall be allocated in order of application to the local Inspector of Fisheries.
- (c) The position of each groyne or trench shall, before construction, be approved and registered by the local Inspector of Fisheries, and shall not be altered or constructed in another position without such approval.
- (d) A registration fee of 2s. 6d. shall be paid to the local Inspector of Fisheries by any person who is allotted a second position in the same season on abandon-ment of the position previously registered.
- (e) Each person having a registered position shall use his groyne or trench for whitebait-fishing on at least four days each week during the whitebait season unless prevented by illness, floods, or other reason which the Inspector of Fisheries considers sufficient; failing which his right to the position shall be forfeited, and in such event may be allocated to the next applicant.
 (f) A twork he registered have a maximum barrier bar
- (f) A trench may be registered by a married couple as a single registrant, and may in such case be fished by either or both.

by either or both. 12. (a) No person who has registered a groyne or trench shall fish at any other groyne or trench without having first notified the local Inspector of Fisheries of his abandonment of his registered position, and without having been duly registered as the holder of the new position: Provided that where two persons have registered as fishing in partnership and are the holders of adjoining trenches, with no other person's trench intervening, it shall be lawful for one of them to fish at the other's trench, provided that nets have been withdrawn from his own trench, and provided that both partners are present. partners are present.

(b) No person holding a registered trench shall fish with a set-net or hand-net between any two trenches or within two chains of the trench situated farthest upstream and farthest downstream respectively.

13. In the tidal portions of the rivers and streams of West-13. In the tidal portions of the rivers and streams of West-land, including the Teremakau River, the groynes or trenches shall be constructed at right angles to the direction of the stream, and in case of doubt or dispute the location shall be as directed by the local Inspector of Fisheries. Such groynes or trenches shall be built up from the natural bed of the river, except in places where the depth of water necessitates the provision of some foundation for the groyne or trench proper, in which case such foundation may be made, provided that the approval of the local Inspector of Fisheries is first obtained. Fisheries is first obtained.

14. A groyne or trench for whitebait-fishing shall not be held by any pupil attending a day school.

15. Nothing in these regulations shall entitle a person to construct a groyne or trench in the Hokitika Biver or in other waters under the control of the Hokitika Harbour Board, or any other Harbour Board, which is deemed by the said Board to be detrimental to navigation or the proper maintenance of berths for vessels in the harbour.

A wing or deflector may be used for the purpose of turning whitebait into a set-net, in the tidal waters only, in the rivers of the Provincial District of Hawke's Bay and in Mahinapua Creek in the County of Westland. Such wing or deflector shall be made of scrim or other similar material, and shall be attached to stakes so as to show above water, and shall be placed and set from a bank of the river and at right angles to the current. Such wing or deflector shall not exceed 12 ft, in length in the Provincial District of Hawke's Bay and shall not extend below low-water mark of ordinary spring tides in the Mahinapua Creek. In the Provincial District of Hawke's Bay the scrim or other similar material shall be attached so as to hang loose at the bottom.

USE OF BOATS FOR TAKING WHITEBAIT.

17. No person shall use a boat, either stationary or in motion, for fishing for whitebait in a river or stream in which groynes, trenches, or similar contrivances for whitebait-fishing are in use.

DISTANCES BETWEEN NETS.

18. No person shall use a set-net or a hand-net within two chains measured along the direction of the stream from a set-net already in use by another person.

19. No person shall use a hand-net within a distance of ten yards from the net of another person already engaged in fishing with a hand-net except on the Grey River, where no person shall use a hand-net within twelve yards of another person already fishing for whitebait.

USE OF SPECIAL FISHING-SITES ON RIVER-BANKS.

20. The following rules shall be observed in whitebaitfishing on the Grey River or any other river where the practice is for a fisherman to remain at one place while fishing

fishing:— The first fisherman to take up a position on any day shall have the right to keep that position for the remainder of the day so long as he stays there. He shall mark the spot by fixing his peg or other mark provided or prescribed for the purpose by the local Inspector of Fisheries. If he leaves the river-bank temporarily he shall not be considered to have vacated the position, provided that his net is left on the spot, and provided also that he does not absent him-self for the duration of more than one hour. On the position becoming vacant the first fisherman to arrive shall have the right to occupy it. right to occupy it.

21. It is an offence against these regulations for any person to act in contravention of the foregoing rules or to prevent any one fishing for whitebait from following these rules.

USE OF CERTAIN TYPES OF NETS PROHIBITED.

22. Fishing for whitebait by what is known as a box-net

22. Fishing for whitebait by what is known as a box.net or by any form of net that is used by being towed or drawn by a rope or line along the bottom or through the water of a river, stream, estuary, or lagoon is hereby prohibited. 23. No net shall be used for whitebait-fishing which is made with an inner opening smaller than the front of the net-mouth or is provided with inside flaps or other device by means of which fish may be trapped and retained in the net for an indepint time. net for an indefinite time.

WATERS IN WHICH WHITEBAIT-FISHING IS PROHIBITED.

24. No person shall take or fish for whitebait with any kind of net or trap whatsoever in the waters named here-

- kind of net or trap Whatsoever in one second under :--(1) The drain or stream known as Amon's Drain, which flows into the Rangitikei River on the north side about two miles from its mouth, and the Rangitikei River within one chain on either side of its confluence with the said drain.
 (2) The drain or stream known as Whakapuni Drain, which flows into the Manawatu River on the north side near its mouth, and the Manawatu River within one chain on either side of its confluence with the said drain.

PENALTY FOR BREACH OF REGULATIONS.

25. Any person committing a breach of these regulations shall be liable to a fine of ± 20 .
