Public moneys shall be kept at the Bank of New Zealand at either or both of its branches known as Auckland in the City of Auckland, and North End in the City of Wellington; at Auckland in two accounts to be distinguished as the Cook Islands Treasury Account and the Niue Island Treasury Account, respectively, and at Wellington in two accounts to be called the Cook Islands Administration Account and the Niue Island Administration Account, respectively."

3. Clause 7 of the principal regulations is revoked and the following substituted:—

"7. (1) Money shall be withdrawn from any of the said bank accounts only by cheque crossed 'Not Negotiable' and signed as hereinafter provided.

"(2) None of the said bank accounts shall at any time be overdrawn.

"(3) Cheques on the Cook Islands Treasury Account shall be signed by the Treasurer of Rarotonga and countersigned by the Resident Commissioner of Rarotonga.

"(4) Cheques on the Cook Islands Administration Account shall be signed by the Accountant, Cook Islands Department, and countersigned by the Secretary for the Cook Islands.

"(5) Cheques on the Niue Island Treasury Account shall be signed by the Treasurer of Niue and countersigned by the Resident Commissioner of Niue.

"(6) Cheques on the Niue Island Administration Account shall be signed by the Accountant of the External Affairs Department and countersigned by the Secretary for External Affairs or other officer authorized by him to act in his stead."

NOTE.—On the whole a windy, wet, and unsettled month, with mean temperatures 2.5 degrees below the average for August. Rainfall for the month was 75 per cent. above the normal. Total bright sunshine, 146.1 hours, 45 per cent. of the possible, and four sunless days.

SUMMARY FOR THE MONTH OF AUGUST, 1932.

General.—August was a cold month in all parts of the Dominion, but in the latter half there were a number of mild days. Rainfall was still below average over the greater part of the Dominion, but the heavy rain from the 27th to the 29th caused a considerable excess in most of Taranaki and in Southern Wellington.

Rainfall.—In the South Island there were only scattered parts of Canterbury and Otago that had more than the normal rainfall. In the North Island, in addition to the areas mentioned, parts of the Auckland Peninsula had more than the average.

Temperatures.—The temperature was everywhere from one and a half to three degrees below normal. There were many severe frosts in the first half of the month, and from the 22nd to the 26th.

Sunshine.—All parts had more sunshine than usual. Nelson recorded 233.7 hours and Blenheim 218.1 hours, while the total of 208 hours at Waimate was very much above the average.

Pressure Systems.—The month began with a continuance of the same type of weather as had ruled during July. Depressions were mainly of cyclonic type, with the centres pursuing tracks which kept to the north of New Zealand. The most important of these cyclones passed Norfolk Island on the 3rd, and its passage coincided with that of a westerly depression to the southward.

On the 7th an anti-cyclone moved on to New Zealand, the highest pressures being experienced in the South Island. This anti-cyclone maintained its position until the 13th, when it began to move away eastward.

The anti-cyclone just mentioned was the precursor to a more spring-like régime. Following it, depressions, though well developed, were of the normal westerly type. From the 13th to the 15th, as the first of these depressions approached, occurred the first really mild weather for a long period.

a most grateful impression. On the 15th the northerly winds freshened and rain became widespread in western and northern districts. By the time the depression had passed on the night of the 16th almost general rains had been recorded, with heavy falls in many places. This depression had been followed in Australia by an extremely intense anti-cyclone, the barometer in South Australia approaching 30.8 inches. New South Wales and Victoria suffered a very unusually cold spell with much snow. These conditions, however, failed to reach New Zealand, the southerly actually experienced being of only slight severity.

Another rather vigorous westerly depression passed during the 21st to 22nd. Rains were fairly extensive, especially in western districts and the North Island generally. In the southerly which followed this storm snowfalls were again fairly widespread.

The last storm of the month was a double westerly depression, the primary being followed by a secondary. It was not deep as it crossed the Tasman Sea on the 26th and 27th, but on the latter day a sharp rise of pressure and a change to southerly winds extended rapidly from Tasmania across the South Tasman Sea to Southern New Zealand. By the morning of the 28th the southerly invasion had covered the South Island, but appeared to have expended itself. Over the North Island, however, the northerlies not only continued to blow, but freshened. Throughout the 28th the situation remained almost unchanged, light southerly winds prevailing to just beyond Wellington, while above them and to the northward blew a strong northerly current of warm air heavily charged with moisture. As a result, torrential rains occurred in the southern portion of the Wellington Province and adjacent parts of Cloudy Bay and the Marlborough Sounds, where the northerly winds were forced to rise over the southerly. On the high levels, and even in the town of Masterton, there was a fall of snow. On the 29th the southerlies became stronger and extended farther northward, and there were more heavy rains. Following these rains unusually severe floods occurred in the Wairarapa and Manawatu districts. From Masterton to Lake Wairarapa it was said to be the severest flood for twenty years, and losses of stock around the lake were very heavy.

The weather improved on the 30th, and the 31st was a perfect day with clear skies, mild temperatures, and little wind.
