IN pursuance and exercise of the powers and authority vested in him by the Local Authorities Empowering (Aviation Encouragement) Act, 1929, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby amend in the manner and to the extent set forth in the Schedule hereto the Order in Council dated the thirteenth day of June, one thousand nine hundred and thirty-five, consenting to the acquisition of an aerodrome-site by the Nelson Harbour Board, and published in the *New Zealand Gazette* dated the twenty-seventh day of June, one thousand nine hundred and thirty-five.

PURSUANT to section one hundred and sixty-seven of the Native Land Act, 1931, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby vary an Order in Council made on the twenty-ninth day of February, one thousand nine hundred and thirty-two, and published in the *Gazette* on the third day of March, one thousand nine hundred and thirty-two, at page 424, and affecting Paeroa East 3B 1 and other blocks, by excluding therefrom the land described in the Schedule hereto.

Amending the Code of Civil Procedure under the Judicature Act, 1908.

ORDER IN COUNCIL.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section three of the Judicature Amendment Act, 1930, His Excellency the Governor-General, with the advice and consent of the Executive Council and with the concurrence of the Right Honourable the Chief Justice and all of the other members of the Rules Committee constituted under the Judicature Amendment Act, 1930 (four of such other members being Judges of the Supreme Court), doth hereby make the following rules amending the Code of Civil Procedure set forth in the Second Schedule to the Judicature Act, 1908.

RULES.

1. These rules may be cited as the Supreme Court (Miscellaneous) Amendment Rules, 1936, and shall come into force on the day following the publication hereof in the *Gazette*.

2. The code of Civil Procedure set forth in the Second Schedule to the Judicature Act, 1908, is hereby amended as follows:—

(a) The Code is amended by inserting therein following Rule 132 thereof the following additional rule:—

“132A. The time within which the plaintiff shall file his statement of defence to the counterclaim shall be seven, ten, or fourteen days after service of the counterclaim on the plaintiff, according as the plaintiff resides not more than twenty miles, more than twenty but not more than one hundred miles, or more than one hundred miles from the office of the Court in which such statement of defence is to be filed.”

(b) Rule 148 is amended by revoking the words “costs of the original statement,” and substituting the following words: “costs of and occasioned by the original statement.”

(c) Rule 188 is hereby revoked, and the following rule substituted in lieu thereof:—

“188. Affidavits or affirmations may be sworn or made outside New Zealand in Great Britain or any other State of the British Commonwealth of Nations, or in any dependency, colony, protectorate, or mandated territory of any such State before any Judge, Court, Notary Public, or person lawfully authorized to administer oaths in such country.

“188A. Affidavits or affirmations may be sworn or made in any country outside the places specified in Rule 188 before any British Minister or Consular Officer exercising his functions in that country.

“188B. Judicial notice shall be taken of the seal or signature, as the case may be, of any Judge, Court, Notary Public, person authorized to administer oaths, or British Minister or Consular Officer, attached, appended, or subscribed to any affidavit or affirmation taken or made under the two last preceding rules.

“188c. (1) Affidavits or affirmations may in any country outside the places specified in Rule 188—

“(a) Where there is no British Minister or Consular Officer conveniently available, or

“(b) Where by the law of the country a British Minister or Consular Officer is not allowed to administer an oath—
be sworn or made before any person lawfully authorized to administer oaths in such country.

“(2) A statement in an affidavit or affirmation so sworn or made to the effect that no British Minister or Consular Officer is conveniently available, or that by the law of the foreign country a British Minister or Consular Officer is not allowed to administer an oath, shall be sufficient evidence of the fact so stated.

“188D. Judicial notice may be taken of the seal or signature of any person before whom an affidavit or affirmation is sworn or made under Rule 188c, and (if in the jurat or any part of the affidavit or affirmation it is so stated) of the fact that such person is lawfully authorized to administer oaths in such country.

"188E. Nevertheless the Court may if it thinks fit require verification by notarial certificate or the certificate of a British Minister or Consular Officer or by such evidence or means as the Court may think fit of any one or more of the following matters:—

- "(a) The seal or signature of the person before whom the affidavit or affirmation was sworn or made;
- "(b) The fact that such person was lawfully authorized to administer oaths in such country;
- "(c) The fact that no British Minister or Consular Officer was conveniently available;
- "(d) The fact that by the law of the foreign country a British Minister or Consular Officer is not allowed to administer an oath.

"188F. For the purposes of Rules 188 to 188E hereof "British Minister" includes an Ambassador, Envoy, Minister, Chargé D'Affaires, and Secretary of Embassy or Legation; and "Consular Officer" includes a Consul-General, Consul, Vice-Consul, Acting Consul, Pro-Consul, and Consular Agent."

(d) Rule 319 is amended by deleting the words "six months after judgment has been signed in the action," and substituting the following words: "six months after such order has been sealed."

(e) The Code is amended by inserting therein following Rule 414 thereof the following additional rule:—

"414A. Except where express provision is made to the contrary, relief sought by petition shall be obtained by moving upon the petition for an order in terms of the prayer of the petition or for such other order as the Court may consider proper. Such motion shall be set down and moved in manner and time hereinbefore provided, and notice thereof if necessary shall be served in accordance with the foregoing provisions of this part."

(f) The Code is amended by inserting therein following Rule 417 thereof the following additional rule:—

"417A. Any order made by a Judge sitting in Chambers (except Chambers for Court) shall be either (a) personally signed by the Judge who made such order, or (b) signed by the Registrar under the Registrar's seal of office. In every case the form of order shall be headed with the words 'In Chambers' and contain the words 'it is ordered by,' followed by the name of the Judge making such order."

(g) Rule 466 is amended by inserting therein after the words "under Rule 464" the following words: "or Rule 465."

(h) The Code is amended by inserting following Rule 466 thereof the following additional rules:—

"466A. Any person claiming the issue of a writ of certiorari in cases not falling within the provisions of Rule 465 may in his discretion, but without prejudice to his right to adopt any other form of procedure, follow the procedure set out in Rule 466.

"466B. In a statement of claim under Rule 466 a claim may be made for more than one of the special forms of relief referred to in Rules 466 and 466A."

(j) Rule 467 is amended by deleting the words "under the last preceding rule," and substituting the following words: "under Rules 466 and 466A."

(k) Rules 468 and 468A are revoked, and the following substituted:—

"468. (a) Every such motion shall be made in manner hereinbefore provided as to motions generally subject to the succeeding clauses of this rule.

"(b) Every such motion shall be made upon notice except in cases falling within paragraphs (a) and (c) of Rule 396.

"(c) When notice of motion is served upon any person there shall be served therewith a copy under the seal of the Court of the statement of claim and a copy of every affidavit filed in support of the motion.

"(d) If by reason of the exigency of the case the provisions of Rule 395 cannot be complied with such notice must be given as the exigency of the case will allow, but the Court shall only hear the said motion at the time stated in the notice if satisfied that the exigency of the case so requires.

"(e) Any party or person against whom an order has been made *ex parte* or without full notice having been given may at any time move to rescind such order, and the foregoing provisions of this rule shall apply, *mutatis mutandis*, to a motion for rescission.

"(f) The Court on the hearing of any motion including a motion for rescission may adjourn the hearing and direct that any other

persons shall be served with notice of the motion, and may give leave to such persons to appear on the adjourned hearing of the motion, but no application for leave so to appear need be sought by a person ordered to be served with notice of the motion.

“(g) It shall not be necessary for a person moving a motion for rescission to file a statement of his defence to the statement of claim if the grounds of his motion are sufficiently set out in his notice of motion.

“(h) If any person served or directed to be served with notice of a motion is an infant, idiot, or lunatic, a guardian *ad litem* to such person shall be admitted prior to the hearing of the motion unless on account of the exigency of the case the Court shall dispense with such admission or permit such admission to be deferred.

“(j) Where a writ of mandamus or any similar remedy is sought against any person, and such person is by reason of death, resignation, or removal from office superseded in his office, then, unless the cause of action has necessarily come to an end, the proceedings shall not abate but may be continued in the name of such person or (on the application of his successor or any person interested) in the name of his successor with all necessary amendments, and any writ or order directed to or made in the name of such person shall be binding on his successor in office.”

(l) Rule 474 is revoked, and the following rule substituted in lieu thereof:—

“474. Any person applying to have an action or proceedings removed from an inferior court into the Supreme Court by virtue of any statutory authority in that behalf shall, unless otherwise provided by the statute, proceed by way of motion, and notice of such motion shall be served upon the opposite party in such action or proceeding.”

(m) Rule 561 is revoked, and the following rule substituted in lieu thereof:—

“561. Except and in so far as the Court or a Judge shall otherwise order, the plaintiff in an action on a judgment recovered in any Court other than a judgment on a bond shall not be entitled to any costs:

“Provided that this restriction shall not affect the right of any person to costs in proceedings under the Reciprocal Enforcement of Judgments Act, 1934.”

(n) Form No. 36 in the First Schedule to the Code is amended by inserting after the word “deceased” where first used the following words: “who died on or about the day of .”

NOTES ON THE WEATHER FOR FEBRUARY, 1936.

General.—February is usually a dry month, but this year not only did we have by far the wettest February hitherto recorded in New Zealand, but, except for the western and southern portions of the South Island, it is doubtful whether even in a winter month so much rain has fallen over the country as a whole. Flooding occurred at times over practically the whole of the North Island, and in parts of the Auckland Province the floods of the 1st to 2nd were of record proportions. In South Marlborough, Canterbury, and north-eastern Otago, also, there was heavy flooding. In Canterbury the floods of the 19th to 21st were the most severe since 1923, and the Ashley River rose to unprecedented heights. In addition, there was much cloudy and humid weather between the rains. In consequence of the wet weather there has everywhere been a rank growth of pasture. Stock are in good condition generally, and the milk-yield has been well maintained. For sheep the grass is too rank and soft, and lambs are not fattening well. Severe damage has been done to the wheat crop, which otherwise would have been excellent. In many cases grain, both standing and in stooks, has sprouted. Other crops are generally poor, and conditions have been extremely unfavourable for haymaking. The apple crop, however, appears to be satisfactory. White butterflies, though not so numerous as in 1934-35, were more plentiful than earlier in the summer.

Rainfall.—Over the whole of the North Island extremely wet weather prevailed, and the totals were generally about three to four times the average for February, though in places with a westerly aspect conditions were, relatively, not quite so bad as elsewhere. In Marlborough, most of Canterbury, and eastern Otago similar conditions prevailed. Most of Westland, the Mackenzie country, the interior of Otago, and Southland had less than the average rain. In South Westland there were some heavy falls.

Temperatures.—Though there were cold spells on the 7th to 8th (when considerable snow fell on the ranges of the South Island), the 19th and the 26th, the month was comparatively mild. In most cases the mean temperatures were below normal, but there were frequent exceptions to this rule. On the west coast means were generally above the average. Marlborough and most of Canterbury experienced a cold month, the departures from normal being approximately 2° F. Few frosts were reported.

Sunshine.—Invercargill, with 187.2 hours, had considerably more sunshine than usual, while Gore and Dunedin, also, were above the average. Everywhere else there were large deficiencies, 40 to 50 hours being common. It was the absence of sunshine and consequent low maximum temperatures which was principally responsible for the low mean temperatures for the month. Auckland, with 217.7 hours, had the highest registration.

Storm Systems.—During the night of the 1st and the morning of the 2nd a deep cyclone, which had originated some days before as a tropical cyclone to the north-west of the New Hebrides, rapidly increasing its speed of movement, travelled down the western side of the Auckland Peninsula and thence across the centre of the North Island and away in a south-easterly direction. In most of the Auckland Province north-easterly gales were followed, after the centre passed, by south-westerly. Elsewhere over the North Island southerly or south-easterly gales were experienced. Though short-lived, owing to the rapid movement of the storm, these winds rose to whole gale force in some exposed positions. It was probably the most violent storm ever experienced at most places in the North Island, and certainly caused more destruction than any previous one. Extremely heavy rains occurred, falls of 4 in. to 11 in. being the rule. Though there were some heavy rainfalls, principally in Marlborough, the South Island was little affected.

The remaining storms were rather complex in structure and none was severe until the centre had passed New Zealand, although heavy rains were produced. The first of these systems operated from the 6th to the 9th. On the 7th to 8th there were southerly gales; the temperature dropped sharply; snow fell on the ranges of the South Island; and there were many violent thunder and hail storms. Rain was practically general and in many places heavy. Canterbury had heavy rains on this occasion. Widespread, though brief, flooding occurred.

Another very wet period was from the 17th to the 22nd. There was no very violent storm, but the persistence of high pressure in the Chatham Islands region while depressions approached from the west led to the rainfall being very heavy especially in Canterbury, where there was severe flooding and much damage done. At Akaroa 9½ in. of rain fell between 9 a.m. and 3.30 p.m. on the 20th, and for twenty-four hours the fall was 11.73 in.

A depression which passed on the 25th deepened when to the eastward, and was followed by a severe southerly gale. Again there was heavy rain at many places.

Thunderstorms were frequent during the month and unusually violent. Several buildings were struck and some stock were killed. A hailstorm in the Nelson district on the 7th did much damage to the tobacco crop.

(b) Articles marked thus † are revised decisions. (c) The rates of duty payable on goods set out hereunder have not been shown except in the case of goods classed under Tariff Items 416, 448, and 449, and of goods admitted (under the provisions of section 11 of the Customs Amendment Act, 1927) at a rate of duty lower than that provided for in the First Schedule to the Customs Acts Amendment Act, 1934. Where goods are admitted under the provisions of section 11 aforesaid, the reduced rate is marked with an asterisk. (d) Steam-engines, gas-engines, oil-engines, and electric or other motors are not, unless otherwise indicated, to be regarded as parts of the machines with which they are imported. THE following regulations were laid before the members of the Westland Trotting Club at a meeting held on the 9th day of March, 1936, at Hokitika, with a recommendation by the Chairman of such Club, Mr. Frank McGregor, that the same be passed at once with a view to their approval by His Excellency the Governor-General in pursuance of the Gaming Act, 1908, section 33.

Mr. Frank McGregor, the Chairman of such Club, and the meeting moved, and Mr. Harry Wells seconded, and it was resolved that such regulations should be adopted and that the Chairman and Secretary be authorized to sign the same in authentication thereof.

The following are the regulations referred to:—

WESTLAND TROTTING CLUB.

REGULATIONS.

(Under the Gaming Act, 1908.)

In pursuance and exercise of the powers in that behalf contained in section 33 of the Gaming Act, 1908, and of all other powers and authorities it enabling in that behalf, the Westland Trotting Club, a racing club within the meaning of the said Act (hereinafter referred to as "the said Club"), doth hereby make the following regulations controlling the admission of persons to that part of the property situated in the district of Westland and known as the Greymouth Trotting Club's Racecourse (Victoria Park), while the said racecourse is used or occupied by the said Club for race meetings.

1. These regulations shall come into force on the date of the same being published in the *New Zealand Gazette*.

2. In these regulations the words "bookmaker," "racing club," and "race meeting" shall have the meanings ascribed to those terms respectively by section 2 of the Gaming Act, 1908.

3. The following persons shall be and are hereby excluded from the racecourse above described while the same is used or occupied by the said club for a race meeting, namely:—

(a) Bookmakers.

(b) Bookmakers' clerks, bookmakers' assistants, and bookmakers' agents.

(c) All persons under disqualification inflicted by any racing or trotting club in the Dominion of New Zealand, the Commonwealth of Australia, or elsewhere if affiliated to the New Zealand Racing Conference, or the New Zealand Trotting Conference, or the New Zealand Trotting Association.

(d) Common prostitutes and persons who habitually consort with thieves or persons who have no lawful visible means of support.

(e) Professional tipsters, persons convicted of house-breaking or pocket-picking, forgery, uttering, or possessing counterfeit coin, theft, false pretences, receiving stolen goods, mischief, assault, or any offence or crime of any kind under the Crimes Act, 1908, and also idle and disorderly persons, rogues, and vagabonds, and incorrigible rogues convicted under the Police Offences Act, 1908, and persons convicted of an offence under the Gaming Act, 1908: Provided always that the executive committee appointed by the New Zealand Racing Conference, upon being satisfied by evidence as to character and otherwise that any person who, by reason of any conviction, comes within the scope of this regulation, should have relief from the effect thereof, may grant exemption to any such person, and may at any time revoke any such exemption without notice to such person and without assigning any reason for such revocation.

The foregoing regulations of the Westland Trotting Club were made and passed by such Club on the 9th day of March, 1936, and signed by the Chairman and Secretary.
