

Revoking the Prohibition of the Exportation of certain Goods. (C. No. 153.)

N pursuance and exercise of the powers conferred on him by the League of Nationa Source (The formation of National Source) L by the League of Nations Sanctions (Enforcement in New Zealand) Act, 1935, and the League of Nations (Export-ation of Goods) Regulations, 1935, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby revoke the Orders in Council enumerated in the Schedule hereto prohibiting, save

with the consent of the Minister of Customs, the exportation of certain goods to countries other than Ethiopia (Abyssinia) or any part of the British dominions, such revocation to take effect on the fifteenth day of July, one thousand nine hundred and thirty-six.

I N pursuance and exercise of the powers and authorities conferred on him by the League of Nations Sanctions (Enforcement in New Zealand) Act, 1935, and the League of Nations Sanctions (Importation of Goods) Regulations, 1935, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby revoke the Order in Council made on the eleventh day of November, one thousand nine hundred and thirty-five, and published in the *Gazette* on the eighteenth day of the same month at page 3328, prohibiting the importation into New Zealand, save with the consent of the Minister of Customs, of goods of Italian origin, such revocation to take effect on the fifteenth day of July, one thousand nine hundred and thirty-six. six.
