Board of Trade (Price of Oranges) Regulations, 1936.

GALWAY, Governor-General. ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 25th day of November, 1936.

Present :

THE RIGHT HON. M. J. SAVAGE PRESIDING IN COUNCIL.

N pursuance and exercise of the power and authority conferred L upon him by the Board of Trade Act, 1919, and of every other power and authority enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby, on the recommendation of the Minister of Industries and Commerce, make the following Board of Trade regulations for the regulation and control of prices of Jamaican oranges.

#### **REGULATIONS.**

1. These regulations may be cited as the Board of Trade (Price of Oranges) Regulations, 1936.

2. These regulations shall come into force on the day following notification in the Gazette of the making thereof.

3. In these regulations, unless the context otherwise requires,---

"Sale by wholesale" means every sale made to any person for the purpose of re-sale : "Sale by retail" means every sale other than a sale made by

wholesale, and includes a sale made to any person for any purpose other than re-sale:

"Oranges" means Jamaican oranges: "Case" means the Jamaican export means the Jamaican export case having internal dimensions of 25 in. by 12 in. by 12 in. with a centre partition of  $1\frac{1}{4}$  in. in thickness.

4. The price of oranges in the localities mentioned in the First Schedule hereto when sold by way of sale by wholesale shall not exceed thirty-two shillings and sixpence (32s. 6d.) per case.

5. In respect of all other localities in the Dominion the price of oranges when sold by way of sale by wholesale shall not exceed thirty-two shillings and sixpence (32s. 6d.) per case together with the usual transport charges in the locality mentioned in the First Schedule hereto nearest to that other locality as well as such incidental charges (including commission) as may be usual.

6. Notwithstanding anything in the provisions of the last preceding clause hereof, this Order in Council shall not apply to the locality mentioned in the Second Schedule hereto.

7. The price of oranges in the localities mentioned in the First Schedule hereto when sold by way of sale by retail shall not exceed-One shilling (1s.) for four (4) oranges of 150 count per case; one shilling (1s.) for five (5) oranges of 176, 200, and 216 count per case; one shilling (1s.) for six (6) oranges of 226 and 252 count per case; one shilling (1s.) for seven (7) oranges of 288 and 300 count per case.

#### SECOND SCHEDULE.

The City of Auckland; the Boroughs of Birkenhead, Devonport, Northcote, Takapuna, New Lynn, Newmarket, Mount Albert, Mount Eden, Onehunga, One Tree Hill, and Otahuhu; the Town Districts of Ellerslie, Glen Eden, Henderson, Howick, Manurewa, Papakura, Papatoetoe; the Road Districts of Mount Roskill and Mount Wellington; and all other places within a radius of twenty-one miles from the Auckland Central Post Office.
