PURSUANT to the Bobby Calf Marketing Regulations, 1938, I, Walter Nash, Minister of Marketing, being satisfied that sufficient majorities of the producers in the respective areas of land defined in the Schedule hereto are desirous that such areas should be declared to be pool areas for the marketing of bobby calves, do hereby declare the areas of land defined as aforesaid to be Bobby Calf Marketing Pool Areas for the purposes of the said regulations under the respective names set out in the said Schedule before the description of each area, and I do hereby further declare that this notice shall take effect on the 29th day of July, 1938.

# SCHEDULE.

FIRST PART.

That area of land lying entirely within the County of Waikato and bounded by a line commencing at the point where the Main Trunk Railway line passes the western corner of Section 35, Block IV, in the Whangamarino Parish, and following the said Main Trunk line in a northerly direction to the point where it crosses the Maramarua River on the boundary of the Waikato County; and thence from this point following the southern bank of the Maramarua River up-stream to the north-eastern corner of Block VII in the Maramarua Survey District; thence from this point in a straight line across country to the Puketoka Trig. Station No. 1530; and thence continuing in the same easterly direction to the Pukekamaka Trig. Station No. 1531 on the eastern boundary of the Waikato County; thence from this point following the said boundary in a southerly direction to the point where it meets the northeastern corner of Section 483 in Block III in the Whangamarino Parish; thence from this point in a straight line across country in a westerly direction to meet again the western corner of Section 35, Block IV, the original point of commencement.

# SECOND PART.

Maungatapere Bobby Calf Marketing Pool Area.

On the Maungatapere-Kaikohe Main Highway as far as the twin bridges at Awarus and generally to the north and south of that highway, comprising the districts of Nukutawhiti, Pakotai, Parakao, Titoki, Poroti, and Maungatapere, the boundaries on connecting roads being at—

The viaduct on the Parakao-Kirikopuni Road: The Houto School on the Houto-Kirikopuni Road: The Aponga Stream on the Titoki-Purua Road: The bridge at Malone's on the Titoki-Ruatangata Road:

On the Maungatapere-Dargaville Main Highway at the Whangarei County boundary,—that is, the Waiotama Bridge—and generally to the east and west of that highway and comprising the districts of Otuhi, Wheki Valley and Wheki this Valley, and Whatitiri:

On the Maungatapere-Otaika Road at the culvert approximately one mile and three-quarters from Maungatapere:

On the Maungatapere-Whangarei Main Highway at the Maunu Hall:

In the Kara-Kokopu district, all that area served by the Poroti-Maunu Road, the boundary on the connecting road to Ruatangata being at Cowan's Road Corner: This area being generally that zoned to the Maungatapere Cooperative Dairy Co., Ltd., by the Executive Commission of Agriculture as their cream-collection area.

That area lying within the Counties of Whangarei and Otamatea as zoned by Orders Nos. 3/6/7/A/8/8A/10 made and issued by the Executive Commission of Agriculture under and in pursuance of the Dairy Supply Regulations of 1936 as the cream-collection area of the Whangarei Co-operative Dairy Co., Ltd.

## SIXTH PART.

Waipu Bobby Calf Marketing Pool Area.

That area lying within the Whangarei County as zoned by Orders Nos. 8/8a/9/21 made and issued by the Executive Commission of Agriculture under and in pursuance of the Dairy Supply Regulations of 1936 as the cream-collection area of the Waipu Co-operative Dairy Co., Ltd.

## SEVENTH PART.

Ruawai Bobby Calf Marketing Pool Area.

That area of land lying within the North Auckland District as zoned by Orders Nos. 11/11a made and issued by the Executive Commission of Agriculture under and in pursuance of the Dairy Supply Regulations of 1936 as the cream-collection area of the Ruawai Co-operative Dairy Co., Ltd.

#### EIGHTH PART.

Rangitaiki Plains Bobby Calf Marketing Pool Area.

All that area lying entirely within Whakatane County and commencing from a point of the Whakatane Heads on the East Coast foreshore and from this point continuing up-stream on the western bank of the Whakatane River to the point where this river forms the boundary-line of Section No. 18 of Block V in the Upper Whakatane Survey

District; thence taking a straight line across country in a westerly direction to meet the boundary of Section No. 31 in Block IV; thence taking a straight line across country in a southerly direction to the Te Tawa Trig. Station No. 2070; thence continuing in the same direction to the Kaipurapura Trig. Station No. 2072; thence continuing the line in a south-westerly direction to the Hikurangi Trig. Station No. 2121; thence continuing in the same direction to the Tawhiuau Trig. Station No. 2120 on the boundary-line between the Counties of Whakatane and East Taupo; thence continuing along this boundary-line as forming the boundary of the Whakatane County in a westerly direction; thence in a northerly direction to meet the sea-coast; thence continuing along the foreshore to again meet the Whakatane Heads, the original point of commencement.
