PURSUANT to the Bobby Calf Marketing Regulations 1939, I, William Lee Martin, acting for the Minister of Marketing, being satisfied that a sufficient majority of the producers in the area of land defined in the Schedule hereto are desirous that such area should be declared to be a pool area for the marketing of bobby calves, do hereby declare such area of land, defined as aforesaid, to be a Bobby Calf Marketing Pool Area for the purposes of the said regulations under the name set out in the said Schedule, and I do hereby further declare that this notice shall take effect on the 25th day of July, 1939.

SCHEDULE.

MAKINO-HALCOMBE BOBBY CALF MARKETING POOL AREA.
ALL that area of land lying entirely within the Counties of Manawatu and Oroua and bounded by a line commencing at the point of the boundary-line between the two counties at the Borough of Feilding; thence from this point continuing in a westerly direction along the Sanson Road to the point where it joins the Halcombe-Palmerston North Road; thence from this point continuing along the latter road to the point of the junction of Cemetery Road; thence continuing along Cemetery Road in a westerly direction to the point where it meets the north-eastern corner of Section 5, Block XVI, Ngitoto Survey District; thence from this point continuing along the northern boundary of Sections 5, 4, and 1, Block XVI, Ngitoto Survey District, to meet the eastern bank of the Rangitikei River; thence continuing along the eastern bank of the river upstream to the point of the boundary-line between the Oroua and KIWITEA Counties; thence continuing along this boundary-line in an easterly and thence south-easterly direction to meet the western bank of the Oroua River at Section XVI, Block D, Manchester District; thence following the western bank of the said river downstream to the point where it meets the eastern boundary of the Borough of Feilding; thence from this point continuing along the southern boundary of Feilding to meet the boundary-line between the Manawatu and Oroua Counties, the original point of commencement.

SCHEDULE.

WOODVILLE BOBBY CALF MARKETING POOL AREA.
ALL that area of land lying entirely within the Counties of Woodville and Pahiatua and bounded by a line commencing at the point where the boundary-line between the Woodville and Pahiatua Counties meets at the Manawatu Gorge in the south-east corner of Block IV, Gorge Survey District; thence from this point crossing the river into the Pahiatua County to embrace Sections 18 and 19 of Ferry Reserve; thence again crossing the Gorge to the Woodville County at Ballance Bridge; thence from this point following the boundary-line between the Woodville and Pahiatua Counties along the northern bank of the Manawatu River in a south-easterly direction; thence leaving the river bank and continuing along the county boundary in an easterly direction to the point where it forms the western boundary of Section 50, Ottawa District; thence from this point continuing in a north-westerly direction along the Otawahao Road to the point where it joins River Road; thence from this point taking a straight line across country in an easterly direction to the south-western corner of Block IX; thence from this point continuing along the southern boundary of Sections 5 and 4, Block XI, Woodville Survey District, to the point where the boundary of Section 4 meets the Woodville-Matahiwi Road; thence continuing along this road in a northerly direction towards Matahiwi to the point where it is joined by Price Road, taking within this distance all farms on both sides of the road having direct access; thence from this point taking a straight line across country in a north-westerly direction to meet the north-eastern corner of Section 12, Block II, Woodville Survey District; thence continuing along the northern boundary of the said Section 12; thence along the northern boundary of Section 7 to the eastern boundary of Section 16, Block II, Woodville Survey District; thence from this point taking a straight line in a south-westerly direction across country to Trig. Station 60A on the boundary-line between the Pohangina and Woodville Counties; thence from this point continuing along the eastern boundary of Block VII and Block IV, Gorge Survey District, to the south-eastern corner of Block IV at the Manawatu Gorge, the original point of commencement.
