#### ORDER IN COUNCIL.

At the Government House at Wellington, this 3rd day of April, 1940.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Public Works Act, 1928, and the Electric-power Boards Act, 1925, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth, subject to the terms and conditions set forth in the First Schedule hereto, hereby grant to the Bay of Islands Electric-power Board (hereinafter referred to as "the licensee") a license which shall become effective on a day hereinafter specified to obstruct, impound, or divert the waters of the Keri Keri River (hereinafter referred to as "the said stream") in the Keri Keri Survey District in the North Auckland Land District, and to take and use therefrom for the purpose hereinafter set forth a stream of water not exceeding twenty-five cubic feet per second at any one time, and, further, for the purposes of section seventy-six of the Electric-power Boards Act, 1925, doth hereby authorize the licensee to use and maintain the electrical works herein authorized, and, further, with the consent of the licensee doth hereby revoke the Order in Council described in the Second Schedule hereto as from the day on which this Order in Council becomes effective.

#### FIRST SCHEDULE.

##### 1. IMPLIED CONDITIONS.

The conditions directed to be implied in all licenses by the Electrical Supply Regulations, 1935, and the Electrical Wiring Regulations, 1935, and by Regulation 6 of the Water-power Regulations, 1934, shall be incorporated in and shall form part of this license except in so far as the same may be inconsistent with the provisions hereof.

##### 2. LICENSE SUBJECT TO REGULATIONS.

This license is issued under the Water-power Regulations, 1934, and the Electrical Supply Regulations, 1935, and the Electrical Wiring Regulations, 1935, and is subject thereto and to any regulations made or to be made in amplification or amendment thereof or in substitution thereof: Provided that the licensee shall not by virtue of this clause be required, except in the normal course of alteration, repair, or maintenance, to reconstruct in conformity with the regulations hereinbefore mentioned any electric lines or works which conformed to the regulations in force at the time of the construction thereof.

##### 3. UTILIZATION OF WATER AND LOCATION OF HEADWORKS.

Water shall be used under the license solely for the purpose of generating electricity and shall be taken from the said stream at the headworks as indicated on the plans marked P.W.D. 75011 and 75012, deposited in the office of the Minister of Public Works at Wellington.

##### 4. GENERAL DESCRIPTION OF WORKS.

The licensee is hereby authorized subject to the conditions herein contained, to maintain and use the following works for the purposes of this license, the position of the said works being indicated on the said plans P.W.D. 75011 and 75012 :—

- Headworks consisting of weirs and necessary intakes.
- Races, penstocks, and pipe-lines leading from such weirs to the power-house hereinafter referred to; also tail-race from the power-house to the said stream.
- Power-house with all necessary equipment for generating electricity.

##### 5. SYSTEM OF SUPPLY.

The system of supply shall be as described in paragraphs (a) and (f) of clause 21-01 of the Electrical Supply Regulations, 1935.

The generating voltage shall be 400 volts between terminals and shall be transformed up to 11,000 volts between phases for transmission purposes.

##### 6. LICENSEE NOT TO INCREASE EXISTING CAPACITY OF PLANT.

The licensee shall not, without the previous consent of the Minister of Public Works first had and obtained in writing, increase the generating capacity of the works beyond its present capacity which for the purposes of this clause shall be deemed to be 88 kilowatts or 110 kilovolt amperes.



#### 7. ELECTRICAL ENERGY OUTPUT OF GENERATING PLANT TO BE MAINTAINED.

The licensee shall operate the generating plant in such a manner that the daily capacity factor as hereinafter defined shall not, on those days on which the generating plant is operating be less than 50 per centum, and that the yearly capacity factor as hereinafter defined shall not be less than 38 per centum: Provided always that a sufficient supply of the water hereby authorized is available to the licensee in terms of this license: Provided further that the plant shall be operated daily except when undergoing repair or normal overhaul.

The Inspecting Engineer shall have full and free access at all times to the licensee's daily log-sheets and other records for the purpose of checking and calculating the daily and annual capacity factors: Provided further that if the generating plant is automatic and unattended the licensee shall at its own expense install suitable recording instruments to the satisfaction of the Minister of Public Works.

It is hereby agreed and declared that the intention of this clause is to restrain the use of the works as a means of altering the normal relationship of payment to energy supplied in respect of electrical energy received by the Board from the Minister of Public Works under contracts either existing or future while at the same time providing for the normal operation of the works; further, it is agreed that the breach of the intention of this clause by the licensee shall entitle the Governor-General to cancel this license forthwith.

For the purposes of this condition the term "daily capacity factor" shall mean the ratio expressed as a percentage of the number of kilowatt hours generated by the generating plant in any day of twenty-four hours commencing at midnight, to the number two thousand one hundred and twelve.

For the purposes of this condition the term "annual capacity factor" shall mean the ratio expressed as a percentage of the number of kilowatt hours generated by the generating plant in any year ended thirty-first day of March to the number seventy-seven thousand and eighty-eight.

#### 8. DAY ON WHICH ORDER TO TAKE EFFECT.

This license is issued pursuant to an Order in Council authorizing the purchase of certain electrical works by the licensee from the Alderton Utility Company, Limited, in pursuance of an agreement dated the 20th day of December, 1939, between the Alderton Utility Company, Limited, of the one part and the Bay of Islands Electric-power Board of the other part (of which agreement a copy is deposited in the office of the Minister of Public Works) and shall take effect on the day when the works vest in the Board in pursuance of that agreement.

#### 9. DURATION OF LICENSE.

This license shall, unless sooner determined, continue in force until the 5th day of August, 1950.

#### 10. RENTAL.

For the purposes of assessing the rental or annual sum payable in respect of this license in accordance with the Water-power Regulations, 1934, the licensee may install a suitable maximum demand indicator to the satisfaction of the Inspecting Engineer of the Public Works Department, and, failing such installation, the rental shall be determined on the maximum capacity of the generating plant installed. The present plant is rated at 88 kilowatts.

#### 11. CHARGES FOR ELECTRICAL ENERGY.

The licensee shall not in respect of electrical energy generated under the authority of this license make any charge exceeding the corresponding charge which the licensee may from time to time be duly authorized to make in respect of electrical energy obtained by the licensee from other sources and distributed within the Bay of Islands Electric-power District.

#### SECOND SCHEDULE.

THE Order in Council dated the 5th day of August, 1929, and published in the *Gazette* on the 8th day of the same month at page 2027, authorizing the Alderton Utility Company, Limited, to use water from the Keri Keri River for the purpose of generating electricity and to erect and use certain electric lines.

2. The Chairman shall have an original as well as a casting vote, and shall hold office until the election of his successor.

3. Special meetings may be convened by the Chairman, provided that two days' notice of such meeting be given to each member, specifying the business to be transacted at such special meeting; and no other business than that so specified shall be transacted at such meeting.

4. Any three members of the Board shall form a quorum. Any meeting may be adjourned from time to time.

5. All questions shall be determined by the majority of votes of the members of the Board present at the meeting.

6. If at any meeting the Chairman is not present at the time appointed for holding the same, the members present shall choose one of their number to be chairman of such meeting.

7. If by resignation, death, incapacity, or otherwise the seat of any member shall be or become vacant, or if any member absents himself, without reasonable cause, from three consecutive meetings of the Board, the Governor-General shall have power to appoint any other person to be a member of the Board in his stead.

8. The Board shall prepare and submit at an annual meeting to be held in the month of April in each year a report of the proceedings of the Board for the previous year ending on the thirty-first day of March, together with a statement of the receipts and expenditure of the Board for such year. A copy of every such report and statement, certified by the Chairman to be correct, shall be sent to the Minister charged with the administration of the Scenery Preservation Act, 1908, as soon as possible after each annual meeting.

9. The Board shall control the said reserves in accordance with the provisions of the Scenery Preservation Act, 1908, and of the regulations made thereunder.

*Open Season for Imported Game and Native Game in Hawke's Bay Acclimatization District.*

**I**N exercise of the powers vested in him by the Animals Protection and Game Act, 1921-22, the Minister of Internal Affairs of the Dominion of New Zealand, doth hereby declare open seasons for the taking or killing of imported game and/or native game of the kinds hereinafter specified in the Hawke's Bay Acclimatization District as described in the *New Zealand Gazette* No. 17 of 12th March, 1925, at page 750, except in the areas described in Condition No. 9 hereof during the periods set forth in each case and subject in all cases to the conditions set out hereunder:—

1. Season for cock pheasants, Californian and Australian quail: 4th May to 31st July, 1940 (both days inclusive).

2. Season for mallard duck, grey duck, spoonbill duck, paradise duck, black swan, and pukeko: 4th May to 18th May, 1940 (both days inclusive).

**CONDITIONS.**

1. No person shall commence shooting earlier than one hour before sunrise or continue shooting later than one hour after sunset on any day during the open season concerned.

2. (a) No person shall use live birds of any species as decoys nor shall use more than fifteen artificial decoys at any one time, and no such artificial decoys shall be spread over a greater area than thirty yards square.

(b) No person shall place any artificial decoys within 100 yards of the nearest of any other artificial decoys set out by any other person.

(c) No person shall in any place, during the period in that place of the open season hereby declared use in connection with the taking or killing of imported game and/or native game any form of decoying game by the aid of corn, wheat, oats, barley, maize, or any other grain or any products of grain, or any other food placed by any person in or near the margin of any river, stream, lagoon, pond, swamp, estuary, or other water.

3. No person shall use or cause to be used any motor-vehicle in connection with the taking or killing of imported game and/or native game: Provided that this condition shall not be so construed as to prohibit the use of any motor-vehicle for the purpose of travelling either generally or to or from a rendezvous.

4. No person shall use or cause to be used for the purpose of taking or killing any imported or native game any unmoored floating stand, pontoon, hide, mai-mai, or loo, or any boat artificially dressed or covered in any way.

5. No person engaged in shooting from any shelter, mai-mai, mudhole, boat, louvre, or other contrivance shall use more than one gun: Provided that a person so engaged may have a second gun in a condition not immediately suitable for use, and held for use only in the event of the first gun becoming damaged or otherwise unfit for use.

6. Licenses to take or kill such imported game and native game within the Hawke's Bay Acclimatization District will be issued to any person on payment of the sum of thirty

shillings (30s.) each: Provided that licenses to take or kill imported game and native game within the said district will be issued to persons receiving an age benefit or a miner's benefit under the Social Security Act, 1938, on payment of the sum of twenty shillings (20s.) each; and the Secretary of the Hawke's Bay Acclimatization Society, or any person authorized by such Secretary in that behalf, is hereby authorized to sign and issue the said licenses.

7. No person shall in any one day take or kill more than—

(a) Twenty-five head in all of cock pheasants, grey duck, shoveller duck, mallard duck, paradise duck, and black swan;

(b) Five head of cock pheasants;

(c) Fifteen head in all of mallard duck, grey duck, shoveller duck, and paradise duck;

(d) Five head of pukeko;

(e) Two head of paradise duck; and

(f) Five head of black swan.

8. No person shall take or kill imported or native game on the 4th, 5th, or 6th days of May, 1940, while occupying any stand, hide, loo, or position as commonly used by duck-shooters (hereinafter referred to as "a stand") which has been duly claimed by any other license-holder in accordance with the following provisions:—

(a) A stand may be claimed by the planting thereon at any time after noon on the 20th day of April, 1940, of a stake with a board attached having plainly marked thereon the name and address of the claimant and the number of his license.

(b) No person shall claim more than one stand.

(c) No stand shall be claimed on or within 100 yards of a stand which has already been duly claimed by any other person, except with the consent of such last-mentioned person:

Provided, however, that any stand which is not occupied by the claimant within half an hour after sunrise on any of the aforesaid days may be occupied on that day by any other license-holder:

Provided further that nothing in this clause contained shall be deemed to affect in any way whatsoever the rights of owners or occupiers of any lands in respect of shooting on such lands.

9. Excepted area wherein imported game and/or native game shall not be taken or killed during the open season:—

All that parcel of land containing by admeasurement 2,428 acres 3 roods 29 perches, being Sections 1, 2, 3, and 4, Puketitiri Bush, and Sections 5, 7, 10-25, 33, 34, 35, 40-46, 49, 51, 53, 54, 56, 57, part 60, and that part of Section 9A, marked as Lot 1, D.P. 2217, all in Block XIV, Pohui Survey District, and parts Sections 6 and 7 of Puketitiri Reserve, being parts of Blocks 96 and 115, Patoka Crown Grant District, situated in Blocks XIV and XV, Pohui Survey District, and Blocks II and III, Patoka Crown Grant District, being the property of John Holt, Ltd.

(5) That the said special loan and the interest thereon shall be secured upon the Board's General Fund and upon all contributions payable to it by and all rates leviable by the local authorities thereof to secure the payment of such contributions upon the City of Auckland (portion) and the Suburban Boroughs of Mount Eden, Mount Albert, Newmarket, and One Tree Hill (portion), and the Road District of Mount Roskill (portion).
