

A PROCLAMATION. WHEREAS the land described in the Schedule hereto forms part of land taken for the purposes of the Hurunui-Waitaki Railway, and it is considered desirable to allocate such land to the purposes of a street : Now, therefore, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by section two hundred and twenty-six of the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto shall, upon the publication hereof in the New Zealand Gazette, become a street, and that the said street shall be under become a street, and that the said street shall be under the control of the Riccarton Borough Council, and shall be maintained by the said Council in like manner as other public highways are controlled and maintained by the said Council.

WHEREAS the Opotiki Borough Council (hereinafter called "the said local authority"), being desirous of raising the sum of nine hundred and fifty pounds (£950) by a loan to be known as "Plunket Rooms Loan, 1940" (herein-after called "the said loan"), for the purpose of erecting Plunket and rest-rooms at Opotiki has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is now expedient that the precedent consent of the Governor-General in Council as required by the said Act should be given to the raising of as required by the said Act should be given to the raising of the said loan :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

W HEREAS the land described in the Schedule hereto was by Warrant published in Gazette of the³ thirty-first day of March, one thousand nine hundred and ten, permanently reserved for a site for a public hall and library: And whereas it is **expedient** that the control of the said reserve should be vested in a special Board as hereinafter provided;

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in exercise of the powers and authorities conferred upon him by section seventeen of the Public Reserves, Domains, and National Parks Act, 1928, doth hereby vest the control of the reserve described in the Schedule hereto, for the period of five years from the date hereof (unless previously amended or revoked under the said Act), in the under-mentioned persons, namely,--

William O'Donnell, Alexander Silitoe Barber Tate, Colin Telfer, Walter Pywell, Edward Ferdinand Gruebner, William James McVeagh, and Frank Edgar Southcombe

who are hereby constituted for that purpose a special Board by the name of the Owhango Public Hall and Library Board (herein referred to as "the Board"), with the powers and subject to the conditions herein-after contained, that is to say,—

1. The Board shall meet for the transaction of business on the second Tuesday of each month at half-past seven o'clock p.m. at the Owhango Public Hall, or at such other time or place as may from time to time be fixed by the Board. The first meeting shall be held on Monday, the twenty-sixth day of August, one thousand nine hundred and forty, at eight o'clock p.m.

2. The members of the Board shall at their first meeting, and thereafter at the annual meeting herein-after mentioned, elect one of themselves to be Chairman, who may join in the discussion, and shall have an original as well as a casting vote. The Chair-man shall hold office until the election of his successor.

3. Special meetings may be convened by the Chairman, provided that two days' notice of such meeting be given to each member, specifying the business to be transacted at such special meeting; and no other business than that so specified shall be trans-acted at such meeting acted at such meeting.

4. Any four members of the Board shall form a norum. Any meeting may be adjourned from time quorum. to time.

5. If at any meeting the Chairman is not present at the time appointed for holding the same, the members present shall choose one of their number to be chairman of such meeting.

6. If by resignation, death, incapacity, or otherwise the seat of any member shall be or become vacant, or if any member absents himself without reasonable cause from three consecutive meetings of the Board, the Governor-General shall have power to appoint any other person to be a member of the Board in his stead.

7. All questions shall be determined by the majority of votes of the members of the Board present at a meeting.

8. The Board shall have prepared and submitted at an annual meeting held in the month of April in each year a report of the proceedings of the Board for the previous year ending on the thirty-first day of March, together with a statement of the receipts and expen-diture of the Board for such year. A copy of every such report and statement, certified by the Chairman to be correct, shall be sent to the Minister of Lands as soon as possible after each annual meeting. as soon as possible after each annual meeting.

9. The Board shall control the said reserve and the building erected thereon for the purposes of a public hall and library, and shall also afford settlers and residents of Owhango and the surrounding district such facilities for meeting within the said hall as may from time to time be determined by the Board; provided that the Board shall have power to fix reasonable charges for the use of the said hall.

PART III.-MINE-SWEEPING OPERATIONS

Amendment :-

H.M. Vessels engaged in mine-sweeping operations or exercises are hampered to a considerable extent in their manoeuvring powers.

Vessels must keep clear of Mine-sweepers.

With a view to indicating the nature of the work on which they are engaged, these vessels will show the signals herein-after mentioned. For the public safety all other vessels, whether steamers or sailing craft, should endeavour to keep out of the way of vessels flying these signals and not approach them inside the distances mentioned herein, specially remembering that it is dangerous to pass between the vessels of a pair or group sweeping together.

1. Signals shown by Day.

When towing sweeps.

All vessels towing sweeps are to show :-

- By day.—A black ball at the fore masthead and a black ball at the yardarm on the side or sides on which it is dangerous for vessels to pass.
 By night.—All round green lights instead of the black balls, and in a similar manner.
 (b) Vessels or formations showing these signals are not to be corrected parts for 500 methods.
- to be approached nearer than 500 yards on either beam and ships are not to cross astern at a less distance than 1,000 yards.
- In no circumstances is a ship to pass through a formation of mine-sweepers.
 (c) Mine-sweepers should be prepared to warn merchant vessels who persist in approaching too close by means of any of the appropriate signals from the Merchant Navy Code or the International Code of Simals of Signals.

Note.—The above amendment cancels "Part III.—Mine-sweeping Operations" in former notices.
