Parts of the Defence Forces called out for Military Service.

[L.S.] GALWAY, Governor-General.

A PROCLAMATION.

WHEREAS by the Defence Emergency Regulations 1939, the Governor-General may by Proclamation call out the Defence Forces or any part thereof for military service:

And whereas, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, in pursuance of the powers and authorities conferred on me by the Defence Emergency Regulations 1939, and of all other powers and authorities enabling me in that behalf, do hereby call out for military service for purposes of defence in New Zealand, as from the dates stated, the following parts of the Defence Forces, namely,-

- (1) As from 7th January, 1941:-
 - 12th Field Regiment, New Zealand Artillery, comprising
 - The 37th and 38th Batteries, and the 30th Light Aid Detachment, New Zealand Ordnance Corps Detachment, (attached).
 - 22nd Field Company, Corps of New Zealand Engineers. 4th Signals Company, New Zealand Corps of Signals.
 - Headquarters, 7th New Zealand Infantry Brigade. 2nd and 3rd Battalions, The Auckland Regiment (Countess of Ranfurly's Own).
 - 2nd Battalion, The Wellington Regiment (City of Wellington's Own).
 - 2nd Battalion, The Hawke's Bay Regiment.
 - 2nd Battalion, The Canterbury Regiment.
 - 1st and 2nd Battalions, The New Zealand Scottish Regiment (personnel not already called out by Proclamation dated 1st August, 1940, published in Gazette Extraordinary dated 2nd August, 1940).
 - 1st, 2nd, and 3rd Provost Companies, Corps of New Zealand Military Police.

Oil Fuel Retail Hours (Rotorua) Order 1940, No. 3.

PURSUANT to the Oil Fuel Retail Hours Emergency Regulations 1940, and pursuant to a requisition in writing received in that behalf, I, Patrick Charles Webb,

Minister of Labour, do hereby direct as follows:—

1. This Order may be cited as the Oil Fuel Retail Hours (Rotorua) Order 1940, No. 3.

2. This Order shall come into force on the day of the gazetting and shall remain in force until the 30th depends on the control of the state of the state

gazetting hereot and shall apply to all establishments engaged in the sale by retail of oil fuel and situate within six miles of the post-office in the Borough of Rotorua.

4. On and after the coming into force of this Order all such establishments except as hereinafter provided shall on every Friday be opened for the sale of oil fuel from 8 a.m. till 9 p.m. and closed at all other times on every Friday and on every Monday, Tuesday, Wednesday, Thursday, and Saturday be opened for the sale of oil fuel from 8 a.m. till 6 p.m. and closed at all other times on the said respective days.

5 This Order shall not apply to the period of twenty-one

6 p.m. and closed at all other times on the said respective days.
5. This Order shall not apply to the period of twenty-one consecutive days commencing on and including the Monday immediately preceding Christmas Day, or to the period of fourteen consecutive days commencing on and including the Monday immediately preceding Good Friday, or to Anniversary Day or to the Saturday immediately preceding Anniversary Day when such day is observed on a Monday.
6. In every successive week, except as provided in clause 5 hereof, commencing upon the coming into force of this Order two of the establishments hereinafter named shall in the weekly rotation hereinafter set out remain open on every Monday, Tuesday, Wednesday, Thursday, and Saturday till 9 p.m. in lieu of 6 p.m.
