237. Tropical Clothing, Sun Helmets, White Canvas Shoes, and White Uniform Clothing.—A gratuitous issue of three tropical shirts (for chief petty officers, confirmed petty officers, and other ratings not dressed as seamen), or three tropical singlets (for ratings dressed as seamen), three pairs of drill shorts, and one pair of white canvas shoes with leather soles is to be made to each permanent rating on first being drafted to a seagoing ship. A similar issue is to be made to loan ratings on joining a seagoing ship, provided that an issue at New Zealand Government expense has not already been made. Subsequent issues of tropical clothing are to be made on the same scale after three years' actual service in seagoing ships of the Royal New Zealand Navy or in other ships employed in the tropics, provided that the rating has not less than one year to serve in the Royal New Zealand

other ships employed in the tropics, provided that the rating has not less than one year to serve in the Royal New Zealand Navy. For the purpose of this regulation a seagoing ship is any ship which is liable for service in the tropics as defined in Navy Orders issued by the Naval Board.

1 (a). During the present emergency the scale of tropical clothing issued gratuitously and referred to in the previous paragraph is to be reduced to two tropical shirts (for chief petty officers, confirmed petty officers, and other ratings not dressed as seamen), or two tropical singlets (for ratings dressed as seamen), two pairs of drill shorts, and one pair of white canvas shoes with leather soles. This free issue is applicable to all mobilized ratings.

2. Prohibition of Stock Traffic.

- (1) No person shall drive, or cause to be driven, or allow any horse, ass, mule, goat, sheep, ox, or other cattle not in harness or yoke upon or along the said highway except with the prior permission in writing of the Main Highways Board or a Transport Department Inspector, and then only in all represents with any condition imposed in granting such respects with any condition imposed in granting permission.

 (2) If any person is charged with an offence under sub-clause (1) of this clause it shall be a sufficient defence to the charges if such person proves that the cattle or sheep in question were being driven to or from some property having a frontage on or entrance from the said highway and to which no other reasonable route was available.

3. ASCERTAINMENT OF OFFENDERS.

- (1) Any authorized person or police officer may require any person driving, or causing or permitting to be driven, or allowing cattle along or upon the said highway, to supply on demand information as to his name and address and the name and address of the owner of the cattle, together with particulars relating to the place from which the cattle were driven, their intended destination, the route by which they travelled, and any other information which may be required by such authorized person or police officer in the exercise of his duties.
- (2) If any person driving, or causing or permitting to be driven, or allowing cattle along or upon the said highway, shall refuse to give any of the information required to be given by him in pursuance of these by-laws, or shall give false information, or shall withhold information so as to create a false improved the state of t impression, he shall be guilty of an offence.

(3) Any other person who, on the request of any authorized person or police officer, shall fail, when required, to give information which is in the power of such person to give, and which relates to any breach or alleged breach of these by-laws, shall be guilty of an offence.

4. OFFENCES AND PENALTY.

(1) Every person who does, or causes or procures to be done, anything contrary to or otherwise than is provided by these by-laws, or who shall omit anything therein required to be done by him, shall be guilty of an offence.

(2) Every person guilty of an offence against these by-laws shall be liable for each such offence to a fine not exceeding

£10 (ten pounds).
