*Revoking Part of a Proclamation defining the Middle-lines of Portions of a Road in Blocks II, III, and VIII, Paekakariki Survey District—viz., Portions of the Plimmerton—Paekakariki Road.*

A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the twelfth day of July, one thousand nine hundred and thirty-eight, and published in the *New Zealand Gazette* No. 52 of the fourteenth day of the same month at page 1640, and deposited in the Land Registry Office at Wellington as No. 2709, defining the middle-lines of portions of a road in Blocks II, III, and VIII, Paekakariki Survey District—viz., portions of the Plimmerton—Paekakariki Road—in so far as it affects Lot 46, D.P. 729, Township of Plimmerton, comprised and described in Certificate of Title, Volume 172, folio 61, Wellington Registry.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Christchurch City Council on the seventh day of September, one thousand nine hundred and forty-two, viz. :—

“The Christchurch City Council, being the local authority having control of the streets in the City of Christchurch, hereby, by resolution, declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the northern side of portion of Edgeware Road adjoining the land comprised in Certificate of Title 254/203, being part R.S. 219 and part Lot 57, D.P. 2004, other part of the said R.S. 219”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the northern side of the portion of Edgeware Road (described in the Schedule hereto) within a distance of sixty-six feet from the southern side of the said portion of street.

## SCHEDULE.

THE northern side of all that portion of street situated in the Canterbury Land District, City of Christchurch, known as Edgeware Road, fronting part Rural Section 219, part of the said rural section being more particularly described as part Lot 57, Plan 2004. As the same is more particularly delineated on the plan marked P.W.D. 115355, deposited in the office of the Minister of Public Works at Wellington, and thereon coloured red.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Dunedin City Council on the fourteenth day of September, one thousand nine hundred and forty-two, viz:—

“That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the north-eastern side of the portion of Oban Street adjoining Allotment 84, Township of Linden, such land being comprised and described in Certificate of Title, Register Book, Volume 28, folio 147”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-eastern side of the portion of Oban Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of street.

## SCHEDULE.

THE north-eastern side of all that portion of street situated in the Otago Land District, City of Dunedin, known as Oban Street, fronting Lot 84, Township of Linden. As the same is more particularly delineated on the plan marked P.W.D. 115385, deposited in the office of the Minister of Public Works at Wellington, and thereon coloured red.

*Authorizing William Davidson Irvine, of Wairoa Gorge, Farmer, to use Water for the Purpose of generating Electricity.*

## ORDER IN COUNCIL.

At the Government House at Wellington, this 28th day of October, 1942.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Public Works Act, 1928, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent

of the Executive Council of the said Dominion, doth hereby grant to William Davidson Irvine, of Wairoa Gorge, Farmer (hereinafter referred to as “the licensee”), a license subject to the conditions hereinafter set forth to take and use from Chrome Creek situated in Block XIII, Waimea Survey District, in the Land District of Nelson, for the purposes hereinafter set forth a stream of water not exceeding one and a quarter cubic feet per second at any one time.

## CONDITIONS.

## 1. IMPLIED CONDITIONS.

THE conditions directed to be implied in all licenses by the Water-power Regulations 1934, and the Electrical Supply Regulations 1935, shall be incorporated in and shall form part of this license except in so far as the same may be inconsistent with the provisions hereof.

## 2. LICENSE SUBJECT TO REGULATIONS.

This license is issued under the Water-power Regulations 1934, the Electrical Wiring Regulations 1935, and the Electrical Supply Regulations 1935, and is subject thereto and to any regulations made or to be made in amplification or amendment thereof or in substitution thereof.

## 3. UTILIZATION OF WATER AND LOCATION OF HEADWORKS.

Water shall be used under this license solely for the purpose of generating electricity up to a maximum capacity of two kilowatts at 230 volts direct current, and shall be taken from Chrome Creek at the point indicated on the plan marked P.W.D. 114363, deposited in the office of the Minister of Public Works at Wellington.

## 4. GENERAL DESCRIPTION OF WORKS.

The licensee is hereby authorized, subject to the conditions hereof, to construct, maintain, and use the following works for the purposes of this license, the approximate positions of the said works being indicated on the said plan P.W.D. 114363:—

- (a) Headworks consisting of a dam and intake with a water-race and pipe-line leading to the pelton-wheel and power-house hereinafter referred to, giving a static head of approximately 40 ft.
- (b) A power-house, with all necessary equipment, for generating electricity.
- (c) Water-race leading from the said pelton-wheel to Chrome Creek.

## 5. SYSTEM OF SUPPLY.

The system of supply shall be as described in paragraph (d) of clause 21-01 of the Electrical Supply Regulations 1935. The generating voltage and the transmission voltage shall be approximately 230 volts direct current.

## 6. DURATION OF LICENSE.

Unless sooner determined, this license shall continue in force until the 31st day of March, 1962, or until electrical energy is available from an Electric-power Board or other general public source, whichever is the earlier.

## 7. RENTAL.

For the purpose of assessing the annual rental payable in respect of this license, the licensee may install a suitable maximum-demand indicator to the satisfaction of the Inspecting Engineer of the Public Works Department, and, failing such installation, the rental shall be assessed on the maximum generating capacity of the plant installed. The present plant is rated at two kilowatts.
