thousand nine hundred and twenty-two (as from time to time amended and as the same are enuring under the Government Railways Act, 1926), in the manner following, that is to say : By omitting paragraphs (b) and (c) of Regulation 67 and sub-stituting therefor the following :—

"(b) To relaying gangers, ballast gangers, quarry gangers, fencing gangers, and line gangers in the Maintenance Branch, and married employees when relieving section-men in the Signal and Electrical Branch, if provided by the Department with sleeping-vans or huts, 5s. 6d. per night.

Act., 1931, His Excellency the Governor-General. of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby revoke the Order in Council dated the fourth day of May; one thousand nine hundred and thirty-two, making the Lake Okataina Scenic Board Regulations 1932, and in lieu thereof doth hereby make the following regulations prescribing the practice and procedure of the Board of Control constituted to control the Lake Okataina Scenic Reserves.

### REGULATIONS.

1. These regulations may be cited as the Lake Okataina Scenic Board Regulations 1943.

2. In these regulations, if not inconsistent with the context,-

"Board" means the Lake Okataina Scenic Board constituted pursuant to the provisions of section:  $17^{(1)}$  of the Native Purposes-Aet; 1938, by the Warrant dated the 3rd day of February; 1943, and gazetted on the 11th day of that month:

- "Reserves" means the areas declared to have been ceded to the Crown by the Proclamation dated the 30th day of May, 1931, and gazetted on the 4th day of June following : "Minister" means the Minister of the Crown for the time being charged with the administration of the Scenery Preservation Act, 1908.

3. The first meeting of the Board shall be held in Rotorua during the month of February, 1943. Thereafter the Board shall meet for the transaction of business at such times and place as may

meet for the transaction of business at such times and place as may from time to time be fixed by the Board. 4. The Board shall, at its first meeting, elect one of its members to be Chairman, who shall have an original as well as a casting vote, and who shall hold office until the election of his successor. 5. Special meetings may be convened by the Chairman, provided that two days' notice of such meeting be given to each member, specifying the business to be transacted at such special meeting. No business other than that so specified shall be transacted at such meeting.

6. Any three members of the Board shall form a quorum. Any meeting may be adjourned from time to time. 7. All questions shall be determined by the majority of votes

All questions shall be determined by the majority of votes of the members of the Board present at a meeting.
 8. If at any meeting the Chairman is not present at the time appointed for holding the same, the members present shall choose one of their number to be Chairman of such meeting.

one of their number to be Chairman of such meeting. 9. If by resignation, death, incapacity, or otherwise the seat of any member shall be or become vacant, or if any member absents himself without reasonable cause from three consecutive meetings of the Board, the Governor-General shall have power, but subject always to the special provisions of section 17 of the Native Purposes Act, 1931, relating to the representation of the Ngati-Tarawhai Subtribe, to appoint any other person to be a member of the Board in his stead.

in his stead. 10. The Board shall control the reserves in accordance with the provisions of the Scenery Preservation Act, 1908, and of the regulations made thereunder.

11. The funds of the Board shall consist of all moneys received 11. The funds of the Board shall consist of all moneys received by it under or by virtue of the Scenery Preservation Act, 1908, or any other enactment dealing with the reserves, or in any other manner whatsoever in respect of the reserves under its control, and all such moneys shall forthwith after receipt by the treasurer or other proper officer of the Board be paid into such bank as the Board from time to time appoints to an account to be called "The Lake Okataina Scenic Board Account." 12. The funds of the Board shall be applied in managing

12. The funds of the Board shall be applied in managing, administering, and improving the reserves under its control, and for no other purpose. 13. No moneys of the Board shall be disbursed except pursuant

to a resolution passed at a meeting of the Board duly convened and held, but no bank or other person shall be concerned to inquire whether this requirement has been complied with or be affected by any notice of non-compliance therewith. 14. All cheques drawn on the bank account of the Board shall

14. All cheques drawn on the bank account of the Board shall be signed, and all negotiable or transferable instruments requiring the endorsement of the Board shall be endorsed by three persons, one of whom shall be a member of the Board, another of whom shall be a member or officer of the Board, and the third of whom shall be a Field Inspector or other officer of the Department of Lands and Survey from time to time appointed for the purpose by the Under-Secretary for Lands. In the case of moneys of the Board being kept in the Post-office Savings-bank, the account shall be in the name of the Board, and shall be operated upon by three trustees, one of whom shall be a member of the Board, another of whom shall be a member or other officer of the Board, and the third of whom shall be a Field Inspector or other officer of the Department of Lands and Survey from time to time appointed for the purpose by the Under-Secretary for Lands.

### THIRD SCHEDULE.

### REGULATIONS.

1. In these regulations, if not inconsistent with the context,-

- "Boat" means any open, decked, or half-decked boat attached to or used in connection with any ship or other vessel lying in or belonging to or visiting Puriri or Whangamata, and also any such boat used for the purposes of business or pleasure by residents of the Thames County, in which the means of propulsion is either exclusively by oars or partly by oars and partly by sails: by sails :
- "Master" means and includes the person actually in charge of any vessel, whether or not he is certificated :
- "Vessel" means and includes every description of launch or ship, whether used in navigation or in any way kept or used as a hulk or storeship, or for any other purpose whatsoever, whether business or pleasure, and not. coming within the above definition of " boat":
- "Wharf" means the County Wharf at Puriri or Whangamata, and includes the foreshore and land below low-water mark extending for one chain on each side of the said wharf necessary for the working thereof :
- "What necessary to the working energy . "What includes every person actually in charge of any what for the time being.

2. The master of any vessel loading or discharging at either wharf shall be deemed accountable for the proper slinging and landing of all goods, and responsible for all damage that may occur either from the breakage of slings or from the goods being improperly slung or improperly handled.

3. The master of every vessel shall cause proper tarpaulins or net to be stretched from the wharf to the vessel loading or discharging as aforesaid, and shall maintain such tarpaulin or net while cargo or ballast is being landed or shipped.

4. In case any vessel does or causes any damage to any wharf or any part thereof, or to any machinery or building thereon or appertaining thereof, then and in any such case the master of such vessel shall forthwith report the occurrence to the Wharfinger by telegraph, or by at once reporting to the Wharfinger in person, or should there be no Wharfinger, then shall he report to the Council in like manner in like manner.

5. Any damage done or caused as aforesaid may be repaired by the Council, and the cost thereof shall be recoverable by the Council from the master and owner of any such vessel, or either of them, in any Court of competent jurisdiction.

6. The owner of all goods landed on any wharf, or brought thereon for shipment, shall place same so as to keep all mooring posts or rings free and all rails or tramways clear, as the Wharfinger or other authorized person directs.

7. Before any vessel or boat is removed from any wharf the master or other person in charge of the said vessel or boat shall cause all dirt or rubbish to be thoroughly cleared from the portion of the said wharf occupied by such vessel or boat, and to be deposited at such places as may be appointed by the Wharfinger or other person in charge.

8. No person shall make fast any boat to any steps or landing-place or so near thereto as to obstruct the approach of other vessels, nor shall such person permit any boat to lie longer alongside than is required for landing passengers.

9. (a) No person shall drive, take, or work, or cause to be driven, taken, or worked, any cart, vehicle, or horse on any wharf on which carts, vehicles, or horses are permitted by the Wharfinger or person in charge to be taken at other than a walking-pace.

(b) If such cart or vehicle is drawn by one horse, the person in charge of the horse shall walk at the head of and lead the horse; and no person shall ride on any wharf, but shall dismount and lead his horse.

(c) Every person driving or taking any vehicle on any such wharf shall remain in attendance thereon, so as to have control of his horse or horses.

10. All watermen, stevedores, carters, and other persons employed on any wharf or any public landing-place shall be under the control of the Wharfinger or other person in charge, and shall obey all orders given by such person in charge.

11. No person shall in any way obstruct or impede traffic on any wharf, nor make use of any provoking, abusive, obscene, or other improper language thereon.

12. (a) No persons shall, otherwise than as specifically permitted by these regulations, obstruct or impede ingress to or egress from any wharf by any vessel, boat, or cable, or in any other way.

from any whart by any vessel, boat, or cable, or in any other way. (b) If in breach of this clause any person obstruct or impede ingress or egress as aforesaid, and does not, upon being ordered so to do by the Wharfinger or other person in charge, remove such obstruction, then, irrespective of the penalty to which such person is liable for such obstruction the officer in charge may remove, cast off or cut any such obstruction and may recover the cost of so off, or cut any such obstruction, and may recover the cost of so doing from such person.

13. The Wharfinger shall have power, on the authority of the Chairman of the Council, to close the wharves, or any of them or any portion thereof, whenever in his opinion it is advisable to do so, and no person shall enter upon any wharf or portion of the wharf so closed without the consent of the Wharfinger.

14. The master of every vessel lying at a wharf shall give way to any mail-steamer, whether discharging cargo or passengers, and shall either vacate his berth or assist the master of the mail-steamer to moor alongside his vessel, and allow the cargo and passengers to be shipped or unshipped over and across the deck of his vessel, as the 0000 may require, under such conditions as the Wharfinger may impose.

impose. 15. The master of every vessel, whether carrying passengers or not when lying alongside any wharf shall fix, and at all times keep fixed, a safe and proper gangway from such vessel to the wharf. Such gangway shall have side rails and stanchions, with ropes rove taut through same, the top rail or rope being not less than 3 ft. high; and he shall also keep a gangway-net properly secured beneath the gangway, and shall at all times throughout the night— that is to say, from sunset to sunrise—show and exhibit a proper light fixed at each gangway, and shall conform to and obey all orders the Wharfinger may give regarding the position, size, and kind of such gangways and lights. such gangways and lights.

16. The master, owner, or agent of every vessel shall produce the certificate of registry of his vessel, and shall give to the Wharfinger or other person in charge a copy of the bill of lading, freight list or manifest of the cargo, or other proper accounts of the weights and measurements of all goods according as freight is payable, intended to be unshipped from the vessel on to a wharf, and also of all goods shipped from the vessel on to a wharf, and also of all goods shipped from the wharf on to his vessel.

### NOTES ON THE WEATHER FOR JANUARY, 1943.

NOTES ON THE WEATHER FOR JANUARY, 1943. General Notes.—January was a dry month with some cloudy, humid spells. Useful rains gave a measure of relief to the parched conditions prevailing in Gisborne and Hawke's Bay, but falls were lighter in the Wairarapa and still less effective in Marlborough. The milk yield has been on the decline. There have been intervals of excellent harvesting weather. Vegetable and fruit crops have done very well and cereal crops are satisfactory. The dryness has adversely affected many of the supplementary root crops, especially those recently planted. *Rainfall*.—In most districts rainfall was appreciably below normal. The month was particularly dry in Marlborough. There were substantial deficiencies in North Auckland. Between East Cape and Castlepoint the January averages were exceeded at the majority of places. Average values were reached also locally near Christchurch. *Temperatures.*—With very few exceptions mean temperatures for the month differed by less than 1° F. from their normals. The only extremes of special interest were the high temperatures prevailing in eastern districts on the 30th, when, for example, Napier had a maximum of 96.5° F. and Blenheim 94.6° F. *Sunshine.*—New Plymouth, Wellington, and Blenheim received slightly more than average sunshine, but at most other places there were deficiencies, which were greatest in the Bay of Plenty area.

Weather Sequence.—The month opened with cold southerlies, but as an anticyclone from the south covered New Zealand on the 3rd and 4th, showers persisted awhile on the east coast, but the weather became fine generally with a rapid rise in temperature. A trough travelled up the country on the 5th and 6th, and a depression from the north passed near East Cape. Fresh southerlies prevailed and the weather was showery in the east with scattered rain, which was fairly heavy in the Gisborne-Napier region. Pressure rose generally on the 7th, the

was showery in the east with scattered rain, which was fairly heavy in the Gisborne-Napler region. Pressure rose generally on the 7th, the weather becoming fair and warm. Between the 9th and 13th a slow-moving trough advanced from the south, and a depression moved down the east coast of the North Island to Chatham Islands. The weather was cloudy and warm with scattered rain. Falls were heavy at first about the southern Sounds, and on the 11th moderately heavy rain occurred near East Cape and over the Central Provinces on the 12th. On the 12th and 13th the centre to the east deepened and cooler southerlies prevailed. Conditions were cloudy and milder on the 14th and 15th, and a disturbance crossing the North Island on the 16th gave scattered rain and increased humidity. A high-pressure wedge passed over central New Zealand on the 17th with fine weather, but rather misty conditions persisted in the north.

and increased humidity. A high-pressure wedge passed over central New Zealand on the 17th with the weather, but rather misty conditions persisted in the north. Between the 18th and 20th a depression moved from the west; fresh to strong winds from a westerly quarter prevailed. Rain developed in the Taranaki area, and some heavy falls occurred about and west of the Alps. Later, brief showers extended to the east, but conditions were improving as an anticyclone covered northern New Zealand between the 21st and 23rd. On the later date a trough slowly advancing from the south brought rain to the south-west. With a centre developing in the west, the weather became more generally unsettled on the 24th with considerable drizzle and rain, especially in central areas. On the 26th an anticyclone over the northern Tasman Sea intensified, and a series of rapidly moving westerly depressions passed in the south. Winds fluctuated between north-west and south-west, with temperatures very warm at times in eastern and northern areas. The depression on the 30th had a very deen trough with north-westerly gales ahead and some strong souther lies in southern districts behind it.
