Revoking a Proclamation declaring French Somaliland to be an Enemy Country for the Purposes of the Enemy Property Emer-gency Regulations 1939 and the Enemy Trading Emergency gency Regulations Regulations 1939.

C. L. N. NEWALL, Governor-General. [L.S.] A PROCLAMATION.

A PROCLAMATION: In pursuance and exercise of the powers and authorities vested in me by the Enemy Property Emergency Regulations 1939 and the Enemy Trading Emergency Regulations 1939, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the twenty-third day of September, one thousand nine hundred and forty, and published in the New Zealand Gazette No. 100 of the twenty-sixth day of the same month, proclaiming and declaring French Somaliland to be an enemy country for the purposes of the Enemy Property Emergency Regulations 1939 and the Enemy Trading Emergency Regulations 1939.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand, and issued under the Seal of that Dominion, this 31st day of March, 1943.

**B**<sup>Y</sup> virtue of the powers and authorities vested in me by the thirty-fourth section of the Public Reserves, Domains, and National Parks Act, 1928, I, Cyril Louis Norton Newall, the Governor-

General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby order and declare that the reserve for recreation in the Wellington Land District described in the Schedule hereto shall be to be subject to the provisions of Part II of the said Act, and such reserve shall hereafter form part of the Nukumaru Domain, and be managed, administered, and dealt with as a public domain by the Nukumaru Domain Board.

#### SCHEDULE.

ALL that area in the Wellington Land District containing by admea-surement 4 acres 3 roods 28.6 perches, more or less, situated in Block IX, Nukumaru Survey District, being part of the Native Land Court Subdivision known as Pakaraka 1<sup>1</sup>3, shown on a plan deposited in the office of the Chief Surveyor at Wellington as No. 19584, and being all the land comprised in Certificate of Title, Volume 492, folio 259 (Wellington Registry).

THE HON. D. G. SULLIVAN PRESIDING IN COUNCIL. IN pursuance and exercise of the powers and authorities conferred upon him by subsection one (b) of section seven of the Public Reserves, Domains, and National Parks Act, 1928, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby cancel the reservation for public-utility purposes over the land described in the Schedule hereto; and doth hereby declare that the said land, being vested in the Crown, is Crown land available for disposal under the Land Act, 1924.

#### SCHEDULE.

ALL that area in the Nelson Land District, Buller County, containing by admeasurement 1 rood 8 perches, more or less, being portion of Section 1B, Town of Charleston, commencing at a point in Camp Street, 100 links from the corner of Camp Street and Darkies Terrace Street 100 links from the corner of Camp Street and Darkis Ferrate Road; bounded on the north-west by Camp Street aforesaid, 150 links; and thence on the north-east, south-east, and south-west by the other portion of Section 1R, 200 links, 150 links, and 200 links respectively. As the same is more particularly delineated on the plan marked L. and S. 6/7/235, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon bordered red.

WHEREAS by the three-hundred-and-fifty-ninth section of the W LEACH by the three-introduct and inty-initial sector of the Land Act, 1924, it is enacted that the Governor-General may from time to time set apart temporarily as reserves, notwith-standing that the same may be then held under pastoral license, any Crown lands which in his opinion are required for any of the purposes in the said section mentioned :

And whereas by the three-hundred-and-sixtieth section of the said Act it is provided that land temporarily reserved under the said three-hundred-and-fifty-ninth section may, at the expiration of one month, but not later than six months, after the publication in the description of any temperature preservation. Gazette of notice of such temporary reservation, be permanently reserved, and that notice of such permanent reservation shall be published in the Gazette:

And whereas the lands described in the Schedule hereto were, by the Warrant dated the eighth day of February, one thousand nine hundred and forty-three, and published in the *Gazette* of the eleventh day of that month, temporarily reserved under the authority of the said Act for the purposes in the Schedule of the said Warrant specified at the end of the respective descriptions of the lands so intended to be temporarily reserved :

Now, therefore, I. Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon me by the said Act, do hereby permanently reserve the lands described in the Schedule hereto for the purposes in the said Schedule specified at the end of the respective descriptions of the lands so intended to be permanently reserved for which purposes the said lands were so temporarily reserved as aforesaid.
