IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the First Schedule hereto is hereby taken, and that the land described in the Second Schedule hereto is hereby taken subject to the drainage rights created in and over such land by memorandum of transfer registered in the Land Transfer Office at Wellington under number 104782, and that the Crown land described in the Third Schedule hereto is hereby set apart for public works; and I do also declare that this Proclamation shall take effect on and after the tenth day of May, one thousand nine hundred and forty-three.

IN PREVALL, Governor-General In pursuance and exercise of the powers and authorities conferred upon him by section thirteen of the Scenery Preservation Act, 1908, His Excellency the Governor-General of the Dominion of New Zealand doth hereby vest the control of the reserve described in the Schedule hereto (being land reserved under the said Act) for the period of five years from the date hereof (unless previously altered or revoked under the said Act), in the undermentioned persons, namely -namely,-

Special meetings may be convened by the Chairman, provided that two days' notice of such meeting is given to each member, specifying the business to be transacted at such special meeting ; and no other business than that so specified shall be transacted at such meeting. such meeting.

4. Any seven members of the Board shall form a quorum. Any

Any seven members of the Board shall form a quorum. Any meeting may be adjourned from time to time.
5. All questions shall be determined by the majority of votes of the members of the Board present at the meeting.
6. If at any meeting the Chairman is not present at the time appointed for holding the same, the members present shall choose one of their number to be Chairman for such meeting.
7. If by resignation death incomparity or otherwise the cost

one of their number to be Charman for such meeting. 7. If, by resignation, death, incapacity, or otherwise, the seat of any member shall be or become vacant, or if any member absents himself, without reasonable cause, from three consecutive meetings of the Board, the Governor-General shall have power to appoint any other person to be a member of the Board in his stead. 8. The Board may, with the approval of the Minister in Charge of Scenery Preservation, make such rules as it deems necessary

for the good conduct of the public frequenting the reserve, and may

for the good conduct of the public frequenting the reserve, and may set apart areas for camping-grounds or other purposes, and may fix reasonable charges for the use thereof in accordance with a scale to be approved from time to time by the Minister. 9. The Board shall prepare and submit at an annual meeting to be held in the month of April in each year a report of the proceedings of the Board for the previous year ending on the thirty-first day of March, together with a statement of the receipts and expen-diture of the Board for such year. A copy of every such report and statement, certified by the Chairman to be correct, shall be sent to the Minister in Charge of Scenery Preservation as soon as possible after each annual meeting.
