Price Order No. 136, Amendment No. 1 (Apples and Pears)

PURSUANT to the powers conferred on it by the Control of Prices Emergency Regulations 1939,* the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following amending Price Order:—

1. This Order may be cited as Price Order No. 136, Amendment No. 1, and shall be read together with and deemed part of Price Order No. 136† (hereinafter referred to as "the principal Order").
2. This Order shall come into force on the 17th day of May, 1943.
3. The First Schedule to the principal Order is hereby revoked and the following Schedule substituted therefor:—
