WHEREAS the Palmerston North Hospital Board (hereinafter called "the said local authority"), being desirous of raising a loan of seventy-one thousand pounds (£71,000), to be known as "Buildings, Plant, and Equipment Loan, 1943" (hereinafter called "the said loan"), for the purpose of providing additions and alterations to and strengthening buildings, and providing services, furnishings, and equipment, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council, as required by the said Act, should be given to the raising of the said loan:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of seventy-one thousand pounds (£71,000), and in giving such consent doth hereby determine as follows:—

(1) The term for which the said loan or any part thereof may be raised shall be twenty (20) years.

(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding three pounds seven shillings and sixpence (£3 7s. 6d.) per centum per annum.

(3) The said loan or any part thereof shall be repaid by the half-yearly redemption of debentures in the half-years set out in the first column of the Schedule hereunder of the amounts stated opposite each such half-year in the second column of the said Schedule.

WHEREAS the Newmarket Borough Council (hereinafter called "the said local authority"), being desirous of raising a loan of nine thousand pounds (£9,000), to be known as "Waterworks Loan, 1942" (hereinafter called "the said loan"), for the purpose of replacing, cleaning, and relining water mains in the borough, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council, as required by the said Act, should be given to the raising of the said loan:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of nine thousand pounds (£9,000), and in giving such consent doth hereby determine as follows:—

(1) The term for which the said loan or any part thereof may be raised shall not exceed twenty-two (22) years.

(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate or rates exceeding three pounds ten shillings (£3 10s.) per centum per annum.

(3) The said local authority shall, before raising the said loan or any part thereof, make provision for the repayment thereof by establishing a sinking fund under the Local Bodies' Loans Act, 1926, or under such other statutory enactment as may be applicable, and shall thereafter make payments to such sinking fund at intervals of not more than one year at a rate or rates per centum which shall be not less than three pounds two shillings (£3 2s.), such payments to be made in respect of every part of the said loan for the time being so borrowed and not repaid, the first such payment to be made not later than one year after the first day from which interest to the lender or lenders is computed on the said loan or any part thereof so raised.

(4) The payment of interest and repayment of principal in respect of the said loan shall be made in New Zealand.

(6) The rate payable for brokerage, underwriting, and procurement fees in respect of the borrowing of the said loan or any part thereof shall not in the aggregate exceed one-half per centum of the amount raised.

WHEREAS by Order in Council made on the seventeenth day of July, one thousand nine hundred and forty, and subject to the determinations as to borrowing and repayment therein set out, consent was given to the raising by the Auckland City Council (hereinafter called "the said local authority"), of a loan of two hundred and twenty-one thousand eight hundred pounds (£221,800), to be known as "Waterworks Development Loan, 1940" (hereinafter called "the said loan"):

And whereas the authority conferred by the said Order in Council has not been exercised to the extent of one hundred and seventy-one thousand eight hundred pounds (£171,800) (hereinafter called "the said sum"):

And whereas the authority has lapsed in accordance with the provisions of clause seven of the said Order in Council, and it is not now lawful or competent for the said local authority to raise the said sum or portion thereof except in accordance with the provisions of a further Order in Council that may be issued pursuant to section eleven of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"):

And whereas it is expedient to authorize the said local authority to raise the said sum on the conditions hereinafter mentioned:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said sum up to the amount of one hundred and seventy-one thousand eight hundred pounds (£171,800), and in giving such consent doth hereby determine as follows:—

(1) The term for which the said sum or any part thereof may be borrowed shall not exceed twenty-five (25) years.

(2) The rate of interest that may be paid in respect of the said sum or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding three pounds fifteen shillings (£3 15s.) per centum per annum.

(3) The said local authority shall, before raising the said sum or any part thereof, make provision for the repayment thereof by establishing a sinking fund under the Local Bodies' Loans Act, 1926, or under such other statutory enactment as may be applicable, and shall thereafter make payments to such sinking fund at intervals of not more than one year, at a rate or rates per centum which shall be not less than two pounds eleven shillings and fourpence (£2 11s. 4d.), such payments to be made in respect of every part of the said sum for the time being so raised and not repaid, the first such payment to be made not later than one year after the first day from which interest to the lender or lenders is computed on the said sum or any part thereof so raised.

(4) The payment of interest and repayment of principal in respect of the said sum shall be made in New Zealand.

(5) No amount payable as either interest or sinking fund in respect of the said sum shall be paid out of loan-moneys.

(6) The rate payable for brokerage, underwriting, and procurator fees in respect of the raising of the said sum or any part thereof shall not in the aggregate exceed one-half per centum of any amount raised.

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the respective local authorities mentioned in the first column of the said Schedule of the respective loans set out in the second column of the said Schedule, up to the respective amounts specified in the third column of the said Schedule, and in giving such consent doth hereby determine as follows:—

The Council may, subject to the provisions of section 171 of the Harbours Act, 1923, erect or license or permit the erection of bathing-sheds or boat-sheds on the foreshore prescribed in the First Schedule hereto, and may make by-laws regulating the use thereof and may fix charges for such use, provided that the funds so received shall be expended in improving the foreshore for the benefit of the public.

6. Nothing herein contained shall authorize the Council to remove or cause to be removed any stone, sand, shingle, or shells without the consent of the Minister being first obtained.

7. By-laws made by the Council under the said Act in respect of the foreshore shall not have effect unless and until approved in writing by the Minister.

8. The rights, powers, and privileges conferred by or under this Order in Council shall continue to be in force for twenty-one years from the date hereof, unless in the meantime such rights, powers, and privileges shall be altered, modified, or revoked by competent authority.

9. The said rights, powers, and privileges may be at any time resumed by the Governor-General, without payment of any compensation whatever, on giving to the Council six calendar months' previous notice in writing. Any such notice shall be sufficient if given by the Minister, and delivered at or posted to the last-known address of the Council in New Zealand.

The Auckland Milk Pasteurizing and Distributing Depot Employees' Labour Legislation Suspension Order 1943, No. 2

IN pursuance of the Labour Legislation Emergency Regulations 1940, the Minister of Labour doth hereby order as follows:—

1. This Order may be cited as the Auckland Milk Pasteurizing and Distributing Depot Employees' Labour Legislation Suspension Order 1943, No. 2.

2. This Order applies to Amburys Limited and Stonex Bros., Limited, both of Auckland, and to female workers employed by those companies on work which is subject to New Zealand (except Marlborough and Wellington Twenty-mile Radius) Milk Pasteurizing and Bottling Factories' Employees' award, dated the 31st day of March, 1941, and recorded in 41 Book of Awards 200.

3. The provisions of the Factories Act, 1921-22, and its amendments, shall be and are hereby suspended in so far as they operate to prevent or restrict the employment of the workers mentioned in clause 2 between the hours of 8 a.m. and 11 p.m. on ordinary working-days, Sundays, holidays, and half-holidays, subject to the following conditions, namely:—

(1) The employment of the said workers shall be in accordance with the provisions of the above-mentioned award:

(2) Where female workers are employed after dark the employer shall, if public transport is not available, provide at his own expense a suitable conveyance for the transport of such workers:

(3) The employer shall keep a copy of this Order posted up in the changing-room provided for the female workers.

4. This Order shall be deemed to have come into effect on the 1st day of May, 1943.

Resolutions passed at a special meeting of the Raglan County Council held on the 12th February, 1943, and confirmed at a special meeting held on the 9th April, 1943. Moved by Councillor W. J. Lusty and seconded by Councillor E. Baker.

SPECIAL ORDER.—ABOLITION OF RIDING ACCOUNTS

“That, in exercise of the powers conferred on it by section 2 of the Counties Amendment Act, 1931, the Raglan County Council resolves and declares, by way of special order, that sections 121 and 131 of the Counties Act, 1920 (as to levy of general rates separately in ridings and as to apportionment of income, &c.), shall not apply to the Raglan County Council.”

Price Order No. 138 (Cabbages and Silver Beet)

PURSUANT to the powers conferred on it by the Control of Prices Emergency Regulations 1939,* the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order:—

1. This Order may be cited as Price Order No. 138, and shall come into force on the 24th day of May, 1943.

APPLICATION OF THIS ORDER

2. (1) This Order applies with respect to the sale for human consumption of cabbages and silver beet.

(2) Every sale of any such vegetables shall be deemed to be a sale for human consumption unless at the time of sale there is a bona fide agreement or stipulation between the buyer and the seller that the vegetables to which the sale relates are intended for a specific purpose other than human consumption.

3. The maximum prices fixed by this Order apply with respect to sales by auction, as well as to other sales.

4. The wholesale prices fixed by this Order apply with respect to sales of the following classes, namely:—

- (a) Sales to retailers (whether made by the grower or any other person); and
- (b) Sales to users in any case where a lot of not less than 5 cwt. of any one kind of vegetable to which this Order applies is sold to any one purchaser for delivery at one time.

5. The provisions of this Order fixing prices by reference to the weight of the vegetables to which any sale relates shall apply notwithstanding that in any such case the seller may sell or purport to sell otherwise than by weight.

FIXING MAXIMUM PRICES OF VEGETABLES TO WHICH THIS ORDER APPLIES

1. This Order may be cited as Price Order No. 121, Amendment No. 1, and shall be read together with and deemed part of Price Order No. 121† (hereinafter referred to as "the principal Order").

2. This Order shall come into force on the 24th day of May, 1943.

3. (1) Clause 5 of the principal Order is hereby extended to apply with respect to honey that is packed in retail containers of a kind that is not described in the first column of the Schedule to the principal Order, as amended by this Order or by any subsequent amending Order that may hereafter be issued: Provided that where the price of any honey to which this clause applies, computed in accordance with clause 5 of the principal Order, is not an exact number of pence or half-pence, the maximum price of the lot shall be the nearest upward halfpenny.

(2) The several prices fixed by clause 5 of the principal Order, in its application to any honey referred to in the last preceding subclause, shall include the price of the containers.

(3) The principal Order is hereby consequentially amended by inserting the words "of a kind described in the Schedule hereto" after the words "in retail containers" in the heading to clause 5 and also in subclause (1) of the said clause.

4. The principal Order is hereby further amended by inserting after clause 5 the following heading and new clause:—

FIXING MAXIMUM RETAIL PRICE OF HONEY SOLD IN COMB

"5A. Notwithstanding anything in the last preceding clause, the maximum price that may be charged or received by any retailer for honey sold in the comb shall be computed at the rate of 1s. 6d. per pound gross weight: Provided that where the price of any comb honey computed as aforesaid is not an exact number of pence or half-pence, the maximum retail price of the lot shall be the nearest upward halfpenny."

5. The Schedule to the principal Order is hereby amended as follows:—
