HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL WHEREAS by Order in Council made on the third day of March, one thousand nine hundred and forty-three, consent was given to the raising in New Zealand by the Palmerston North City Council (hereinafter called "the said local authority") of a loan of thirty-five thousand pounds (£35,000), to be known as "Municipal Buildings Loan, 1942," for the purpose of demolishing the old portion of the existing building and erecting on the present site a new municipal building, strengthening the remaining portion of the old building, and the purchase of furnishings—*i.e.*, floor-covering. coverings :

And whereas the said local authority is desirous of raising a further loan of ten thousand pounds ($\pm 10,000$), for the purpose of meeting additional costs of the work, and has complied with the provisions of the Local Government Loans Board Act, 1926 (herein-after called "the said Act"):

And whereas the said Act): And whereas the said loan of thirty-five thousand pounds (£35,000) has not yet been raised, and the local authority is desirous of raising the amounts of thirty-five thousand pounds (£35,000) and ten thousand pounds (£10,000) in one loan of forty-five thousand pounds (£45,000), to be known as "Municipal Buildings Loan, 1944" (hereinafter called "the said loan"), and it is expedient that the precedent consent of the Governor-General in Council, as required by the said Act, should be given to the raising of the said loan : loan :

(1) The term for which the said loan or any part thereof may be borrowed shall be twenty-five (25) years.

(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding three pounds five shillings (£3 5s.) per centum per annum.

(3) The said loan shall be repaid by the half-yearly redemption of debentures in the half-years set out in the first column of the Schedule hereunder of the amounts stated opposite such half-years in the second column of the said Schedule.

**PURSUANT** to the powers conferred on it by the Control of Prices Emergency Regulations 1939,* the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order :--

1. This Order may be cited as Price Order No. 258, and shall come into force on the 21st day of July, 1944.

#### APPLICATION OF THIS ORDER

2. This Order applies with respect to towels and towelling imported into New Zealand from the United States of America.

FIXING MAXIMUM RETAIL PRICES OF GOODS TO WHICH THIS ORDER APPLIES

3. The maximum price that may be charged or received by any retailer for any goods to which this Order applies shall be the appropriate maximum price set out in the Schedule hereto.
