*The Foodstuffs Rationing Coupon Notice (No. 2) 1944, Amendment No. 1*

PURSUANT to the powers conferred on the Rationing Controller by the Rationing Emergency Regulations 1942, and duly delegated to me by the said Controller pursuant to Regulation 4 of the Supply Control Emergency Regulations 1939, I, Andrew John Costelloe, the Secretary to the Rationing Controller, hereby give the following directions:—

1. This notice may be cited as the Foodstuffs Rationing Coupon Notice (No. 2) 1944, Amendment No. 1, and shall be read together with and deemed part of the Foodstuffs Rationing Coupon Notice (No. 2) 1944\* (hereinafter referred to as "the principal notice").
2. This notice shall come into force on the 19th day of March, 1945.

3. Clause 4 of the principal notice (which prescribes the four-weekly ration of sugar) is hereby amended by omitting the expression "3 lb.", and substituting the expression "2½ lb."

*Notice of a Scheme of Development and Reconstruction (Hutt Valley)*

IN accordance with subsection (2) of section 29 of the Finance Act (No. 3), 1944, I, Robert Semple, the Minister of Works, hereby give notice of the nature of the work included in the scheme of development and construction described in the First Schedule hereto. The approximate boundaries of the area hereby affected are as described in the Second Schedule hereto, such area being hereinafter referred to as "the area." This notice shall remain in force until the 31st day of March, 1955.

FIRST SCHEDULE

NATURE OF WORK

THE development of the area for residential and business and industrial purposes with the provision of additional, and the improvement of existing, access and public utilities and amenities, including in particular the provision of:—

- (1) *Water-supply.*—A water-supply scheme comprising the collection of water from the Hutt River from a point above the confluence of the Hutt River with the Pakuratahi River and the conduct thence of such water by tunnels and pipe-lines to give supply where determined by the Minister to be necessary within the area.

thence along the northern and western boundaries of that section, the western boundaries of Sections 118 and 117, Ohariu District, and the western boundaries of Sections 28, 26, and 24, Porirua District, Block VII, Belmont Survey District, to the westernmost corner of the said Section 24; thence southeasterly along the south-western boundary of that section to Stebbing's Road; thence southerly along the western side of that road and the western side of the Wellington-Paekakariki Centennial State Highway to the northern boundary of Johnsonville Town District; thence easterly along that boundary, as described in *New Zealand Gazette* of 12th September, 1940, page 2308, to its easternmost point; thence easterly and northerly along the southern and eastern boundaries of Paparangi Settlement; thence northerly along the eastern boundaries of part Section 19, Sections 21, 23, 25, 27, 29, 30, 33, 35, 37, 39, 40, 42, 44, 46, and 48, Porirua District, Block VII, Belmont Survey District, along the eastern boundaries of Sections 50, 51, 53, and 56, Porirua District, Block V, Belmont Survey District, and along the eastern boundaries of Sections 58, 59, and 61, Porirua District, Block II, Belmont Survey District, to the westernmost corner of Section 17, Tukapu District; thence generally easterly along the south-western and south-eastern boundaries of the said Section 17, the south-eastern boundary of Section 19, and the south-western boundary of Section 22, Tukapu District; thence generally northerly along the eastern boundaries of Sections 22, 24, 26, and 32, Tukapu District, Block II, Belmont Survey District; thence easterly along the northern boundaries of Sections 35, 37, and 39, Tukapu District, to the north-western corner of Section 1, Pahautanui District, Block III, Belmont Survey District; thence southerly and easterly along the western and southern boundaries of the said section; thence easterly and northerly along the southern and eastern boundaries of Section 8, Pahautanui District, to the westernmost corner of Section 69, Pahautanui Agricultural Reserve District; thence generally easterly along the southern and eastern boundaries of the said Section 69, the eastern boundary of Section 12, Pahautanui District, the southern boundary of Section 81, the southern and eastern boundaries of Sections 80 and 88, the southern boundary of Section 94, the southern and eastern boundaries of Section 41, Pahautanui Agricultural Reserve District, Block III, Belmont Survey District, and the southern boundary of Section 8, Pahautanui Agricultural Reserve District; thence northerly along the eastern boundary of the said Section 66; thence generally westerly along the northern boundaries of Sections 67 and 68, Pahautanui District, along the northern boundaries of Sections 90, 89, 88, 87, and 86, Porirua District, Block IX, Paekakariki Survey District, along the northern boundary of Section 85, Porirua District, Block VIII, Paekakariki Survey District, to its northernmost corner; thence by a right line to the intersection of the eastern side of the Main Trunk Railway and the north boundary of Block VIII, Paekakariki Survey District, and the production of the said line to the eastern side of Pukerua Track; thence generally southerly along the eastern side of that track and the eastern side of Motuhara Road to the western boundary of the Plimmerton Railway-station yards; thence southerly along that boundary to the Taupo Creek; thence south-westerly along the north side of that creek to mean high-water mark; thence southerly by mean high-water mark to the railway bridge at Paremata; thence southerly along the western side of that bridge and by mean high-water mark to the point of commencement.

*Danger Areas*

IN accordance with Regulation 18 of the Defence Emergency Regulations 1941, the following are danger areas until further notice:—

- (a) *Live Bombing Range.*—The target consists of a small rocky island situated in the Hauraki Gulf at latitude 36° 42' 35" S., and longitude 175° 0' 23" E. This point is 5,800 yards from the northern tip of Rakin Island on a bearing of 090° T. The danger area is all that area within a circle described, with the target as a centre and having a radius of 2,000 yards. The area includes all those rocks known as David Rocks.
- (b) *Forward Firing Rocket Projectile Range.*—The danger area is bounded on the west by a line joining 175° 4' 25" S., 36° 55' 0" S.; 175° 4' 25" E., 36° 55' 15" S.; on the north by a line extending 3,000 yards on a bearing 040° T. from 175° 4' 25" E., 36° 55' 0" S.; on the south by a line extending 3,000 yards on a bearing 100° T. from 175° 4' 25" E., 36° 55' 15" S.; on the east by a line joining the seaward extremities of the north and south boundaries.

This range may be popularly described as being the bay on the south side of Tamaki Strait between Koherunui Point and a point half-mile north-east of Whaka-Kai-Wharu Point.
