Altering Boundaries of Clutha and Southland Counties and including Areas in Maclennan Riding, Clutha County, and Toetoes Riding, Southland County

C. L. N. NEWALL, Governor-General [L.S.] A PROCLAMATION

A PROCLAMATION TN pursuance and exercise of the powers and authorities conferred on me by section fourteen of the Counties Act, 1920, and of all other powers and authorities enabling me in that behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the First Schedule hereto, being now part of the South-land County, shall be added to and form part of the Clutha County; that the area described in the Second Schedule hereto, being now part of the Clutha County, shall be added to and form part of the Southland County; that the boundaries of the Clutha and Southland Counties as so altered shall be those set forth under the respective headings in the Third Schedule hereto; that the area added as Counties as so altered shall be those set forth under the respective headings in the Third Schedule hereto; that the area added as aforesaid to the Clutha County shall be included in the Maclennan Riding of the said county; that the boundaries of the said Maclennan Riding as so altered shall be those set forth in the Fourth Schedule hereto; that the area added as aforesaid to the Southland County shall be included in the Toetoes Riding of the said county; that the boundaries of the Toetoes Riding as so altered shall be those set forth in the Fifth Schedule hereto; and I also proclaim and declare that this Proclamation shall take effect as on and from the first day of April, one thousand, nine hundred and forty-six.

FIRST SCHEDULE

Area excluded from Southland County and included in Clutha County

ALL that area containing 6,800 acres, more or less, being part of Blocks V, XII, XIII, and XIV, Tautuku Survey District : bounded towards the north by other part of Block V; towards the north-east generally by the Chaselands River to the ocean; towards the east and south generally by the ocean to Longbeach Creek; towards the south-west by the centre of Longbeach Creek and part of Chaselands Highway; and towards the west by Section 13, Block XV, and Sections 4 and 2, Block XIV, Waikawa Survey District.

SECOND SCHEDULE

Area excluded from Clutha County and included in Southland County

ALL that area containing 788 acres, more or less, being parts of Sections 1, 2, 3, and 4, Block XIV, Waikawa Survey District, commencing at a point due north of Black Horn on the southern boundary of Rimu Survey District; thence bounded towards the north by Block XI, Rimu Survey District, towards the east by Block V, Tautuku Survey District, to a point in line due east of Black Horn; thence towards the south by that line to Black Horn; thence towards the west by a straight line to the starting noint. thence towards the west by a straight line to the starting-point.

THIRD SCHEDULE

CLUTHA COUNTY

BOUNDED towards the north by a right line running due east from a point in the middle of Back Creek in Block V, Rankleburn Survey District, due west from Trig. Station D, said survey district, to the middle of the Clutha River; thence towards the east and north-east by a line along the middle of the said Clutha River and the Koau Branch thereof to the ocean; thence towards the south-east generally by the ocean to the middle of the Longbeach Creek, north-westerly by the centre of that creek to Chaslands Highway:

thence westerly by that highway to the eastern boundary of Block XV, Waikawa Survey District; thence northerly by that boundary and the eastern boundary of Block XIV, Waikawa Survey District; thence westerly by that highway to the eastern boundary of Block XV, Waikawa Survey District; thence northerly by the northern boundary of said Block XIV; thence northerly by the northern boundary of Section 5, Block XIV; Mokoreta Survey District, and its production to the northern side of the road forming the northern boundary of the said Section No. 5, by the said side of that road and the northern side of the road forming the northern boundary of the said Section No. 5, by the said side of that road and the northern side of the road forming the northern boundary of the said Section No. 5, by the said side of that road and the northern side of the road forming the north-eastern boundaries of Sections Nos. 3, and 2, Block XIV aforesaid, to a point due south of Trig. D to Peg XLII, D.P. 3412, Southland Registry, on the south-western boundary-line of Run No. 258; thence again towards the south-west by the last-mentioned boundary to the Wyndham or Mokoreta River, by that river to a point in line with the south-western boundary-line of Section No. 5, Block VII, Slopedown Survey District; and the production No. 2, Block VI, Slopedown Survey District; and the production No. 2, Block VI, Slopedown Survey District; and the production of its eastern boundary-line to the centre of the road forming its northern boundary, by a line along the centre of Sections Nos. 12, 13, 7, 6, 4, and 1 of Block II, Slopedown Survey District, across the main South Road, by the centre of the road forming the eastern boundary-line of section No. 23, Block V, Waipahi Survey District, by that boundary-line of the waipahi River to a point due east from the north side of a road intersecting Section No. 4, Block XII, Waipahi Survey District, by that boundary-line of the Waipahi River to a point due east from the north side of a road intersecting Section No. 4, Blo by that boundary-line and its production to the middle of the Leithen River; thence again towards the north-east by a line along the middle of that river and the middle of the Pomahaka River to its confluence with the Waipah River; and thence towards the north-west by the continuation of the line along the middle of the Pomahaka River and Back Creek to the place of commencement; excepting that portion of the Borough of Balclutha which comes within the above-described area, and the Clinton Town District.

SOUTHLAND COUNTY

SOUTHLAND COUNTY Commencing at Hummock Peak; thence in a south-easterly direction to Jane Peak; thence in an easterly direction by a right line to Eyre Peak; thence in a southerly direction generally by a right line to the source of the Mataura River; thence in a south-easterly and south-westerly direction generally by the centre of the Mataura River to a point in line with the south-eastern boundary of Section 5, Block III, Nokomai Survey District; thence to and by the south-eastern boundary of the said Section 5, and Sections 6, 7, and 8, all in Block III, Nokomai Survey District; thence to Trig Λ ; thence in a north-easterly direction by right lines to Trigs. E and C, Block I, Trigs. GS and D, Block VII, Nokomai Survey District; thence in a north-easterly direction generally by the summit of the Slate Range and the Hector Mountains to Lorn Peak; thence in a south-easterly direction by a right line to Rocky Mountain; thence due east by a right line to the summit of the Umbrella Mountains; thence in a south-westerly direction generally by the summit of the Umbrella Mountains to Black Umbrella; thence in a southerly direction by a right line to the source of the Leithen

Burn; thence in a south-easterly direction generally by the centre of the Leithen Burn to Clutha County hereinbefore described; thence southerly by the Clutha County boundary to the ocean; thence in a westerly direction generally by the ocean to the centre of the mouth of the Waimatuku Stream; thence in a north-westerly and south-easterly direction along the centre of the Waimatuku Stream to a point in line with the centre of the new channel through Sections 2A and 1A, Block XIX, New River Hundred, approximately 1750 links south-east from the westernmost corner of the aforesaid 1750 links south-east from the westernmost corner of the aforesaid Section 2A; thence to and along the centre of the said new channel on a bearing of $352^{\circ} 45'$ to the centre of the said Waimatuku Stream ; thence by the centre of the said Waimatuku Stream to a point in line with the centre of the said new channel; thence due north by the centre of the said road forming the eastern boundary of the said Section 69, Block III, Oreti Hundred; to the centre of the road forming part of the southern boundary of Section 166, Block III, Oreti Hundred; thence due east by the centre of the said road forming part of the southern boundary of Section 166, Block III, Oreti Hundred; thence due east by the centre of the said road forming part of the southern boundary of the aforesaid Section 166, Block III, Oreti Hundred, to the centre of the road forming the eastern boundary of the aforesaid Section 166; thence in a northerly direction by the centre of the said road forming the eastern boundary of the aforesaid Section 166 and Sections 165, 164 h, 164 h, part Section 163, Lot 1, D.P. 2888, Section 162 and 161, all in Block IX, Oreti Hundred, thence in an easterly direction to and along the southern boundaries of the said Section 61 and Section 51, Block IX, Oreti Hundred; thence due east along the centre of the said road forming the southern boundary of the said Section 237 and Section 238, Block XXXIX, Taringatura Survey District, to a point in forming the southern boundary of the said Section 237 and Section 238, Block XXXIX, Taringatura Survey District, to a point in line with the eastern boundary of the said Section 238; thence due north to and along the eastern boundary of the said Section 238 and Sections 239, 240, 241, 242, all in Block XXXIX, Taringatura Survey District, Sections 243, 244, 245, and part 119 all in Block XXXV, Taringatura Survey District, Run 135A, Block XXXII, Taringatura Survey District, and that line produced to a point in line with the southern boundary of Section 188, Block XXIX, Taringatura Survey District; thence due east to the southern boundary of Section 188 aforementioned; thence in a northerly direction generally by part of the eastern boundary of Section 369, Block XXVIII, Taringatura Survey District, and Sections 368 and 367, both in Block XXII, Taringatura Survey District; to the line forming the southern boundary of Run 1508, Block XVIII, Taringatura Survey District; thence due east by the southern boundaries of the said Run 1508 and part Section 186, both in Block XVIII, Taringatura Survey District, and Sections 261 and 79 and Lots 18 and 19, part Section 123, Block XIX, Taringatura Survey District, and Sections 126, 17, 66, 10, and 18, Block XX, Taringatura Survey District, and the southern boundary of the said Section 18 produced to the centre of the Oreti River; thence in a northerly, north-westerly, and northerly direction generally by the 238, Block XXXIX, Taringatura Survey District, to a point in line with the eastern boundary of the said Section 238; thence section is produced to the centre of the Oreti River; hence in a northerly, north-westerly, and northerly direction generally by the centre of the Oreti River to a point due west of Hummock Peak; thence by a right line due east to Hummock Peak, the point of commencement, excluding therefrom the City of Invercargill, the boroughs of South Invercargill, Gore, Winton, Mataura, and Bluff, and the town districts of Lumsden and Wyndham.

FOURTH SCHEDULE

MACLENNAN RIDING, CLUTHA COUNTY

MACLENNAN RIDING, CLUTHA COUNTY ALL that area in the Clutha County, commencing at Catlins Cone, Trig. D, and bounded on the north-west by a straight line from Trig. D, to Peg XLII, D.P. 3412, Southland Registry, on the south-western boundary of Run 258; thence south-easterly by that boundary to Run 129; thence southerly and easterly by the western and southern boundaries of Run 120 to the Catlins River; thence south-easterly by that River to Block III, Woodland Survey District; thence south-easterly by the western boundaries of Blocks III and VIII, Woodland Survey District, to Purakaunui Stream; thence south-easterly by the centre of the said stream to the ocean; thence south-westerly generally by the Ocean to Clutha County herein described; thence northerly generally by the Clutha County boundary to Catlins Cone, Trig. D.

FIFTH SCHEDULE

TOETOES RIDING, SOUTHLAND COUNTY

TOETOES Riding is bounded by a line commencing at the junction of the middle of the mouth of the Mataura River and the ocean; thence in a north-easterly direction generally by the centre of the Mataura River to its junction with the centre of the Mimihau Stream; thence in an easterly and northerly direction generally by the centre of the said Mimihau stream to where it crosses a road the centre of the said Mimihau stream to where it crosses a road forming part of the southern boundary of Section 25 and Section 15, Block II, Slopedown Survey District; thence in an easterly direction by the southern side of the said road to the westernmost point of Section 3, Block VI, Slopedown Survey District; thence in a south-easterly direction by the south-western boundary of the said Section 3 to the boundary of Southland County herein described; thence southerly generally by the Southland County houndary to the ocean; thence in a westerly direction generally by the ocean to the centre of the mouth of the Mataura River, the place of commencement, save and except all that area in the Wyndham Town district.

FIRST SCHEDULE

WAIKOHU COUNTY ALL that area in the Gisborne Land District, and bounded as follows: Commencing at the northernmost point of Motu No. 1 Block, Block II, Motu Survey District; thence in a north-westerly and north-easterly direction generally by the south-western and north-western boundaries of Whakapaupakihi No. 2 and Sections 23 and 1 of 24, Block II, Motu Survey District, to a point on the southern boundary of Section 3, Block III, Urutawa East Survey District; thence in a westerly direction generally by the southern boundary of Section 3, Block III, Urutawa East Survey District, to the right bank of the Pakihi Stream; thence by the right bank to the right bank of the Pakihi Stream; thence by the right bank of the said stream to a point in line with the northern boundary of Section 4, Block III, Urutawa East Survey District; thence across a road reserve to the northernmost corner of Section 4, Block III, Section 4, Block III, Urutawa East Survey District; thence across a road reserve to the northernmost corner of Section 4, Block III, Urutawa East Survey District; thence in an easterly direction generally by the northern boundary of Sections 4, 6, and 5, Block III, Urutawa East Survey District, to a public road, and thence due north by the western boundary of said public road and Section 3, Block I, Urutawa East Survey District, to the north-west corner of said Section 3; thence due east by the northern boundary of Section 3 aforesaid to and across a public road to its eastern side; thence in a northerly direction by the eastern side of said road to the north-western corner of Section 2, Block II, Urutawa East Survey District; thence by the north-western boundary of Section 2 aforesaid to and across a public road and the north-eastern Survey District; thence by the north-western corner of Section 5, Block VIII, Urutawa Survey District; thence in an easterly direction generally by a public road and the north-eastern boundary of Section 3, Block VIII, Urutawa Survey District, to a point on the western boundary of Section 1, Block V, Otipi Survey District; thence in a northerly direction by the western boundary of said Section 1 to its north-western corner; thence in a north-easterly direction generally by the north-western boundary of Sections 1, Block V, and 2, Block VI, Otipi Survey District, to and across a road reserve, and thence across the Motu River to the right bank thereof; thence down the right bank of the Motu River to the north-western boundary of the worther to the right bank of the Motu River to across a road reserve, and thence across the Motil Kiver to the light bank thereof; thence down the right bank of the Motu River to its intersection with the northern boundary of Lot 8 (D.P. 2480), Block IX, Maungawaru Survey District; thence in a south-easterly direction generally by the north-eastern boundary of Lots 8 (D.P. 2480), 7 and 6 (D.P. 2479), 3 (D.P. 2395), and 2 (D.P. 2394),

Blocks IX, X, XIV, and XV, Maungawaru Survey District, and III and IV, Arowhana Survey District, to the intersection of the north-eastern boundary of Lot 2 (D.P. 2394) with the north-western boundary of Waipaoa 1E Block, Block IV, Arowhana Survey Dis-trict; thence in a north-easterly direction by the north-western boundary of Waipaoa 1E Block, and in a south-easterly direction by the north-eastern boundary of Waipaoa 1E Block to its inter-section with a right line through Trig. Stations 139 and Arowhana; thence in a north-easterly direction to Arowhana Trig. Station; thence along a right line in the direction of Kapua Trig. Station to its intersection with the western boundary of Huiarua No. 3 Block; thence by the western and southern boundaries of that block to the boundary of the Uawa County; thence along the western boundary of the Uawa County, as hereinafter described, to a point in line with the north-west boundary of Lot 1 of Small Grazing-run No. 43A; thence by a right line across a public road to the west side thereof; thence along the north-eastern boundary of Lot 2 of Small Grazing-run No. 43A; thence along the western and north-western boundaries of the Cook County, as described in the *New Zealand Gazette*, 1919, page 1243, to the north-eastern corner of Section 1, Block VIII, Fundar Grazing-run No. 43A; thence along the western and north-western boundaries of the Cook County, as described in the New Zealand Gazette, 1919, page 1243, to the north-eastern corner of Section 1, Block VIII, Tuahu Survey District; thence along the northern boundary of that section, across the Mangatahae Stream, along the eastern boundary of Lot 21 of Tahora 2F Section 2 Block, the eastern and northern boundaries of Lot 24, Tahora 2c 1 Section 3 Block, the northern boundary of Lot 23, same block, the northern and western boundaries of Lot 18 of Tahora 2F Section 2 Block, and the pro-duction of the last-named boundary to its intersection with a right line between Puketapu Trig. Station and Maungapohatu Trig. Station ; thence north-westerly to Maungapohatu Trig. Station to its intersection with the western boundary of Tahora Block ; thence northerly along a direct line to Maungatapere Trig. Station to its intersection with the western boundary of Tahora Block ; thence northerly along that boundary to a point in line with the northern boundary of Small Grazing-run 89 ; thence to and along that bound-ary, the northern boundaries of Small Grazing-run 90, Sections 2 and 3, Block XII, Moanui Survey District, Sections 4, 1, and 2, Block IX, Motu Survey District, and Section 2, Block V, Motu Survey District, to Pokaikiri Trig. Station ; thence along a right line to Trig. Station 149A ; thence by a right line to the northernmost corner of Motu No. 1 Block, Block II, Motu Survey District, being the point of commencement. the point of commencement.

UAWA COUNTY

UAWA COUNTY All that area in the Gisborne Land District, and bounded as follows: Commencing at a point called Koangaumu on the sea-coast; thence towards the north generally by Subdivisions B, C, D, and E, Anaura Block, to the left bank of the Hikuwai River; thence up the left bank of the said river to a point in line with the south-eastern boundary of Tauwhareparae 1F Block; thence by a right line across the Hikuwai River to the south-eastern boundary of Tauwhareparae LE Block : thence towards the north-east renerally south-eastern boundary of Tauwhareparae 1F Block; thence by a right line across the Hikuwai River to the south-eastern boundary of Tauwhareparae 1F Block; thence towards the north-east generally by Tauwhareparae 1F and No. 3 Blocks to the south-western corner of the latter block; thence in a northerly direction by the western boundary of Tauwhareparae No. 3 Block for a distance of 12800 links; thence by a right line running due west 12000 links to Trig. Station 171, Puakato; thence by right lines bearing 262° distance 12400 links bearing 173° 15′ distance 8700 links, and bearing 210° 30′ distance 5200 links, to Rimututahi Trig. Price Order No. 506 (Milk) (Hutt Valley and Bays Metropolitan Milk District)

PURSUANT to the powers conferred on it by the Control of Prices Emergency Regulations 1939,* the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order :--

PRELIMINARY

This Order may be cited as Price Order No. 506, and shall come into force on the 1st day of April, 1946.
 (1) Price Order No. 419† is hereby revoked.
 (2) The revocation of the said Order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.

 "Consumer" means a person who buys milk or cream for purposes other than resale:
 "Shop dairy" means a shop where milk or cream is sold for consumption or use off the premises and not otherwise and where the milk or cream so sold is sold in the form in which it me received into the shop dairy form in which it was received into the shop dairy.

APPLICATION OF THIS OBDER 4. (1) Nothing in this Order shall apply with respect to milk or cream sold to a Hospital Board for use in any institution under the control of that Board or to milk or cream sold for use in any separate institution within the meaning of the Hospitals and Charitable Institutions Act, 1926. (2) Except as provided in the last preceding subclause, this Order applies with respect to all milk and cream wherever produced that is sold—

- (a) To the occupier of any shop dairy within the Hutt Valley and Bays Metropolitan Milk District; or
 (b) By the occupier of a shop dairy or by any other person to a commercial user or to a consumer within the Hutt Valley and Bays Metropolitan Milk District.

(2) The prices fixed by this Order are fixed as for delivery as follows: —
